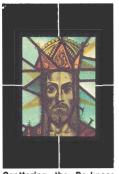

Dear Mr. Blackwell:

Thank you for the latest mailing concerning the School Prayer Amendment. I believe it is the third or fourth mailing the White House has sent us on the subject in three months.

We are honored to have such regular attention. But we are also troubled. Let me try to explain why.

First, the White House is clearly lobbying the religious bodies of the United States on this subject--far more, it seems to us, than on matters that are much more consequential for the well-being of our nation and of the global community. We wonder why such an investment of energy goes to this particular matter just now, when there is no clear evidence of support from the religious bodies of the country.

Second, the White House seeks our support but never seems able to take the time to respond to our reservations. I sent a response to Elizabeth Dole\* expressing our concerns when the first mailing arrived in late May. I felt those concerns were expressed with respect and in a way which deserved comment. But we have received no word, except the continuing flow of general mailings repeating the same positions. (\*copy enclosed)

That is not sufficient to bring us on board. I share with you again a copy of our church's position on the subject, articulated in some detail and developed carefully over a period of many years. I believe the points we are raising deserve to be dealt with.

In addition, could you please tell us why the White House believes this issue has taken on such importance for the life and welfare of our nation at this time, when matters of nuclear arms restraint and economic justice seem so pressing as moral issues within our common life in the U.S.?

Dear Ms. Dole:

We wish to thank you for sending the material related to "The Administration's Proposed Constitutional Amendment Relating to School Prayer."

In response, I send to you a collection of materials concerning the subject which express the position of The American Lutheran Church, "Public Schools and Religious Practices." Let me also summarize the problems we continue to see in any proposal such as the one being offered by President Reagan.

- 1. Genuinely voluntary prayer by individuals is always possible, in public schools or anywhere else. What is neither permitted now, nor desireable in our view, is group prayer sponsored by government. Once sponsored by a school board and aministered by an employee of a local government agency, prayer is no longer "voluntary," nor would it be truly optional. The practice would inevitably place government in the role of sponsoring corporate religious activity. It strikes one as ironic that this Administration, with its strong support for limiting the role of government in the everyday lives of the citizens, should champion a proposal for public-school prayer which moves in precisely the opposite direction:
- 2. What is the intended value of government-sponsored school prayer? The document you provide argues that such prayers should not be understood as "non-denominational" or least-common-denominator expressions, but should be framed in relation to local religious climates. That implies that a majority view would prevail, meaning that Buddhist theology would characterize school prayer in Hawaii, Mormon theology in Utah and Idaho, Lutheran theology in North Dakota and Minnesota, Jewish theology in metropolitan New York City. Will such praying accomplish other than local resentments and community-threatening struggles to find acceptable wordings? Can school boards welcome the prospect?
- 3. There is danger that government-sponsored prayer will stress nationalism, an uncritical view of country, which would be offensive at least to the biblical tradition which warns against linking religious faith to the interests of any one political entity.

We urge the President and the Congress to leave the situation precisely where it now is. While not an ideal solution for anyone, the consequences of the 1962-63 Supreme Court decisions are fair to all in our society of great diversity. There is no way that same fairness could be retained by any revival of government-sponsored prayers.

Focusing on the specific efforts necessary to ensure that the American Church bodies are networked into the the nuclear freeze and related issues, I am enclosing a strategy outline of work to be carried out over the next six months, starting June 1.

Having just returned from a two day Lutheran Church Conference on Business and the Church, I can tell you that Church professionals have already begun to formulate views in response to the nuclear freeze activities of last April — thus, as I see it, time is of the essence.

Well organized, vocal, and posturing themselves as the defenders of the poor and needy, Church professionals can be expected to take early and visable positions which will both demonstrate their concern for the poor and their overwhelming desire for peace discussions a la Billy Graham.

Nevertheless, I believe, there is a reservoir of support among a good number of Church professionals, which, when combined with the potential power of the pew, and equipped with facts and a strong defense/Reagan reduction strategy, can serve as the core support for fair and balanced discussion, favorable decisions at church conventions, and ultimately, a majority resolve to ensure U.S. deterrence capability.

With all of this in mind, I have prepared the attached strategy, and I look forward to discussing it with you.

#### Monitoring the Defense Debate within the American Churches

#### June:

- \* Identify and schedule interviews with up to 20 chaplains and others, representing different denominations within the Armed Forces. The interviews will ascertain the best way of presenting our position within each denomination.
- \* Identify and subscribe to the most important of the periodicals and communication organs within each of the denominations, and summarize, on a bi-weekly basis, editorial and reporting comments garnered from these periodicals, and
- \* Identify the dates of up-coming national and regional church body gatherings and conventions, and determine when the pre-convention decisions might be made regarding agenda.

#### July:

- \* Meet with and interview the chaplains, and from these interviews, obtain names of members within each denomination, who are perceived as the most thoughtful and influential decision makers;
- \* Meet with and interview these decision makers, ascertaining the best way of presenting our position within each denomination, and
- \* Attend those church gatherings which are identified as having a session planned which will deal with defense matters.

#### August and September:

- \* Have designed and distribute materials to be used by those leaders speaking at these church gatherings.
- \* Prepare written analysis of the interviews of the church leaders, showing an overall perspective of how the churces look at the defense options;
- \* Identify and speak with national political leaders who are recognized as leading laymen and laywomen within each denomination who could be networked into the debate (i.e. Senator Dick Lugar for the Methodists, Ed Meese for the Lutherans, etc.)

#### October and November:

- \* Identify and meet with representatives of church groups which are organized along other than denominational lines, such as womens groups, youth organizations, and other such ecumenical groups, and
- \* Schedule identified representatives to participate in the various convention dialogues, providing them with necessary briefings and support material, and
- \* Continue identifying and meeting with lay Church leaders to ensure a continued participation in the debate within their denominations.

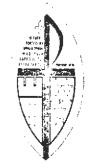
This mail arrived while I was on vacation.

Dear Diana:

Thank you very much for the time you gave the officers of the Washington Interreligious Staff Council (WISC), and for the opportunity of learning first hand about the staff responsibilities in your office, and also for our telephone conversation which followed the meeting. I am sending a copy of this letter and a summary of the discussions with you and Mrs. Dole to all of those who were at the meeting so that the results of our telephone conversation may be shared in that manner.

We hope that the information which we provided about the Washington Interreligious Staff Council was helpful. We reported back the following day to the July 15 meeting of the plenary session of WISC, and you have probably seen President Paul Kittlaus' letter to Mrs. Dole. Please let me know if you detect any inaccuracies in the enclosed summary of our meeting. It seemed to us a good learning experience for all concerned.

I am including a copy of the officers of the Washington Interreligious Staff Council. You will be hearing from Rev. Kittlaus about
specific issues that we feel will be helpful in briefing your office.
There are issues, such as Supreme Court jurisdiction, prayer in the public
schools, voting rights, capital punishment, and similar legislative proposals that are very important to us and on which Mr. Morton Blackwell's
political organization and Moral Majoritarians will very probably support
the opposite view.

We are the official government advocates for our denominations, and I do want to remind you of our request that there might be some discussion of some of the institutional issues of church and state, particularly the issue of integrated auxiliaries and what is the advocacy ministry of the Church. I am enclosing some material that will be helpful in that regard. In regard to our request for a meeting with President Reagan, please note that the national Bishops and church leaders will next meet in Washington September 30 and October 1. I am appreciative of our telephone conversation and we agree you would best serve as our contact in Mrs. Dole's office.

Previous administrations have had clergy persons as religious liaison, and they have not been officially officers or leaders of political action lobby groups. Our tax exempt status would be endangered by our

participation in support of political candidates; we serve as advocates for issues voted by our national bodies. Therefore we feel that there is much that your staff might learn about the work of the church which clergymen would know but which would not be included in the experience of Mr. Blackwell, with his active membership in The Council for National Policy and other groups. I am enclosing also a copy of Group Research's summary of the political organization called "The Council for National Policy," a new coalition following a series of previous coalitions of political action groups, especially of the conservative right wing.

As we indicated in our conversations, the Moral Majority is a political organization and is not representative of any church body, even though it is headed by Rev. Falwell. He himself is an independent religious preacher. I think the reaction to the criticism of the announcement given by President Reagan about the appointment of Mrs. O'Connor as Associate Justice of the Supreme Court is indicative of the questions about political action groups such as Moral Majority and NCPAC who use religious terminology. Most important, we hope there can be a growing acceptance of differences between religious and other groups. We hope that our relationship with you will be helpful to your office as well as to us. We look forward to being of service to you in every way possible.

Outline of the meeting with representatives of WISC with Mrs. Elizabeth Dole and Ms. Diana Lozano, July 14, 1981

The Rev. Paul Kittlaus, United Church of Christ, together with Ms. Mary Jane Patterson, United Presbyterian, Rabbi David Saperstein, Union of Hebrew Congregations, Attorney John Baker, Baptist Joint Committee, and Dr. Charles Bergstrom, Lutheran Council, met with Mrs. Elizabeth Dole, Assistant to the President for Public Liaison, and also with her deputy, Diana Lozano. James Robinson, government liaison representative of the U.S. Catholic Conference had planned to meet with the WISC officers, but was unable to do so because of illness. He has sent his letter of regret to Mrs. Dole's office.

The meeting included a description of the Washington Interreligious Staff Council (WISC) by its president, Paul Kittlaus, followed by an exchange of questions and answers. WISC includes 38 religious offices here in Washington—the official government liaison offices of corporate religious bodies. Secondly, Rabbi David Saperstein, chairman of IMPACT, described that organization and its work. It is the network from the Washington offices to people in various parts of the country. Mary Jane Patterson described the quarterly meetings of the national bishops and church leaders which is held here in Washington with members of Congressional committees and subcommittees in the capitol building.

There also was discussion of the organization of Mrs. Dole's office and the present division of contacts with religious organizations between Mr. Jack Burgess, Mr. Jack Stein, and Mr. Morton Blackwell. The WISC representatives made clear that they work together as religious organizations and in most instances would want to meet with Administration representatives as one group rather than three religious organizations divided.

A request was made that the office of Mrs. Dole arrange for a meeting between President Reagan and the national church leaders and bishops. The WISC organization would help to arrange such a meeting. (Since this meeting, Rev. Paul Kittlaus has written a letter of appreciation to Mrs. Dole.)

It was also agreed that WISC contact Ms. Lozano concerning briefings on particular issues or legislation of interest to the church offices. John Baker described some of the church-government areas of concern and the consultation on church-state in February of this year. This consultation involved nearly 90% of religious groups in the USA.

During the discussion the importance of the mainline church and synagogue organizations expressing their views at every occasion possible was pointed out. It was also pointed out that the approach of many of these organizations would differ quite often from those taken by the right wing fundamentalist organizations.

The WISC group itself does not always agree on all issues, but has developed a mutual respect for one another and member offices participate together as authorized on given issues. Issues of present concern include voting rights and the cutbacks on funding for the poor.

After the meeting with Mrs. Dole, the WISC officers had a very helpful meeting with Diana Lozano who reviewed the organization's structure with herself as a deputy to Mrs. Dole. The request for a meeting with President Reagan and the national church bishops and leaders was repeated.

Washington, D.C.--(LC)--The White House has been asked to arrange a meeting between President Reagan and national bishops and church and synagogue leaders.

This was reported by Dr. Charles V. Bergstrom, executive director of the Office for Governmental Affairs of the Lutheran Council in the USA, following a session at the White House with Mrs. Elizabeth Dole, Assistant to the President for Public Liaison. Bergstrom arranged the meeting for five members of the Washington Interreligious Staff Council (WISC), of which he is former chairman.

Bergstrom said that President Reagan 'has the ear of the Moral Majority and other right-wing fundamentalist groups and needs to get the input of leaders of mainline Protestant, Catholic and Jewish groups as well."

"We pointed out," Bergstrom said, "that the Moral Majority is a lobbying office, not a church, and that our organization represented a point of view based on actions of church conventions." WISC is composed of 38 churches and Jewish organizations.

The group told Mrs. Dole and her deputy, Diane Losano, that their religious bodies differ with "right-wing fundamentalists" on a number of issues, such as prayer in the public schools, jurisdiction of the U.S. Supreme Court and the voting rights bill.

"The White House early on had wanted to have three contact people -- one for Catholics, one for Protestants and one for Jews," Bergstrom said. "We told the administration that since we all work together, we would prefer only one person."

With Bergstrom at the July 14 meeting were representatives of the United Church of Christ, United Presbyterian Church, Joint Baptist Committee and Union of American Hebrew Congregations.

### New Right organizes a super coordinating group

An umbrella group, holding company, super group or -- as they are calling it -- a coordinating group of some 50 conservative leaders has been announced
to influence public policy under the name of Council for National Folicy.

The executive committee includes three of the top four leaders of the new right network, as they occasionally refer to themselves: Richard A. Vigueria, the fund-raising expert or "Godfather" of the new right; Paul Weyrich, head of the Committee for the Survival of a Free Congress; and Howard Phillips, head of the Conservative Caucus.

Viguerie was host the next evening at a reception for the powerful new group which presented David Stockman, Director of the Office of Management and Budget in the Beagan Cabinet, an award for his efforts to cut the budget.

Among members of the new Council are Morton Blackwell, a right-wing professional staffer who is now an assistant to Reagan for public liaison; Robert Billings, a former leader of Moral Majority who is now a top official of the Department of Education; Joseph Coors, the Colorado brewer who funds right-wing causes such as the Heritage Foundation; Edward Feulner, head of Heritage; Nelson Bunker Munt, the Texas tycoon who is also on the National Council of the John Birch Society; Reed Larson, President of the National Right to Work Committee; Edward McAteer, President of the Religious Roundtable; Bill Saracino of Gun Owners of America; and Phyllis Schlafly, head of the STOP-ERA movement and famous right-wing activist.

Many Congressmen attended the reception, along with such luminaries as T. Cullen Davis, another Texas oil millionaire who has become a born-again Christian and works with Rev. James Robison, a leader of the Christian right.

## Officers are professionals

To run the new organization, the group chose two established names with administrative and cause experience. The President is Rev. Tim

LaHaye of San Diego who, with his wife Beverly had been running Family Life Seminars until he went full-time with Moral Majority on the West Coast. The reverend is reported to have initiated the Council by calling his friend Davis, who called Hunt. LaHaye's wife has been active in the anti-ERA drive and in so-called pro-family issues. A recent fund-raising letter from LaHaye was a lengthy attack on "humanism," a favorite target of the right wing recently.

The Executive Director is Louis (Woody) Jenkins, a Democratic legislator from Louisiana who was defeated for the U. S. Senate. Jenkins has been Secretary and Chairman of the American Legislative Exchange Council; a Trustee of the Conservative National Committee; Director of the Conservative Campaign Committee; on the board of advisors of Haritage Foundation; a Director of The Conservative Caucus and Secretary of its Research, Analysis & Education Foundation; and on the faculty of a 1979 conference in Chicago of the National Pro-Life PAC. After the 1976 election of Jimmy Carter, Jenkins was chosen by The

# No-Frills Academy Thrives in Fairfax

### Prominent Families Lining Up to Enroll Children in Christian School

Fairfax Christian Academy often crowds 35 or more students into a classroom, has no school teams or extracurricular activities, requires kids to bring their own lunches, seldom has a parents' meeting and charges tuition of \$1,350 a year.

But families are lining up to get their children in.

Its clientele includes such prominent parents as Sen. Strom Thurmond (R-S.C.); Richard A. Viguerie, master fund-raiser of the New Right; Howard E. Phillips, founder of the Conservative Caucus; Rep. Phillip M. Crane (R-Ill.), former presidential candidate, and New Right political organizer Morton Blackwell.

Robert L. Thoburn, founder, direc-

tor and headmaster of Fairfax Christian, only chuckles at the suggestion that his profit-making school is an exclusive haven for the newly influential conservative political elite—a sort of St. Albans School for the New Right.

Former liberal Democratic senator Birch Bayh sent a child to the school briefly in the 1960s, Thoburn notes, and children of Redskin quarterback Joe Theisman attended more recently.

But Thoburn is the first to agree that Fairfax Christian, by virtue of its prestigious clientele, is giving a mantle of establishment respectability to an educational "movement" that Thoburn believes could revolutionize American education.

His is one of a growing number of Christian schools that stresses fundamental religious values and teach courses ranging from the story of man's evolution to economics from "Christian perspective."

The critics of this developmer warn that its success has been but on parental fears of forced busing an concern over deteriorating published school discipline and the ban oschool prayer. The most vehement complaints about the president's hour-long telephone call to the Moral Majority leader came from evangelical Protestants. "I have been under the impression that Ronald Reagan, not Jerry Falwell, was elected president of the United States last fall," wrote Dr. Presnall Wood, editor of the Baptist Standard, official publication of 2.2 million Texas Southern Baptists.

Wood, whose weekly journal is one of the most influential in Southern Baptist circles, asked: "Why was Falwell singled out? Has Falwell's media power risen to the level where he is fast becoming the uncrowned religious pope of America?... America does not need a crowned or uncrowned religious pope, whether he be fundamentalist Baptist, Roman Catholic or Southern Baptist."

Wood's fellow Texan, Spurgeon Dunnam III, editor of the Dallas-based United Methodist Reporter, said editorially he was "bothered, personally, by the type of religious folks Mr. Reagan tends to listen to .... Mr. Falwell epitomizes a very narrow, legalistic and not always Christian—from my understanding of the Scriptures—point of view."

Falwell has opposed the confirmation of Judge O'Connor because of concern that she would be proabortion. In meetings with members of Congress this week, she declined to provide specific answers to questions about her views on the Supreme Court's rulings on abortion, but said she was personally opposed to abortion.

Criticism of the president's consultation with Falwell, who gave him strong support in last fall's election, also came from R.G. Puckett, executive director of Americans United for Separation of Church and State, and from Dr. James Dunn, government affairs expert for the Baptist Joint Committee.

The appointment of O'Connor, the fulfillment of a Reagan campaign pledge to appoint a woman to the Supreme Court, brought plaudits from leaders of the National Council of Churches, the liberal interdenominational agency which has thus far found little to praise in Reagan's conservative policies.

It also brought commendations from major Jewish organizations, including B'nai B'rith, the American Jewish Congress, the American Jewish Committee and the Union of American Hebrew Congregations.

branch of Judaism in this country, split on the O'Connor appointment, with the Union of Orthodox Rabbis opposing her confirmation because of the abortion issue and the National Council of Young Israel commending the appointment.

Robert Dugan, director of public affairs for the National Association of Evangelicals, applauded Reagan's appointment of a woman to the court. "That historic step was overdue," he said. But he expressed "deep misgivings about Judge O'Connor's views on abortion."

Fundamentalist preacher Carl McIntire called the nomination of O'Connor "a dark and sad day for the fundamentalists in our churches" because of her record on abortion and religious schools. "This woman is dangerous to us." he said. "Our churches throughout the land will now arise to fight the appointment

# 2 on Hill Call for Probe of NCPAC

Two members of Congress have asked Attorney General William French Smith to investigate actions of the National Conservative Political Action Committee that they consider illegal. One member of the House has accused NCPAC's chairman, John T. (Terry) Dolan, of attempted bribery and blackmail.

The Justice Department has not decided whether to initiate formal investigations, a spokesman said yes-

terday.

The charge of attempted bribery and blackmail was made by Rep. Stephen L. Neal (D-N.C.) and was based on a letter he received from Dolan. In the letter, dated last Fri-

day, Dolan wrote:

"If you will make a public statement in support of the president's tax-cut package and state that you intend to vote for it, we will withdraw all radio and newspaper ads planned in your district. In addition, we will be glad to run radio and newspaper ads applauding you for your vote to lower taxes."

The federal statute regarding bribery of public officials makes it illegal to give or offer "anything of value to any public official . . . for or because of any official act performed

or to be performed . . . . "

A senior federal prosecutor said yesterday that the wording in the letter was "very, very close to the line" dividing acceptable behavior from an illegal attempted bribe. The prosecutor, who asked that he not be identified and said he had no direct

familiarity with the matter, added that the Justice Department would have to conclude that there was a criminal intent involved to press any charges.

The second complaint against Dolan and NCPAC came from Sen. Daniel Patrick Moynihan (D-N.Y.), who received a letter from the NCPAC chairman last month urging him to vote against a proposal to close certain tax loopholes involving "straddles." Moynihan forwarded the letter to William F. Hildenbrand, secretary of the Senate, asking if Dolan was registered as a lobbyist.

He was not, and Hildenbrand forwarded the matter to Justice Department for possible investigation.

Dolan and NCPAC are familiar with political controversy. The group has specialized in running negative radio and television ads attacking liberal Democrats. NCPAC and Dolan have been criticized by some Republicans, but in May President Reagan's political adviser, Lyn Nofziger, endorsed the group's activities.

NCPAC's commercials create "a climate of doubt" about the Democrats and are, "on balance," a help to the administration. Notziger said,

Dolan was traveling outside Washington yesterday and could not be reached for comment.

Dr. Jerry Falwell has announced a major thrust in the 1980's to aid the nation's poor, particularly those in America's inner cities.

Speaking at Thomas Road Baptist Church in Lynchburg, Va., where he is pastor, Dr. Falwell said the program will involve at least two of his ministries: The Old-Time Gospel Hour and Liberty Baptist College

Dr. Falwell said Christian people, particularly, have a special obligation to the poor. He criticized some social welfare programs, saying:

"I (hink most of you know me well enough to know that there is no greater enemy to the massive welfare state that we have established in this country, than I am. I believe that we have generated and produced a society of professional bums and we can't blame the people, we must blame government. We have made it easier for people to obtain without working (so, now) they are not willing to obtain by working."

He also said there are 67 promises and curses in the Bible concerning Christian relationships to the poor and they can be ignored only at an individual's own peril.

Dr. Falwell said the Old Testament social security program required the people of God to take care of the poor and the needy around them. In the New Testament, he said, the Apostle Paul said if a man will not work, he shouldn't eat.

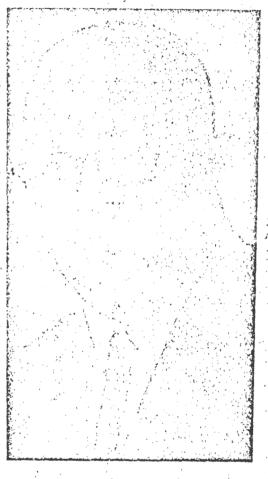
Falwell announced a 10-point program designed to meet the legitimate needs of those who are poor. It involves the establishment of a working relationship between 10 suburban, affluent churches and one inner city church in communities throughout the country. The suburban churches would provide manpower, training, help in finding jobs and money. They would also call on their members to "adopt" a poor family and see to its needs.

Other items on the agenda include calling on President Reagan to establish a Presidential commission on the poor, the founding of a world Christian Training Center to promote social as well as religious activity in the inner cities, assisting the inner city churches in establishing a "think tank" on the poor that would serve as an advisory group on the problems of the disadvantaged and recommend solutions for dealing with them, a docu-drama film on poverty that could be used to educate people about poverty and a national meeting of fundamentalist pastors to encourage fundamentalist church people to become "re-involved in the world."

Dr. Falwell announced that nationally-known black pastor, E.V. Hill, pastor of Mt. Zion Missionary Baptist Church, Los Angeles, is designing training manuals and the program to be used by fundamentalist churches.

Falwell said liberal churches quit preaching the Gospel years ago and even their social programs have failed.

He said, "while the liberals have been talking about social action, the conservatives are now going E. V. Hill, Outstanding Black Leader, Designs Manuals, Program For 'War' On Poverty

to do the work. While the liberals have been doing a poor job caring for the body and ignoring the spiritual needs of the poor, we are going to do both." He said you can't share the Gospel with a starving refugee or someone in the inner city without a place to live unless you have first met his physical needs.

Dr. Falwell said conservatives "have overreacted" to the social gospel of the liberal churches, "and have at times turned our hearts and our backs to those who are helpless,"

"I am saying to you there is a happy medium" he said. "We don't want to join the Harry Emerson Fosdick variety, we don't want to join the National Council of Church variety, we don't want to get caught up in social reform or the social gospel. We don't want to get caught up in something that is treating the body but is ignoring the spirit." h

Initially, Dr. Falwell said teams of students from Liberty Baptist College will visit Detroit, Los Angeles and Philadelphia this summer to work with the inner city poor. Dr. Falwell dispatched a team from Thomas Road Baptist Church to Kenya and Somalia to survey the refugee situation there which is among the worst in the world. He pledged his church will be sending people and aid to those in refugee camps as it has done before in Cambodia. He also said his ministry will be involved in some of the technical apparatus necessary in so large a program.

Dr. Falwell sald, "You can't expect that God would bless us unless you consider the poor," who make up more than 80 per cent of the world's population.

Quoting Psalm 41, he said, "Blessed is he that considereth the poor."

New 'War on Poverty' involves establishment of a working relationship between 10 suburban, affluent churches and one inner city church in communities throughout the country. The suburban churches would provide manpower, training, help in finding jobs and money.

## Distortions and Public Trust

Well, politics ain't beanbag, as Mr. Dooley said, and prudish punctilio over political tactics can be silly. But politics ain't beanball, either, and NCPAC - the National Conservative Political Action Committee – has, on the record, gotten to confusing hardball with beanball.

As it cranks up for the 1982 congressional campaigns, the public needs to keep a sharp eye on its propensity for mudslinging.

In a recent article Sen. Thomas Eagleton. of Missouri, one incumbent NCPAC "targeted" for defeat in 1980, lists several distortions in the NCPAC campaign to discredit and unseat him. The campaign failed; and some of the distortions may not have been deliberate: but that is neither here nor there. The voters, to speak of those most at interest, deserve bet-

NCPAC put it about that Senator Eagleton had voted for a \$75 million aid package for Nicaragua. In fact, he opposed that aid on three occasions and never voted for it at all. NCPAC accused the senator of voting against production of the neutron bomb.

He did no such thing. NCPAC charged the senator with voting not to build B-1 bombers. That was true, for a change. But NCPAC omitted the clarifying context. Senator Eagleton's anti-bomber vote was on a reluctant motion by Senator Stennis, a leading B-1 advocate, to delete funds President Carter had blocked by executive order. This was a parliamentary technicality, not a test of sentiment on the **B-1** bomber, but what's a fundamental distinction when it might spoil the demagogic impact? '

NCPAC also accused Senator Eagleton, a supporter of a separate Department of Education, of voting to "require taxpayers to support almost 18,000 bureaucrats," at a 1981 cost of \$15 billion.

Here, again, was a "fact" on which the legislative setting sheds revealing light. Whether or not you approve of a separate Department of Education, a legitimate issue, it's slimy business to cite costs its creation did not entail. As the senator notes, the department was essentially a consolidation of personnel under a new roof; and the bill "specifically provided that manpower was to be reduced by 500 from the levels of the old agency, with commensurate budget savings.

In Indiana, where Sen. Birch Bayh lost his seat last November, there was similar NCPAC

fudging of the record. Mr. Bayh, the target, recalls the circulation of a survey of farmvote sentiment that had to do with his votes on such issues as the Panama Canal and labor reform - not with his votes on agricultural matters. Yet the survey was used so as to insinuate to farmers that Senator Bayh was their foe on farm issues.

In Oklahoma, more recently, NCPAC circulated "poll" results purporting to show that House Budget Committee Chairman James Jones, of Tulsa, supports reduced defense spending and increased social spending. In relation to the Reagan budget, that was true. In relation to the Carter budget, which is the benchmark informed people know to be at issue when 1982 cuts and increases are discussed, NCPAC's insinuation was false.

NCPAC contends, we gather, that its main business is letting voters know whether their representatives represent them. That is obviously a fair objective. But NCPAC, if the above episodes are typical, can't or won't distinguish between information and distortion.

This is not surprising when you consider the arrogant assertion of NCPAC'S director. Mr. Terry Dolan, that "a group like ours could lie through its teeth and the candidate it helps stays clean." Perhaps he isn't proclaiming falsehood as NCPAC's currency, but only saying that it could be, without injuring the candidates it supports and patronizes.

The assumption is wrong. It may take time for the public to get the message, but politicians are known by the company they keep, and their integrity is inescapably colored by the quality of the support they accept. And should be. No candidate who knowingly condones lies and distortions that poison the public dialogue can evade responsibility for them.

On that point, the new chairman of the Republican Party, Mr. Richard Richards, recently aroused snarls at NCPAC when he said that unaccountable political groups can "create all kinds of mischief."

But the mischief is not that NCPAC efforts temporarily change voting balances in Congress. It is that they insuit the intelligence and trust of voters who expect to make political choices on the basis of real, not false, issues. This is fundamental. Every time that trust is deliberately violated, government by consent dies an inch or two.

# A Statement on Religion and Politics

Issued by the Lutheran Council in the USA on behalf of
The American Lutheran Church, The Association of
Evangelical Lutheran Churches and Lutheran Church in America.

Endorsed by LC/USA General Secretary John R. Houck,
ALC President David W. Preus, AELC President William H. Kohn
and LCA President James R. Crumley Jr.

The American Lutheran Church, The Association of Evangelical Lutheran Churches and Lutheran Church in America firmly disagree with Christians or coalitions of Christians who plan political action under any guise of religious evangelism, worship or revivalism—or "in the name of Jesus." These partner churches in the Lutheran Council support pluralism and freedom of all people in the political process in the United States and maintain that pushing for total agreement on moral issues is not the same as advocating for legislation which will enhance the common good. "Religious grounds" should not be used as the exclusive yardstick for determining the quality of candidates for political office.

As leaders of Lutheran church bodies, we strongly discourage members of Lutheran churches from joining or supporting movements which confuse church-government relations and distort the churches' advocacy mission in the political world. We support parish pastors and church leaders who do not endorse such movements.

As Lutherans in the U.S., we recognize that an increasingly complex society has produced growing interdependence and interaction among groups, persons and resources in the governmental, economic and voluntary sectors. The government's responsibilities to maintain equity and order have led both the churches and the state into greater contact and, at times, into tension. As governmental bodies seek to perform their roles and the churches seek to fulfill their missions, each needs to be aware of the other's purposes, principles and methods. In their endeavors, both the churches and the government have the task of formulating and clarifying position statements and guidelines for implementation and application when appropriate.

Lutherans acknowledge the twofold reign of God, under which Christians live simultaneously. God is ruler of both the world and the church. The church is primarily the agency of the Gospel in the new age of Christ, while the state is primarily the agency of the Law in the old age of Adam. Given the balance of interests and differing responsibilities of the churches and the government in God's world, the Lutheran churches advocate a relationship between the churches and the government which may be expressed as "institutional separation and functional interaction." Both the churches and the government are to delineate and describe the proper and responsible extent of their functional interaction in the context of God's rule and the institutional separation of church and state.

In affirming the principle of separation of church and state, Lutherans in the U.S. respectfully acknowledge and support the tradition that the churches and the government are to be separate in structure. As the Constitution provides, government neither establishes nor favors any religion. It also safeguards the rights of all

persons and groups in society to the free exercise of their religious beliefs, worship, practices and organizational arrangements within the laws of morality, human rights and property. The government is to make no decisions regarding the validity or orthodoxy of any doctrine, recognizing that it is the province of religious groups to state their doctrines, determine their polities, train their leaders, conduct worship and carry on their mission and ministries without undue interference from or entanglement with government.

Lutherans in the U.S. affirm the principle of functional interaction between the government and religious bodies in areas of mutual endeavor, so that such interaction assists the maintenance of good order, the protection and extension of civil rights, the establishment of social justice and equality of opportunity, the promotion of the general welfare and the advancement of the dignity of all persons. This principle underscores the Lutheran view that God rules both the civil and spiritual dimensions of life, making it appropriate for the government and the churches to relate creatively and responsibly to each other.

Lutherans hold that their churches have the responsibility to describe and clarify to their members and to society the mission of the Lutheran churches and to determine, establish, maintain and alter the various forms through which that mission is expressed and structured. The distinctive mission of the churches includes the proclamation of God's Word in worship, in public preaching, in teaching, in administration of the sacraments, in evangelism, in educational ministries, in social service ministries and in being advocates of justice for participants in the social order. According to Lutheran theology, the civil government's distinctive calling by God is to maintain peace, to establish justice, to protect and advance human rights and to promote the general welfare of all persons.

It is a misuse of terms to describe government and politics as godless or profane, because God rules both the civil and the spiritual dimensions of life. Thus it is unnecessary and unbiblical for any church group or individual to seek to "Christian-ize" the government or to label political views of members of Congress as "Christian" or "religious." It is arrogant to assert that one's position on a political issue is "Christian" and that all others are "un-Christian," "immoral" or "sinful." There is no "Christian" position; there are Christians who hold positions. Government under God employs reason and power for social justice, peace and freedom.

To describe one group's political position as "The Christian Voice" and one movement's political agenda as a movement "for Jesus" is wrongly judgmental. It is also an affront to Jewish and other religious advocates whose religions hold social justice as a social form of love of neighbor. Devout Christians and Jews agree and disagree between and among themselves regarding political decisions and can agree and disagree with nonbelievers. Advocacy for social justice is part of the mission of the churches according to Lutheran theology. Such advocacy may often bring disagreement on issues and votes as to how to strive for justice.

So we challenge members of Lutheran churches as evangelical Christians to worship and pray as Christian congregations. All persons need forgiveness. We also challenge all citizens and corporate religious groups to participate in the process of decision-making for the common good, and we encourage cooperation with other religious and voluntary associations in this work of advocacy.

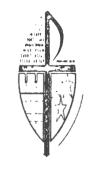
