Dear Admiral Nance,

On the recommendation of Mr. Morton Blackwell, I am writing to you in the hope that you can assist us with a critical problem involving one of our Cathedral families, Mr. and Mrs. G. Arthur Padmore, Jr. and their three daughters. Mrs. Pairlene E. Padmore was granted political asylum here in March, 1981, because her father, Harmon Carey Thomas, was one of the government officials killed in the coup that occurred in Liberia in April, 1980. Her husband and children are with her under the terms of the asylum. In an unprecedented and shocking reversal, the Immigration and Naturalization Service has notified her that her asylum is to be revoked. As a congregation, we are appalled that our members could be returned to a situation in which their lives would be in peril. We are trying to contact everyone in government who can help us. We hope that through your office, pressure can be brought to bear on the INS.

The Padmores have been an integral part of our congregational life, serving in choirs, altar guild, lector and on the Board of Cathedral Community Services. They have been members of our community since July, 1980.

We are anguished to think that one of our families could be ripped from our midst and sent back to Liberia where under the present regime, they would be exposed to harrassment, imprisonment or death. Please help us by speaking to those persons in the INS who could effect a reversal of this order.

I am writing to you out of a deep concern for the wellbeing of one of the families in our Cathedral church. Mr. Morton Blackwell suggested that you might be able to help us. Mrs. Pairlene E. Padmore, her husband. G. Arthur Padmore, Jr., and their three daughters are refugees from Liberia. They have been members of the Cathedral since July of 1980. Mrs. Padmore was granted political asylum here in March, 1981, because her father, Harmon Carey Thomas, was one of the government officials who was arrested, killed and buried in an unknown grave during the coup in Liberia in April of 1980. In an unprecedented action, the Immigration and Naturalization Service has recently given notice of intent to revoke her political asylum status. We are appalled at the injustice and insensitivity of this action. congregation we are trying to contact everyone in Washington who could help in reversing this decision. We hope you will assist us.

The Padmores are deeply involved in the life of our community. Mrs. Padmore serves on the Altar Guild, sings in the Choir and teaches in the Church School. Arthur Padmore is a Lector and will serve on the Board of Cathedral Community Services. Their daughters sing in the Gorls' Choir.



Dear Dr. Blackwell:

Thank you for adjusting your schedule on that snowy 14th day of January to audit our summary of Valuing Analysis. We believe this program is an effective means to facilitate communication between groups in dealing with issues and solving problems.

Fifteen years of research and testing in communities and organizations nationwide provide scientific validation that 80-90% of all citizens -- self-identified by almost every possible label -- agree on the essential, interrelated principles which comprise a common moral standard of acceptable behavior. However, such agreement becomes apparent only after individuals have had the opportunity to consider the logical consequences of adequate alternatives.

When a person discovers for himself this common norm, he begins to recognize how to deal with issues more effectively. More and more thoughtful leaders realize that top priority must be given to help individual citizens and youth, as well as leaders, become aware of the latent matrix of moral common sense within themselves, presently smogged over with confused cultural conditioning.

Our evidence reveals that this moral valuing standard supports traditional Judeo-Christian values. The critical element in communication between groups is that one does not impose his dogma, no matter how right, on others, but permits them their own God-given freedom and reason to discover this common norm from which they cannot easily escape.

The almost unanimous positive response to the Valuing Analysis approach gives us confidence it is only a matter of time before its broad implementation.

Consider how helpful it would be if the President could confidently refer to an objective data bank of current evidence that identifies a common moral standard for action and judgment which has been recorded by scientific measurement as the deliberate consensus of citizens representing all labels in our society. He could clearly outline how his proposals are consistent with the principles that they believe to be necessary and right.

We met with enthusiastic response from the leaders we contacted in Washington. They are interested in participating in a pilot Valuing Analysis session soon in

Dear Mr. President,

It has just come to our attention that you will be coming to Utah on Tuesday, September 7 to campaign for Senator Orrin Hatch, and to view some of the Mormon relief and self-help programs near Ogden. As religious leaders of Utah's non-Mormon community, we would like to request a brief audience with you also to discuss the following:

1. VOLUNTARISM OR GOVERNMENT? While we applaud the emergency relief and self-help efforts of the L.D.S. Church, we are painfully aware that they do not and can not serve the needs of everyone: And neither can we, despite our joint efforts. All of our church agencies are swamped with demands running from two to four times their normal levels.

Instead of each denomination trying to meet the needs of its own people, and letting the unchurched go hungry, sick and cold, we have generally supported basic uniform services provided by government with professional expertise where needed, and supplemental services provided by church agencies to help the people who do not meet government criteria, or who need additional aid.

2. JOBS OR CHARITY? Telling people that "prosperity is just around the corner" does not help a young mother feed her children today. The unskilled, less gifted and unfortunate who are also God's beloved children continue to swell the ranks of the unemployed, and find little comfort in decreasing public service job training, placement, or employment. The growing diversion of funds for even their emergency help into fewer highly technical defense jobs further diminishes their livelihood.

We question the wisdom of trying to stimulate more jobs through general tax reductions for the wealthy, as opposed to tax incentives for such specifics as employing the hard core unemployed or retooling an outdated plant. We lament the inflationary effect of military spending that increases the national debt and pays large salaries while producing no consumer goods for those salaries to buy.

3. JUSTICE OR SELF-INTEREST? We question the righteousness of budget priorities which take from the needy to reward the wealthy. The Bible defines righteousness as deciding FOR the widow, the orphan and the sojourner or refugee.

- 4. LIFE OR DEATH? Observing our nation's rapidly escalating arms buildup, we would like to ask:
 - a. Whether our great desire for more first strike nuclear weapons is really needed for nuclear deterrence, or is an attempt to forestall Soviet ground advances with a threat of nuclear annihilation so complete as to prevent effective Soviet nuclear response.
 - b. Whether we could actually destroy ALL Soviet land, sea and air-based missiles so totally as to prevent tens of millions of retalliatory American deaths.
 - c. How "tactical" or "limited" nuclear wars can be kept from spreading into total holocausts.

Valuing ALL human life as we do—not just American lives—we find the apparent direction of our nation's defense strategy not only technically flawed but morally reprehensible in the eyes of God and of humankind. Most of our national church bodies have issued statements urging a halt to the arms race and a negotiated disarmament. We earnestly pray that our government will heed their voices before it is too late.

If the shortness of your visit precludes your meeting with us, will you please respond by letter?
