S.J. Res. 123 authorizes and requests you to issue a proclamation designating the week of November 7, 1982, as "National Disabled Veterans Week", and calling upon Government agencies at the Federal, State, and local levels and the people of the United States to observe the week with appropriate programs, ceremonies, and activities. It was passed by voice vote in both the House and the Senate.

The resolution notes that there are 2.3 million veterans with disabilities resulting from their service in the United States Armed Forces. This legislation is intended to give recognition to the contributions that these disabled veterans have made to our national security and welfare through their efforts to help preserve our freedom, strength, and prosperity. The VA, in its views letter, states that no group of its size is collectively so deserving of special recognition as the men and women disabled in America's defense.

An appropriate proclamation will be drafted and forwarded to the White House for issuance in a timely manner.

I am writing this letter to bring a matter to your attention and hopefully, through you, to the attention of President Reagan.

The issue involves certain aspects of the Fiscal Year 1983 Veterans Administration Budget Request recently submitted to the U. S. Congress by the Administration. Specifically, it involves two legislative proposals contained in the request which, if adopted, would result in substantial VA disability compensation benefit reductions to service-connected veterans, many of whom would be combat disabled and of the Vietnam Era.

The first proposal would eliminate the dependency allowance portion contained in the compensation checks of service-connected veterans who are rated by the VA as being 30% and 40% disabled. There are approximately 314,400 veterans so rated nationwide. The Fiscal Year 1983 "savings" is estimated to be \$135.3 million.

The following is an example of the adverse impact of this proposal on an individual veteran:

A combat disabled veteran service-connected for a below the knee amputation of a leg, who has a wife and two children, would receive, effective October 1, 1982, a \$42 reduction in his monthly VA compensation check. This would occur despite the fact that his basic rate of compensation would be increased by 8.1%, effective the same date. (As also proposed in the VA Budget Request.)

Would you agree that this is a somewhat ill conceived "good news/bad news" joke?

A second legislative proposal would discontinue current payments of additional compensation that are now provided to severely disabled service-connected veterans who cannot work because of their service-connected disabilities and who are also in receipt of any other federal benefit by reason of disability or retirement. Such other federal benefits would include: social security payments (both SSDI and OASI), black lung, railroad retirement, civil service retirement, etc. (Present law does preclude concurrent receipt of VA disability compensation benefits and military retirement pay.)

There are presently some 113,000 veterans determined to be totally disabled and unable to engage in gainful employment by virtue of their service-connected disabilities. The Fiscal Year 1984 "savings" associated with this proposal is \$282.5 million (the statutory change would be made this year, with an effective date of 10/1/83).

An example of this proposal's impact follows:

A service-connected wartime disabled veteran has the following disabilities: 60% for an above the knee amputation of the right leg, 30% for residuals of a gunshot wound to the remaining leg, and 40% for residuals of a gunshot wound to the pleural cavity of the chest—a combined 90% rating. He has been determined "unemployable" because of his service—connected disabilities and he therefore receives from the VA a total unemployability rating. Assuming he is married and has no dependent children, his VA check is presently \$1,254 per month. This veteran also receives \$324 per month in OASI payments. The Administration proposal would require that \$324 be eliminated from his monthly VA disability compensation check.

Should totally disabled service-connected veterans, indeed should any veteran, be required to forego earned social security entitlement?

Administration witnesses will shortly be defending the VA Budget Request before the House and Senate Veterans Affairs Committees and those of Appropriations and Budget. Hard questions will be posed to them concerning the economic and moral propriety of the above legislative proposals. Additionally, this organization intends to immediately commence a nationwide "grass roots" campaign aimed at informing our national membership and the general public of these legislative proposals.

Admitting the very parochial interest that the Disabled American Veterans has in this issue, and not (here) attempting to set forth our opposing arguments, my question to you is: Are you and the President aware of this aspect of the VA Budget Request and do you, after a realistic assessment of all factors, believe that these proposals should be retained in the Administration's Budget Request?

I am reminded of recent Administration "problems" associated with the issue of tax exemptions for private educational institutions and, quite simply, I am suggesting to you that this could prove to be an analogous situation.

May I close by saying that I have attempted to be frank and forthright in this letter and I trust that it has been received in that vein. I also hope that the subjects discussed will be given more than cursory attention and I would deeply appreciate being apprised of your views.

I've noticed that some in Washington, D.C., are beginning to see veterans' affairs and the national defense as related issues.

I found strong evidence of this positive trend in a recent issue of New Beginnings, a Republican National Committee (RNC) newsletter designed to support the economic policies of the Reagan administration.

Noting that "Victory for President Reagan's Program for Economic Recovery insures a strong national defense and strong veterans' benefits," the publication went on to promise, "National Defense and Veterans' Benefits will not be compromised!

"President Reagan, honoring his campaign pledges, asked for restoration of several veterans' programs which were initially pared back" in the budget request prepared for him by the Office of Management and Budgets (OMB), the flyer continued. It went on to comment that "Veterans did share; however, in the sacrifice of necessary budget cutting, but less than was first anticipated."

The New Beginnings issue was a direct pitch to veterans, asking them to support the President's overall economic policies. "The veterans' stake in the success of the Economic Recovery Program is immense," stated a cover letter attached to the flyer by RNC Chairman Richard Richards. "Pension and benefit payments, education and job training, and medical aid all require a healthy economy for funding."

Before I'm misunderstood, let me remind you that the DAV, its state departments, and its chapters are prohibited from taking stands on issues not directly related to veterans benefits and services. As an organization, we cannot and will not take a position on the President's overall tax and spending plans.

However, there are many ways in which veterans and military issues are related in ways that do affect benefits and services for disabled veterans and their families. And, while the RNC's New Beginnings didn't cite these relationships directly, I'm encouraged to see the RNC beginning to think about veterans' and defense issues as linked together.

If New Beginnings didn't make the linkage directly, its phrasing strongly implied that veterans' and defense

During the 1970s, particularly after the Vietnam War, there was a growing tendency to view veterans' programs as elements of the nation's social welfare programs: . . as separate from the national defense.

This allowed our politicians to ignore the consequenes that a new war would hold for veterans' programs. It permitted them to disregard' the effects of shoddy treatment of veterans on the recruitment and retention efforts of our Armed Forces. And many politicians saw this attitude as a green light, making it somehow okay to gouge the VA and 'veterans' job programs for budget savings.


Of course, veterans' benefits and services are not social welfare programs. They're earned entitlements paid for by the sacrifices veterans were asked to make in the defense of our country.

All veterans, particularly those who served during wartime, have given up considerable time out of their lives to participate in the national defense. This set back their careers, their educations, their family lives and more. Our country owes something to these people.

And in no case is the entitlement aspect of veterans' benefits and services more clear than in the case of veterans with service-connected disabilities. Our government has a conspicuous moral obligation to those who spilled blood, lost their health, or suffer mentally as the result of their military service.

Unfortunately, the notion that veterans' programs are social welfare programs permeated the Carter administration, and cuts in the VA, particularly its health care system, resulted. Job programs for disabled and Vietnam era veterans were held at a low priority in the Labor Department, and veterans' preference in federal employment was viciously attacked.

Hopefully, things will improve during the Reagan administration, if the idea takes hold



that veterans' and defense issues go hand-in-hand in many respects. In this regard, I would strongly urge

two Republicans, OMB Director David A. Stockman and Senate Veterans' Affairs Committee Chairman Alan K. Simpson of Wyoming, to pay close heed to the commitment their party's national committee made to veterans' programs in its New Beginnings bulletin.

Of course, the growing realization that veterans and military issues are linked is not limited to the Republican Party or the White House. Many Democrats have recognized the vital connection of these issues for some time, and we've noted expressions of this idea by members of both major parties in recent proceedings in Congress.

A good example of this appeared in a recent letter sent to all U.S. Senators in support of a three-year extension of the VA's "Operation Outreach" psychological readjustment program for Vietnam era veterans,

"At a time when the military is plagued with manpower problems, and the All-Volunteer Force is facing increasing challenges in recruiting adequate numbers of qualified personnel, we must meet our obligations to the veterans of the last war," said the letter signed by Senators Alan Cranston (D-Calif.) and John H. Chafee (R-R.I.).

In encouraging this kind of philosophical linkage between veterans' and defense programs, the DAV recognizes that more is at stake than meeting commitments to current veterans. Here are some further considerations:

(1) Though we are not now at war, our country certainly does not exist in a peaceful world. One look at the evening news should be enough to convice anyone that at least the threat of U.S. involvement in conflict overseas is a fact of life.

The DAV is deeply concerned about the welfare of those veterans who would come home wounded or otherwise disabled if the United States were forced into some future conflict. We're particularly worried about the

 to finte of the VA health care system. We don't want a repeat of what happened during the early years of the Vietnam War when our VA hospitals were caught completely offguard.

(2) Législation is pending in Congress that would enable the VA and military medical systems to operate cooperatively in a number of ways. Those interested in reducing the cost of government should look closely at this legislation. The VA medical system provides health care at considerably reduced cost when compared to the private medical sector—approximately 15 percent less, according to former VA Administrator Max Cleland. This legislation has the potential to begin an expansion of this efficiency.

There is no doubt in my mind that the budget-cutting policies of the past few years, as applied to the VA health care system, are actually increasing federal health care costs.

Tens of thousands of eligible veterans have been denied VA care in recent years due to a lack of medical resources caused by budget constraints on the VA. Many of them were referred to other public sources of care that cost more than the VA, with the expensive Medicare and Medicaid programs leading the list. And the CHAMPUS health insurance program for military people and their dependents is in no way inexpensive, though benefits are frequently inadequate.

(3) Cooperative arrangements between the VA and military systems could make medical treatment more readily available to veterans, military people, and eligible military dependents. This would be added to the cost benefits of such arrangements.

(4) Finally, I want to expand on the idea that Senators Cranston and Chaffee mentioned, concerning the relationship of veterans' programs to military recruitment and retention, a situation that must be viewed realistically.

The Armed Foces today are highly technological. They need technicians and highly qualified people in other fields. They need the trained NCOs and middle-ranking officers who are leaving the services today in droves. In terms of new recruits, the uniformed services seldom get the kind of men and women needed to replace these people in sufficient numbers. This is a widely recognized problem.

I remember the old sergeant who said, "If the Marine Corps wanted me to have a wife, it would have issued me one." Realistically, that kind of soldier is rare. Military people have families. Regardless of how patriotic our service people may be, practical considerations come into play when we're talking about family people.

Why should a highly qualified person join or stay in the Armed Forces when civilian jobs offer a far better deal in terms of pay, benefits, and retirement? Veterans' programs are part of the deal offered to military people, and cutting those benefits and services back makes the deal that much less inviting.

The inability to attract enough qualified

VA Administrator Hearings Set

Hearings on the confirmation of Robert P. Nimmo as VA administrator will be held July 9 by the Senate Veterans' Affairs Committee.

No one anticipates any problems in the hearings, after which the committee is expected to recommend confirmation of the World War II and Korean War veteran to the full Senate. President Reagan's choice of the California rancher and businessman for the VA's top job was announced April 30.

Last month the President announced his nominations for the positions of deputy VA administrator and VA inspector general

administrator and VA inspector general.

Chosen for the VA's second-in-com-



mand job was Allen B. Clark, Jr., a combat-wounded veteran of the Vietnam War, who currently works as a special assistant to Texas Governor Bill Clements. Frank S. Sato, the Department of Transportation's inspector general (IG), was picked for the IG job in the VA.

The Senate Veterans' Affairs Committee will hold confirmation hearings on Clark and Sato immediately following its hearings on the Nimmo nomination on July 9.

Former VA Deputy Administrator Rufus Wilson has gone to work with the House Veterans' Affairs Committee as its minority counsel. Also moving from the VA to the House committee staff is J.C. Peckarsky, who left his job as the VA's director of Com-

people to the military and retain them once they're in the service is costing our government money. And what good is a brand-new weapons system when there's no one there who knows how to operate it or fix it if it breaks down?

The DAV wants to reinforce the idea of a direct relationship between veterans and military programs, because we see the potential for improved services for disabled veterans. But these further considerations should be weighed by those in Washington who are making the decisions.

The idea of a direct relationship between veterans' and military programs hold the potential for improved services to veterans. In the DAV's opinion, such a relationship would certainly result in a strengthened VA medical system.

Our nation's leaders should give strong consideration to this idea, because it would demonstrate a commitment to good services to members of our Armed Forces, as well as a commitment to adequately care for these people should they become disabled veterans.

pensation and Pension Service to become a professional staff consultant for the majority of the House Committee.

The Reagan administration has still not nominated anyone to become assistant deputy secretary of labor for veterans' employment, a position which has been vacant since March.

Clark Withdraws Name

Allen B. Clark, Jr., withdrew his name from consideration for deputy VA administrator just as this issue of DAV Magazine was going to press. He made no public statements regarding the reasons for his withdrawal. However, informed sources say the Vietnam veteran was unhappy with the role planned for him in the VA's second highest office. DAV Magazine will report details when they become available.

Clark, the deputy VA administrator designate, served as a Green Beret captain during the Vietnam War. The 38-year-old Austin, Tex., resident holds a master's degree in business administration from Southern Methodist University, in addition to a bachelor of science degree from West Point.

Clark lost both legs due to combat in Vietnam, and is a life member of the DAV. His military decorations include the Silver Star, Bronze Star, Purple Heart, and two battle stars. He also holds the Combat Infantryman's Badge and Airborne Wings.

Prior to his appointment as special assistant to Governor Clements, Clark worked for Texas businessman Ross Perot, and later was employed by the Republic Bank in Dallas.

He served as president of the West Point Society of North Texas in 1973, president of the Young Executive Group of the Dallas Council on World Affairs in 1977, as chairman of the Horizons Committee in 1976.


The IG designate, Sato, developed a considerable reputation for combatting fraud and abuse in federal highway programs following his appointment as Transportation Department IG in 1979. Very well respected, he serves on several committees and boards of accounting and government auditing associations and other professional organizations.

From 1974 to 1979, Sato worked as deputy secretary of defense (audit) in the office of the assistant secretary of defense (comptroller). From 1977 to 1979, he was director of the Defense Audit Service. He held various positions with the U.S. Air Force auditor general and the office of the secretary of defense between 1953 and 1974.

Born in Puyallup, Wash., Sato holds a bachelor's degree in accounting from the University of Washington and did post-graduate work at the University of California in Los Angeles.



President Reagan, honoring his campaign pledges, asked for the restoration of several veterans' programs which were initially pared back. The approved resolution calls for \$450 million in additional outlays and \$600 million in increased budget authority over the earlier targets. The President supported the higher figures for veterans in the House, and moreover, made sure they were maintained in the work of the House-Senate Conferrees. The result? Medical and Department of Veterans' Benefits personnel will not be cut and funds are available for Readjustment Counseling Centers.

Veterans' programs will grow by almost \$1.5 billion in FY 1982. Veterans did share, however, in the sacrifice of necessary budget cutting, but less than was first anticipated.

Cuts were made by eliminating programs earmarked by the Veterans' Affairs Committees and in the rescission and deferral of several hospital construction projects. Such adjustments allowed the Conference Committee to meet the economic objectives of the President while protecting veterans' health care, counseling and compensation plans.

The approved resolution also achieves the President's goals for strengthening America's national defense. After a decade of decline when compared to the GNP, military programs will see real increases with outlays of \$188.8 billion in FY 1982. Budget authority, a better measure of the ability to buy new weapon systems and increase military preparedness, will similarly rise to \$226.3 billion, an increase of 25 percent.

Reaction in Congress Positive for Veterans' Programs

Reactions to the historic votes were quick in coming from leading Congressmen. It was apparent that veterans had done a good job in communicating their concern for specific programs. Congressman Delbert Latta (R-Ohio), co-author of the Gramm-Latta bipartisan resolution, was enthused by the 253-176 House vote. "This shows that a new attitude has taken hold in Congress", Latta said. "The fact is that government spending must be slowed and unnecessary programs eliminated. Unless inflation is brought under control, veterans and all others who retire on fixed incomes will continue to see the substance of their pensions eaten away." Latta was especially pleased that the House-Senate Conference Committee could meet the President's budget objectives while still providing sufficient funds for veterans' medical care. Earlier, Latta had been informed by the House Veterans' Affairs Committee that the amounts set forth in the Gramm-Latta resolution were adequate for the Veterans' Administration and that no change was anticipated in the number of hospital patients treated.

Congressman John P. Hammerschmidt (R-Arkansas) was pleased that, "Congress did not forget those who have served so valiantly to keep their fellow countrymen free." As the ranking minority member of the House Veterans' Affairs Committee, Hammerschmidt played a pivotal role in seeing that necessary benefits were kept on track while carefully examining areas where some cuts could safely be made. Along with the House Veterans' Affairs Committee Chairman "Sonny" Montgomery (D-Mississippi), their meetings with veterans' organizations and then with Administration officials cleared the way for acceptance of the funding targets in the approved resolution. "With President Reagan's support", Hammerschmidt explained, "the House-Senate Conferrees needed only to dot the i's."

The Budget Process

When President Reagan announced, on February 18, 1981, the dramatic changes in national priorities that were needed to return the country to economic sanity, a loud groan was heard from the cadre of budget analysts who serve Congress. Extra Congressional effort would, indeed, be necessary to enact the Program for Economic Recovery. This year, the First Congressional Budget Resolution contains "reconciliation instructions" directing the legislative authorizing committees to report the changes in law necessary to implement budget savings. The following highlights the time-frame of budgetary decision-making.

Your recognition of our Vietnam veterans at the Medal of Honor ceremony for Master Sergeant Roy P. Benavides and on other occasions is deeply appreciated. Vietnam stands out as the most controversial of our wars and the longest.

While the average age of our Vietnam dead was 23 years; six out of ten had been in service less than two years and three out of ten were married. Nearly a third of the 303,000 wounded were seriously disabled.

The Commonwealth of Virginia has recently completed a structural addition to the Virginia War Memorial at Richmond to honor our 1289 Virginia Vietnam dead. Some minor details remain such as the placement of items in the Memorial coffers.

Re: Disabled American Veteran Opposition To Budget Cuts

As I am sure you are aware, the Disabled American Veterans (DAV) has been strongly opposing cutbacks in the Reagan budget particularly in the area of hospital closings. A recent edition of their monthly magazine pictured a crippled vet sitting in a wheelchair reading a newspaper with headlines about the cuts. The issue was filled with critical stories.

I today had lunch with an employee of DAV who would rather remain nameless. He works in their HQ and thus observe the situation there firsthand. He said that after that issue was received by the DAV members the national HQ received an avalanche of critical mail from veterans saying they supported the cuts in the budget even if it meant some of their programs would be hurt. Many threatened to drop their membership in DAV if the organization persisted in opposing the Reagan program. So vehement was the reaction that DAV decided to cancel a major mailing that was scheduled to go out to the entire membership to raise funds.

The above information is FYI only in the event you are dealing with the DAV leadership in the weeks ahead.



When Mary Korona lost her 20year-old son in the Vietnam War, she received a Gold Star from the federal government.

Fourteen years later, the star is gone, along with the medallions she and her late husband received for their work in veterans' organizations.

Last month, several youths broke into her South Broad Street home, taking jewelry, furs and money.

But the items, valued at much more than the star, are insignificant to Mrs. Korona.

What she really wants returned are the medallions and the cherished star she received after her son, Albert, died.

"You have got to understand about Vietnam War mothers. We never got anything for our sons who never returned. Only that pin," she said yesterday.

"Our sons never got credit, recognition. We were heartbroken and the government sent us the Gold Star." Although she wore it seldom — usually to attend Gold Star Mothers benefits and meetings — Mrs. Korona said she'll miss it like no other possession.

SHE IS EVEN considering writing President Reagan to ask for a duplicate, if possible.

Mrs. Korona, whose husband died last year, is president of the Gold Star Mothers of Trenton and second vice president of the Gold Star Mothers of New Tersey. She is also a past state commander.

The pins that signify those offices were also taken in the breakin.

organization which benefits veterans' hospitals across the state and nation.

Mrs. Korona said she was originally hopeful that the police would be able to recover the Gold Star memorabilia. But now she's taking her request to the community.

SHE THEORIZES the burglars who broke into her third-story bedroom gained entry by climbing onto the roof of her building and dislodging the glass pane. She said neighbors saw several youths in the alley behind her home discarding possessions as they ran from the scene.

The Gold Star is placed on a purple background and has a diamond chip at the center, Mrs. Korona said. Her name is not on it.

Also taken in the robbery were her diamond engagement ring and platinum wedding ring.

"I would ask people to be on the look-out for the items," she said.

Robbery Victim Wants One Thing The Gold Star

When her weighbor called about a week ago and said she saw some teen-agers throwing jewelry in the alley, all Mary Korona was hoping to find was her gold star.

Korona's 20-year-old son, Albert, was killed in Vietnam on May 18, 1968, and the gold star the Army sent her was one of the last cherished remembrances she had of her son.

Korona, who lives on South Broad Street, searched the alley between Elm Street and Chestnut Avenue but was only able to find a "ripped apart" pair of cultured pearl earrings.

"I don't care about anything else that was stolen. What's important to me is the gold star. That's all that I really want back," she said last night.

On Feb. 27, Korona noticed that someone had tampered with several drawers in her bedroom while she had been out.

"They tried to put things back in place but some of them weren't where they belonged. That's when I realized someone had broken into my house." Korona recalled.

She called police and they showed her how the burglars had removed a third-floor storm window to get in her house.

"They took all my jewelry, including my wedding ring. They also took my mink stole," she said.

Korona said the gold star has a diamond chip in the center and is attached to a white ribbon. The ribbon is decorated with pins she received for being past president of the Gold Star Mothers and past commander of the Disabled Veterans Women's Auxiliary.

This form should be submitted to the appropriate unit (see back page) not less than 30 nor more than 90 days in advance of a scheduled program. Please realize that all Armed Forces units have specific military missions and training requirements. Participation in public programs will only be authorized when such support is in the best interests of the Department of Defense and the Armed Services and does not interfere with mission or training programs. In all cases, operational commitments must take priority and could preclude a previously scheduled appearance at an approved public activity.

Department of Defense policies require that Armed Forces participation in public events will be provided at no additional cost to the Government. The sponsor is required to pay, when necessary, the standard Military Services allowance for quarters and meals for all Armed Forces participants and for other services which have been determined in advance by the Military Services and agreed to by the sponsor. Transportation and meal costs are not usually incurred when support is provided from a local military installation. However, circumstances may dictate that reimbursement for any or all of these costs may be necessary. All costs are binding after a unit, personnel, or exhibit have arrived at an event site, even though weather conditions or other unforeseen circumstances force the event to be cancelled.

Armed Forces musical units are organized for ceremonial and traditional purposes and to support recruiting activities. However, they may be authorized to provide certain specified presentations, such as patriotic ceremonies, for public programs. Armed Forces musical organizations are not permitted to provide entertainment, background, dinner, dance or other social music at public or private events in competition with the customary or regular employment of local civilian musicians.

This will supplement our recent conversation concerning the participation of an Armed Services Band at our National Convention to be held in Miami, Florida, July 12-16, 1981.

The Department of Defense has traditionally provided, at government expense, the DAV with this type of support at all previous National Conventions, including our Miami Convention in 1976. In February 1981 we formally requested the Office of the Assistant Secretary of Defense to provide a military band for our Convention (copy attached). This request was acknowledged on March 16, 1981 (copy attached).

It was brought to our attention, during the first week of May 1981, that military bands were not available for the date requested, July 12, 1981. As a result and at the suggestion of the Department of Defense, the Florida Army National Guard was formally requested to support our Convention (copy attached). This request was denied on May 14, 1981 (copy attached).

Since that time we have been attempting to resolve this situation through informal contacts at the Department of Defense. Most recently the Office of Assistant Secretary of Defense for Public Affairs has advised us that the only alternative would be to fly a band to Miami and all expenses incurred would be the responsibility of the Disabled American Veterans.

This suggestion is not acceptable to us in view of past participation of military units at our National Conventions. We believe the military should not be reluctant to provide support to an organization whose membership is composed solely of this nation's service-connected disabled veterans.
