State Caucus: 6 (1) A state caucus consisting of the accredited state delegates and 7 any members of the Executive Council whose membership is credited to 8 that state, shall be convened whenever: 9 (a) In an Army or Air National Guard Area Caucus of which the 10 state is a part, where there are names of more eligible members 11 proposed than there are vacancies to be filled on the Executive 12 Council from the area concerned. 13 (b) A vote by roll call of the states on the floor of a General 14 or Special Conference is ordered pursuant to the demand of five 15 or more states. 16 (2) A state caucusing pursuant to clause (a) of paragraph 1 of this 17 subsection shall cause the vote of its delegate in the appropriate 18 Area Caucus to be cast for each of the two members of the ASSOCIATION 19 who receive the highest number of votes in the State Caucus. 20 (3) A state caucusing pursuant to clause (b) paragraph 1 of this 21 subsection shall cast the vote of the state under the unit rule: 22 (a) If the question is on election to an office of the 23 ASSOCIATION, for the nominee who received the highest number 24 of votes in the caucus; 25 (b) If the question is on election to the Executive Council 26 for each of the two nominees who receive the highest number 27 of votes in the caucus: or 28 (c) If the question is on the adoption or rejection of a 29 motion, as determined by majority vote of the Caucus. 30 b. National Guard Area Caucus: 31 (1) A National Guard Area Caucus consists of one Army and one Air 32 accredited delegate to a General or Special Conference from each 33 state in the geographical area concerned, designated by the President 34 of the state, and the four (4) Area Directors from the respective 35 36 area.

"two-thirds vote" means and includes two-thirds of the legal votes 31 32 cast.
