However, this was not a substantive meeting with the President as he did not make a major statement. Presidents Nixon and Ford spoke at the League's annual banquet, and President Carter had a 45 minute meeting in the Cabinet Room with League officials thirteen days after taking office.

JULY 9 DESIGNATED POW/MIA DAY

In cooperation with the Department of Defense, the Veterans Administration will lead the Nation July 9 in honoring America's 100,000 former prisoners of war.

President Reagan, in conjunction with a Congressional Resolution, has designated July 9 as P.O.W. - M.I.A.

Recognition Day. Administrator of Veterans Affairs

Robert P. Nimmo has asked that VA facilities conduct appropriate ceremonies on that day to honor all former POWs and those still unaccounted for in Southeast Asia.

In a message to VA employees, Nimmo said: "All Americans should recognize the debt we owe our fellow citizens who, while serving the Nation, were imprisoned by the enemy. We should not forget the unresolved casualties of war -- those who are still missing. Their families, relatives and friends still wait, not knowing the fate of their loved ones."

In Washington, Recognition Day ceremonies will be held at the Pentagon, hosted by the Defense Department.

The Prisoners of War Health Care Benefits Act of 1981 gives former POWs special priority for VA medical treatment. It also reduces from six months to 30 days the requisite internment period for presumptions relating to certain diseases associated with prison camps in compensation claims.

In the 12-month period that ended Oct. 1, 1981, VA hospitals treated 4,553 former POWs, including 2,530 with service-connected ailments.

A 14-member Advisory Committee on Former Prisoners of War assists Administrator Nimmo. Committee members represent European and Pacific theaters of World War II, Korea and Vietnam and each branch of the military.

Since the Revolutionary War, when General George Washington complained of the treatment accorded to captured soldiers of the Continental Army, the United States has recognized the uncommon hardships experienced by our soldiers held prisoner during times of war. Called upon to defend American ideals while undergoing extreme adversity in violation of fundamental moral standards and the international codes and customs for the treatment of prisoners of war, our soldiers have fulfilled their duty to their services and country.

Similarly, our country has recognized the acute suffering experienced by the families of our soldiers held captive or missing in action. The uncertainty these service families live with day-to-day surely touches the heart of every American.

The Congress has by Joint Resolution designated July 9, 1982 as National P.O.W. - M.I.A. Recognition Day and on this day we should recognize the special debt owed to our fellow citizens who gave up their freedom and their families in the service of our country. We must also remember our still-missing servicemen, for whose families, relatives and friends the anguish and bitterness of war are enduring aspects.

Our Nation must not forget and will continue to seek answers to their fates.

NOW, THEREFORE, I, RONALD REAGAN, President of the United States of America, do hereby designate July 9, 1982 as National P.O.W. - M.I.A. Recognition Day, a day dedicated to all former American prisoners of war, to those still missing, and to their families. I call on all Americans to join in honoring those who made the uncommon sacrifice of being held captive in war, and their loved ones.

I call upon State and local officials and private organizations to observe this day with appropriate ceremonies and activities.

IN WITNESS WHEREOF, I have hereunto set my hand this first day of June, in the year of our Lord nineteen hundred and eighty-two, and of the Independence of the United States of America the two hundred and sixth.
