ROA CONFERENCE

TO HONOR REAGAN

WASHINGTON, Feb. 16. - President Ronald Reagan will be named the Minute Man of the Year when 2,000 members of the Reserve Officers Association of the U. S. meet here next week.

Reagan will be honored at the ROA banquet Feb. 23 for his stand on national security and his "dedication to the Citizen-Soldier tradition."

Vice President George Bush is expected to represent Reagan at the dinner, the final event of four days of activities for the ROA's 60th anniversary Mid-Winter Conferences and national council meeting, Feb. 20-24.

Headquartering at the Washington Hilton hotel, the conference also will hear discussions by government and defense leaders. Retired Army General William Westmoreland will be a featured speaker at 2 p.m., Feb. 22.

Air Force Secretary Verne Orr, General Robert H. Barrow, Commandant of the Marine Corps, and Dr. Edward J. Philbin, deputy assistant secretary of defense for reserve affairs, will address the service luncheons on Feb. 22 of, respectively, the Air Force, Naval Services, and Army.

Two controversial legislative topics will be discussed by members of Congress on Feb. 21. The nuclear freeze will be the topic of Sen. Jeremiah Denton (R.-Ala.) and Rep. Howard Wolpe (D.-Mich.). The problem of industrial mobilization will be the subject of Reps. William L. Dickinson (R.-Ala.) and Bill Chappel (D.-Fla.).

Also attending will be 200 cadets and midshipmen of Reserve Officer Training Corps units from colleges and universities throughout the country. They will hear a talk by Rep. John McCain (R.-Ariz.) in a Feb. 22 Capitol Hill breakfast hosted by Sen. John Warner (R.-Va.). They will also take special evening tours of Mount Vernon, on the Washington Birthday holiday, and the U. S. Capitol. The latter will be escorted by the U. S. Capitol Historical Society.

In Washington: Vietnam has dominated Sonny Montgomery's congressional career, not only during the years of fighting, but after the ceasefire as well, when most other members were

no longer thinking much about it.

Montgomery ran for Congress in 1966 pledging to "bring the boys home" in honor. He spent every Christmas for the next several years visiting soldiers at the front. When the conflict finally drew to a close, he served on two committees seeking facts on men missing in action. Now, as chairman of the Veterans' Affairs Committee, he has to struggle with the question of benefits for those who served in Vietnam.

It is the career focus his personal life prepared him for. He spent most of his adult years in the military on active duty in World War II and Korea, and in the Mississippi National Guard until 1980. He headed immediately for Veterans' Affairs as a House freshman in 1967, and added a place on Armed Services four years later.

He is a member whom colleagues usually listen to, not necessarily because they agree with him but because they like him. Firmly within the tradition of soft-spoken Southern grace, Montgomery is rarely disagreeable even to those who have never agreed with him on defense issues. Many of his friendships were developed on the paddleball court in the House gym; others on Washington's dinner party circuit, where Montgomery has long been a bachelor much in de-

Like most Mississippi Democrats, Montgomery came to Washington with the firm belief that the national Democratic Party had moved too-far to the left for him to support it very often.

He was one of only three House diehards to stick by President Nixon even after the House Judiciary Committee voted in favor of impeach-



ment. These days he votes with his own leader. ship only about a third of the time, and House Republicans refer to him casually as "one of us."

At times in the past, GOP members interested in building a bipartisan conservative coalition to take formal House control have sought him out as a potential leader. But he has never talked seriously of bolting the Democratic Party - not so long as it controls the levers of power in the House. In 1981, Montgomery helped start the Conservative Democratic Forum, the group that lobbies for conservative positions within the Democratic Party.

Montgomery began traveling to Vietnam in his first year on Capitol Hill, initially at Agriculture Committee expense, inspecting Food for Peace programs. Later, he went on Veterans Committee business, reviewing VA facilities. But mostly, Montgomery went because he wanted to see the military and the war firsthand.

As a result, he became an acknowledged expert on the war, although his support for it drove him far from majority opinion in the House in the early 1970s. "The time is past when can discuss whether this is the wrong war," he said in 1967. "Our flag is committed." Three years later, he was still defending the ability of American troops to help the South Vietnamese win the war. "The morale of the American fighting man is quite high," he said then. "The one thing that seems to disturb him most is the continued anti-

Montgomery's committee, known formally as the Select Committee on U.S. Involvement in Southeast Asia, went to Vietnam and to Europe to meet with representatives of the communist regime in Hanoi. It finally concluded, in December 1976, that there were no Americans still imprisoned in North Vietnam.

Montgomery resisted pleas from fellow conservatives to continue pressing Hanoi for more information. He was the bearer of bad news: There was no hard evidence, he said, that any of

the missing men were still alive.

Again the next year, Montgomery was called for Vietnam duty when President Carter sent a special commission to Vietnam, headed by labor leader Leonard Woodcock. Again Montgomery presented a report that did not please his conservative colleagues. He and the commission advised the president to explore the possibility of normal diplomatic relations with what had become the Socialist Republic of Vietnam.

On the Armed Services Committee, Montgomery has spoken for years in behalf of military reserve units and the National Guard. It is a subject other members treat with only intermittent attention, but Montgomery has made a specialty of it, does his homework and often gets his way. He is largely responsible, for example, for the new planes the Air National Guard is able to obtain in each year's defense authorization.

Montgomery has been less successful in his long fight to reinstate the draft. As someone who worries about the ability of American forces to fight a protracted war, he has continually questioned the merits of the all-volunteer army. Most of the Armed Services Committee agrees with him, but they have made little progress in moving the House toward a peacetime draft, although peacetime registration was reinstituted in 1980.

As Montgomery took over the Veterans' Committee in 1981, there were few major changes. The committee has been dominated by members dose to traditional lobbying groups such as the American Legion and Veterans of Foreign Wars. Many of the members themselves are World War II veterans.

This 1940s orientation has set up a conflict with younger members who want to see more resists enacted for Vietnam-era veterans. They need a potential challenge for Montgomery as he

set out in 1981 to write a new GI Bill for men and women now in the service. Montgomery has expressed a desire to increase benefits to attract more qualified persons to military service.

At Home. For years Montgomery has had the best of both worlds — a personal popularity in Congress and bipartisan support back home.

Not since 1968 has he won a primary or general election with less than 90 percent of the vote. "Sonny Montgomery votes with us," explained former state Republican Chairman Clarke Reed in 1974. "We don't have any issues against

him except party."

Montgomery was a state senator and prominent National Guard officer when he first ran for the House in 1966. The 3d District had gone Republican on a fluke in 1964, electing little-known chicken farmer Prentiss Walker, the only Republican who had bothered to file for Congress anywhere in the state that year. Barry Goldwater carried Mississippi easily in his 1964 presidential campaign, and he carried Walker into office with him. Two years later Walker ran unsuccessfully for the Senate — he would have been beaten for re-election to the House anyway — and Montgomery found the field clear.

There were three other candidates for the Democratic nomination in 1966, but Montgomery was an easy winner. He drew 50.1 percent of the primary vote, avoiding even the necessity of a

runoff.

His general election campaign was easier. Describing himself as "a conservative Mississippi Democrat," Montgomery said he opposed the new, big-spending Great Society programs but favored older ones like Social Security and rural electrification. He claimed that his Republican opponent, state Rep. L.L. McAllister Jr., was against all federal programs, and linked McAllister with the national GOP, which he called the "party of Reconstruction, Depression and 'me-too' liberalism." Sweeping every county, Montgomery won the seat with 65 percent of the vote.

He had little trouble holding it in 1968, drawing 85 percent of the primary vote against a black civil rights activist and 70 percent in the fall against Walker, who was trying to regain the seat. The Republican had lost his Senate race to veteran Democrat James O. Eastland by a margin of more than 2-1, and ran almost as poorly in his comeback attempt against Montgomery. He carried only one county.

That crushing defeat seemed to remove any remaining Republican interest in contesting Montgomery. Opposition has been negligible

Mississippi - 3rd District

since 1968.

The District. Like the two northern Mississippi districts, the T-shaped 3rd is predominantly rural. But it is far more Republican than they are in voting behavior.

The reason is the presence of two major population centers — Lauderdale and Rankin counties — which cast more than a quarter of the vote and regularly turn in substantial GOP majorities. Rankin County includes the eastern suburbs

of Jackson. Lauderdale County includes Meridian, the district's largest city. Located in the midst of the Piney Woods, Meridian has several lumber-related industries, Lockheed and General Motors plants and a Navy base.

Democratic strength is concentrated in the heavily black, cotton-growing Delta region at the western end of the district. The rest of the 22-county district tends to be more marginal in its voting habits.

others, the 3d was so constructed ten years ago as to prevent blacks from controlling the outcome of congressional elections here. Of all of Mississippi's districts, this is the most rural and agricultural. Its only urban areas of any size are the small city of Meridian and the part of Rankin County across the Pearl River from Jackson. More typical—and notorious—are towns such as Philadelphia in Neshoba County, where three civil rights workers were murdered in 1964, and in which Ronald Reagan unaccountably chose to make a campaign appearance in 1980.

The congressman from the 3d district is Sonny Montgomery. He is an exemplar of the traditional southern Democrat: devoted to his work, a delightful companion, dedicated to his principles but possessed of a fine sense of humor. A veteran of both World War II and Korea, Montgomery serves on the Armed Services and Veterans' Affairs Committees, In 1981 Montgomery became chairman of the House Veterans' Affairs Committee, a body led for years by conservative southerners sympathetic to the major veterans' organizations. He grainly falls under that description himself and has tended to oppose counseling programs and benefit extensions advanced in the name of Vietnam veterans. But those who favor the less traditional and more innovative approaches find him somewhat flexible and willing to isten. He is not considered likely to be one of the House committee chairmen who will fight against Reagan Administration budget cuts in his committee's programs. He has always been on the side of urging a strong defense and is an unabashed enthusiast for things miliary, He is Capitol Hill's strongest champion of the Reserves and the National Guard bodies with much support in Congress, although they were used sparingly or not at all in the Vietnam war. On other issues Montgomery almost invariably votes with the bulk of Repubicans and the still fairly significant number of conservative southern Democrats.

Montgomery occupies an important position in a House where Democrats have a relatively small majority. With the Republicans united as they were in the late 1970s, the Democrats can lose no more than 26 votes and still command a majority on a given issue. But men the Montgomery are not very likely to vote with most Democrats on the merits of most issues. Montgomery, however, does not seem temperamentally inclined to rebellion and appeals to party loyalty by senior Democrats could prevail with him.

Montgomery is regularly reelected by near-unanimous votes; the last time he had a Republican opponent, in 1978, he won 92% of the vote. His district could be altered considerably if the legislature creates a black-majority seat, but in all likelihood he will continue to but wherever the district lines go—even in Jackson, which has had Republican congressant for 10 years now.

FOURTH DISTRICT

Mississippi's capital and largest city, Jackson, is the center of one of the state's two significant urban concentrations. It has experienced considerable growth in the 1960s and 1970s—aside from the Gulf Coast, more growth than any other part of the state. It is still only a small city by northern standards, but the boom atmosphere is apparent. Much of Jackson's growth has been accounted for by well-to-do whites; the city has its new subdivisions of pleasant large colonial houses under huge, overhanging trees, inhabited by new Mississippi millionaires. Even the less well-to-do—people who grew up poor and now make \$23,000 a year more than they ever dreamed of—tend to think of themselves as new rich, and in fact mone goes a good deal further in Jackson than it does in one of our major metropolitan area.

As a result of this kind of growth, Jackson has become one of the most Republican part of the state. The young, better-educated, upwardly mobile Jacksonites find great appeals the crisp ideology of the Republican Party. There is a countervailing factor in politics here however, and that is the appeal in Jackson of Governor William Winter. A Democrat with background in the Jackson establishment, Winter was an early supporter of civil rights who
