Vets Line Up Against Nimmo

Washington, DC (S&S)-Pressure is apparently mounting across the country to force the Administration to either remove VA Administrator Robert P. Nimmo from office or have him address and rectify the complaints that have mushroomed over the past few months as a result of his casual remarks to the wire services, his reported misuse of VA funds to refurbish his offices, his alleged holidays from VACO, his reported refusal to support programs, and the Administration's apparent intent to slash VA services to veterans.

The Stars and Stripes has been informed that the major veterans organizations who have queried Nimmo by letter concerning the complaints, have not been answered.

Veterans' leaders who were interviewed are expressing their concern that because of Nimmo's actions, columnists for major newspapers and television commentators are reporting stories that reflect discredit upon the Administration and upon the VA at a time when the agency is fighting for its financial life on the Hill.

It is noteworthy that the Veterans of Foreign Wars (VFW) who were the only veterans organization to publicly support the candidacy of Ronald Reagan for President in

1980, are leading the mounting attack.

Veterans' leaders who were interviewed are expressing serious concern that columnists for major newspapers and television commentators are portraying Nimmo in a posture that reflects discredit upon the VA at a time when it is fighting for its financial life before the Congress.

Citing the "disservice" Nimmo does the agency by such comments "which play right in the hands of the press," the VFW notes in particular an editorial which appeared in the Wall Street Journal entitled "Touching the Untouchable," and mentions a number of other media efforts.

The VFW said "We both know the VA is anything but un-See Nimmo, Pg. 6

touchable. This is evidenced by the ever declining percentage of the overall Federal budget which goes to the VA.

"Untouchable is certainly an unearned title when you consider the emasculation, indeed the eradication, of the pension program by PL 95-588."

The VFW noted that the VA is up to 22.5 percent less expensive than other community hospitals," and yet Nimmo would throw us to the wolves of the private hospital community just to fill up hospitals they overbuilt."

Noting that they have taken care to assume a "sit back and wait" attitude during the beginning of Nimmo's tenure, the American Legion, the Disabled American Veterans and the VFW said they had taken care not to indiscriminately attack Nimmo or his efforts and give him a chance.

In speaking of the recent hospital construction curtailment, the VFW said, "Nimmo should not allow politics, or a simplistic effort to save money, to influence the IG's or the VA's revalidation of the construction program."

"We do not need a rabid IG who is as 'mean as a junkyard dog', as President Reagan refers to them. We need compassion and recognition that honors loyalty and service," said Cooper Holt, Executive Director of the VFW. *

2 views of federal spending

ur bucks stop here

Despite all of Ronald Reagan's tough talk about cutting waste in government spending, it still de-pends on which side of the bureaucrat's desk you're sitting.

Two examples:

First, there's Robert Nimmo, who sits on the bureaucrat's side. He is Reagan's appointee as administrator of the Veterans Administration.

When Nimmo moved into his Washington offices, he was not impressed by the decor. So he ordered that the place be spruced up.

Start with the floors. His predecessor used a wheelchair, so the floors were a bit scuffed.

They were refinished at a cost of \$3,000. Then

they were covered with carpeting. Carpeting comes in a wide range of prices. I recently bought three pretty nice Scandinavian rugs—dining room, living room and TV room—for

about \$1,500. The carpeting that was put into Nimmo's governmental office was in the Karastan "plush and "new grace" styles and cost \$6,000. 'plush elegance"

THEN THEY DROPPED about \$4,000 for some wall treatments and bookshelves. Another \$1,400 for a coffee table and TV set. A comfy chair for

Nimmo to sit in cost \$332. And almost \$400 was spent on pictures to hang on his wall. (Don't bureaucrats have any nice family photos that can fill the space?)

The office finally looked nice, but it lacked a

certain something.
That something was a private bathroom and shower for Nimmo. He likes to freshen up before he goes out to dinner.

So the plasterers and carpenters and plumbers came in and installed a private shower and bath-room in Nimmo's office. Cost: \$8,477.

(Nimmo's predecessor was a triple-amputee, but he somehow managed to perform his bodily functions without a private bathroom.)

There's more, but I won't go into all the details. The bottom line is that in these hard-eyed times, with social services for the poor being slashed, the cost of remodeling Nimmo's offices was \$46,000.

Think about that when you're trying to scrape up enough money, after paying your income tax, to buy some plywood so you can refinish your own basement. If you can afford to own your own basement.

THEN THERE'S Nimmo's car.

Nimmo had the government lease a 1982 Bulck Electra for him at about \$720 a month. And the government provides him with a chauffeur.

And he likes to ride in the car so much-apparently using the chauffeur to take him to and -that the driver plied up more than rom his home-\$8,000 in overtime in less than a year.

(Nimmo's predecessor, the triple-amputee, used to

drive himself to and from home.)

So to give Nimmo pleasant carpeting upon which to walk, and a big car for him to sit in, it has cost more than \$60,000 in one year.
It takes a lot of W-2 forms to raise \$60,000.

Then there is Mary Bevelch, who sits on the other side of the bureaucrat's desk, which is where most of us sit.

Mrs. Bevelch is 85, and a childless widow. She lives in a two-flat on the Southwest Side and



scrapes by on a monthly \$264.70 check from Social Security. That's \$61.08 a week-not exactly mad money.

Recently Mrs. Bevoich received a letter from the

Social Security office that said:
"We have determined that you received \$1,058.80 more in supplemental security income payments than you were due.

"... If you repay a portion of this in cash, you may become eligible again for these payments.

"Please refund the \$1,058.80 immediately. Make your check or money order payable to ..." etc.,

MRS. BEVCICH was confused. Bureaucrats easily confuse people her age.

But a friend of hers checked into the matter for

her, and this is what the problem is: Mrs. Beveich is just too rich for her own good. The Social Security people discovered that Mrs. Bevelch has two bank accounts.

In one she has \$453.40. She has set that aside for .

emergencies. In the other, she has \$1,081. That money is being

reserved for her funeral expenses. She also owns a grave site in a cemetery, which is worth about \$300. The burial plot is for herself, of course.

So when you add up her funeral money, the value of her burial plot, and her emergency money, it comes to about \$1,800.

And a Social Security burgaucrat said she cannot have more than \$1,500 and still draw her payments.

"She simply exceeded her allowable limit in cash assets," a Social Security spokesman said.

BUT HOW CAN the government include the money she has earmarked to bury herself with and the value of the small patch of ground in which she intends to be burled?

The bureaucrat said: "Having that burial plot doesn't preclude someone from selling it. She could go out tomorrow and sell it and never tell us. If it's accessible as cash and she can reach for it at any time, it translates as cash."

But he was not without a heart. He said that Mrs. Bevolch wouldn't have to pay back the entire \$1,058.80 in one lump sum. She could start paying installments.

And, by getting rid of some of her money-guess she should go on a mad spending spree guess she should go on a mad spending spree-they'll begin sending her that \$61.08 a week.

Say, maybe forcing Mrs. Bevelch to spend her funeral money is just a clever trick to stimulate the economy.

After all, Mr. Nimmo in Washington is doing his part.

Nimmo - An Embarrassment

PRESERVATION

First nominated by President Reagan some fourteen months ago after an ignoble seven-month period when various individuals were offered the job and turned it down, the Administrator of the VA, Robert P. Nimmo, has become a public issue which must be addressed and resolved by the White House.

It was confounding enough to veterans and staunch supporters of the new Administration's commitment to austerity, that the agency with the second largest number of government personnel, and the third largest Federal budget, received no more than cursory consideration as to who would judiciously and effectively administer its vast operations in the future.

However, veterans who were used to the military modus operandi of hurry up and wait, and supporters of the new regime who desired to fairly offer the President and his men sufficient time to become acclimated, presumed that the serious impediments surfacing in VA operations across the country were temporary, and based on the short time in office of the new appointees and their remarkable tendency to be ill-informed about how Washington works, regardless of their political affiliation.

It is noteworthy that the VA functioned without losing one bed or similar catastrophe during the seven-month quibble over who would run the outfit.

The situation now, however, is ludicrous.

It has become vividly apparent in national press reports which have sleuthed out the Administrator's activities since his appointment, that because of his actions, Robert P. Nimmo's credibility is nearly zero and probably irreparably damaged.

The hierarchy is entitled to their perqs, and really, who cares, as long as the integrity of the agency and its functions are not touched.

The Administrator and his staff, like it or not, by the title of their offices are levied with the responsibility of setting an appropriate example for the minions to follow.

Unless they want a revolt—"Do as I say, and not as I do" has banished many from the role of statesman.

Despite his recent repayment to the VA treasury of some six thousand, four hundred dollars for costs associated with the illegal use of government transportation, (opinions on the use of agency vehicles and drivers were provided his office in June and November 1981 by the VA General Counsel's office, expressly forbiding unofficial commuting), the suspicion that Nimmo et al have become a political public relations disaster, are being confirmed daily.

How long will the Administration allow this self-humiliation to continue?

Nimmo has announced that he will give up his lease on his favored Buick Electra for a vehicle consistent with government regs. It is hoped that he will no longer continue to park in the handicapped area at VA headquarters alloted for paraplegics and comparably disabled veterans. At least one national organization has already issued a formal complaint coupled with the reasons why they cannot attend meetings at Central Office.

It is pointless to comment on all of the absurdities perpetrated by the Administrator and some of his staff in the name of austerity, although commandeering a military aircraft to fly his aide-decamp and himself home from Reno (\$5,600), and refusing to allow VA employees to take leave to attend the Vietnam Veterans Memorial groundbreaking ceremony while he kept a golfing commitment, are heights worth noting.

More to the point is the fact that Nimmo has said all along he did not want the VA job and accepted it only to carry out the budget cuts President Reagan wanted.

Reliable sources in VA headquarters confirm that Nimmo has vowed to remain as head of the VA long enough to assure that he and OMB Director David Stockman can effect the severe slashes already being considered for the VA in the Fiscal '84 Budget, and the word has been passed.

While the FY '83 Budget was being reviewed, Nimmo personally supported the enactment of S. 1066, which would have paved the way towards making the GI Bill of Rights a welfare program.

When the FY '83 Budget came out, Nimmo wanted to reduce the payments to dependents of 30 to 40 percent service-connected disabled. After an interview with the VA Administrator, an AP reporter incorrectly played down the effects of the proposed cuts by portraying them as "those with relatively minor service-connected disabilities such as flat feet, chronic laryngitis, convulsive tics, or moderate ulcers."

The White House did not correct this announcement or direct the VA Administrator to clarify that this also included people who had suffered legs blown off at the knee or the loss of the sight in an eye.

No one should be surprised, therefore, that this ridiculous travesty continues, but there is serious concern that it seems to be interminable.

Reasonable budget cuts not geared to penalize the service-connected disabled or attacking earned benefits such as the GI Bill, might have been acceptable...if they had been presented by an Administrator respected by veterans organizations and the thirty million they speak for.

How can they, the Congress or the Nation, take this man's sincerity at face value in the future when he attempts to defend any future slashes in the name of the Reagan Administration?

The issue here is not what political persuasion one professes; the Administrator of any Federal agency should represent the policies of the President who appointed him, no matter which Administration is in power.

At the same time, this individual must represent the citizens of the United States, fairly and judiciously.

The present Administrator clearly does not meet these requirements. *

ALVAREZ TO BE NOMINATED DEPUTY ADMINISTRATOR

A former prisoner of war in Vietnam, Everett Alvarez, Jr., will be nominated by President Reagan to be Deputy Administrator of Veterans Affairs. He will succeed Charles T. Hagel, who has resigned.

Alvarez, 44, will join VA Administrator Robert P. Nimmo in leading the government's largest independent agency. He comes to the VA from the Peace Corps where he has served as Deputy Director since being appointed by the President in 1981.

A native of Salinas, Calif., Alvarez currently oversees the day to day management of more than 5,000 Peace Corps volunteers serving in over 60 countries.

The former Navy pilot received his Bachelor's Degree in electrical engineering from the University of Santa Clara in 1960, the same year he entered the Navy, beginning a 20-year career. He received his Master's Degree in Operations Research and Systems Analysis in 1976 from the Naval Post Graduate School in Monterey, Calif., and in December 1982 will receive his J.D. Degree from the George Washington University National Law Center in Washington, D.C.

From November 1976 to July 1980, Alvarez served as assistant program manager for the U.S. Naval Air Systems Command, and director of the U.S. Naval Air Production Management Project Office in Washington, D.C.

As assistant program manager, he managed the Navy's \$200 million A-4 aircraft program, accountable for management of development, testing, evaluation, and production of A-4 systems involving 15 models and more than 2.000 aircraft.

As director of the U.S. Naval Air Production Management Project Office, he established and implemented production readiness procedures and managed government contracting and procurement processes.

Among his numerous military awards are: Silver Star, two Legion of Merits (with combat 'V'), two Bronze Stars (with combat 'V'), a Distinguished Flying Cross and two Purple Hearts.

Upon his retirement from the Navy in 1980, Alvarez went to work for a Washington, D.C. law firm.

In 1973, following his release by the North Vietnamese, after eight and one-half years as a prisoner of war--the longest-held American POW of that conflict--he established the Everett Alvarez, Jr. scholarship foundation "to help youngsters get ahead and develop a sense of responsibility and positive feelings toward being an American." The foundation is administered by the University of Santa Clara.

As VA deputy administrator, Alvarez will assist the VA chief in carrying out the agency's numerous responsibilities in serving the nearly 30 million living veterans and overseeing the agency's \$25 billion budget.

Alvarez and his wife, the former Thomasine Ilyas of Pittsburgh, Pa., reside in Rockville, Md., with their two children Marc and Bryan.
