# VFW Leader Asks Group to Approve Campaign to Help Nicaraguan Rebels

The national commander of the Veterans of Foreign Wars has asked the group to approve a nationwide campaign to raise money for the U.S.-backed guerrillas who are fighting to overthrow the leftist Sandinista government of Nicaragua.

VFW National Commander Bob Currieo, who has talked up the project with local VFW commanders, said he expects "strong support" when it comes to a vote at the group's national convention in New Orleans this month. He noted that the organization's bylaws require it to oppose communism in Latin and Central America.

Federal law does not prohibit a private group from offering nonmilitary aid to foreign groups that are not acting against the national security interests of the United States, according to congressional legal counsel.

With 1.9 million members, the VFW is the second-largest veterans' organization; the American Legion has 2.7 million members.

Currieo spent eight days traveling through Honduras, El Salvador and Costa Rica last month, and then briefed President Reagan on his trip for a half hour in the Oval Office July 27. He said he was not seeking to circumvent a recent House vote to stop steadily increasing CIA support of the anti-Sandinista guerrillas, called "Contras."

"I met with the Contras while I was in Honduras and Costa Rica, and these are freedom-loving people trying to retake control of their country [Nicaragua] from dictators and bring about a democratic society," said Currieo. "They consider their country to be under the influence of a superpower, the Soviet Union, and they are asking only for help to keep the Soviet Union out."

No amount has been set for the VFW contribution to the guerrillas, but Currieo predicted that several million dollars can be raised for food, clothing and medical supplies. He said the money would be channeled through a nonprofit, Washington-based anti-communist group called the American Security Council and would allow the "Contras" to spend their funds on military hardware.

The vote on the resolution for the fund drive will come after Reagan addresses the convention. Sen. John Glenn (D-Ohio), a candidate for the Democratic presidential nomination, is scheduled to speak immediately after Reagan. But Currieo said he didn't expect either to take a stand on the resolution. He said he had not discussed it with Reagan, although White House aides are aware of it.

"We are doing this without consulting with the president," he said. "But I am behind his policies in that area 100 percent. I told the president there is no question in my mind that our effort down there is right and we should feel obligated to help those people."

In addition to addressing the VFW and several Hispanic groups during his three-week vacation on the West Coast, Reagan is scheduled to speak to the American Legion's annual convention.

"We are very supportive of the president's Central American policies," said Mylio Kraja, executive director of the American Legion. Kraja said the American Legion has no plans to funnel aid to Latin America independently.

Its own charter prevents the other major veterans' group, the Disabled American Veterans, from taking a position on American military action in Latin America, but its members are supportive of Reagan's policies.

Reagan will face a challenge in warning the support of Vietnam-era veterans, who have made recent gains in the groups' hierarchies. Those men, according to officials of both groups as well as Reagan's political advisers, are less amenable to the idea of possible military intervention.

# Angry VFW nails Reagan for no-show

WASHINGTON — With one move, President Reagan has angered the 1.9 million-member Veterans of Foreign Wars, a group he is counting on to support his Central American policies, and handed that forum to a major political opponent, Sen. John Glenn of Ohio.

The national commander of the VFW, James Currieo, has informed the White House that he will sharply criticize Reagan for skipping the VFW's annual convention in New Orleans next month during his California vacation.

In a bitter letter to the White House, Currieo reminded Reagan aides that his organization is considering whether to conduct a major fund-raising drive to help the rebels who are fighting the government of Nicaragua.

Currieo, in fact, is in Central America this week on what a VFW spokesman calls a "fact-finding trip" related to that drive. He is visiting the countries the administration strongly backs in that region: El Salvador, Costa Rica and Honduras

The VFW will decide at its convention whether to conduct the major fund-raising drive through its 10,000 local chapters.

Currieo's spokesman said the organization — which endorsed Reagan in 1980 and has routinely backed his foreign policy and defense initiatives — was led to believe the president would keynote the annual convention.

Currieo's letter calls the president's refusal a slap in the face to veterans, and warns that he intends to read a copy of the letter in full to the convention before Glenn appears as replacement keynoter.

Thorne H. Marlow, director of public affairs at the VFW, said of Glenn: "Our folks empathize with him as a former military man and as an astronaut."

White House officials, who have not yet sent a reply to the letter, would not say who made the decision on the convention.

One conceded that several aides in the White House, attuned to the president's re-election campaign, had recommended that Reagan attend the convention by making a quick trip to Louisiana from his California ranch, but the recommendation was rejected.

Glenn was invited and accepted shortly after Reagan declined the invitation.

The politics of the situation is causing some head-shaking in the White House, where Glenn is still considered the toughest potential opponent to the president because of his appeal to many of the constiuency groups, such as the veterans, that Reagan counted among supporters in 1980.

Mr. Stump. Mr. Speaker, the planned landing site of the Space Shuttle was not the only aspect of this recent and historic mission to be overcast by dark clouds.

I would like to enter in the RECORD and bring to the attention of my colleagues and the American people the following article from the Arizona Republic regarding VIP's at the shuttle launch.

#### THE OTHER JANE FONDA

Millions of fawning Americans have lionized actress Jane Fonda by buying her diet and exercise book, thereby adding to her considerable wealth and making her a best-selling author.

There is another Jane Fonda, however, one that she might want to forget, but one whom others cannot forget.

Fonda was the darling of extreme left wing groups who took her anti-American venom deep into the enemy camp in North Vietnam during the war, and willingly consorted with communists to aid and abet their propaganda, even as American prisoners of war were rotting and being tortured in nearby camps.

As for Fonda, she merely has become more famous and immensely wealthier.

The members of the Veterans of Foreign Wars have long stood in steadfast support of a strong and free America. Your presence in our democracy is a continuing reminder that true patricts throughout our nation's history have always been aware that the price of liberty is unceasing vigilance.



VFW: NO CYNICAL POLITICAL USE OF THE VIETNAM VETERANS MEMORIAL

WASHINGTON, D. C. -- James R. Currieo, National Commander-in-Chief of the Veterans of Foreign Wars of the United States, today described the impending July 2nd use of the Vietnam Veterans Memorial area by a coalition of far-left activists ("Ad Hoc Committee for July 2nd Emergency Mobilization") as being "a mass obscenity."

The VFW leader continued by noting:

"The Vietnam Veterans Memorial was paid for by private American citizens and organizations. The VFW -- with well over 500,000 Vietnam Veterans on our rolls -- made an early and substantial contribution.

"The Memorial was conceived as making a non-political, humanitarian point about the human cost of war.

"The cynical, political use of the Vietnam Veterans Memorial area by aging anti-Vietnam War activists attempting to defeat U. S. Central American policy by a 'no more Vietnams' type of media conscious demonstration must not be allowed to succeed."

Commander Currieo concluded by noting that "the Park Police have been informed about the July 2nd demonstration and will, presumably, prevent the desecration of the Memorial proper by the left wing activists.

"It will now be the task of all who value freedom to assure that the purposes of this July 2nd demonstration are decisively defeated. Failure in Central America is out of the question."

#### VFW LEADER "HEARTENED" BY START OF DIALOGUE ON POW/MIAs

WASHINGTON, D. C. -- James R. Currieo, National Commander-in-Chief of the Veterans of Foreign Wars of the United States, today stated that he was "heartened" by the apparent start of a dialogue between U. S. professionals from the Joint Casualty Resolution Center (JCRC) in Hawaii and the Vietnamese Communist regime on POW/MIA matters.

"From my discussions with Lt. Col. Joe Harvey, Commander of the JCRC, I am cautiously optimistic that some additional progress can be made."

(As reported, some nine to twelve sets of U. S. remains will be turned over to Lt. Col. Harvey's delegation in Hanoi today. The remains will be flown to the JCRC in Hawaii for identification.)

"Not all is roses, however," the VFW leader continued. "Not long ago, Hanoi categorically denied it was holding any remains of U. S. servicemen, despite a first-hand live sighting by a Vietnamese mortician that placed some 400 sets of U. S. remains in a Hanoi warehouse.

"Must we now anticipate a score or more occasions of returning 'recently discovered'
U. S. remains?"

Mr. Currieo concluded by pointing out that "if Hanoi can lie so facilely about holding the remains of our honored dead, the probability increases that they are holding

living Americans against their will. Once and for all, the Administration and the Congress must make it clear beyond any chance of miscalculation that we regard the prompt return of all our unreturned from Southeast Asia precedent to, and not a part of, any normalization of relations between our two nations."

SUBJECT: STRATEGIC MODERNIZATION

On May 16, Commander-in-Chief Bob Currieo led a small VFW party to the East Room of the White House where President Reagan, Vice President Bush, and others, set forth the case for deploying the M-X and asked for VFW support with the Congress to make this happen.

As what the President requested was clearly mandated: Resolution Number 413, "American Defense Primacy: The Enduring Commitment;" Resolution Number 414, "National Strategy of Peace Through Strength;" Resolution Number 417, "Support for Real, Equitable, Mutual and Verifiable Arms Reduction;" and Resolution Number 469, "Nuclear 'Freeze' or Peace Through Strength?" the Chief approved the following two communications:

- (a) a memorandum to selected members of the House Appropriations Committee which was scheduled to vote on the M-X on May 17; and
- (b) a memorandum to every member of the 98th Congress in anticipation of the M-X floor votes scheduled for both the House and the Senate during the week commencing Monday, May 23d.

The M-X should pass the Senate fairly easy; the Senate Appropriations Committee voted it up 17 to 11.

My "guesstimate" is that the President's proposal will pass the House in a squeaker.

WASHINGTON, D.C.--"I pledge that every member of the

VFW and its Ladies Auxiliary will fight the new move by a Senate

Study Group to shut down the Veterans Affairs Committee in the

U.S. Senate, " said VFW National Commander-in-Chief James R. Currieo.

A group chaired by former Senators James B. Pearson and Abraham A. Ribicoff has recommended that the committee be disbanded and designated a sub-function under the Senate Armed Services Committee. The study group was convened to examine the operation of the Senate and recommend changes to improve overall efficiency.

"The VFW and its Ladies Auxiliary led the fight to defeat this recommendation in the mid-1970s. The idea is still (over)

preposterous. Those who served their country in time of war need their programs protected by a separate committee in both houses of Congress. To that end, I call upon our membership and other veterans groups to again express their opinion to their Senators.

We cannot let the committee be dissolved, "Currieo continued.

The Senate rules and Administration Committee, is scheduled to begin hearings on the veterans affairs recommendation and others contained in the study on May 9.

Commander-in-Chief Currieo continues to push for a bill to grant compensation for diseases which may be caused by exposure to Agent Orange or other herbicides used in Vietnam. The Washington Office is working with sponsors in both houses of Congress to draft bills which will permit payments for disabilities while the Centers for Disease Control studies the effects of exposure.

Over 100,000 veterans have received an Agent Orange examination by the VA. About 23,000 have been scheduled for a follow-up exam, but many veterans are not keeping these second appointments. The VFW urges any Vietnam veteran who thinks he was exposed to get a check at a VA medical center.

The 1984 VA budget proposal which increases the funds by over \$1 billion from last year has been called "extremely good in view of the deep cuts proposed in other budgets." In testimony before the two veterans affair's committees of Congress, the VFW pointed out some areas of concern such as the postponement of cost of living increases in compensation and pension payments. However, the increases in the medical care system and construction reconfirms President Reagan's commitment to veterans.

There are 106 dean's committees at VA medical centers which are supposed to have a veterans service organization representative. The VA wants to improve communication with veterans organizations, but 22 committees do not have a representative.

VFW members are asked to check with their service officer to determine if a nearby VA medical facility is in need of a VFW member on the committee.

Unemployed or underemployed Vietnam Era veterans may be eligible for an extension of their educational benefits.

There has been an extension of the 10-year eligibility period, fought for by the VFW, for certain veterans who may wish to get vocational, apprenticeship, on-the-job training or a high school diploma.

To qualify, a veteran must have been unemployed or underemployed for six months. Veterans should see a VFW service officer or the VA.

Veterans in jeopardy of losing their homes with a VA guaranteed loan should contact the VA and their lender to discuss ways of keeping their domicile.

The VA has asked lenders to do all they can before foreclosing a VA loan.

The United States Coast Guard informs that some veterans organizations have turned membership applications down from those who served in the USCG during war periods.

In 1915 Congress specifically identified the Coast

Guard as a military service. If eligible for VFW membership, all

USCG personnel should be welcomed.

The week ending Saturday, May 21, is Armed Forces Week.

Posts should participate with their local military installation
to salute those now on active duty defending this nation.



"VFW: ADMINISTRATION RIGHT ON NO U. S. DOLLARS FOR UN "RIP-OFF"

WASHINGTON, D. C. -- James R. Currieo, National Commander-in-Chief of the Veterans of Foreign Wars of the United States, today hailed the Administration's decision not to pay an annual one million dollar assessment to a UN commission set up to create an "international authority" to mine manganese, copper, cobalt, and nickel from the oceans' floors under a Law of the Sea Treaty which the U. S. refused to sign.

Describing the envisioned "international authority" as a "typical, UN rip-off mechanism," the VFW leader further stated that "this refusal by President Reagan to submit to blackmail on this Law of the Sea issue will, I believe, finally open up an even more basic question: why should America, one of some 157 UN member states, pay 25% of the total annual budget of the UN rather than 1/157th?

"We are subsidizing a 'Cavern of Winds' whose principal product seems to be an emotional and reflexive anti-Americanism cloaked in Third World globaloney. Drawing the line at the proposed annual Law of the Sea million dollar example of duly-sanctioned looting is a healthy and realistic first step."

#### VFW HAILS CONGRESSIONAL ACTION ON AFGHANISTAN

WASHINGTON, D. C. -- Mr. James R. "Bob" Currieo, National Commander-in-Chief of the Veterans of Foreign Wars of the United States, today praised the U. S. Senate for unanimously "calling upon the United States Government to support the people of Afghanistan with material assistance in their struggle to be free from foreign domination based on the total withdrawal of Soviet troops."

Mr. Currieo noted that the delegates to the VFW's 83rd National Convention duly resolved that:

- "(a) U. S. military aid to the Afghan freedom fighters -- principally small arms and anti-tank and anti-helicopter weapons -- be sharply increased; and
- "(b) U. S. humanitarian aid to Afghan refugees in neighboring Pakistan be promptly provided in amounts and categories needed."

This mandate, the VFW leader further noted, has been selected as a "Priority Security Goal" for 1982-83.

Mr. Currieo concluded by reaffirming the commitment of the 1.9 million member organization he heads to the cause of the Afghan freedom fighters.

"Were it not for the on-going military suppression in Poland and the brave resistance of the Afghan freedom fighters, I have little doubt that the Soviets would have applied direct military pressure in Lebanon to our strategic disadvantage.

"I again commend the Senate for taking this step. We stand for freedom or we stand for nothing."

WASHINGTON, D.C.--"Due to the hard work of the VFW leadership, Congress exempted veterans groups from the requirement that royalties must be paid to copyright holders," said James R. Currieo, National Commander-in-Chief of the VFW.

"While Post Commanders will be notified officially of the new law and legal interpretations, we understand that VFW Posts will not be required to pay royalty fees after the effective date of the law when live music is played in Post homes provided: the function is limited to VFW and Auxiliary members and their bona fide guests and not open to the public; and, all profit after paying expenses is used for charitable purposes only," Currieo said.

"I want to thank each member who helped get this legislation through the Congress," Currieo said.

## VFW ASKS QUICK SEARCH FOR VA ADMINISTRATOR



"The nomination of an Administrator-designate prior to the November elections would be highly desirable," Currieo said.

In his letter to the President, Currieo pointed out that the VFW believes there is a great need for an Administrator to finalize the 1984 VA budget and voice his concerns for the veteran.

Currieo also cited the turbulence in the leadership positions in the VA as a cause for concern. "The absence of a dedicated Administrator may further contribute to the instability of the VA," he said.

"The VFW asks for an individual who knows veterans'



BUDGET ACTION

WASHINGTON, D.C.--"The VFW was delighted with the Congressional action which increased funds for the Veterans Administration," said James R. Currieo, National Commander-in-Chief.

"The override of the president's veto of the supplemental appropriations bill will enable the VA to continue the nurses scholarship program, allow funding for Agent Orange studies and give pay increases to VA employees without taking the money from other VA assets," Currieo said.
