Vietnam Memorial Changes Clear Last Major Hurdle

The Commission of Fine Arts yesterday unanimously approved the addition of a flagpole and a sculpture of three infantrymen to the Vietnam Veterans Memorial in Constitution Gardens, but demanded that the proposed locations for the added elements be changed.

Approval of the additions by the commission was the last major legal hurdle for proponents of changes in the controversial memorial.

The sculpture should not be allowed to "shiver naked out there in the field," said commission chairman J. Carter Brown, referring to its proposed location in an open area approximately 170 feet from the apex of the angle formed by the long walls of black granite in Maya Ying Lin's

original, competition-winning design.

Instead, Brown proposed that the flagpole, sculpture and third proposed element—an alphabetical "locator" for the names of the American war dead that are engraved in chronological order of their deaths upon the walls of the nearly completed V-shaped memorial—be grouped together in a different location to "help enhance the entrance experience of the memorial."

"We're feeling very positive," commented Jan Scruggs, president of the Vietnam Veterans Memorial Fund, immediately after the vote, which came at the end of a long, intense afternoon session conducted before an overflow crowd of more than 200 in the Cash Room of the Treasury Department. "We got the

Donald Paul Hodel, underseeretary of the Interior, testified before the seven member commission that the department would grant a per-mit to dedicate the memorial only if "the compromise design is apthe compromise design is approved." After the meeting, its spite of the conditions attached to the commission's approval, Hoder said that, "It looks good for the dedication—we're very pleased and would like to commend the commission for its work."

Maya Lin's reaction to the change in location was, she said, "relief, in a small sense." The young designer, who won the competition for the memorial while an undergraduate student at Yale University, said she was most concerned that the new elements "not interrupt the memorial." "I don't know where they will end up," she continued, "but care will have to be taken so you don't have three isolated elements floating in space.

Frederick Hart, sculptor of the statue, called the commission's decision "Solomon-like" in an interview with the Associated Press

In his remarks prior to the vote, Brown suggested that a "natural en-trance" to the memorial, and therefore presumably a location the comsion would favor for the cluster of additions, is near the western end of the memorial wall-a location nearer to the Lincoln Memorial than the proposed site—and not in direct line with the wall itself.

Brown said the commission could consider a revised proposal from the Vietnam Veterans Memorial Fund for grouping the three elements at its next regular meeting on Nov. 10, which is the opening date of a five-day National Salute to Vietnam Veterans to take place in Washington. Commission member Walter Netsch said the commission would be willing to call a special session to consider an alternative proposal on the location of the new elements. The pro-posed additions will be considered by the National Capital Planning Commission on Oct. 21.

Lin's original design, selected by a jury from more than 1,400 entries to the competition, foresaw the walls rising gradually from the ground in the glade near the Lincoln Memorial to a height of 10 feet at the apex.

The additions were a compromise worked out in sessions sponsored early this year by Sen. John W. Most of the witnesses who opposed the changes in the design did so on esthetic grounds. "Esthetics alone matters here today," said Michael Straight, a World War II bomber pilot and former deputy chairman of the National Endowment for the Arts who testified that ment for the Arts, who testified that the two concepts—Lin's abstract walls and Hart's realistic sculpture-"cannot be melded."

Robert M. Lawrence, president of the American Institute of Architects, protested that the proposed change is not a modification [of] or an addition to the original competitionwinning design. It is a new design altogether ... We should not allow a patched-up, modified, compromised memorial to be built."

When the day was done it turned out that the commission agreed, up to a point. "We wanted to clear those elements out of interfering with the experience" of the memorial as Lin had designed it, Brown said. "We wanted something that pleased all Americans, not just a group of veterans, although we recognized the need for healing and recognition and all of that. But it was up to us to take the long view."



Dear Mr. Secretary:

We appreciate your meeting with us recently regarding the addition of the sculpture and flag staff to the Vietnam Veterans Memorial.

As we discussed, it is in the best interest of all parties, including the Administration, the Veterans community, the arts community, and the Vietnam Veterans Memorial Pund, to resolve this matter as expeditiously as possible. One course of action suggested in our meeting — to submit a number of options to the Commission on Fine Arts (CFA) for consideration — appears to be reasonable and advantageous for all. In this regard, we have requested the Vietnam Veterans Memorial Fund (VVMF) to forward to you two proposals, in addition to that of December 8th, for locating the sculpture and the flag staff. VVMF has indicated its willingness to comply with our request and we understand that the two additional options will be forwarded to you shortly.

One of the two additional options will be that proposed by former Congressman Donald Bailey and his associates. The second option will be one suggested and supported by the American Institute of Architects. The VVMF proposal of December 8th is, we are advised, supported by the major veterans' organizations who helped raise the funds for the Memorial.

It is inevitable that on matters of aesthetics reasonable persons may disagree, which is the situation at hand. There is general consensus, however, on the appropriateness of adding the sculpture and flag staff to the memorial site; we strongly support this consensus. The three proposals represent a range of opinions as to the most appropriate locations for these elements. We believe that consideration of all three options by the Commission on Fine Arts, one of the governmental entities mandated to consider these matters, in an open public meeting is the best way for all opinions to be heard. Our support for this course of action is conditional on your approving and forwarding to the Commission on Fine Arts all three VVMF proposals as a set of options.

At last! The day we've all been waiting for -the time when our fellow Americans who served in the Vietnam war get their deserved thanks from a grateful nation -- is almost here. Thanks to your generous support and that of nearly half a million other caring and patriotic individuals, we are well on our way to seeing our dream of a national Vietnam Veterans Memorial become a reality.

I know you haven't heard from us for awhile, so I'd like to take this opportunity to give you a progress report on the construction of the memorial you helped build. In addition, I'd like to tell you about an exciting event to honor our Vietnam veterans that will take place in Washington, D.C. in November. Please read on for the details ...

On March 26, 1982, ground was broken for the Vietnam Veterans Memorial in a moving ceremony with 123 Vietnam veterans (representing all 50 states) and dignitaries simultaneously turning spadesful of earth along the chevron-shaped outline of the future memorial. We were able to break ground at that time because of the heartwarming and generous response from many of you to our most recent mailing. Thanks again!

Since then, progress has been swift:

- the earth was excavated immediately after groundbreaking
- the granite was cut and polished in Barre, Vermont
- * the memorial shape was cut out of the earth and a storm drainage system was built
- * On July 1, VVMF announced it had selected Frederick Hart (the highest ranking sculptor (third place) in our national design competition) to design the sculpture for the Vietnam Veterans Memorial
- * the concrete walls and base of the memorial were completed on July 7
- * inscription of the nearly 58,000 names of those killed and missing began in Memphis, Tennessee (using a specially designed photo stencil method) in early July

I don't have to tell you how exciting this is for all of us at the Fund. We are especially grateful to the American people for answering our call for help. I know you'll be proud to see this beautiful memorial when it's finished, which it will be (except for the statue) by the first of November. Here's what we still have to do: we are continuing to install inscribed granite panels on the memorial walls; in September we will begin landscaping activities. In early October we hope to begin sodding the memorial grounds and finish planting the trees. By November 1, we expect to have all the inscribed panels installed and all construction complete.

Now that I've brought you up to time in November, let me tell you about the big event that will take place then. As you know, the purpose of our national memorial is to honor all Americans who served in the Vietnam war. Therefore, to celebrate the memorial's purpose and progress, we are sponsoring a National Salute to Vietnam Veterans. Scheduled for November 10 through 14, in Washington, D.C., it features entertainment (with Jimmy Stewart as Master of Ceremonies!); military unit reunions for Vietnam veterans; a candlelight vigil to remember those who died and remain missing; a parade in tribute to veterans of that war; and nationwide religious services in honor of all who served in Vietnam. A schedule of events is enclosed for your review.

An important component of our National Salute are the religious services we hope will be scheduled throughout the nation during the weekend of November 12-14, 1982. But to be successful, we need your help. We've already contacted the religious leaders of America to ask them to encourage their members to hold special services and prayers for those who served in Vietnam. To make sure your place of worship participates, ask that a special time be reserved for services and activities from November 10 to 14, to remember our fellow Americans who answered their country's call to duty during the Vietnam wer.

Enclosed in this package is some information that I believe will be of interest to you. First, besides the schedule of events for National Salute Week, you'll find a form for unit reunions/registration and information about the parade for Vietnam veterans (so you can pre-register). Second, we'd really like to know if you will be able to participate in this historically important event, so we've enclosed a response card that asks a few questions. (Please send this to us if you are coming (or want to buy a Souvenir Program) and tell us where you will be staying.) The enclosed list of hotels (many of them giving super-discount rates for National Salute attendees) should help you make accommodations.

Finally, you'll find a brochure that describes official VVMF souvenir items -- made of the same beautiful granite that forms the mirror-like face of the Vietnam Veterans Memorial. We know many of you will wish to have a memento of the memorial stone that will honor forever those Americans who served in the Vietnam war.

This will be our last written report to you, our special donors, who have made the memorial possible. To see the fruits of your efforts, we hope you will join us for the National Salute to Vietnam Veterans in the nation's capital in November. Even though the memorial won't be officially dedicated at that time (it can't be until the flag and bronze statue are in place), the memorial will be "open" and you will be able to visit it and find a name of a lost loved one or friend on the inscribed walls. You'll also be able to see a model of the statue that will become a part of the memorial.

The dream I had -- the dream many of us had -- three years ago is about to become a reality, thanks to you. You can be very proud of the part you have played in building this long overdue tribute to all who served in the Vietnam war.

On behalf of all of us at the Vietnam Veterans Memorial Fund, I wish to thank you again. May God Bless You for your caring and for your gifts.

By Air

National Airport is located in Northern Virginia, 15-20 minutes from the center city. Limousine service to central hotels is approximately \$4.00 and cab fare is \$7.00. Information number at the airport: (703) 557-2045.

Baltimore Washington International Airport is located near Baltimore, Maryland, approximately an hour's drive from downtown Washington, D.C. Airport limousine service is in the \$8 range. Cab fare is up to the individual driver since there are no set fees. Negotiate fare ahead of time (\$40 range is average). Information number at the airport: (301) 859-7111.

Dulles International Airport is located in Chantilly, Virginia, 35-40 minutes from downtown Washington, D.C. Limousine service to downtown hotels is approximately \$8. Approximate taxi fare is in the \$28 range. Information number for the airport: (703) 471-7596.

Travel within the city is easy on the Metro (subway). Directions on how to use it will be available in your hotel room and at National Salute activities.

Tribute to Vietnam Veterans Parade

On November 13, 1982, a Tribute to Vietnam Veterans Parade will be held in Washington, D.C. on Constitution Avenue, between 7th and 17th Streets, N.W. The theme of the parade is "Marching Along Together Again" (i.e. Vietnam veterans marching together again, as well as a cross section of America marching with them).

This parade will feature large formations of Vietnam veterans, marching by state, supported by bands, floats, active duty military units, and groups of veterans from other wars. Highlights of the parade will include the participation of disabled Vietnam veterans, service organizations such as the American Red Cross and the U.S.O., massed colors and twenty-five Grand Marshals drawn from the ranks of Vietnam veterans in sports and show business, government, Vietnam Medal of Honor winners, and ranking officers and enlisted Vietnam veterans still on active duty.

Since the parade is being organized by states, each of the fifty-five governors (including territories) has been asked to appoint a single point of contact to handle National Salute matters, especially parade participation. In most cases, these individuals are the state Directors of Veterans Affairs.

The American Legion, V.F.W., AMVETS, and DAV have volunteered to help coordinate marchers and support groups that will appear in the parade. If you wish to participate in the parade, you should contact either the State Office of Veterans Affairs or the State Department of one of the above veterans organizations for specific information on state involvement in the parade.

If you have difficulty locating the person in charge in your state, contact K. Hunter, Parade Coordinator for the National Salute at (202) 659-2490.

The parade will begin at 10 a.m. and will continue through 12:30 p.m. Spectators will include Vietnam veterans, veterans of other wars, the families of those whose lives were lost in Vietnam, and the general public. At the end of the parade Vietnam veterans from among the spectators may fall in and march down Constitution Avenue toward the site of the Vietnam Veterans Memorial.

Vietnam Veterans Memorial Ceremonies

This morning Cooper Holt, Executive Director of the VFW, visited me to warn of potential problems at the mid-November ceremonies relating to the Vietnam Veterans Memorial. The principal event is scheduled to be a candlelight vigil (at the National Cathedral) starting on the evening of November 10 and running through November 12 with a parade scheduled on Saturday, November 13. After the parade it is hoped there will be a formal dedication of the memorial.

You will recall that the original design was strongly opposed by a number of veterans organization leaders and that a compromise was reached whereby the original design was to be augmented by a flagpole for the American flag and a "heroic statue".

In a compromise, largely arranged by Senator Warner and Rep Phil Crane, the Memorial Foundation, the national veterans groups, the opponents to the original design, Secretary Watt, the National Capital Planning Commission, and the Commission of Fine Arts, all agreed in principle to the addition of the flag and the statue.

Secretary Watt and the Memorial Foundation have submitted to the Fine Arts Commission and the National Capital Planning Commission the specifics regarding the flagpole and the statue. The veterans groups strongly support the design. The statue is excellent.

Pursuant to the compromise, Secretary Watt has informed the two commissions by letter that he will approve the formal dedication of the memorial on November 13 provided the two commissions approve the design. If the commissions do not approve the design, there will be no dedication. Jan Scruggs of the Memorial Foundation states that in that case he does not plan ceremonies at the site, even though the names of the war dead have now all been carved in the marble on the site.

Cooper Holt this morning advised me that he has strong indications that some of the smaller but radical veterans groups, such as Vietnam Veterans of America and Vietnam Veterans Against the War, may attempt to tear down the fence around the site and "dedicate" the site on November 13 anyway.

Holt strongly suggests that the White House contact Carter Brown of the Commission of Fine Arts to urge him to be sure the statue and flagpole design are approved at the meeting on October 13.

Holt says that the veterans organizations are prepared to give strong testimony in behalf of the compromise design but up to 75 architects are planning to give testimony to the Commission against the addition of the statue and the flag. Only strong urging from the White House can assure that the compromise design will be approved by the Commission of Fine Arts. He anticipates no problems from the National Capital Planning Commission.

It should be noted that the Commission of Fine Arts and the National Capital Planning Commission both approved, in principle, the addition of a statue and the flagpole before the ground breaking ceremony last March.

Jan Scruggs of the Memorial Foundation says the Vietnam Veterans Against the War have told have told him they intend to "respect the dignity" of the event and would be in the parade which will precede the scheduled "dedication". Cooper Holt has indications that radical elements would use a cancellation of the "dedication" as an excuse for a protest at the site on November 13. I suggest it would be appropriate for a senior staff member to privately contact Carter Brown on this topic. His telephone number is 566-1066.

Dear Jan:

Thank you for your submission of September 23 which outlines the design plans and specifications for the sculpture and the flag staff to be added to the Vietnam Veterans Memorial. These elements were agreed to in the compromise struck under the leadership of Senator John Warner.

Based upon the commitments made in March 1982 and our review of your submission, I enthusiastically approve your latest submission. The addition of a heroic sculpture and our flag to the site will transform the design into one which honors both those who served our country and those who made the ultimate sacrifice. We must not forget that our objective is to build a fitting monument to honor thousands of men and women who served their country in Vietnam. Design aesthetics are a secondary concern.

We have forwarded your submission and our approval to the National Capital Planning Commission and the Commission on Fine Arts for their review. Based on previous communications between my office and the Commissions, I have every reason to believe that your submission will receive timely approval from these entities. Be assured that I have committed the full weight of this Department to securing the necessary approvals for your latest submission.

I am also prepared to direct the National Park Service to issue the required permits for dedication of the memorial on November 11, 1982, if both Commissions approve the additions of the sculpture and the flag staff to the memorial at their scheduled October meetings.

Pursuant to the compromise struck last spring, it would be inappropriate to permit a dedication to proceed if either of these critical design elements were disapproved or located in such a fashion as not to have the wall, the flag, and the sculpture constitute a single memorial.

The men and women who served our country in Vietnam deserve a fitting memorial and I congratulate you on your organization's unstinting efforts to fulfill this worthy objective.

Vietnam Veterans Memorial

This morning I was invited over to look at the artist's model of the statue for the Vietnma Veterans Memorial.

Frederick Hart, the sculptor, has his studio in an office building on F Street. Attached is a <u>Horizon</u> magazine which includes an article on Page 28 about Hart. He has done important work at the National Cathedral.

I must say that the statue, a grouping of three Vietnam era soldiers, is outstanding. I think it highly unlikely, once the artist's conception is revealed to the public, there will be much difficulty in approving his rendering.

The group includes the first black soldier to be represented in any U. S. war memorial. It is a very clearcut, straightforward, and moving representation, without being pugnacious.

The model has been virtually completed but it has not been photographed. They did not want to invite premature criticism before it was ready to be unveiled.

Because the White House car I took over there had two drivers, I invited one of the sergeants, a Vietnam veteran, up with me to see the statue. He was as impressed as I and is quite enthusiastic. It looks like we have a winner here.

Last Saturday's <u>Washington</u> <u>Post</u> carried the story that Secretary Watt has referred to the Fine Arts Commission and the National Capitol Planning Commission the compromise plan for the design of the Vietnam Veterans Memorial.

This compromise was worked out through the leadership of Senator Warner and several other members of Congress. Supporters and opponents of the original design, after a very long session, agreed to certain changes. All present agreed to support these changes.

The newspaper story has been followed by some communications to Mrs. Dole and to me from veterans group leaders expressing fear that serious problems have developed. One telegram suggested that Secretary Watt has "raised another obstacle" to the construction of the memorial.

That is not the case. It was understood by all concerned that the approval of the compromise was subject to action of the Fine Arts Commission and the National Capitol Planning Commission. On receiving from the Vietnam Veterans Memorial Foundation last week the design reflecting the compromise, Secretary Watt promptly submitted the design to the two commissions which must approve it. The National Capitol Planning Commission is scheduled to meet on March 4 and the Fine Arts Commission on March 9. Secretary Watt sits on both commissions. He will urge both groups to approve speedily this compromise design.

I received a call from Jan Scruggs of the Foundation this morning. He expressed some embarassment that supporters of the memorial are "hard to control" on this issue. He assured me that the actions taken by the Secretary are "justifiable" and "don't show any bad faith." Mr. Scruggs said "We believe he (Secretary Watt) will make good faith efforts" to win approval of this design which is now endorsed by virtually everyone on all sides.

The ball is now in the court of the two commissions. I am sure they would appreciate receiving advice on this matter from veterans and service-related groups.
