SUBJECT: Regional Outreach Briefings on Central America

On Friday afternoon, December 2, I met with Otto Reich and others of his State Department colleagues regarding our planning for White House outreach briefings in selected major United States' cities. We left in agreement on the following points:

1. The State Department Public Affairs Office would arrange for co-sponsorship in each city. Co-sponsors would be groups such as the World Affairs Council, the Chamber of Commerce, Kiwanis, Rotary, etc. The idea is to find sponsors that would not be identified with either end of the political spectrum but towards the center.
2. The invitations would be from the White House and, depending upon the speakers, would read something like: "The White House Office of Public Liaison, the U.S. Department of State, the U.S. Department of Defense and the Agency for International Development, in cooperation with the Pittsburgh World Affairs Council and the Greater Pittsburgh Chamber of Commerce cordially invite you to attend a briefing on United States policy in Central America."
3. The list of invitees would be initially provided by the local sponsoring organization. The list would be submitted to the White House to make sure that the major opinion leaders in each locality are included. This would include the prominent educators, clergy, union leaders, business leaders, and local editors, publishers, and broadcasters. The idea here is for the invitation list to reach out beyond those normally invited to foreign policy briefings.

4. Target cities. We plan eventually to cover all twenty-four of the cities we have been discussing for some time, but we will start with one pair of cities. Either Philadelphia and Pittsburgh, or Cincinnati and St. Louis, depending upon the availability of appropriate sponsors.
5. Sponsors. For the first pair of cities, we will not shoot for "superstars" such as Secretary of State Shultz, or Secretary of Defense Weinberger, but will go for a reasonably balanced team of three sponsors, one each from the defense area, the diplomacy area and the development area.
6. Funding for the hall will be provided by the local sponsoring organization. Each agency will fund the travel expenses of its personnel. The invitations will be issued by the White House.
7. Scheduling. Otto Reich's office will coordinate this with the State Department Bureau of Public Affairs, in consultation with the White House Office of Public Liaison and other appropriate offices. It was agreed that we would not schedule any cities in the month immediately prior to each respective state's Presidential primary. The first pair of cities would be covered in mid-January, after which we would evaluate this pilot and make appropriate changes in procedures.

All in all, it was a very successful meeting. I expect that we will, by the end of next week, have obtained sponsors, sites, and speakers for the first two cities Outreach Briefing.


Dear Mr. Huber:



### GIVE CAPTURED SOVIET ARMS TO AFGHAN REBELS

Rep. WILLIAM BROOMFIELD (R-MI) has come up with the perfect Christmas present for YURI ANDROPOV: we should give all the Soviet arms captured in Grenada to Afghan rebels fighting the Soviet invasion forces. When American forces liberated Grenada (see Issue #320), I suggested we destroy


every captured Soviet weapon. But Broomfield's idea adds an ironic twist: use communist weapons against their maker. "The Afghan guerrillas are desperately short of arms and ammunition," Broomfield says. "These brave patriots are using ancient rifles and often have to fabricate their own weapons. Why don't we help these people and send them weapons that the Soviets and Cubans were planning to use against the free and democratic nations of the Caribbean?" Write President REAGAN (The White House, Washington, DC 20500) and suggest he implement Rep. Broomfield's idea.

### SENTINEL SUBSCRIBERS BACK STRONG ACTION IN CENTRAL AMERICA

Responding to our recent poll on Central America, 73% of AMERICAN SENTINEL subscribers "strongly approve" and 10% "approve" of President REAGAN's overall policies to stop the spread of communism into the hemisphere. Only 2% "disapprove" and another 2% "strongly disapprove," while 3% were "unsure." This finding concurs with national polls showing widespread support for the President's actions in Central America. Despite media attempts to portray Central America as "another Vietnam," mainstream Americans think their president is doing the right thing. The poll also indicated what specific actions SENTINEL subscribers think the United States should take:

- By a margin of 81% to 5%, with 18% unsure, they think President Reagan should order a naval blockade of Nicaragua to cut off the flow of Soviet/Cuban weapons and ammunition into Central America.
- If Soviet-backed Marxist forces were on the verge of winning a military victory in El Salvador, 82% of SENTINEL subscribers support the use of combat troops to prevent a communist takeover, while 7% oppose such action and 1% aren't sure.
- Eighty-nine percent of SENTINEL readers think the major network news shows are not providing them full, fair and unbiased reports on the crisis in Central America. Six percent think TV reporting has been fair, while 5% aren't sure.

I'm sending the results of this poll to the White House for their reaction.

Please find attached the copy of the refugee paper that I received from Bob Reilly. A copy of this was sent to FRW's office yesterday and they have acknowledged receipt.

This paper, along with all the other drafts I have received, have been entered onto my display writer disk so there should be no danger of finding ourselves without an available copy.

### CENTRAL AMERICA: THE REFUGEE CRISIS

America is not an ordinary country. Our love of freedom and generous appreciation of diverse cultural values, our dedication to an open exchange of ideas -- these things we share in many different forms with other democracies, but America's openness to immigrants and, in particular, to refugees has contributed significantly to the richness of our national life. Refugees hold a special place in our sense of who we are and what we stand for as a nation. Their contributions fill the pages of our history books; yet for every refugee who finds his way to safety and a new life with us, thousands of others know only bitterness or even death.



Since 1945 perhaps 20 million persons have emigrated, fled or been expelled from Communist controlled countries. . . Although 2½ million have settled in the U.S., less fortunate refugees have remained homeless for years. To the tortuous history of Vietnam, Cambodia and Laos, we add new names from our own hemisphere. Today it is Cuba and Nicaragua, tomorrow other countries in Central America may appear on the list as a new refugee crisis develops. The outcome depends upon our actions. The postwar record demonstrates that the coming to power of a Communist regime always inevitably creates a large scale exodus and frequently a continuing flow of refugees. The ultimate destination for many of these victims has been the United States.

#### FROM CENTRAL AMERICA

Today, the 25 million people of Central America and Panama face the same threat. Should Central America fall to Communism, experience indicates that a flood of sudden emigrants would pour out of the region. The best estimates indicate that at least 1.5 million and probably 2.5 million people would flee.1/

We can avert this tragedy by helping our neighbors resist the current Soviet-Cuban assault. As Ambassador H. Eugene Douglas, the U.S. Coordinator for Refugee Affairs, has said:

"If we truly care about the people of Central America, then we must not allow them to be forced onto the refugee trail... Democracy allows many options: the option to vote for or against the government; the option to stay or to leave. Communism offers only one option -- to flee. But if the free world allows any country to be forced so far along the Communist path that millions of its people feel they have no choice but to flee, then we have already failed. No provisions, no matter how compassionate, that may be made for the refugees, can make up for that failure."2/

WHY SO MANY ?

All estimates of future refugee flows are subject to debate. Experts disagree even on the numbers of existing refugees. Refugees, after all, flee out of chaos, many secretly, many fearing for their lives, to strange countries where they encounter overwhelmed bureaucracies and confusing linguistic and cultural barriers. And the Communist countries from which refugees flee are often unwilling to give reliable estimates of the number of refugees who have fled. Finally, many die during flight.

But experience does give us some guide to what to expect should Central America fall.

Since 1959, 1,250,000 Cubans, more than 12 percent of the island's population, have fled Cuba's Communist regime. Nearly 85 percent have come to the United States. That high percentage is partly due to Cuba's proximity to this country. Because the United States is prosperous and free it is the most popular destination for those fleeing Communism, so the exodus from Communist governments can be expected to be higher when those governments are nearby.

Because Central America is not much farther and, unlike Cuba, is connected to the United States by land, we could expect a similar percentage of Central Americans to leave their homelands. With 25 million people living in the region, a 10 percent exodus -- slightly less than that out of Cuba -- would yield 2.5 million people. A rock bottom estimate of five percent would yield 1.25 million. These numbers do not include the Caribbean island nations, which may also be vulnerable.



### OUT OF NICARAGUA

Events in Nicaragua, now run by a Communist clique, suggest that the five to 10 percent range is a good guess. By most estimates, up to 100,000 people, 3.4 percent of that country's population, have fled since the beginning of the fighting that concluded with the Sandinista takeover. An estimated 60,000 of those Nicaraguans have come to the United States.3/

Yet the revolution is only four years old. The Nicaraguan Communists have not yet fully consolidated their power. If 3.4 percent of the population has already fled, it seems clear that the Nicaraguan exodus will exceed five percent and likely that it will approach or surpass 10 percent.

Edgard Macias, who was once the Vice Minister of Labor for the Sandinista regime in Nicaragua, but who resigned and fled the country when the Sandinistas revealed their totalitarian intentions, has commented on this mass emigration:

"The FSLN [the Sandinista regime] with its totalitarian oppression and communist model has produced in only four years more expatriated persons (refugees, exiles, and emigrants etc.) than the Somoza regime did in 45 years [though the Somoza regime was] a terrible regime that must never return to power in Nicaragua."4/

### THE REAL VICTIMS

The prime victims of a mass exodus from Central America would be the refugees. They would lose their homes, their livelihoods, their native languages and cultures, their friends, perhaps their families. Journeying in poor conditions, many would lose their health, some their lives.

But for all the suffering of the refugees, the potential social and economic impact on this country of such a sudden migration cannot be safely ignored. If the Cuban experience is any guide at least 80 percent of sudden emigrants from Central America would come to this country.



### COUNTING THE COSTS

In financial terms alone, the strain would be significant. The average refugee costs the federal government more than \$10,000 over his first three years in this country. Federal assistance alone could cost this country more than \$20 billion within a few years should there be a mass migration from Central America. Billions more would be spent in succeeding years, all at a time when the federal deficit is approaching \$200 billion. State and local costs would also be high.

The people who do not emigrate but are left behind in the new Communist state also would suffer severely from the emigration. Not only do Communist countries inevitably subject their people to great economic hardship, the loss through emigration of many of the country's most able people and much of its entrepreneurial class causes additional hardship. Even if the Communist threat is turned back many of those who leave for fear of the Communists will never return.

### THE MARIEL EXPERIENCE

The 125,000 Cubans and the few thousand Haitians who arrived in this country during the great 1980 exodus total barely five percent of the numbers anticipated in the event Central America should fall to Communism.

Yet, federal reimbursements to Florida alone (Florida was the hardest-hit state, though many other states received refugees) for recent sudden immigrants totaled nearly half a billion dollars for fiscal years 1980 through 1983.<sup>5</sup> That doesn't include federal administrative costs, which are considerable.

Nor does that figure include other local expenses such as large sums for special and bilingual education programs,

criminal enforcement and detention, costs for special medical problems, etc.

Finally, our churches and charitable institutions, as well as tens of thousands of private citizens have spent hundreds of millions of dollars of their own funds to help these people.

Eventually, states and localities receive offsetting benefits from an influx of able, patriotic refugees, even as Miami received new life from the Cuban exodus that started in the '60s. Given time, refugees become taxpayers. For the U.S., the problems come not from the people themselves but from the manner of their arrival -- suddenly, in great numbers, and frequently destitute.

Any mass migration brings chaos, and that chaos brings costs -- costs that are expressed not only in dollars and cents but in significant strains on the social fabric. Even in Miami, which has been accustomed to heavy immigration for more than 20 years, the sudden immigration from the 1980 exodus has certainly, and unfortunately, contributed to social tensions in that city.

Should Central America fall to the Communists, Florida, still reeling from the Cuban-Haitian exodus, would not be able to absorb 2.5 million new sudden immigrants, nor could the other states along our southern border. The immigrants would have to be distributed throughout the country, as would the temporary financial and social burden.

#### THE LADY'S PLEDGE

Of course, the benefits of immigration are more difficult to measure, and over the long run they must be immeasurably greater.

The Statue of Liberty symbolizes not only hope for the homeless who come here, but also the contributions they make to building America. Every wave of immigrants has brought great gifts to this country. We have reaped enormous dividends from keeping out the welcome mat -- not only economic and cultural dividends, but dividends in patriotism, for it must be admitted that adopted Americans frequently are the best Americans of all.

And Caribbean area immigrants, if most of those who have already come from Castro's Cuba serve as an example, would do particular credit to this country.

But we must distinguish between steady, if strong, streams of immigration, such as those that carried our ancestors to America, and the tragic mass migrations caused by Communist oppression. Such migrations, which inevitably include many who would never have dreamed of leaving their homelands but for the Communists, are intolerably cruel to those who are forced to flee, and dangerously straining to this country.

The American people have always welcomed refugees from Communism. But we can make that refugee stream unnecessary. We can give our Central American neighbors the military aid and training and, even more important, the economic assistance they need to turn back the Communist challenge. There is no excuse for not doing our duty.

The Economic and Strategic Importance of the Caribbean Sea Lanes: Draft went to Constantine to start the informal clearance process 1-20-84.

Soviet Objectives in Central and South America: Edited and sent to Morton Blackwell 12-30. Sent by FRW to Constantine 1-13.

Persecution of Miskito Indians: Sent to Morton Blackwell 1-18-84.

Violation of Human Rights in Nicaragua: Sent to Morton Blackwell 1-20-84.

Nicaraguan Repression of Labor Unions: Draft arrived from Jim Taylor's office at Labor 1-10-83. I sent this to Otto Reich's office Monday to get input from State's Human Rights and Labor Affairs bureaus.

1985 Elections in Nicaragua: I have a short analysis from State. Jackie Tillman offered to draft this and should have it next week.

Nicaraguan Disinformation: With Reich's office. No due date. Reich office is getting information from the Embassies, examples of Nicaraguan disinformation, to work into a draft. I made arrangements with John Scofe, in Otto Reich's office, to send me the compiled information at the same time he sends it to U.S.I.A.

Cuban Involvement in Drug Trafficking: Due out of S/LPD on 12/20. The staffer working on it (Jim Welch) is still out sick. Due date consequently postponed. In the meantime, I have asked Judy Bertini in the Drug Enforcement Administration to draft a paper, which she should have ready in two weeks.

What Central Americans are Saying About Central America: Peter Romero is working on this; January 20th was the tentative due date, but I spoke to him today and he has not started it yet.

Development of Democracy in Central America: with Reich's office and also with Mike Skol. Drafts due Jan 7th but will not be in until the end of the month.

Sandinista Interference in Private Lives: Spoke to Fairbanks on 12/23 and he told me he was dissatisfied with the draft he received so he went back for another. He and Elliot Abrams just returned from Nicaragua and I now expect a draft the beginning of February.

August/Sept/Oct in Nicaragua: In progress. No due date yet.

High Life Style of Nicaragua's Sandinistas: The Agency was assigned to draft that. Romero is planning to get additional input from the Embassy in Nicaragua after he sees the CIA draft. The CIA draft still has not arrived.

SUBJECT: STATUS OF WHITE HOUSE DIGESTS

I spoke with Peter Romero today and received the following information concerning these projects:

1. Strategic and Economic Importance of the Caribbean Sea Lanes: The Eco/Bus office at State sent over a draft, with DOD input. I will give my comments on it to Morton tomorrow morning.
2. 1985 Elections in Nicaragua: State sent a two-page analysis of the electoral process as it has begun to develop so far. Romero suggests combining this with the paper on Violation on Human Rights, since there may not be enough info to merit a separate project.
3. Persecution of the Miskito Indians: Romero asked the desk office about it again on Friday and hopes to have a draft from them this week.
4. High Life Style of Nicaragua's Sandinistas: The Office of Public Diplomacy is working on it and he hopes to have a draft next Monday.
5. What Central Americans are Saying About Central America: He has translated articles and quotations from Central American newspapers and from Carlos Rangel, who writes out of Venezuela. We need an analysis tying these quotes together, since we do not simply reprint articles from other sources.
