Fellow Statehood Supporters:

Permit me to share with you briefly my observations, with the latest development in the Philippines. My three weeks recent visit to the Philippines where spent partly on these places; Visayas, Luzon and Metro Manila. During those weeks I interviewed all sorts of people, analyze the news, attend radio and press conferences, guests to civic and social affairs, meetings with the leaders of the Statehood Movement, meeting with high official of the U.S. embassy in Manila. Also I had the pleasure of meeting Jaime Cardinal Sin at his residence at the Bishop's palace in Mandaluyong, the Cardinal has signify to be our guest speaker next year's Statehood Convention.

During our convention in Phoenix on Sunday August 31, I will be discussing in details Philippine Statehood. Some of the events that will shape our statehood agenda are the following:

- 1. The constitutional commission adopted in July 15 a people power provision, which allow a people petition representing 10% of the total voters in the Philippines to propose a legislation.
- 2. The Aquino government wrote Statehood stating that they will consider plebiscite or referendum on Statehood during election at the proper time ( I have copy of the letter)
- 3. I received massive support from the Association of Barangay Council of the City of Manila the largest in the country. The Council says that they can provide one(1) million people in two weeks notice to rally in support of Statehood.( I have copyof the letter)
- 4. The intellectuals and the professionals are moving into the leadership of the Statehood Movement in the Philippines.
- 5. There is growing anti-U.S. Bases sentiment and nationalist group in Manila. The U.S. is concerned of this development.
- 6. I meet with the U.S. embassy official, my feeling is that Stathood could be funded if properly programmed acceptable to Washington.
- 7. The Filipinos are saying, it will take more than 10 years to reverse the economic trend, if the present conditions persists, the people can not last even for a few years.
- 8. There is absence of economic activity and investment from abroad. What is needed quickly is solution to the people's unemployment and deep poverty in the Philippines.

Dear Mr. Regan:

I appreciate your taking action on my letter of September 8th anent the alarming signs in the Philippines. Director Charles B. Salmon, Jr., of the State Department's Philippine Desk, at your behest has written to me to convey the official stand of our Government toward the regime in Manila: "The government of the Philippines, under the leadership of President Aquino, enjoys the unequivocal support of the U.S. government. We fully support her strategy for dealing with the communist insurgency .... We have no evidence that any members of the Cabinet are communists."

Some people like to think that the Establishment knows best. I hope to God, for the sake of America, that the Administration is correct in its perceptions and that subsequent events will prove me wrong.

Sir, I can not help but feel concerned when U.S. media correspondents dish out almost daily in the newspapers reports to the contrary of what the State Department believes in. I trust that America's envoys in Manila have not buried their heads in the sand along Manila Bay's shore, ostrich-like and oblivious to events as they really are.

Let us look at the record. Shortly after assumption of the presidency, Mrs. Aquino released Communist Party and New Peoples Army top leaders Jose Maria Sison and Bernabe Buscayno alias Commander Dante. Several weeks after they regained their freedom, these two insurgents make trips abroad to shop for arms for the NPA!

Over the objections of her Defense Minister and Army Chief of Staff, she relentlessly pursues "peaceful reconciliation" with the communist insurgents even as hundreds of soldiers continue to be slaughtered in the countryside.

Over the objections and the warnings of business and industry leaders, U.S. investors and executives in the Philippines included, Mrs. Aquino unwittingly has contributed to labor unrest by making it easier for unions to strike and by pursuing pro-labor and anti-management policies drafted by a Minister of Labor and Employment whose patently communistic views have been denounced far and wide throughout the Philippine archipelago. News reports are to the effect that there have been over 500 walkouts and strikes since March 1. I challenge the State Department to explain why this is so.

If Mrs. Aquino is on America's side, how come her handpicked Constitutional Commission enacted a draft Constitution with a provision clearly directed against U.S. bases: the one calling for freedom from nuclear weapons on Philippine territory "consistent with the national interest." It does not take to be a bright Director to digest the painful reality that if that provision is fully implemented, American naval vessels would be barred from entering America's biggest military base abroad, the sheltered deep-water Subic Bay Naval Base, thus jeopardizing -- if not neutralizing -- the U.S. strategic advantage in the Western Pacific and Indian Ocean.

But that is just the edge of the woods. Mrs. Aquino's new Constitution would treat the Military Bases Agreement as a treaty to be entered into between the United States and the Philippines, subject to ratification by the Philippine Senate and a plebiscite by the whole country. This will be the excuse for the nationalists -- and their leftist allies -- who are opposed to American bases to stir up anti-American feelings and endless acrimonious debates on the U.S. presence.

Sir, can the State Department tell us how it is possible for the Communist Party to have established a "parallel government" in the Philippines? One does not have to look far for evidence that there are communists in the Aquino Cabinet. The Cabinet Ministers who are advising her to make conciliation with the insurgents the theme of her administration are suspect. Because of her insistence for the peace talks, the insurgents have been given a breather: a time to strengthen their political base and stock up on their arsenal of weapons.

I can seen why Defense Minister Juan Ponce Enrile and Army chief General Fidel Ramos are against the ceasefire and the negotiations with the rebels: President Reagan and yourself will agree with Minister Enrile's observation that "Negotiations entered into by Marxists are not negotiations for peace but negotiations for war." Given the track record of communists the world over, the Philippine communists are negotiating as part of a grand strategy to take over the Aquino government and the entire country. It does not take a fool to see that the Philippine insurgents are using the negotiating process to consolidate their armed strength and increase -- nay, maximize -their use of political front organizations.

Our newspapers and TV stations are again predicting that the Aquino government will fall due to her policy of accommodating the rebels. Let's see the State Department prevent Minister Enrile, allied with other despised political groups, from ousting President Aquino.

Does "unequivocal support of the U.S. government" for the leadership of Mrs. Aquino include the sending of U.S. Marines to the Philippines? And at what cost in American lives will this entail?

The people at the State Department may be blind, but I like to think that President Reagan and his Chief of Staff at the White House are not blind fools.

I have been asked to reply to your September 8, letter to White House Chief of Staff Donald Regan. You wrote to express your concern over Philippine President Aquino's strategy for dealing with the Philippine communist insurgency and over allegations that certain members of the Philippine government are communists.

The government of the Philippines, under the leadership of President Aquino, enjoys the unequivocal support of the U.S. government. We fully support her strategy for dealing with the communist insurgency -- a strategy that combines economic and political reform and measures to strengthen the effectiveness of the military with political dialogue. We have no evidence that any members of the Cabinet are communists.

I am enclosing for your information, President Reagan's recent public statement on the Philippines released during the visit of President Aquino. I hope the statement will be useful in clarifying U.S. policy toward the Philippines.

REMARKS OF THE PRESIDENT AND PRESIDENT CORAZON AQUINO OF THE PHILIPPINES AT DEPARTURE CEREMONY

The South Lawn

#### LIJS P.H. BOT

THE PRESIDENT: "It was truly a pleasure to welcome and meet today with Philippine President Corazon Aquino. Her courage and her commitment to democracy, mirroring those same qualities in the Filipino people, have inspired the world and it's been an honor to have her as our quest.

President Aquino and I discussed her strenuous efforts to bolster the democratic institutions of her country and to insure its becurity and strengthen its economy. And I assured her that all America wants the Philippine democracy to succeed and to prosper and that we'll do what we can to help.

These have been trying times in the Philippines. President Aquino has been overseeing an historic transition. In the Coming months a new constitution will be submitted which will pave the way for strong, democratically elected local and national governments. In the meantime, President Aquino has been doing her level best to unite her richly diverse people under a banner of freedom and opportunity.

Her efforts to reconcile all elements of her society and bring them into the democratic process are applauded here. I might add that her personal bravery in this heroic endeavor to diffuse conflict has won the hearts and imagination of the people everywhere.

Despite President Aquino's efforts, however, well-armed Communist guerrillas remain a threat to democracy in the Philippines. President Aquino and I discussed her strategy to meet this challenge. It includes attacking the root political economic and social problems that feed insurgencies. The second half of the formula is building the Philippine military into a professional, properly armed and trained force that is capable of dealing with any threat.

The United States stands ready to assist President Aquino in her guest to create a stable and secure land, as well as in her Semmitment to invigorate the Philippine economy.

During our discussion today, President Aquino reaffirmed her belief that free enterprise is the surest path to development, the surest method of opening the door of opportunity and advancement to all her people. Her government stands for free trade and is encouraging private investment. She knows in the long-run nothing would better serve the filipino people than unleashing the entrepreneurial spirit and putting the creative and economy building power of the marketplace to work.

As one might surmise after hearing this, I'm bullish on the Philippines. I would hope American as well as foreign investors take motice of this incredible opportunity to help build a country. For our part, we will hold our -- mold our efforts to encourage development in the Philippines. Today, for example, we discussed the idea of increasing Philippine exports to the United States, including improved treatment under our generalised system of preferences. We also considered ways in which the Philippines can provide a larger share of the goods and services consumed by the U.S. Military facilities within that country.

And just a side note. When talking about those bases, Our two countries share common interests in the peace and stability of the Pacific region. I'm confident that we will continue to enjoy a strong mutual defense relationship for the foreseeable future.

President Aquino reaffirmed today that the military base -agreement will be respected through its current term. I understand -and an confortable with her position. The next review of our defens telations is scheduled in 1988, and that gives us and the people of the Philippines plenty of time to think about it.

In the meantime, I will continue to ask Congress for oppropriate levels of economic and military assistance above and beyond existing 0.8. base-related commitments.

The latest installment of our current aid effort -- a \$100 million grant of econonic support funds, which I am pleased to announce will be signed by our respective Cabinet members in a few moments -- a \$50 million grant of military assistance, along with a \$20 million package of medical supplies and services, has been approved.

In the future, to the largest extent possible, future U.S. aid will be designed to provide the greatest benefit without exacerbating the country's debt burden.

And one last thought. Today governments, businesses, financial institutions and individuals are dealing with a new kind government in the Philippines. We are dealing with a noble and bonest people -- people with ideals, people we can trust, and we place a high value on character and hope everyone appreciates this and takes it into account.

A great Filipino hero, Dr. Jose Rizal, once wrote, "G is justice: he cannot abandon his cause -- the cause of liberty without which no justice is possible." Well, Jose Rizal, like President Aquino's husband, died for freedom and inspired his nat

President Aquino and I reaffirmed the commitment of c two peoples to the ideals which so many Americans and Filipinos F given their lives, and we also reaffirm the bonds of friendship a affection between the United States and the Philippines.

It was truly an honor to have her here.

Thank you and God bless you. (Applause.)

**PRESIDENT AQUINO:** Thank you, President Reagan. Thi been an opportunity to get to know each other, to explore commor issues together. Above all, though, I can say that for my part most important aspect has been the chance to meet each other.

We are both politicians who set great store on face-to-face encounters. Government-to-government contacts hav their proper place, yet when the leadership of a country change such a dramatic fashion,

as happened in the Philippines, it is only right that the Presidents of two such close allies meet and get to know each other. Issues do not generate of their own accord the decisions that will resolve them. In the end, decisions will be made by the people who have the gesponsibility to make them.

From this meeting today, both our governments will go ou with a clear sense of priorities, with a recognition that we must both work hard to strengthen the bonds between us. I hope we have set the tone and direction for a new relationship. By recovering our democracy, we Filipinos have recovered our self-confidence and prime and hence our ability to deal with our major ally on an equal families. This is the only basis for a relationship between friends. And I think we were able to start on that agenda today. I was able to explain to President Reagan the problems we have inherited, all of them repted in a devastated economy. I was also able to outline to his what we are doing to set things right. I am gratified that President Reagan understands and supports what we are trying to do.

As you know, we have placed our faith in the private sector as the stimulus of growth. I also briefed the President on the wide range of reforms we have embarked on to resolve our difficulties. A new constitution is in the final stages of drafting. There will be a referendum on it followed by elections early next year.

We are carrying out a long overdue program of military reform. Within this context of an economic reconstruction, political rebuilding and military reform, we can combat our remaining problem -- the insurgency. As you know, we are pursuing a political approach, but this is backed by the military option. In all these areas of rebuilding, I hope we can count on American support and understanding.

But most important, reform is being done in a new environment of freedom, human rights, and democracy. So, as today's discussions showed, we have a lot of values in common again. We embige freedom and hard work in just the way you do. For two emuntries who have a faith in God, in freedom, in the family, and in democratic values, we should allow nothing to come in the way of an everyrowing friendship.

Today was a good beginning and I thank you all for it.

Dear Mr. Regan:

I am an old retired serviceman who saw action in the Philippines during World War II. I have taken the liberty of writing to you because I am not happy with recent U.S. policy decisions affecting the Philippines and I am afraid that the leader we hand-picked to replace President Ferdinand Marcos, Mrs. Corazon C. Aquino, is naively being manipulated by leftists in her Cabinet and the government bureaucracy.

It is too late to cry over spilt milk and it was regrettable that U.S. support was decoupled from the Philippine Government and thrown to a rabble-rousing revolutionary movement fueled by an opportunistic alliance between left-radical and reactionary elements in our former colony. Now, an August 31 dispatch from The New York Times news service reports that "Reagan Administration officials are increasingly concerned by what they see as a lack of effectiveness by Philippines President Corazon Aquino in handling insurgencies by Communists and other groups." Well, what can you expect from a plain housewife without any political experience whatsoever.

The pro-communist color of the Aquino Government should be very evident to the Administration in Washington by now. Mrs. Aquino has made conciliation with rebel groups the main theme of her presidency. Anybody who knows the communists knows that they will not honor their plighted word, so it is useless to talk to them. Yet, she sticks to her conciliatory approach.

President Aquino has been yielding to the demands of the Communist Party of the Philippines and its military arm, the New Peoples' Army. Her first official act after we helped install her as President was to release all the captured communist and NPA leaders who had been jailed by Marcos. She did this over the vehement objections of her Defense Minister and Army Chief. This action has emboldened the insurgents and strengthened their ranks: they have seized additional territory, they have been killing soldiers who are under military orders to exercise maximum tolerance, they're grabbing and capturing arms and munitions from the Philippine armed forces.

What is more despicable is the fact that President Aquino has appointed known communists to her Cabinet and in high decision-making levels of the bureaucracy. She has replaced career officers with card-carrying Communist Party members and left-leaning radicals. This is confirmed by wire reports. The Honorable Donald Regan

Aquino Government key officials favor the early removal of the U.S. bases, at Subic Bay and Clark Field. I do not have to remind you that the Philippines is the most strategically situated nation in that part of the globe and forms an integral part of our defense network. It straddles vital air and sea "chokepoints" -- narrow passages connecting the Pacific Ocean, the South China Sea, the Straits of Formosa and the Indian Ocean.

Considering the ominous military presence of the Soviets at Cam Ranh Bay and Danang in Vietnam, which have made the China Sea a veritable "Russian pond," there is geostrategic necessity that the Philippines remain friendly to the U.S. and that the American bases there be held safe and available for the deployment of American forces to maintain the "balance of forces."

If we allow the Philippines to continue its inexorable slide into communist hands, I am terrified at the prospect of another Vietnam-that will draw-us into war again. That is why it is necessary to eliminate by military action the communist insurgents in the Philippines while there is still time. Already Communist Party and NPA leaders are boasting that they now have the capability to overrun Subic Bay Naval Base and Clark Air Force Base.

No less than the Philippine Armed Forces Chief of Staff, General Ramos, warned the U.S.-Philippines Mutual Defense Board recently that there is "real danger that the Philippines will turn into another Vietnam."

I read that some of your own people and Minister Enrile himself have expressed concern over on-going peace talks with the rebels and the belief that the Communists are infiltrating and subverting the Philippine Government. The Defense Ministry in an assessment published recently by the <u>San Francisco</u> <u>Examiner</u> accused the National Democratic Front, the grouping of political organizations dominated by the Communist Party, of delaying the talks while strengthening their forces to seize power. In the interim, they have consolidated their political base and bolstered their bargaining position. <u>The</u> <u>New York Times</u> reports that some aides of President Reagan, "unlike the Aquino Government, (are) convinced that many of the insurgents do not wish to end their rebellion."

Nobody can be more naive than our hand-picked President Aquino. And it is going to be the same President Aquino who will deliver the Philippines -and our military installations in the Philippines -- to the communist forces.

We do not have to return Marcos to power to rectify our error. It is important that the Administration must do something immediately to stop the continuing slide of the Philippines into communism and the inevitable loss of our bases. The Aquino Government has shown by word and by deed that it is not in sympathy with our business interests and security needs. We are slowly losing one of our biggest trading partners in the Orient and soon, also lose an important link in our global security network. The U.S. Government, especially the Republican leadership, must act decisively now!

Dear Mr. Andit:

I have been asked to respond to your October 16 letter to President Reagan requesting funds to repair a building damaged in the 1984 typhcon, "Nitang."

As you may know, the U.S. Agency for International Development (USAID) assisted the Filipino people in 1984 and again in July 1986 when devastating typhoons hit parts of the Philippines. U.S. assistance was provided in direct response to requests made by the Philippine Government to help alleviate problems arising from damage caused by the typhoons. Following the 1984 typhoons we provided food, medicines, blankets, and other necessities to meet the immediate critical needs of those affected. U.S. disaster assistance contributions exceeded \$4.2 million and was coordinated directly between our two governments. Such assistance is normally provided within the first 90 days after a disaster; however, because of the extent of the damage, we continued the assistance well into 1985.

We are no longer providing assistance resulting from damage caused by the 1984 or the 1986 typhoons. Even when our disaster assistance programs were under way, we were only able to provide assistance if specifically requested by the Philippines Government.

I regret that we cannot be more responsive to your prequest. I hope you will be successful in finding funds to make the repairs you wish to undertake in Kabataang Barangay.

This memorandum presents for your approval a proposal for a meeting between President Aquino and the Economic Policy Council during her upcoming visit to Washington, September 16-19. The two principal purposes of the Aquino visit are to provide an opportunity for personal exchanges between the Presidents and for discussion of economic issues. Such a meeting with the EPC, preceded by an informal breakfast with the President, will provide an excellent opportunity for Presidential rapport, and the EPC may prove an efficient use of Cabinet time as well as a beneficial educational experience for both Aquino and the economic policy agencies.

Preparations for the Aquino visit are underway. A major element of the proposed Philippine agenda will be economic issues and a desire on President Aquino's part to engender greater U.S. investor confidence in the Philippine economy. As for all such visits by heads of State, arrangements must be made for meetings between Mrs. Aquino and Cabinet members representing the major economic agencies.

For this visit, it may be desirable to consolidate these purposes in a special session of the Economic Policy Council, with the President as Chairman, to meet directly with Mrs. Aquino to discuss the economic issues of primary importance to the Philippines.

There would be several advantages to holding such a meeting:

-- It would be a high profile event highlighting U.S. interest in the concerns of a less developed country.

-- It would be a practical "one-stop shopping" approach for Aquino to present the Philippine economic story to the U.S. government. Of course she may well schedule separate stops at Treasury or State, but she ought to obtain from the meeting of all economic ministers a better understanding of the interrelationship between economic issues, e.g., debt and investment, AID and trade.

-- It may be a useful educational experience for Aquino to see firsthand the varied economic and political pressures under which the President operates, and for members of the Economic Policy Council to see firsthand the problems faced by a developing country and the effect of various U.S. policy decisions (Farm Act, 301 cases, etc.) upon a struggling democracy.

Although there have been meetings between the Cabinet and other heads of state (i.e., Nakasone this spring), this would be the first time the Economic Policy Council would be used in this role. While it would not be desirable to establish a precedent that the EPC meet with every head of state, scheduling a meeting between an important visitor and the <u>de facto</u> controlling economic policy body in the U.S. Government, in the President's presence, may be a useful means of communicating U.S. policy objectives and forcing policy coherence.

The breakfast portion would be an extra occasion to emphasize the special U.S.-Philippines relationship and provide additional time for our President to make clear the U.S. commitment. We would envision a 30-45 minute breakfast at 8:30 a.m. on Thursday, September 18 or Friday, September 19, followed immediately by a 45 minute EPC.

In addition, on a purely bureaucratic level, the initiative to hold an EPC meeting with Aquino would come from the NSC, represents an excellent opportunity for full NSC-EPC coordination on an international economic issue, and may assist in the strengthening of the NSC-EPC relationship.

## **RECOMMENDATIONS:**

That you approve the concept of a special session of the EPC, with the President as Chairman, to meet with Mrs. Aquino during her visit to Washington.

## Talking Points

- -- We are preparing over here for Mrs. Aquino's visit to the United States in September.
- The major objectives of Mrs. Aquino's trip will be to provide an opportunity for her to develop a personal relationship with the President and to have a discussion of economic issues.
  - In order to fully coordinate the U.S. Government's response to her economic presentation, I would like to recommend that as part of her White House visit we schedule a special session of the Economic Policy Council, with the President in his role as Chairman, to meet with President Aquino. I would see this EPC meeting being preceded by an informal breakfast with the President and representatives from the U.S. and Philippines.
- -- I think an EPC session could be a useful high profile meeting demonstrating our concern for the Philippines and be a sort of one stop shopping experience for Aquino, rather than having a series of meetings all over town.
- It may be a useful educational experience for her, and also for the EPC members themselves.

We wouldn't have these special EPC meetings routinely for visits of heads of state; but for important visits, I think it might be worth trying. I'd like some of our Cabinet officers to hear firsthand the effect of errant policy (Farm Act, §301 cases) upon struggling Third World democracies.
