

I have been deeply honored by being called to serve your Administration as United States Attorney for nearly five years and then to be your nominee for United States District Judge for the Southern District of Alabama. Since 1981, Mr. Sessions has served as United States Attorney for the Southern District of Alabama. Prior to his appointment as United States Attorney, he was an associate and partner in the law firm of Stockman and Bedsole, 1977-1981; an Assistant United States Attorney for the Southern District of Alabama, 1975-1977; and an associate with the law firm of Guin, Bouldin and Porch, 1973-1975.
