Dear Mr. President:

After many discussions here on the Hill, it is my conclusion that the members of the Senate are extremely shocked and disturbed at the attempt on the life of President Reagan. It is a sad thing and we need to hold some hearings on how we can possibly make it safer for the President and the Vice President.


Since your safety and leadership are so valuable to us, I would make the following three recommendations:

- 1) That the President and Vice President limit their appearances before groups in public hotels and other places where security is a problem. It is my recommendation that such groups be addressed over closed circuit TV as much as possible. Also, if they could hold some of these meetings on the White House grounds or in smaller groups, it would be safer.
- 2) That the President and Vice President hold as many functions outside of Washington on Military Bases or in secure areas. This limits access to the public somewhat but we simply cannot have our President and Vice President so vulnerable.
- 3) That the President and Vice President should wear flak jackets when they appear in public. I know these jackets are bulky and detract slightly from an individual's appearance but it is essential that we take all steps to protect our President and Vice President.

In addition, we need to once again evaluate the issues of Saturday night specials, of the Secret Service performance and of the general causes in our society that lead people to commit such acts. Also, the leniency of punishment of crimes perpetrated with armed weapons needs to be reviewed at the Federal and State levels.

In short, as a United States Senator, I thought it appropriate for me to pass along my suggestions. I am very discouraged, since during my lifetime, four Presidents have been shot at at close range and one has been killed and one has been injured. We just cannot let this go on. I am sorry that we have this situation. We in the Congress must do everything we can to alleviate it. Meanwhile, I would recommend that the President and Vice President take at least the above steps to lessen the possibility of being shot at.

# The Way Washington *Really* Works

The sad fact is that it doesn't. And it won't until we have a government that can control our unresponsive bureaucracy

**T**HERE IS a permanent government in Washington whose power does not depend on election results. It includes the courts and military, as well as two unofficial but powerful branches, the press and special-interest lobbyists. But the largest part of the permanent government is the bureaucracy. With over 2.8 million federal civilian employees, it's no wonder that the bureaucracy's power is increasingly dominant in our lives.

Some bureaucrats do essential work: air-traffic controllers, Forest Service firefighters, nurses at Veterans Administration hospitals. But there are many others whose contribution to the public interest is less clear: employees with such titles as

Schemes Routing Specialist, Employee Suggestion and Incentive Awards Administrator or Confidential Assistant to the Confidential Assistant—all real titles.

I first encountered the federal bureaucracy when I moved to Washington in 1961. There I was exposed to a Civil Service system characterized by too much defensiveness, too little courage.

Of course, in many clerical jobs openness or courage is irrelevant. But as people climb the administrative ladder, they seek to avoid anything that could disturb their steady career progress. The result: Over the years, the bureaucracy has become lethargic and self-protective.

Consider the joke of performance evaluations within the bureaucracy. Early in the Carter Administration, Barbara Blum, deputy administrator of the Environmental Protection

Agency, tried to institute performance evaluations in that agency. Back came the supervisors' reports: 97 percent satisfactory. Actually, Blum's supervisors were a bit more candid than most. Throughout the 1970s, 99 percent of all eligible federal employees got annual merit salary increases.

Because performance is not measured in realistic terms, the civil servant knows the only way he can lose his job is through a budget cut that affects his program. So as any new agency ages, more and more of its manpower and energy are devoted to obtaining funds.

In its annual struggle to protect or enlarge its budget, a government agency has a decisive advantage over its natural enemy, the Office of Management and Budget (OMB), which appraises budget requests. The OMB might assign half-a-dozen employees to size up a Cabinet-level department's budget, but the department will have up to 500 budget people whose job is to keep the OMB from finding out the truth.

One ploy often works even when the OMB spots it. Faced with a budget cut, the bureaucrat cuts funds where it will hurt a Congressman's constituents the most, not the least. In 1975, threatened with such a budget cut, Amtrak considered eliminating routes from Norfolk, Va., to Chicago—which just happened to run through the home states of Birch Bayh, then chairman of the Senate Appropriations Transportation Subcommittee; Vance Hartke, chairman of the Senate

Commerce Committee's Subcommittee on Surface Transportation; Harley Staggers, chairman of the House Commerce Committee; and Robert Byrd, Senate Majority Whip. Senator Byrd promptly said he would "introduce an amendment providing sufficient funds or try to get language adopted that would guarantee funding for the route."

Simply put, the bureaucrat just doesn't want any reduction in programs or personnel. Indeed, he hopes to expand—rank is determined in part by the number of employees one supervises. Four popular expansion techniques help explain bureaucracy's uncontrollable growth:

1. *Inflated payrolls.* Besides their automatic "merit" increases, federal employees receive annual raises to maintain "comparability" with private industry. But the comparison places much too heavy emphasis on higher-paying jobs in big corporations, rather than on positions in small business. The result: Except for the very top jobs, federal civil servants generally make more than their counterparts in business.

2. *Inflated slots.* Suppose the country were being overrun by Albanian moths. The Department of Agriculture would ask the OMB and Office of Personnel Management (OPM), formerly called the Civil Service Commission, for authority to establish positions for, say, 200 Albanian-moth-control officers. Then suppose the moths were brought under control. Would the slots be abolished? Certainly not.

3. *Inflated grades.* In 1977, the Civil Service Commission—not one of the bureaucracy's most severe critics—found 154,000 workers whose salaries and ranks were higher than their required level of work. The commission estimated these workers were being overpaid a total of about \$780 million each year.

4. *Inflated job descriptions.* Even the smallest bureaucratic unit has at least one person skilled in writing the job descriptions that determine rank and salary. They try to turn typists into "word processors," and elevator operators into "vertical vehicle controllers"—ten-dollar words that produce thousand-dollar raises. An embellished job description can also give an employee the chance of becoming a supervisor with a staff of his own—which means hiring new people. Between 1965 and 1977, the number of GS-13s, the government's first supervisory grade, grew from 65,000 to 108,000.

Reducing all this inflation will not be easy. Civil servants have managed to get regulations and court rulings that make them next to impossible to fire. As one observed, "We're like headless nails. Once we get in, you can't get us out."

The result is a bureaucracy that is not only overstaffed, but overstaffed with unproductive employees who know that the Civil Service's rate of discharge for inefficiency has been only *one-seventh of one percent*. Translated into a small business with ten employees, that's a rate of firing

one person every 70 years; and President Carter's efforts at reform succeeded in improving that figure by only 15 percent.

Probably the greatest obstacle to Civil Service reform is that most people believe "merit" hiring to be better than political patronage. In fact, getting a government job has only the most modest relation to merit.

Veterans get five free points added to their Civil Service exam scores; disabled veterans get an extra ten. For non-veterans the trick is to get their names requested from the OPM by the agency filling the job—and the way to do that is to know someone inside the agency. People already in the system are the first to know about a job opening and can tailor the job description to fit the person they want to hire.

So the Civil Service merit system is actually a patronage system based on friendship instead of politics. Insiders call it the buddy system.

What, then, is the solution? It is widely assumed that a political-patronage system would result in a government run by unqualified people. But might not government jobs best be filled by politicians interested in putting together an Administration that will do a good enough job to get them re-elected?

There are reasons for not doing away completely with the Civil Service tenure system. Continuity is important. So perhaps only 50 percent of federal jobs, as they open up

through normal attrition, should be filled with political appointees who can be fired. Firing permits the hiring of people we want and the jettisoning of those we don't want.

The key here is accountability. If you don't deliver the goods, you can be thrown out. When the Post Office was political, it worked. Congressmen knew that if the postmasters they appointed didn't deliver the mail, the Congressmen would be blamed by the voters. Now they say it's out of their hands. And it *is*.

Congress has surrendered vast powers to independent federal agencies over which it and the President have little or no authority. Bureaucrats in such agencies feel beyond public control.

Recently, for example, the Library of Congress studied federal agencies' compliance with the Sunshine Act of 1976, which was supposed to open up government to the public. The study found that of 1003 government meetings listed in the Federal Register, 627 were either completely or partially closed to the public. One meeting held by the Federal Reserve Board to consider the design of its furniture was closed on the ground that "matters of a sensitive financial nature were being considered."

Bureaucrats aren't accountable to the people because they can't be fired by the elected representatives of the people. If elections are going to mean anything—and they often mean nothing now because they do

not change the permanent government—the Administration must be given the authority to hire and fire not just Cabinet members and agency heads, but enough other officials, high and low, so the President can move the machinery of government.

Power over federal appointments made within a Congressional district should be shared with the Congressman, or with local party officials when the Congressman is not in the President's party. That way the voters will know the Congressman shares responsibility for the performance of federal officials in his district.

With an accountable bureaucracy, Congressmen and the President—because they would share the appointing authority for federal officials working at the grassroots level—should finally be able to overcome the communication gap that can prevent those at the top from knowing what's going on down below, and therefore from knowing what actions to take to meet *the people's* needs and wishes.

Washington doesn't really work. The present system is designed to protect those within it, not to serve those outside. Until we have a government that can control the bureaucracy, we are not going to have effective government.

Thoughts of calling the phone company, waiting for service, having no phone and picking up a dead line on and off for the next few days seemed a big bother. There was also the phone bill sitting in a pile on the desk, unpaid. But, that's happened before...couldn't be.

Earlier at lunch, I heard the wind pick up. I lookd out the window and saw the force hurl a solid, red metal chair across the length of the terrace as it crashed down on its side at the far end. It had happened before, many times. Boy, those old things were well made.

But now I had no phone, the rain was coming hard and I couldn't go outside.

Suddenly the phone is ringing.

A friend is on the line and we speak:

"I can't get a line. Something's wrong."

"No. Yes. The circuits may be overloaded. The President's been shot. Turn on the TV."

Today, I pick up the phone and the line is clear. So is the day. The wind is still and the red metal chair sits firmly beside the potted rose bush with its earliest, gently fluttering leaves.



ANNUAL MEETING

CHAMPAIGN, ILLINOIS

APRIL 3, 1981

I WAS PREPARED TO SPEAK TONIGHT ABOUT THE FEDERAL BUDGET AND ITS IMPACT ON BLACK AND POOR AMERICANS. I WAS PREPARED TO OUTLINE IN SOME DETAIL JUST HOW DEVASTATING THAT BUDGET WILL BE TO AMERICA'S FORGOTTEN FAMILIES THAT DWELL IN POVERTY.

BUT EVENTS HAVE OVERTAKEN THAT TALK. THIS IS NO TIME TO ARGUE WITH A PRESIDENT OVER HIS PROGRAM. FOR THAT PRESIDENT LIES WOUNDED IN A WASHINGTON HOSPITAL.

INSTEAD, THIS IS THE TIME FOR ALL AMERICANS TO AFFIRM THEIR UNITY, AND TO RALLY BEHIND THE SYMBOLS OF OUR NATION -- THE PRESIDENT, THE FLAG, AND THE CONSTITUTION.

AND THOSE ARE NOT EMPTY SYMBOLS. THEY ARE MEANINGFUL SYMBOLS THAT REFLECT THE REALITY OF OUR PRIDE AND INDEPENDENCE.

IF THE LEADER OF ANOTHER COUNTRY IS SHOT, WE CAN EXPECT TANKS TO BE DRAWN UP IN FRONT OF THE PRESIDENTIAL PALACE. WE CAN EXPECT TROOPS TO IMPRISON THE POLITICAL OPPOSITION. WE CAN EXPECT THE NEW LEADERS TO TEAR UP THE COUNTRY'S CONSTITUTION.

BUT LAST WEEK, AMERICA'S RULES PREVAILED. THE VICE PRESIDENT STEPPED INTO THE BREACH. THE CABINET PULLED TOGETHER. THE GOVERNMENT FUNCTIONED. SURE, THERE WAS CONFUSION. BUT IT WAS A CONFUSION REGULATED BY LAW AND WITH THE SURE KNOWLEDGE THAT OUR CONSTITUTION IS OPERATIVE AND DEMOCRACY WOULD SURVIVE.

SO EVEN AS WE ARE SHOCKED AT THE ATTACK ON THE PRESIDENT WE MUST REALIZE THAT THE SAME FREEDOM THAT SENDS HIM INTO CROWDS AT SUCH GREAT RISK, PROVIDES THE LAWS AND ORDERLY STABILITY THAT PERMITS OUR GOVERNMENT TO FUNCTION WHEN THE WORST HAPPENS.

THANK GOD, THE WORST HAS NOT HAPPENED. THE PRESIDENT'S LIFE WAS SPARED. HE IS ON THE WAY TO RECOVERY. ALL OF US ARE UNITED IN THANKS GIVING FOR THAT. WE PRAY FOR HIS COMPLETE AND TOTAL RECOVERY AND FOR THE COMPLETE RECOVERY OF HIS PRESS SECRETARY, JIM BRADY, FOR THE SECRET SERVICE AGENT AND FOR THE POLICEMAN WHO WERE WOUNDED IN THE ATTACK.

BUT WHY IS IT THAT AMERICANS SEEM ABLE TO BE UNITED ONLY IN TIMES OF TRAGEDY OR CRISIS?

AN EXPERIENCE LIKE THE TERRIBLE ATTEMPT ON THE LIFE OF PRESIDENT REAGAN BRINGS ALL PEOPLE TOGETHER IN PRAYERS FOR HIS RECOVERY AND OUTRAGE AT THE VICIOUS ATTACK ON HIS LIFE.

AND THAT FEELING CUTS ACROSS THE POLITICAL SPECTRUM. EVEN THE MOST OUTSPOKEN OPPONENTS OF HIS ECONOMIC PROGRAM, INCLUDING MYSELF, LIKE HIM AS A HUMAN BEING, RESPECT THE OFFICE HE HOLDS, AND ABHOR VIOLENCE OF ANY KIND, ESPECIALLY VIOLENCE OF THE SORT WE WITNESSED IN WASHINGTON.

I WANT TO BACK HIM WHEN I THINK HE IS RIGHT. AND I WANT TO OPPOSE HIM WHEN I THINK HE IS WRONG. I WANT THE OPPORTUNITY TO EDUCATE HIM TO MY WAY OF THINKING, AND IF I FAIL, WANT TO KNOW THAT I MUST RESPECT HIS VIEWS WITH THE SAME TOLERANCE WITH WHICH HE MUST RESPECT MINE.

AND IN A DEMOCRACY, I DO NOT WANT A MAN WITH A GUN TO DEPRIVE ME OF MY PRESIDENT, FOR, RIGHT OR WRONG, HE IS MY PRESIDENT AND THE SYMBOL OF MY NATION'S AUTHORITY AND LEADERSHIP.

AMERICA CHOSE RONALD REAGAN TO BE ITS PRESIDENT, AND ALL AMERICANS WANT HIM TO SERVE HIS TERM IN THE WHITE HOUSE FOR THE NEXT FOUR YEARS.

THE PRESIDENT IS PRESIDENT OF ALL OF THE PEOPLE, AND ALL OF THE PEOPLE HAVE A STAKE IN HIS ABILITY TO DISCHARGE THE FUNCTIONS OF HIS OFFICE. WE ALL HAVE A STAKE IN THE STABILITY OF THE GOVERNMENT. WE ALL REALIZE THAT OUR FREEDOMS ARE ENDANGERED WHEN DANGEROUS WEAPONS IN THE HANDS OF PEOPLE WITH TWISTED MINDS REPLACE THE POLITICAL PROCESS.

AS ONE WHO HAS BEEN THE VICTIM OF A SIMILAR ATTACK, I KNOW WHAT THE PRESIDENT IS GOING THROUGH, AND HE HAS MY PRAYERS AND HOPES FOR A COMPLETE RECOVERY.

THE WOULD-BE-ASSASSIN WHO WOUNDED THE PRESIDENT ALSO WOUNDED AMERICA. IT IS IMPOSSIBLE TO LOOK BACK AT THE PAST TWENTY YEARS OF ASSASSINATIONS AND ATTEMPTED ASSASSINATIONS WITHOUT SINKING INTO AN AWFUL FEELING OF DOUBT ABOUT OUR SOCIETY.

IT HAS BECOME A CLICHE TO TALK OF A "SICK SOCIETY" AND PEOPLE ARE TIRED OF THAT KIND OF TALK. BUT AFTER YET ANOTHER ASSASSINATION ATTEMPT WE HAVE TO FACE THE AWFUL TRUTH OF VIOLENCE AND MINDLESS BRUTALITY SO OFTEN DISPLAYED IN AMERICA.

WE HAVE TO FACE THE FACT THAT PRESIDENTS OF AMERICA ARE GUNNED DOWN WHILE THEIR COUNTERPARTS IN EUROPE AND OTHER INDUSTRIAL DEMOCRACIES ARE NOT. WE HAVE TO FACE THE FACT THAT AMERICA HAS AS MANY GUNS AS PEOPLE, WHILE OTHER COUNTRIES DO NOT. WE HAVE TO FACE THE FACT THAT OUR SOCIETY PRODUCES MANY PEOPLE WHO ARE ROOTLESS, ANGRY AND ALIENATED, WHILE OTHER SOCIETIES DO NOT.

AND IT IS NOT JUST THIS ONE INCIDENT, OR EVEN THE CHAIN OF ATTEMPTS ON THE LIVES OF AMERICAN LEADERS THAT GIVE RISE TO THIS LINE OF THINKING. IT IS ALSO THE KILLINGS OF THE BLACK CHILDREN IN ATLANTA, AND THE SIMILAR EVENTS THAT HAVE OCCURED IN RECENT YEARS. MASS KILLERS HAVE WORKED THEIR EVIL IN CHICAGO, HOUSTON AND NEW YORK JUST IN THE PAST FEW YEARS.

AND THERE IS MINDLESS VIOLENCE IN THE STREETS AS WELL. IT HAS BECOME A PART OF AMERICAN LIFE WE CANNOT AND SHOULD NOT ACCEPT.

ONE WAY TO EXPRESS OUR INDIGNATION IS TO PRESS FOR GUN CONTROL. BUT EVEN A SIMPLE SUGGESTION THAT HANDGUNS, WHICH ARE NOT USED FOR SPORTS, BE REGISTERED, HAS BEEN DEFEATED TIME AND AGAIN.

I KNOW THIS IS AN EMOTIONAL ISSUE. I KNOW WHAT GUNS MEAN TO PEOPLE. I GREW UP IN THE SOUTH, WHERE PEOPLE GO HUNTING AND WHERE HANDGUNS ARE COMMON. BUT SO TOO IS VIOLENCE.

I CAN UNDERSTAND SOME OF THE FEARS PEOPLE HAVE ABOUT GUN CONTROL LEGISLATION. BUT THOSE FEARS ARE OFTEN DERIVED FROM AN EARLIER SOCIETY THAT NO LONGER EXISTS. THE FRONTIER IS GONE. WE ARE NOW A MASS SOCIETY, FULL OF THE TENSIONS AND FRICTIONS A MASS SOCIETY PRODUCES. IN SUCH AN ENVIRONMENT, GUNS ARE GOING TO BE USED FOR PURPOSES MANY LAW-ABIDING GUNOWNERS DARE NOT IMAGINE.

WE HAVE TO RECOGNIZE WE LIVE IN A SOCIETY WHERE AN OSWALD CAN MAIL OFF A COUPON AND GET A DEADLY WEAPON; A SOCIETY IN WHICH A HINCKLEY CAN WALK OFF THE STREET INTO A PAWNSHOP AND BUY A DEADLY HANDGUN, A SOCIETY IN WHICH ANY PETTY HOODLUM OR DERANGED PERSON CAN EASILY GET HIS HANDS ON A WEAPON THAT CAN KILL.

YES, IT IS AN INFRINGEMENT ON OUR LIBERTIES TO HAVE ACCESS TO SUCH WEAPONS RESTRICTED. BUT THAT IS A LIBERTY I WOULD GLADLY GIVE UP TO SAVE LIVES. IT IS NOT A LIBERTY ON THE SCALE OF OTHERS WE TREASURE — THE FREEDOMS THAT PROTECT INNATE RIGHTS.

RATHER, IT IS AN EXPENDABLE LIBERTY, ON THE ORDER OF OTHER RESTRICTIONS THAT PREVENT US FROM SHOUTING "FIRE" IN A CROWDED THEATER OR SLANDERING SOMEONE.

PERHAPS IT IS TIME TO DECLARE FOR FULL AND COMPLETE DOMESTIC DISARMAMENT. I KNOW THE OLD LINE, "GUNS DON'T KILL PEOPLE, PEOPLE DO." BUT PEOPLE WITH GUNS KILL PEOPLE. TAKE AWAY THE GUNS AND YOU DRASTICALLY REDUCE THE CHANCE FOR SUCH LETHAL POSSIBILITIES.

BEYOND SUCH STEPS, WHAT CAN WE DO TO MAKE OUR SOCIETY LESS PRODUCTIVE OF MISFITS AND VIOLENCE-PRONE PEOPLE? A LONG HISTORY OF FRONTIER VIOLENCE, RACISM, AND MINDLESS SELFISHNESS MAY BE AT THE ROOT OF THE PROBLEM.

HOW DO WE COUNTER THAT AWFUL HERITAGE TO ENCOURAGE TOLERANCE AND RESPECT FOR HUMAN LIFE? THERE ARE NO EASY ANSWERS. NO ONE KNOWS HOW TO CREATE A CARING SOCIETY THAT VALUES THE LIVES OF ITS MEMBERS.

BUT IT IS A COPOUT TO BLAME THE VIOLENCE ON ISOLATED, ALIENATED INDIVIDUALS. WE MUST ASK WHY THERE ARE SO MANY SUCH PEOPLE, WHY THEIR SICKNESS TAKES THE FORM OF VIOLENCE AGAINST OTHERS, AND WHAT THERE IS IN OUR SOCIETY THAT ENCOURAGES THIS.

MY OWN FEELING IS THAT A SOCIETY THAT DIRECTS ITS ENERGIES TO SOCIAL JUSTICE, THAT DEVOTES ITSELF TO CARING CONCERN FOR THE LEAST OF ITS CITIZENS, AND THAT DEMONSTRATES RESPECT FOR LIFE BY TRYING TO MAKE ALL LIVES MEANINGFUL, WOULD BE A SOCIETY THAT HAS A BETTER CHANCE TO ESCAPE THE DESTRUCTIVE PATTERN IN WHICH WE SEEM TRAPPED TODAY.

I THINK IT IS IMPORTANT TO UNDERSTAND THAT PHILOSOPHY, WHICH SUPPORTS THE URBAN LEAGUE'S ACTIVITIES. TOO OFTEN WE ARE BOGGED DOWN IN THIS PROGRAM OR THAT PROJECT TO KEEP THE BIG PICTURE IN MIND.

WHEN WE TRY TO PROVIDE A HOUSING PLACEMENT FOR A FAMILY OR A JOB TRAINING PROGRAM TO YOUNG WORKERS WE DO MORE THAN PROVIDE A SERVICE TO CERTAIN INDIVIDUALS. RATHER, WE HELP TO BUILD A CARING SOCIETY THAT OPENS DOORS OF OPPORTUNITY. WE DEMONSTRATE RESPECT FOR OUR FELLOW HUMAN BEINGS. WE HELP TO BUILD A COMPASSIONATE SOCIETY.

AND WHEN WE ADVOCATE MEASURES BY FEDERAL, STATE OR LOCAL GOVERNMENTS WE ARE NOT ADDING OUR VOICES TO THOSE OF A SPECIAL INTEREST GROUP. WE SPEAK IN SOCIETY'S BEST INTERESTS IN ADVOCACY OF PHILOSOPHIES AND PROGRAMS THAT WOULD BRING EVERYONE INTO THE COMMUNITY OF AMERICA'S MAINSTREAM.

AND WHEN WE URGE THE PRIVATE SECTOR TO TAKE STEPS LIKE TRAINING PROGRAMS, AFFIRMATIVE ACTION PROGRAMS, OR SUPPORT FOR COMMUNITY ACTIVITIES, WE DO IT NOT AS ANNOYANCES TO BUSINESSES THAT OUGHT TO BE CONCENTRATING ON OTHER THINGS, BUT AS FELLOW-CITIZENS THAT SHARE THE PRIVATE SECTOR'S NEED FOR A STABLE, JUST SOCIETY.

WE OF THE URBAN LEAGUE ARE TRYING TO MAKE AN IMPERFECT SOCIETY WORK BETTER FOR ALL ITS PEOPLE. AND WE ARE ESPECIALLY COMMITTED TO A PRIVATE SECTOR ROLE IN THAT EFFORT.

WE INSIST ON STRONG GOVERNMENT ACTION TO PROVIDE JOBS AND SOCIAL SERVICES. BUT WE INSIST NO LESS STRONGLY ON PRIVATE SECTOR EFFORTS TO MAKE OUR SYSTEM WORK FOR EVERYBODY.

I THINK THE URBAN LEAGUE, THE REAGAN ADMINISTRATION, AND THE PRIVATE SECTOR ALL AGREE ON THE KIND OF SOCIETY WE WOULD LIKE TO SEE -- A SOCIETY THAT IS STRONG, FREE, AND OFFERS EQUAL OPPORTUNITIES TO ALL AMERICANS.

WE MAY DISAGREE ON THE MEANS. SOME PEOPLE MAY CHARGE THAT THE PROGRAMS I WANT ONLY LEAD TO TOO MUCH GOVERNMENT AND TO A SOCIETY HEYMED IN BY TOO MANY REGULATIONS. I MAY THINK THAT THE PROGRAMS OTHERS ADVOCATE WILL RESULT IN TOO MUCH MISERY FOR POOR PEOPLE AND A SOCIETY WEAKENED BY CONTINUED INEQUALITIES AND INJUSTICES.

BUT THIS IS A TIME TO CONCENTRATE ON ENDS -- ON AGREEING THAT WE ALL WANT TO SEE AN AMERICA IN WHICH MINDS CAN BLOSSOM AND NOT BECOME DERANGED AND VIOLENT; AN AMERICA IN WHICH A PERSON'S SKIN IS JUST THE COVER OF HIS BODY AND NOT THE CAUSE OF UNEQUAL TREATMENT AND UNEQUAL OPPORTUNITY.

THESE ARE DIFFICULT DAYS FOR OUR NATION, AND MORE DIFFICULT DAYS ARE AHEAD UNLESS WE CAN HELP UNITE ALL AMERICANS BEHIND THE BANNER OF A COMPASSIONATE SOCIETY THAT CARES FOR ITS PEOPLE AND ITS IDEALS.

YES, THIS WEEK'S TRAGEDY CALLS FOR A TEMPORARY TRUCE IN PUBLICLY FIGHTING THE PRESIDENT ON HIS PROGRAM. BUT WHEN IT ENDS, WE WILL PRESS OUR CLAIMS WITH ALL THE VIGOR AT OUR COMMAND, KNOWING THAT THIS IS THE WAY A DEMOCRACY OPERATES.

WE WILL WIN ON SOME ISSUES AND LOSE ON OTHERS. BUT BETTER TO LOSE IN A DEMOCRACY AND HAVE THE RIGHTS AND FREEDOM TO PROTEST WHAT WE DO NOT AGREE WITH, THAN TO WIN UNDER SOME OTHER FORM OF GOVERNMENT AND KNOW THAT OUR VICTORIES ARE EMPTY AND HOLLOW WITHOUT FREEDOM.

WE OF THE URBAN LEAGUE HAVE A RESPONSIBILITY TO OUR PRESIDENT, OUR CONSTITUENTS, AND OUR NATION, TO FIGHT FOR THE RIGHTS AND NEEDS OF BLACK, MINORITY, AND ALL POOR PEOPLE. WE HAVE THE OBLIGATION TO PRESS FORWARD WITH CREATIVE SOLUTIONS TO NATIONAL PROBLEMS. WE HAVE THE DUTY TO HELP EDUCATE THE PUBLIC TO UNDERSTAND THE INTERDEPENDENCE OF ALL AMERICANS --

AN INTERDEPENDENCE THAT IS THE LIFELINE OF OUR PLURALISTIC SOCIETY, AND A MIRROR FOR AN INTERDEPENDENT WORLD.

WE MUST SPEAK LOUD AND CLEAR TO A FORGETTING NATION WITH THE MESSAGE THAT THE ASPIRATIONS OF MINORITY PEOPLE IN AMERICA'S GHETTOS CANNOT BE DENIED. WE MUST NEVER LET IT FORGET THAT BLACK AND BROWN PEOPLE, TOO, ARE AMERICANS; THAT LIKE OTHERS, OUR BLOOD, SWEAT AND TEARS BUILT THIS NATION, MADE IT GREAT, SUSTAIN IT TODAY, AND WILL REBUILD ITS GREATNESS TOMORROW.

BLACK PEOPLE KNOW WELL THAT AMERICA CAN CHANGE. IT CAN CHANGE BECAUSE WE HAVE SEEN IT CHANGE; WE HAVE MADE AMERICA CHANGE.

YES, WE WANT AN AMERICA THAT IS CHANGED TO THE POINT WHERE LITTLE BLACK CHILDREN CAN WALK FREELY IN THE STREETS OF THEIR NEIGHBORHOOD IN ATLANTA WITHOUT FEAR. AN AMERICA IN WHICH OUR PRESIDENT CAN WAVE TO FRIENDLY CROWDS WITHOUT THINKING OF DANGER. AN AMERICA THAT IS FREE FROM THE CHAINS OF DISCRIMINATION AND INEQUALITY.

WE SEEK THE AMERICA OUR GREAT POET LANGSTON HUGHES SANG OF WHEN HE WROTE:

"O, LET AMERICA BE AMERICA AGAIN ---  
THE LAND THAT NEVER HAS BEEN YET --  
AND YET MUST BE ---  
THE LAND WHERE EVERY MAN IS FREE,  
THE LAND THAT'S MINE ---  
THE POOR MAN'S, INDIAN'S, NEGRO'S, ME --  
WHO MADE AMERICA  
WHOSE SWEAT AND BLOOD, WHOSE FAITH AND PAIN,  
WHOSE HAND AT THE FOUNDRY, WHOSE PLOW IN THE RAIN,  
MUST BRING BACK OUR MIGHTY DREAM AGAIN."
