

Dear Ms. Wicks:

Your October 8, 1984 letter to the President regarding John Hinckley, Jr. and his parents has been referred to me for response. You ask that the President call John Hinckley, Sr. and "try to arrange for John Jr. to be transferred to a hospital near Denver so that the Hinckleys can go home and try to pick up the pieces of their lives." You suggest that by doing so, the President can raise the awareness of the nature of the disease of schizophrenia.

The President has great sympathy for the pain and suffering that the Hinckley family has endured. During an interview conducted on April 23, 1981, the President stated that ". . . indeed I pray he [John Hinckley, Jr.] can find an answer to his problems. He seems to be a very disturbed young man. He comes from a fine family. They must be devastated by this, and I hope he'll get better."

The specific terms and duration of John Hinckley, Jr.'s confinement at St. Elizabeth's Hospital here in Washington, D.C., however, are determined by the Federal Court. It would be inappropriate for the President to attempt to intervene in such matters.

The President nonetheless shares your desire to elevate the public's awareness of mental illness. To that end, he proclaimed the week of April 15, 1983 as "National Mental Health Week," and the week of April 8, 1984 as "National Mental Health Counselors Week."

Thank you very much for your kind words in support of the President, and we wish you and the Alliance much success in your endeavors on behalf of the mentally ill.

Dear Mr. President:

I am tempted to open my letter with "How would you like to pick up another ten or twenty million votes?", just to get your attention. Who are they? They are the victims and families of the victims of Schizophrenia. And they are strongly democrates because the democrates tell them that they alone will help us. But, my request is most important that just votes.

You can see by the letterhead that I am a member of the Alliance the Menatlly Ill of Michigan. We are a national organization with many chapters in every state and many affiliate organizations, who are family, friends and victims of Schizophrenia. There are 2.5 million victims -- usually stricken in their college years -- and they are almost never dangerous as was John Hinkley Jr. And, John Jr. only became dangerous after being so terrible misdiagnosed and not treated for his illness, by that Denver psychologist.

I am writing to tell you of the plight of John Hinkley Sr and his wife, whom as you probably know, have been living is Washington ever since that terrible day whey you were almost killed at the hand of their son, John Jr. They have given up their home, their other children, their business, their friends -- their whole lives, to be near the St. Elizebath's Hospital and see John Jr. and to develop a national campaign to raise funds for medical research and to raise awareness of the warning signs of this They have been going all around the country on speaking engagements to raise awareness. (They, of course, don't know that I'm writing to you. They don't feel that they deserve your understanding for forgiveness). He is really a very fine man and so is his wife.

What I want to ask of you is that you call him and perhaps try to arrange for John Jr. to be transfered to a hospital near Denver so that the Hinkley's can go home and try to pick up the pieces of their lives. With your help, we can raise awarenss of the nature of this disease, the warning signs, the treatments and you could help us persuade the government to provide research money to cure this disease.

You can get more information about Schizophrenia from Dr. Fuller Torrey who works at St. Elizabeth's and wrote the "bible" of Schizophrenia, "Surviving Schizophrenia".

Even if you don't find it in your heart to help Mr. Hinkley and all of us families and victims -- your are a great president and a great blessing to America and for this I sincerely thank you.

President Reagan, in constant ''pain or discomfort'' from his chest wound, says he wonders why the attempt on his life didn't happen ''27 times before.''

Reagan said would-be assassins had many opportunities to gun him down since he took office three months ago, but he plans no additional security because of the March 30 shooting.

''I have a hunch I'll be more alert'' in the future, Reagan said in an interview Wednesday with United Press International and The Associated Press -- his first since being hit by a .22-caliber slug 25 days ago.

The 70-year-old president, wearing a gray light wool suit, walked a bit stiffly. But he was in good spirits, had rosy cheeks and punctuated many of his comments with humor.

Generally, he said, ''I'm feeling fine.''

Late in the interview, he said:

''There is just that kind of pain or discomfort there constantly that you hope day by day is getting less, and that I think is getting less and less.

''But ... other than that, I've resumed at a little slower pace my regimen of exercise that I've always done for keeping fit and I don't think I'm going to hurdle any tables in the room here for awhile.''

Reagan said he isn't plagued with nightmares about the shooting, but has thought about it often, particularly in the context of his brief term in office.

''I look back now in some of these reviews that they've shown of the first few months (in office) and so forth,'' he said. ''I see some of the milling in crowds and so forth that we've done and I find myself wondering, 'Well, why didn't this happen 27 times before.'''

The interview was held in the White House map room. Reporters Helen Thomas of UPI and James Gerstenzang of the AP agreed to limit the questions to Reagan's health and his recollections of the shooting.

Reagan vividly recalled the attempted assassination. The shots. The pain. Initially not realizing he was hit. Then seeing his own blood.

Asked if he ever felt in mortal danger, Reagan said:

''No, as a matter of fact it still seems kind of unreal. I knew there had to be shots and my first instinct was to take a look behind and see what was going on and the Secret Service man behind me had a different idea, and the next thing I knew I found myself pushed into the car.

''I knew I had been hit but I thought it was from the Secret Service man landing on me in the car. I must say it was the most paralyzing pain. I've described it as if someone hit you with a hammer.

''But that sensation came after I was in the car ... and I thought the pain wouldn't go away. Suddenly I found I was coughing up blood. We both decided that maybe I had broken a rib, and had punctured a lung so we had to go to the hospital.''

Reagan said his main concern on the way to the hospital was that he felt he was ''getting less air and you know that panic you get when you're strangling.''

But he said he remained alert, and with his typical humor added, ''I knew the manner in which I was unclothed (his attire was cut off by emergency room personnel) that I probably wouldn't wear that suit again.''

Since the shooting, there has been renewed interest in gun control. Reagan, however, said he remains against it.

Reagan said he believes there are adequate gun laws and that no additional measures could have prevented the shooting.

The president was asked if he had any feelings about John W. Hinckley Jr., the accused gunman.

''Yes, the feeling is I hope, indeed I pray, he can find an answer to his problems. He seems to be a very disturbed young man. He comes from a fine family. They must be devastated by this. And I hope he'll get better.''

As for his work as a recovering president temporarily confined to the White House, Reagan said:

''It's convenient this way (working mostly in the White House family quarters) because there still are calls by the doctors -- they come and check.'' He said he also can make telephone calls in his robe, take naps and hold meetings at a leisurely pace.

Reagan also said he:

--Has held regular staff meetings, lobbied members of Congress by telephone on his economic package and thinks ''it's going very well.''

--Is taking an afternoon nap, ''and that was never, in spite of some stories to the contrary, that was never a habit of mine.''

Proclamation 5174. April 8, 1984

By the President of the United States of America

#### A Proclamation

Mental health counselors use special counseling skills and understanding of human development to help their fellow Americans cope with problems of adjustment, the pain of illness, and the stresses of life. They provide 50 percent of the mental health services delivered in this country, working with the chronically mentally ill, the depressed, the anxious, the abused, and others, who, through no fault of their own, cannot fully meet their daily obligations or experience life's pleasures.

Through a variety of techniques, mental health counselors assist people to attain selfunderstanding and skills needed to solve problems, make decisions, and successfully deal with others in an increasingly complex world. Mental health counselors work in hospitals, community agencies, clinics, and the private practice sector and with all types of health professionals, applying the expertise gained through their many years

of education and training.

In recognition of the important services that these counselors perform for others to save lives and reduce suffering, the Congress, by Senate Joint Resolution 203, has designated the week beginning April 8, 1984, as National Mental Health Counselors Week and has authorized and requested the President to issue a proclamation in observance of this event.

Now, Therefore, I, Ronald Reagan, President of the United States of America, do hereby proclaim the week beginning April 8, 1984, as National Mental Health Counselors Week. I call upon health care professionals, educators, the media, individuals, and public and private organizations concerned with mental health to observe this week with appropriate ceremonies.

In Witness Whereof, I have hereunto set my hand this 8th day of April, in the year of our Lord nineteen hundred and eighty-four, and of the Independence of the United

States of America the two hundred and eighth.

#### National Mental Health Week, 1983

Proclamation 5051. April 15, 1983

By the President of the United States of America

#### A Proclamation

Mental illness costs this Nation more than \$50 billion a year and contributes to declining productivity and rising health costs. Approximately 35 million people a year suffer from a diagnosable mental disorder. In addition, millions more seek professional assistance to alleviate the physical and emotional problems created by excessive stress.

These facts and figures, however, cannot describe the high cost in human suffering from mental illness. Incapacitation—most often temporary but permanent for some—may result from severe depression, crippling anxieties, or other manifestations of mental disorders. Yet public fear and misunderstanding of their illnesses place additional burdens on the afflicted and their families.

It is important that the public understand that major advancements brought about by science have made mental illnesses and stress-related disorders greatly amenable to treatment. New technologies have added significantly to the numbers of patients who have improved or recovered following treatment and promise further advances.

In recognition of the importance for our Nation of the treatment, care and support for the mentally ill provided by health professionals, volunteers, and family members, the Congress, by Senate Joint Resolution 52, has authorized and requested the President to issue a proclamation designating the week of April 10 through April 16, 1983, as National Mental Health Week.

Now, Therefore, I, Ronald Reagan, President of the United States of America, do hereby designate the week beginning on April 10, 1983, as National Mental Health Week. Even if you don't find it in your heart to help Mr. Hinkley and all of us families and victims -- your are a great president and a great blessing to America and for this I sincerely thank you.
