REMARKS OF THE PRESIDENT AT CEREMONY FOR STATUE OF LIBERTY-ELLIS ISLAND COMMISSION

The Rose Garden

1:35 P.M. EDT

THE PRESIDENT: I'm very proud to accept that on behalf of the people of the United States, my landlords. (Laughter).

Good afternoon. And today we're launching, as you well know, a commission whose task will be the rehabilitation of one of our most cherished symbols of liberty.

Much has been said over the years about the diversity of the American people and the vitality and resilience of the American character.

Well, that character isn't centered around any one religious denomination for in our country there are many religions. Everyone has a right to worship God as he or she chooses. It isn't based on any one ethnic group or race for our people come in all shades and shapes and we remain dedicated to the proposition that all of them are created equal. And I've found out in my present capacity now that -- I love to tell jokes now and then but I -- almost restricted to Irish jokes. (Laughter). I can't stray for fear of some misunderstanding. (Laughter).

But our national character is based on a common identity with a single ideal, a shared value that overcomes our differences and unites us as a people. What has made us a nation is our love of liberty and our realization that we're part of a great historic venture, an experiment in freedom to test the ability of people to live together in freedom, respecting the rights of others and expecting that their rights, in turn, will be respected.

I've said on a number of occasions that I can't help but believe, you can call it mysticism if you will, that God must have placed this land here between the oceans to be found by a certain kind of people and a kind only in one thing, that whatever corner of the world they came from they had the courage and the desire for freedom that went with it to uproot themselves and come to this strange land beginning back when it was the most underdeveloped land in the world

and come here leaving family and come to a strange language and everything that went with that kind of a move.

I think our vision of liberty is reinforced by shared symbols and experiences. Perhaps the strongest image of them all is the one that for millions of Americans was their first glimpse of America that Statue of Liberty.

At the turn of the century, America was blessed with an influx of new immigrants who became citizens and played a significant role in building our country and protecting our freedom. Most of them entered under the shadow of the Statue and were processed into the United States, as we know, through Ellis Island. Between 1892 and its closing in 1954, Ellis Island was the clearing house for millions of immigrants. Many who passed through the gates at Ellis Island had little more than what they carried with them. Yet they possessed a determination that with hard work and freedom, they would live a better life and their children even more so.

They were captured by the American dream and both they and their new country were the better for their efforts and their faith because they not only came here for something but just as they came from every corner of the world, they brought something from every corner of the world to this great melting pot. And maybe in so doing, they proved how artificial are the prejudices and the hatreds that exist in the world because we proved that we could all mix and, I don't know, to this day, one of the first questions you usually ask when you make friends with someone is, what is their ancestry, what country and it use to be that they'd say Irish or German or French or whatever and now they have to say three or four names because they've mixed. In fact, I've got three in mine -- Irish, English, and Scotch but -- and our children can add a fourth and have another country now. But today we declare that no longer functioning as it is, the Ellis Island as a processing center, its contribution is not over. It remains a unifying memory for millions of our citizens.

Our goal is to restore Ellis Island in time for the celebration of the centennial of the Statue of Liberty beginning on July 4th, 1984. I might add one note. The Statue of Liberty was built with funds contributed by people from all over France. Its base was constructed in part with contributions from American school children. And restoring Ellis Island, another monument to our freedom, is worthy of the same kind of heartfelt, voluntary effort. Both the Statue of Liberty and Ellis Island can help us all remember how grateful we should be to live in this land of freedom and good will.

You know, I know that there's one here, or have you already told them? Lee's parents came to this country in search of that kind of opportunity and through Ellis Island. And he certainly has proven what America has to offer for those immigrants or for the sons and the daughters of them.

So, now I just thank you all for being here with us today to help launch this campaign. And God bless you all.

SECRETARY WATT: Thank you very much, Mr. President. (Applause.)

When I introduced the other members of the commission, I failed to have them stand up. Would you stand up and -- I'm not sure where you are, the other members of the commission that have been appointed and if, Mr. President, I'd like -- if these men that have agreed to serve on the President's commission would come forward, I'd like to introduce the President to you and we'll catch him before he gets out, if I could ask you men to come over here. And Lee, if you'll join us.

(The Secretary introduces the commission members.)

THE PRESIDENT: I think we're all grateful to these gentlemen who that are going to take on this task and I know that we'll get it done. And they told me now that I have to leave and go back to work. (Laughter. Applause.)

I have discussed our questions regarding the tax status of the Princess Grace Foundation and the duties of Mrs. Reagan as an Honorary Trustee with the attorney for the Foundation, George Hauptfuhrer.

Hauptfuhrer states that the Foundation has been organized as a § 501(c)(3) entity but that such organization will not be finalized until the first meeting of the Foundation's trustees. It is possible that a decision on the programs of the Foundation will result in its being a tax exempt charitable organization but not necessarily a § 501(c)(3) organization.

The first meeting of the trustees is set for February 22, 1983. The public announcement of the formation of the Foundation is expected to occur immediately following that meeting. A six month start-up period for any Foundation activities is expected.

Hauptfuhrer agrees "absolutely" that no personal involvement in fundraising of the Foundation will be expected of Mrs. Reagan; Prince Rainier and his family would not want that. The only personal involvement which he forsees being requested of Mrs. Reagan could be for her to attend a concert sponsored by the Foundation at the Kennedy Center; of course if she could not attend that would be understood.

As to the nature of Mrs. Reagan's position as an Honorary Trustee, Hauptfuhrer advised that this is a personal invitation which will not expire with the President's term of office; she may serve as long as wishes. In fact, Prince Rainier would like, at the appropriate time, to write Mrs. Reagan and thank her personally for her acceptance of this position.

Although I am somewhat concerned about the uncertainty of the tax status of the Foundation, I feel confident that it will be organized as a non-profit charitable organization. Nevertheless, I think it advisable to request that Rosebush, in his correspondence to Hauptfuhrer, request a copy of the Foundation's request to the IRS for qualification as a § 501(c)(3)

organization and a copy of the IRS approval letter, once it is issued to the Foundation.

Attached for your review and approval is a memorandum to Rosebush advising that we have discussed the details of the Princess Grace Foundation with the Foundation's attorney, George Hauptfuhrer, and have no legal objections to Mrs. Reagan's acceptance of a position as Honorary Trustee of the Foundation. The memorandum sets forth our understanding of Mrs. Reagan's duties and responsibilities as a Trustee and the tax status of the Foundation. It further states that at the appropriate time Prince Rainier would like to write to Mrs. Reagan personally to thank her for agreeing to serve as an Honorary Trustee and Hauptfuhrer has requested that he be informed as to the appropriate timing of such a letter so that he may advise the Prince. As discussed above, Rosebush is requested to obtain verification of the Foundation's tax status as it is presented to and verified by the IRS.

As to the "appearance" aspects of Mrs. Reagan's participation, we note that she may wish to distinguish her position and support of the Princess Grace Foundation from her efforts on behalf of the President's Council on the Arts and Humanities, an organization which, ostensibly, may serve the same purposes as the Princess Grace Foundation.

Please advise as to whether Mrs. Reagan wishes to be an Honorary Trustee of the Princess Grace Foundation. Following that we will be happy to pursue these issues with the Foundation's attorney and give our final approval of her participation in this project.

Dear Mrs. Reagan:

We were introduced by Governor Thornburgh at the private reception following Princess Grace's funeral services. I mentioned then very briefly the ideas which were being put forth with regard to a foundation in her name to carry on her charitable works for the creative arts. You indicated that you would consider helping with this endeavor if it appeared appropriate in the light of your office, the many limitations on your time, and the manner in which the foundation developed.

The foundation is now in existence and duly qualified as a charitable tax-exempt organization. The founding trustees have been selected and will soon be meeting to define more precisely the foundation's mission and to establish its program. The twelve founding trustees were selected by Princess Grace's immediate family after careful reflection on persons of national stature who were friends of hers. You will undoubtedly recognize many of the names -

William P. Rogers (NYC) - Senior partner of law firm of Rogers & Wells and former U. S. Secretary of State

Dennis Stanfill (L.A.) - Former Chairman of the Board of Twentieth Century-Fox Corporation

Prince Rainier and Governor Thornburgh will serve as honorary trustees, and it is hoped very much that you too will serve as an honorary trustee. The time demands on the honorary trustees will be very minimal.

It is difficult at this time to describe the foundation's probable activities other than that they will be supportive of the creative arts (especially those in which Princess Grace was interested), they will endeavor to project a cultural bridge between the United States and Europe (as Princess Grace herself provided), and they will be done with the utmost dignity (consistent with the way in which Princess Grace conducted her own charitable efforts).

When the founding trustees meet with Prince Rainier and Prince Albert in late January or early February for the first trustees'

meeting, various suggestions will be under consideration. To illustrate, Rostropovich has offered to hold a memorial concert for Princess Grace and another foundation has expressed an interest in underwriting the costs thereof. Such a concert at the Kennedy Center - especially if you and the President could be present - would appear to be an appropriate vehicle for the foundation's first public exposure. Other somewhat similar events are also on the agenda for consideration. The foundation would probably not have more than one or two events a year, and they would probably be in different parts of the country.

The awarding of the funds collected will also be decided by the trustees, but my guess at this time is that grants may be given to well-known charitable organizations to provide for international exchange students in the creative arts, or later perhaps, to help support a tour of the United States by the Ballet de Monte Carlo (which is now on the planning boards in Monaco in Princess Grace's name). Your suggestions as to program and use of the funds will be most welcome.

The names of the trustees have not yet been announced publicly. If your name as an honorary trustee could be included in the initial announcement, it would not only aid the work of the foundation but would indeed be a very significant tribute to Princess Grace. It would also mean a great deal to everyone who loved her, not the least of whom are her own family.

I am in Washington with some regularity. If it would be an aid to you for us to meet to discuss the foundation in greater depth, I would be pleased to do so. Of course, I will be happy to supply you with whatever additional information you might like to have. Because the foundation is still in its formative stage, however, I cannot be much more expansive than this.

In view of the fact that the first trustees' meeting will probably be in January or February, it would be most helpful if I could have an early response from you. I apologize for not writing to you earlier, but I wanted matters to be as definite as possible before writing. As I have been meeting personally with most of the trustees, it has taken some time.

Beyond the basic concept of a safe ride home, the organization will be looking for ways to become involved in the overall alcohol and drug education programs in the schools. This could include presentations by **SAFE RIDES FOR TEENS** members to local organizations and underclassmen. The preparation of printed materials on this subject and the sponsoring of a drunk driving test program in conjunction with the appropriate State Agency will also be anticipated.

BACKGROUND/PURPOSE

Anne Arundel County has had its share of alcoholrelated fatal automobile accidents involving young people over the last several years. Up until now, the high school students responded to the tragedies by driving more carefully—for awhile. However, continued anxiety about needless death has prompted the students to establish a program aimed at eliminating driving while intoxicated (DWI).

SAFE RIDES FOR TEENS is a program designed to provide a free and confidential safe ride home to any student who is not in a condition to drive safely, or to any student who wants to avoid being a passenger in such a situation. SAFE RIDES FOR TEENS is also a program which holds the potential for changing young people's attitudes about drinking while driving; the students' concern for each other's safety should lead to greater appreciation of both the risks and responsibilities associated with driving while impaired.

THE SAFE RIDES FOR TEENS PROGRAM

Every Friday and Saturday night from 10:00 p.m. -3:00 a.m., students and adult volunteers will gather in the SAFE RIDES FOR TEENS headquarters as the team responsible for giving local young people a safe ride home if it is needed. One student is the dispatcher, handling all incoming telephone calls as well as maintaining contact via CB with each of the SAFE RIDES FOR TEENS cars out on call. The other students are paired into coed driving teams. Each driver uses his or her family car, and is accompanied by a rider who is responsible for CB contact with the base, and the maintenance of minimal information on departure times, pickup times, addresses, and passenger names, which is required for insurance purposes. (SAFE RIDES FOR TEENS team members have agreed to keep confidential all details of their service activities.) The adult volunteers are on duty for the students to consult if they need help. If any further assistance is desired, the crew may contact the **SAFE RIDES FOR TEENS**' advisor or the Police Department.

We will attempt to have this service publicized via PA announcements in the high school, posters, buttons, and bumper stickers which will advertise SAFE RIDES FOR TEENS' operating times and phone number.

MEMBERSHIP

SAFE RIDES FOR TEENS is primarily a student organized and operated program—created and developed by responsible students who care about the health and safety of their peers. The program is open to any student in grades 10-12 who is willing to take the training course, attend monthly meetings, serve periodically on Friday or Saturday nights, and evidence a commitment to help prevent tragedies associated with alcohol and drug abuse. In addition to the adult on-duty volunteers, adults on the Advisory Committee help in basic organization, soliciting funds, and setting up training. Each SAFE RIDES FOR TEENS member joins SAFE RIDES FOR TEENS EXPLORER POST, which is associated with the Boy Scouts of America.

SAFE RIDES FOR TEENS TRAINING

Each student member of SAFE RIDES FOR TEENS must complete a 12 hour training program set up by the SAFE RIDES FOR TEENS Advisory Com-

mittee in conjunction with the Police Department and the Explorer Post. This training program includes:

- examining motivation for joining SAFE RIDES FOR TEENS, (e.g., commitment to help peers avoid accidents and attitudes toward drunkeness and drunk driving;
- development of communication skills, particularly those designed to facilitate ability to help, without being judgemental;
- program procedures (including use of telephone, CB radios, log books, etc.);
- special situation preparation, designed to encourage clear thinking in unexpected situations;
- interfacing with other local services, e.g., Police Department and Explorer Post; discussion of insurance questions; referral procedures for problems beyond the scope of SAFE RIDES FOR TEENS.

Adult members have a shorter training program, dealing with the same subjects.

FINANCIAL SUPPORT

Initial funding will be provided by local service organizations and interested individuals. Fund raising will be an activity of the student members. Expenses include telephone, gasoline reimbursement, mailing costs, and the purchase of CB equipment.

INSURANCE

In addition to each car owner's private insurance, group liability insurance is available to **SAFE RIDES FOR TEENS** and its members through its designation as an Explorer Post of the Boy Scouts of America.

SAFE RIDES FOR TEENS is a student program designed to provide a free and confidential safe ride home to any student who is not in a condition to drive safely, or to any student who wants to avoid being a passenger in such a situation. SAFE RIDES FOR TEENS is also a program which holds the potential for changing young people's attitudes about driving while drinking; the student's concern for each other's safety should lead to greater appreciation of both risks and responsibilities associated with driving while impaired.

SAFE RIDES FOR TEENS is patterned after a similar program in Darien, Connecticut, currently in operation since April 1982. We anticipate beginning our operation by the Christmas break of this year. Our program will work in the following manner:

- Every Friday and Saturday night between 10:00 p.m. 3:00 a.m., five trained student volunteers and one adult volunteer will take duty at our SAFE RIDES FOR TEENS Center.
- One student is the dispatcher, handling all incoming telephone calls as well as maintaining contact via CB with each of the SAFE RIDES FOR TEENS cars out on call. The other students will be paired into co-ed driving teams. Each driver will use his or her family car, and is accompanied by a rider who is responsible for keeping CB contact with the Center.

- Each student member, as well as adult members, must complete a 12 hour training program set up by the SAFE RIDES FOR TEENS Advisory Board.

ristin Otero, a 16-year-old senior at South River High School in Edgewater, has quit her job at the Roy Rogers restaurant. She could have used the money, she says, but she figures her time is better spent helping teen-agers who drink and drive.

"Every weekend after games, and sometimes on school nights till 10, people are out partying—you know, drinking beer," said Otero, who lives in Davidsonville, Md., a rural community in southern Anne Arundel County. "We're not telling the other kids not to drink. All we're saying is: "That's OK. If you need our help, don't hesitate to call.'"

Otero and 30 other South River students have formed Safe Rides For Teens, a program modeled after one in Connecticut offering free trans-

portation to students too drunk to drive or passengers unwilling to travel with a drunk driver.

Safe Rides, which supporters plan to launch Dec. 17, would be Maryland's first anti-drunken driving campaign organized and run entirely by students.

Around Davidsonville teen-age drinking and driving "has been a problem for quite a while, but it's also been growing lately," said Jim Smith Jr., a 16-year-old junior at South River. Davidsonville and

Edgewater have no local taxi or bus service and many teen-agers get a car while still in high school.

"Drinking is a pretty big thing around here. I've seen it: the kids who go out drinking and then drive home," Smith said.

Maryland State Police report that of the 572 traffic deaths statewide between the first of the year and last Monday, 270 of those were alcohol-related. In the first six months of this year, police and 32 of the 96.

drivers killed in alcohol-related accidents were between 16 and 21 years old; nine of the 32 who died were 16, 17, or 18 years old. Authorities said that although high, the number of drunken-driving deaths is still about 10 percent lower than in past years.

But the trauma remains for South River students a year after two of their classmates died in a car accident that some of their friends say may have been alcohol-related, and that's why, four months after the

state raised the drinking age from 18 to 21, they're fighting the young drunk driver by offering to do the driving for him or her.

And the Chesapeake Bay-area county is not alone. In Bowie, officials started a Dial-a-Ride program two years ago that helped dozens of people during the holiday season.

According to John Gibbons, the Youth Service Bureau counselor who started the program, Dial-a-Ride will resume around Thanksgiving and run through the Christmas season.

This week, Bowie ninth graders will take part in a special two part program on alcohol, drugs and driving, and similar programs will mark the week of Dec. 12-16, which the Prince George's County Board of Education has designated Drugs and Drugsed Driving Awareness Week.

In Montgomery County, whose "Scared Stff" slide program on drunken driving has drawn regional attention, a group of businessmen county officials and students offered free rides during the spring prom and graduation season. A county spokesman said the program will be revived again next year.

While Bowie's ride program deceparent-student teams to chauffeur others safely home, South River's will use pairs of students. Those vol

unteers must complete an eight-hour defensive driving course taught by Anne Arundel police at their training facility in Millersville, Md.

This idea is fantastic," said Cody Godman, executive director of the Safety Council of Maryland, sponsor of the driving course. Six adult supervisors and 22 teen-agers will give up four consecutive Tuesday nights for the training.

Several groups have climbed aboard the Safe Rides bandwagon. The Safety Council decided not to charge its usual fee for the course. A national firm with a factory in Anne Arundel has contributed \$350 for the program and another \$325 has been donated. Rep. Marjorie S. Holt (R-Md.), several House of Delegate members and leaders of other campaigns against drunken driving have also endorsed Safe Rides for Teens.

But among South River pupils, enthusiasm is only lukewarm, the students say. "The kids aren't behind it," Otero said. "From their point of view, I think, they don't feel it's important. They think it's a parents' group, and students just don't listen to what parents say about drinking and driving. But kids formed it. Maybe their attitude will change.

"You can tell teen-agers as many times as you like, but there's no way to tell them to stop drinking," said Smith, who also lives in Davidsonville. "And we may not be able to stop it, either, but at least we can save some lives in the long run."

Some South River students said their principal, Martin J. Eichhorn, was less than thrilled with the idea of teen-aged drivers carting their peers home on Friday and Saturday nights. "At first, I thought the program was condoning drinking—and that should not be the school's message," Eichhorn said last week. "Our message to students is 'Don't drink—and certainly don't drink and drive.'"

In a fall term already plagued by a number of student driving accidents, Safe Rides "offers our kids and young people the option of being driven home," Eichhorn said. "And that's very useful."

This is how the program will work: Students needing a ride can call one of two telephone numbers to reach a communications center in the parish hall of Davidsonville's Holy Family Catholic Church. Radio dispatched teams—coed pairs who provide their own cars and are reimbursed for gasoline—would then pick up the person and drive him home. The passengers' identities will be kept confidential; an adult will supervise operations from the church during the Friday and Saturday night shifts, which start at 10 p.m. and end at 3 in the morning.

The drivers, who will be affiliated with a local Boy Scout Explorer's Post, will be covered by the organization's liability insurance.

"It's time for some good news about teens," said Smith's mother, Pat. "The kids are behind this idea. They're the ones getting it off the ground."
