Biography

Neil Romano graduated *summa cum laude* from New York University in 1976 in with a degree in history and political science. He received a master's degree from Brown University in political science in 1978.

Romano specializes in the marketing of ideas and messages to help save lives and promote public policy. In 1982, Romano joined the Department of Health and Human Services where he developed a film and supporting materials entitled, "Youth Homicide: A Public Health Crisis." For this film, Romano was nominated for an Emmy award in the Best Producer category.

In 1985, Romano accepted a position in the White House Drug Abuse Policy Office as a detailee from the Department of Health and Human Services working on public awareness and communications campaigns for drug abuse and AIDS policy. Romano was promoted as Director of Communications for the Drug Abuse Policy Office in April 1988. He remained in the White House through 1988.

Since leaving the White House, Romano has had multiple positions in the private/non-profit sector including founding Romano & Associates for producing public awareness programs and "America's Strength" which promotes the importance of hiring individuals with disabilities. He has been a member of the President's Committee for People with Intellectual Disabilities. Romano has also served a number of diverse boards of directors, including the United Cerebral Palsy of Central Maryland, Oral Health America, the Professional Baseball Athletic Trainers Society, and the , Committee for Purchase from People who are Blind or Severely Disabled.

Additionally he has advised the Association for People in Supported Employment, the U.S. Business Leadership Network, and other disability employment groups with use a "business to business" approach to promote the hiring of people with disabilities.

In 2007 President George W. Bush nominated Romano as the second Assistant Secretary for Disability Employment Policy at the Department of Labor. He was confirmed in March 2008 and served until the end of the George W. Bush Administration. In 2015, Romano was appointed to the independent federal agency, the National Council on Disability. In March 2018, Senator Mitch McConnell, reappointed Romano for a three year term to the Council and later that month President Trump named Romano as the new Chairman of the National Council on Disability.

Romano is married and has two adult daughters. He lives with his family in Clarksville, Maryl

Scope and Content Note

Romano focused on developing the Drug Abuse Policy Office's (DAPO) communications campaigns. He worked with outside agencies and private companies to incorporate anti-drug abuse and AIDS policy messages into general media campaigns aimed at the wider public.

This collection consists of proposals, memos, letters, newspaper articles, and audio-visual material developed, used or sent to Romano for use during the course of his work. All audio-visual material is stored with Reagan Library Audio-Visual collections for preservation purposes. This collection consists of two series.
