## **Brief Biography**

Elaine L. Morton is a former State Department official specializing in policy planning.

Morton received a bachelor's degree and a Ph.D. from Stanford University. Morton's master's degree is from the Fletcher School of Law & Diplomacy at Tufts University.

Morton began work at the State Department in 1974 as a special assistant to the director of the Bureau of Intelligence and Research. In 1978 she became a member of the Policy Planning staff in the State Department where she periodically briefed senior State Department and White House officials on analysis of Libyan policy options. In June 1985 Dr. Morton worked in the Office of the United States Permanent Representative to the Organization of the American States as an international relations officer.

From August 1985 to October 1986 Dr. Morton was detailed to the National Security Council in the Crisis Management Center where she was the director of Crisis Policy Analysis. Her collection focuses on the economic and political issues in the Middle East, North Africa, and South Asia. In 1986 Dr. Morton returned to the State Department.

Morton retired from the State Department in 1993. She resides in Washington, DC.
