1. CONFIDENTIAL - ENTIRE TEXT.

2. SUMMARY: PRESIDENT CEAUSESCU MET WITH PRESIDENTIAL EMISSARY (AMBASSADOR) WARREN ZIMMERMAN NOV. 22. THE MEETING WAS ARRANGED AT THE LAST MINUTE BECAUSE OF THE CONCURRENT STATE VISIT OF POLISH PRESIDENT JARUZELSKI. AMBASSADOR ZIMMERMANN BRIEFED PRESIDENT CEAUSESCU ON THE RESULTS OF THE GENEVA SUMMIT. FOCUSING ON THE MAIN POINTS OF THE JOINT STATEMENT. PRESIDENT CEAUSESCU EXPRESSED HIS THANKS TO PRESIDENT REAGAN FOR SENDING AMBASSADOR ZIMMERMANN. HE WELCOMED THE SUMMIT PROCESS AND THE STEPS THAT HAD BEEN MADE, BUT SAID HE WAS DISAPPOINTED THAT CONCRETE RESULTS HAD NOT BEEN ACHIEVED IN ARMS CONTROL. CEAUSESCU EXPRESSED SPECIAL CONCERN OVER EUROPEAN INF DEPLOYMENTS AND PARTICULARLY ABOUT DEVELOPMENTS AFTER DECEMBER 31. ZIMMERMANN POINTED OUT THE RECENT U.S. PROPOSAL TO HALT INF DEPLOYMENTS AS OF DECEMBER 31 AND SAID BOTH SIDES FELT PROGRESS HAD BEEN MADE AT GENEVA. AFTER HIS WHIRLWIND MOV. 21 TRIP TO PRAGUE, AND A FULL DAY'S SCHEDULE WITH JARUZELSKI NOV. 22, CEAUSESCU APPEARED TIRED BUT FIT. HE FOLLOWED THE BRIEFING CAREFULLY, AND MADE HIS POINTS IN A RESTRAINED BUT FORCEFUL MANNER. ZIMMERMANN'S LAST-MINUTE MEETING WITH THE PRESIDENT WAS A CLEAR SIGN OF ROMANIAN INTEREST IN THE GENEVA SUMMIT, BUT AN EVEN CLEARER SIGN THAT ROMANIA'S LEADERSHIP PUTS MUCH VALUE ON MAINTAINING AND STRENGTHENING THE DIALOG WITH US. END SUMMARY.

3. PRESIDENT CEAUSESCU RECEIVED AMBASSADOR WARREN ZIMMERMANN, PRESIDENT REAGAN'S SPECIAL EMISSARY ON THE GENEVA TALKS, THE EVENING OF NOV. 22. WHILE WE HAD HINTS, THE FIRST DIRECT MENTION OF SUCH A MEETING CAME AT THE END OF A LUNCH HOSTED BY DEPUTY FOREIGN MINISTER TRAIAN POP (OTHER MEETINGS REPORTED SEPTEL), WHEN ZIMMERMANN WAS ASKED IF HE COULD STAY ANOTHER DAY TO MEET THE PRESIDENT. TOLD THAT ZIMMERMANN'S SCHEDULE DID NOT ALLOW THAT. THE ROMANIANS APPARENTLY WENT INTO HIGH GEAR TO ARRANGE A MEETING THAT NIGHT. THE POSSIBILITY OF A MEETING WITH CEAUSESCU WAS AGAIN MENTIONED, BUT NOT CONFIRMED, DURING LATER TALKS WITH FOREIGN MINISTER VADUVA. FINALLY, AT A LATE AFTERNOON MEETING, CENTRAL COMMITTEE SECRETARY PETRU ENACHE TOLD ZIMMERMANN, IN EFFECT, HE HAD LITTLE TO DISCUSS SINCE THE PRESIDENT WOULD SEE HIM THAT EVENING. IMMEDIATELY AFTER CEAUSESCU SAV JARUZELSKI OFF AT THE AIRPORT. ENACHE TOLD ZIMMERMANN HIS PLANE, A BULGARIAN AIRLINE FLIGHT, WOULD BE HELD FOR HIM AT THE AIRPORT, SEVERAL HOURS IF NECESSARY.

- 4. THE MEETING WITH CEAUSESCU LASTED ABOUT 50 MINUTES. CEAUSESCU WAS ACCOMPANIED BY FOREIGN MINISTER VADUVA AND THREE HOTETAKERS; AMBASSADOR ZIMMERMANN WAS ACCOMPANIED BY CHARGE AND POLOFF.
- 5. CEAUSESCU WELCOMED ZIMMERMANN. ZIMMERMANN REPLIED BY EXPRESSING HIS GRATITUDE, AND THAT OF PRESIDENT REAGAN FOR CEAUSESCU'S RECEIVING HIM ON SUCH A BUSY DAY. HE SAID HE HAD JUST COME FROM THE FIRST MEETING BETWEEN U.S. AND SOVIET LEADERS IN SIX YEARS. PRESIDENT REAGAN HAD ASKED HIM TO INFORM PRESIDENT CEAUSESCU ABOUT THE MEETING AND OUR FUTURE RELATIONS WITH THE SOVIET UNION, AND WOULD BE KEENLY INTERESTED IN HEARING

PRESIDENT CEAUSESOU S VIEWS ON THE SUBJECT.

- 6. ZIMMERMANN TOLD CEAUSESCU THAT PRESIDENT REAGAN WENT TO GENEVA WITH THE INTERTION OF MAKING A FRESH START. WE UNDERSTOOD THAT RELATIONS WITH THE USSR HAVE NOT BEEN GOOD AND THAT IT WAS NECESSARY TO PUT THEM ON A MORE STABLE BASIS THROUGH A SERIES OF CONCRETE STEPS. IN OUR VIEW WE ACHIEVED THIS. WE BELIEVE THAT THE COMMUNIQUE AGREED TO AT GENEVA PROVIDES A BASIS FOR PUTTING THIS PROCESS IN PLACE.
- 7. OF THE FIFTEEN HOURS OF MEETINGS BETWEEN THE TWO LEADERS, ZIMMERMANN SAID, APPROXIMATELY SIX WERE SPENT IN DIRECT MEETINGS BETWEEN THE TWO. RT

WITH ONLY TRANSLATORS PRESENT. THE PERSONAL RELATIONSHIP BETWEEN THE TWO LEADERS WAS A GOOD ONE. BASED ON THE FRANKNESS AND CANBOR OF THE DISCUSSIONS AS WELL AS A MUTUAL DESIRE FOR PEACE. WE DID NOT HIDE OUR DIFFERENCES. INDEED, THERE WERE DIFFERENCES ON ISSUES OF GREAT IMPORTANCE. THE JOINT STATEMENT REFERS TO DIFFERENCES, AS WELL AS TO THE HOPES OF BOTH LEADERS.

8. ZIMMERMANN SAID THAT A GREAT DEAL OF ATTENTION WAS PAID TO AN ISSUE OF GREAT IMPORTANCE TO PRESIDENT CEAUSESCU, ARMS CONTROL. IN PARTICULAR THERE WAS DISCUSSION REGARDING THE NUCLEAR AND SPACE TALKS NOW GOING ON IN GENEVA (IN WHICH. ZIMMERMANN NOTED, HE HAD PERSONALLY TAKEN PART). ALTHOUGH THERE WAS NO AGREEMENT IN THIS AREA, THERE WAS A MUTUAL DECISION TO ACCELERATE THE NEGOTIATIONS IN THE HOPE AGREEMENTS CAN BE REACHED. SPECIAL EMPHASIS WILL BE PLACED ON THOSE AREAS WHERE THERE IS ALREADY COMMON GROUND: STRATEGIC WEAPONS, WHERE EACH SIDE ADVOCATES A 50 PERCENT REDUCTION, AND INF. WHERE BOTH SIDES HAVE EXPRESSED A DESIRE TO REACH AN INTERIM AGREEMENT. BOTH SIDES AGREE, ZIMMERMANN UNDERLINED, THAT A NUCLEAR WAR CANNOT BE WON AND MUST NOT BE FOUGHT. THIS IS A VERY IMPORTANT REALIZATION. EACH SIDE PLEDGED NOT TO SEEK NUCLEAR SUPERIORITY.

9. REGIONAL PROBLEMS WERE THE SE GENEVA AGENDA. PRESIDENT REAGAN APPRO AREA FROM THE POINT OF VIEW THAT REGIONAL CAUSE DISTRUST. ARMS RACE. THE TWO LEADERS DISCUSSED ALL MAJOR AREAS OF CONFLICT IN THE WORLD. IT WAS AGREED

TOR: 327/1726Z CSN: HCE201 THAT THERE WOULD BE FUTURE MEETINGS BETWEEN FOREIGN MINISTERS AND BETWEEN EXPERTS, ON A REGULAR BASIS, TO CONTINUE DISCUSSION OF THESE ISSUES.

> 18. THE THIRD AGENDA ITEM -- HUMAN RIGHTS -- IS OF GREAT IMPORTANCE TO PRESIDENT REAGAN. THERE WAS A ONE-HOUR PRIVATE DISCUSSION BETWEEN PRESIDENT REAGAN AND GENERAL SECRETARY GORBACHEV ON THIS ISSUE. IN THAT DISCUSSION BOTH EXPRESSED THEIR VIEWS VIGOROUSLY.

11. BILATERAL ISSUES WERE FOURTH ON THE GENEVA AGENDA, ZIMMERMANN TOLD CEAUSESCU. THE TWO SIDES MADE SPECIFIC AGREEMENTS TO STRENGTHEN BILATERAL RELATIONS. MOST IMPORTANT, THEY AGREED TO HOLD SUMMIT MEETINGS IN 1936 IN THE UNITED STATES, AND IN 1987 IN THE SOVIET UNION. THE TWO SIDES ALSO AGREED THAT FOREIGN MINISTERS WOULD MEET MORE REGULARLY AND WOULD DIG DEEPLY INTO MUTUAL PROBLEMS, ESPECIALLY ON REG ONAL ISSUES.

12. ON PEOPLE-TO-PEOPLE EXCHANGES, THE TWO SIDES AGREED TO EXPAND SCIENTIFIC, CULTURAL AND EDUCATIONAL EXCHANGE. THIS IS AN ISSUE OF PARTICULAR INTEREST TO PRESHDENT REAGAN THO MADE IT THE SUBJECT OF HIS LAST SPEECH BEFORE HE WEST TO GENEVA.

13. ZIMMERMANN CONCLUDED BY SAYING THAT WHILE IT WOULD BE POSSIBLE TO DISCUSS OTHER ARMS CONTROL AND BILATERAL SUBJECTO COVERED AT THE SUMMIT IN VIEW OF THE PRESIDENT'S ALREADY-FULL DAY, HE WOULD SUMMARIZE. IN THE OVERALL, HE SAID, THE GENEVA SUMMET COULD BEST BE SUMMED UP BY SAYING THAT PRESIDENT REAGAN REALIZED IT WAS NOT POSSIBLE TO CHANGE UNITED STATES-COVIET RELATIONS COMPLETELY IN TWO DAYS OF MEETINGS. HE ALSO REALIZES THAT THERE ARE STRONG (BEOLOGICAL AND PHILOSOPHICAL DIFFERENCES BETWEEN THE TWO COUNTRIES AND THAT THESE DIFFERENCES WILL ENDURE. PRESIDENT REAGAN BELIEVES STRONGLY, HOWEVER, THAT THE TWO GOVERNMENTS HAVE AN OBLIGATION -- NOT ONLY TO THEIR OWN PEOPLES BUT TO ALL THE PEOPLES OF THE WORLD -- TO WORK FOR PEACE. COOPERATION BETWEEN THE TWO COUNTRIES IS THEREFORE NECESSARY. HE BELIEVES THAT WITH THE MEETING AT GENEVA WE HAVE BEGUN THIS PROCESS. PRESIDENT REAGAN, CONTINUED SIMMERMANN, ASKED ME TO CONVEY

HIS DETERMINATION TO CONTINUE THIS PROCESS AND PUT IT ON A MORE PERMANENT BASIS. ZIMMERMANN CONCLUDED BY TELLING PRESIDENT CEAUSESCU HE WOULD BE HAPPY TO ANSWER ANY QUESTIONS THE PRESIDENT HAD, AND TO CONVEY PRESIDENT CEAUSESCU'S THOUGHTS ON THESE MATTERS TO PRESIDENT REAGAN.

14. CEAUSESCU THANKED PRESIDENT REAGAN AND AMBASSADOR ZIMMERMANN FOR THE INFORMATION ABOUT THE GENEVA MEETING. HE SAID HE HAD BEEN BRIEFED THE PREVIOUS AFTERNOON (NOV. 21) BY GENERAL SECRETARY GORBACHEV IN PRAGUE, AND THAT HE APPRECIATED PRESIDENT REAGAN'S SENDING AMBASSADOR ZIMMERMANN TO PROVIDE HIM WITH THE U.S. POINT OF VIEW ON THE MEETINGS.

15. "WE WILL COMPARE THE TWO BRIEFINGS," CEAUSESCU SAID. "THEY AGREE ON THE DIRECTIONS THAT THINGS WENT. WE BELIEVE THAT THE MEETING BETWEEN GENERAL SECRETARY GORBACHEV AND PRESIDENT REAGAN WAS VERY IMPORTANT TO US. THERE WAS NO DOUBT THAT A LONG AND THOROUGH DISCUSSION OF THE ISSUES TOOK PLACE, AND THERE IS NO DOUBT OF THE NEED TO CONTINUE DISCUSSIONS BETWEEN THE TWO SIDES. "

16. SPEAKING BOTH PERSONALLY AND ABOUT OTHER HEADS OF STATE WITH WHOM HE HAS DISCUSSED THE MATTER. CEAUSESCU SAID HE DID NOT EXPECT THAT THIS FIRST MEETING WOULD RESULT IN MAKING GREAT PROGRESS, BUT HE KNEW THAT SOME OF THESE OTHER LEADERS EXPECTED MORE PROGRESS. AS FAR AS HE WAS CONCERNED. CEAUSESCU SAID, HE KNEW THAT ONE COULD NOT EXPECT TOO MUCH. "CERTAINLY, THE FACT THAT THE DISCUSSIONS OCCURRED IS IMPORTANT. ALSO VERY IMPORTANT IS

> 17. BUT, HE CONTINUED, "THE QUESTION THAT WE IN ROMANIA ASH, AND PERHAPS IN THE REST OF THE WORLD AS WELL, IS 'WHAT IS GOING TO HAPPEN WITH THE ARMS RACE?" NEGOTIATIONS STARTED IN GENEVA IN MARCH, MANY PROPOSALS HAVE BEEN TABLED BY BOTH SIDES. BUT IN PRACTICAL TERMS, NO AGREEMENTS WERE REACHED. CEAUSESCU SAID HE UNDERSTOOD THAT THE EMPLACEMENT OF INTERMEDIATE-RANGE MISSILES CONTINUES IN EUROPE AND THE COVIET COUNTER-DEPLOYMENTS THAT WERE "MADE IN A CERTAIN PERIOD OF TIME ALSO REMAIN IN PLACE. " THIS SUMMER THE SOVIET UNION STOPPED DEPLOYING ITS COUNTERMEASURES UNTIL THE END OF THE YEAR. "BUT WHAT WILL HAPPEN AT THE END OF THIS YEAR? IN JANUARY WILL DEPLOYMENTS IN EUROPE CONTINUE ON BOTH SIDES' THIS IS A BIG CONCERN HERE IN EUROPE. PEOPLE OF ALL PHILOSOPHICAL CONVICTIONS SHARE A GREAT LEVEL OF CONCERN ON THIS MATTER. CHRISTIANS AND INTELLECTUALS ARE PERHAPS EVEN MORE CONCERNED THAN OTHERS. SO THE CUESTION IS WHEN WILL THE DEPLOYMENT OF NUCLEAR WEAPONS IN EUROPE BE STOPPED?

18. CEAUSECC, VELOCMED THE UC NO DECICION THAT A NUCLEAR WAR CANNOT BE WON AND SHOULD NEVER BEGIN. HIS POINT, HE SAID, IS THAT ANY WAR BETWEEN THE TWO POWERS OF BETWEEN THE TWO BLOCS WOULD INEVITABLY BECOME A NUCLEAR WAR. "IN OTHER WORDS THERE IS NO POSS BILLTY OF ANY KIND OF WAR BETWEEN

THE TWO NATIONS AND THE TWO BLOCK." HE ALSO WELCOMED THE DECISION THAT NUCLEAR SUPERIORITY WOULD NOT BE SOUGHT, BUT SAID THAT HE HIMSELF WOULD HAVE LIKED TO SEE THAT "THE MECESSAPY CONCLUSIONS" HAD BEEN DRAWN FROM THAT STATEMENT

19. CEAUSESCU SAID HE UNDERSTOOD THAT THERE COULD NOT BE AGREEMENTS IN ALL AREAS IN TWO DAYS, BUT THAT THE SUMMET WAS WELL PREPARED FOR, AND ARMS CONTROL NEGOTIATIONS HAD BEGUN IN GENEVA IN MARCH. ROMANIA AND OTHER COUNTRIES EXPECTED AN AGREEMENT, AT LEAST IN PRINCIPLE, THAT THE DEVELOPMENT OF NEW WEAPONS AND NUCLEAR TESTS WOULD BE STOPPED WHILE NEGOTIATIONS WERE BEING HELD. THIS WOULD

HAVE BEEN PROOF THAT THE LEADERS OF THE TWO

LARGEST NUCLEAR POWERS WERE DETERMINED TO ACHIEVE REAL NUCLEAR DISARMAMENT.

20. CEAUSESCU SAID HE WISHED TO MAKE SOME OTHER POINTS -- "SINCE BOTH SIDES HAD AGREED THEY WOULD REDUCE STRATEGIC WEAPONS BY 50 PERCENT, AND REACH AN INF AGREEMENT, WHY CONTINUE TO PRODUCE NEW TYPES OF WEAPONS AND ESPECIALLY THOSE TYPES THAT WILL BE INTERDICTED? IN OTHER WORDS THE WORLD EXPECTS. WE EXPECT. SOME TYPE OF AGREEMENT THAT WOULD SET A CERTAIN COURSE TOWARDS NUCLEAR DISARMAMENT." CEAUSESCU SAID HE "HOPED WE WERE NOT GOING TO WAIT A LONG TIME FOR THIS TO OCCUR."

21. IN SHORT, CEAUSESCU SAID, HE HOPED THERE WILL BE AGREEMENTS REACHED AT GENEVA. IT WOULD HAVE BEEN GREATLY DESIRABLE THAT WORK FOR THE NEXT SUMMIT MEETING COULD HAVE FOCUSED ON IMPLEMENTING ACCORDS ALREADY REACHED. CEAUSESCU SAID HE WOULD WELCOME PRESIDENT REAGAN USING HIS INFLUENCE TO COMPLETE AGREEMENTS TOWARDS THAT GOAL. "IT IS CLEAR THAT POLITICAL WILL TO ACHIEVE THAT GOAL IS NECESSARY -- AND IT IS NECESSARY ON BOTH SIDES. "

22. CEAUSESCU SAID HE WOULD LIKE TO APPEAL TO PRESIDENT REAGAN "THAT HE AND THE UNITED STATES ADDRESS EVERY EFFORT TOWARDS ACHIEVING AGREEMENTS." IN PRAGUE GENERAL SECRETARY GORBACHEV TOLD CEAUSESCU AND THE OTHER LEADERS HE WAS "READY AT ANY MOMENT TO GO ANYWHERE TO REACH AN AGREEMENT." CEAUSESCU SAID HE BELIEVED THIS STATEMENT WAS EVEN INCLUDED

TOR: 327/17337 CSN: HCF204 IN THE COMMUNIQUE FROM THE PRAGUE SUMMIT. HE SAID HE HOPED THAT PRESIDENT REAGAN WAS EQUALLY WILLING. THE TWO SIDES CAN DO ALOT, HE SAID, THOUGH IT SHOULD BE RECOGNIZED THAT CHANGES IN THE WORLD MAY COMPLICATE THE PROCESS IN THE FUTURE.

> 23. CURRENTLY THERE ARE TWO MUCLEAR POWERS THAT DOMINATE THE WORLD'S ARSENAL OF NUCLEAR WEAPONS AND, IF IT IS SO DIFFICULT TO GET THEM TO AGREE ON THINGS, "HOW MUCH HARDER WOULD IT BE TO REACH AGREEMENT IF THERE WERE THREE OR FOUR NATIONS INVOLVED?" THEREFORE WHILE WE AGREE WITH THE WORDS OF THE STATEMENTS SQUED AT GENEVA, AND VALUE YOUR VISIT HERE. AT THE CAME TIME WE REGRET THE LACK OF AGREEMENTS IN GENEVA."

24. CEAUSESCU SAID "IT COULD BE SEEN" HE WAS "SPEAKING FRANKLY" TO AMBASSADOR ZIMMERMANN, AND HE THANKED PRESIDENT REAGAN FOR INFORMING HIM ABOUT THE TALKS. "IT IS TO BE HOPED THAT MEETINGS AT THE LEVEL OF FOREIGN MINISTER WILL CONTINUE," ESPECIALLY ON REGIONAL ISSUES, "BUT THE U.S. AND THE USSR, AND THEIR LEADERS, COULD HAVE DONE MORE" TO REACH AGREEMENT. 'I DON'T SAY THAT THEY COULD HAVE SOLVED ALL THE PROBLEMS BUT (MORE) PROGRESS COULD HAVE BEEN MADE. WHAT ABOUT THE MIDDLE EAST? THIS IS AN AREA OF GREAT MPOFTANCE TO THE WORLD. WHAT ABOUT RECO. AND THE TRANSTRAC CONFLICT?" SAID PRESIDENT FEAGAN NED INFORMED HIM BEFOREHAND THAT HE WOULD RAISE THESE TOPICS AT GENEVA. CEAUSESCU SAID HE CONSIDERED THESE TWO TO BE THE MOST ESSENTIAL ESSUES.

25. CEAUSESCU SAID HE HAD ONE MORE POINT: "MANY -DEVELOPING COUNTRIES (ROMANIA WAS NOT AMONG THEM) EXPECTED THAT AT LEAST A VERY SHORT MENTION OF THEIR PROBLEMS WOULD BE MADE AT THE MEETING BECAUSE THE SITUATION OF THESE COUNTRIES IS VERY DIFFICULT WITH ECONOMIC PROBLEMS AND THE PROBLEM OF HEAVY DEBTS. IN OTHER WORDS, I AM CONCERNED WITH WHAT HAD NOT BEEN ACHIEVED" AT GENEVA.

26. "IT IS A SIMPLE FACT," CEAUSESCU NOTED, "THAT . CONTINUING PROBLEMS IN THE WORLD WILL MAKE IT MORE DIFFICULT TO ACHIEVE AGREEMENTS IN THE FUTURE. IT IS NECESSARY THEREFORE TO CONTINUE THIS PROCESS AS LONG AS PROBLEMS EXIST, AND HOPE THAT EVENTS WILL

- 27. "GORBACHEV AND THE UNITED STATES INFORM US THAT THE TWO SIDES HAVE DETERMINED TO ACCELERATE NEGOTIATIONS," CEAUSESCU SAID. "THAT MEANS THAT YOU AT THE NEGOTIATIONS" (INQUIRY WHETHER ZIMMERMANN WAS PART OF THE NEGOTIATING TEAM, WHICH ZIMMERMANN CONFIRMED) "HAVE A HEAVY RESPONSIBILITY TO CARRY OUT THE TASK YOUR TWO LEADERS HAVE SET FOR YOU -- TO CONCLUDE AN AGREEMENT AS QUICKLY AS POSSIBLE."
- 28. CEAUSESCU CONCLUDED BY AGAIN THANKING PRESIDENT REAGAN FOR SENDING AMBASSADOR ZIMMERMANN TO INFORM HIM OF DETAILS OF THE MEETING AND THANKED ZIMMERMANN FOR CARRYING THE MESSAGE.
- 29. ZIMMERMANN SAID HE WISHED TO MAKE TWO SHORT POINTS. ON ARMS CONTROL, HE SAID WE SHARE YOUR CONCERN AND HOPES. EACH GOVERNMENT HAS THE OBLIGATION YOU HAVE MENTIONED TO REACH AGREEMENTS. WE HAVE READ WITH CARE THE (ROMANIAN) GRAND NATIONAL ASSEMBLY'S APPEAL ON THIS SUBJECT, AND WE TAKE SERIOUSLY THE CALL FOR EACH SIDE TO ACCELERATE THE NEGOTIATIONS. WE BELIEVE THAT PROGRESS WAS MADE AT THE TALKS IN GENEVA AND WE FEEL THAT THE JOINT DECLARATION IS AK HPORTANT BASIS TO BUILD ON.
- 38. IN REGARD TO PRESIDENT CEAUSESCU'S QUESTION AS TO WHEN INF DEPLOYMENTS WILL STOP, AMBASSADOR ZIMMERMANN NOTED THAT IN OUR NST PROPOSAL THE DEPLOYMENT WOULD STOP ON DECEMBER 31. WE WOULD STOP DEPLOYMENT OF PERSHING 2 AND CRUISE MISSILES

- 31. FINALLY, ZIMMERMANN SAID, THE INTERESTS AND CONCERNS OF DEVELOPING COUNTRIES WERE VERY MUCH ON PRESIDENT REAGAN'S MIND IN MEETING WITH GORBACHEV. THESE CONCERNS WERE REPRESENTED IN PRESIDENT REAGAN'S COMMITMENT TO END THE ARMS RACE, AND IN THE SPEECH PRESIDENT REAGAN MADE TO THE UNITED NATIONS ON REGIONAL ISSUES.
- 32. COMMENT. THE ROMANIANS WENT TO GREAT LENGTHS
  TO ENSURE THAT CEAUSESCU MET WITH ZIMMERMANN. THIS
  WAS PROBABLY MOTIVATED IN PART BY ROMANIA'S DESIRE
  TO APPEAR EVENHANDED -- AFTER GOING TO PRAGUE THE
  DAY BEFORE TO HEAR GOBB+CHEV, THEY WANTED TO MAKE
  THE EFFORT TO HEAR OUR SIDE -- IN PART BY CEAUSESCU'S
  PERSONAL INTEREST IN ARMS CONTROL, AND IN PART
  BY ZIMMERMANN'S PRESIDENTIAL EMISSARY TITLE, WHICH
  GAVE HIM THE PROTOCOLAR- STATUS TO MEET WITH
  CEAUSESCU.
- 33. IN THE MEETING, CHAUSESCH WAS FATIGUED, BLT
  FOLLOWED I MMERMANN C BRIEFING CLOSELY. CHAUSESCI
  WAS AT TIMES ANIMATED. ESPECIALLY ON THE SUBJECT
  OF THE NEED FOR SPEEDY AGREEMENTS AND ON INF.
  HE EXPRESSED HIS DISAPPOINTMENT WITH THE FAILURE
  TO ACHIEVE CONCRETE ARMS REDUCTION PROPOSALS CLEARLY
  AND FORCEFILLY, BUT IN TERMS OF REGRET OVER A LOST

OPPORTUNITY, RETHEF THAN IN AN ACCUSATORY OF CONFRONTATIONAL TONE. UNLIKE HIS PUBLIC ARMS CONTROL STATEMENTS, HE DID NOT MENTION ONCE THE "MILITARIZATION OF SPACE," AND WAS THUS ADDRESSING MAINLY THE U.S. AGENDA FOR GENEVA.

34. CLEARLY CEAUSESCU PLACES A HIGH VALUE ON THIS TYPE OF PERSONAL DIPLOMACY AND DIALOG WITH HEADS OF STATE. WHILE THESE MAY NOT PRODUCE NOTABLE SUBSTANTIVE GAINS, AND CHOULD HOT BE ALLOWED TO PAPER OVER OUR DIFFERENCES, THEY DO PROVIDE AN OPPORTUNITY TO ENGAGE THE ATTENTION OF ROMANIA'S ULTIMATE DECISION-MAKER, TO ADDRESS MAJOR CONCERNS ON BOTH SIDES, AND THUS TO STEER OUR BILATERAL RELATIONSHIP IN A MORE POSITIVE DIRECTION. END COMMENT.

2. SUMMARY. IN A SPEECH TO ARMY LEADERS DEC. 17 PRESIDENT CEAUSESCU SAID THAT ROMANIA WOULD FULFILL ITS WARSAW TREATY COMMITMENTS BY STRENGTHENING ITS OWN ARMED FORCES TO PARTICIPATE IN COMMON DEFENSE. CONTRARY TO SOME WESTERN PRESS REPORTS, THE SPEECH WAS IF ANYTHING WEAKER IN ITS FORMULATION ON WARSAW PACT COOPERATION THAN PREVIOUS CEAUSESCU LANGUAGE. THE NEW MINISTER OF DEFENSE, GENERAL VASILE MILEA, TOLD THE AMBASSADOR ON DECEMBER 21 THAT THERE WAS NO CHANGE IN ROMANIA'S MILITARY COLLABORATION WITH THE WARSAW PACT -- "WE WILL RESPECT OUR OBLIGATIONS, BUT DUR CURRENT FORCES

. . . ARE NOT UNDER ANY OUTSIDE HIGH COMMAND." END SUMMARY.

3. IN A DECEMBER 17 SPEECH (THE TEXT OF WHICH WAS PUBLISHED IN ALL MAJOR ROMANIAN DAILIES) TO A MEETING TO REVIEW THE PERFORMANCE OF THE HILITARY'S COMMAND AND PARTY LEADERS, PRESIDENT CEAUSESCU DEVOTED ONE OUT OF 41 PARAGRAPHS TO THE WARSAW PACT. HE SAID:

WE MUST ALSO DEVELOP THE FEELING OF COOPERATION WITH THE ARMIES OF THE WARSAW TREATY MEMBER STATES, WITH OTHER FRIENDLY ARMIES. WE ARE FIRMLY RESOLVED TO FULFILL, UNDER THE CURRENT CONDITIONS OF THE INTER-NATIONAL SITUATION, THE PLEDGES WE HAVE ASSUMED AS WARSAW TREATY ORGANIZATION (WTO) MEMBERS REGARDING THE DEFENSE OF OUR COUNTRIES AGAINST AN IMPERIALIST AGGRESSION, THE DEFENSE OF THE PEACEFUL LABOR AND INDEPENDENCE OF OUR COUNTRIES. WE BELIEVE THAT THE FULFILLMENT OF THESE ORI IGATIONS ENTAILS EXACTLY THE STRENGTHENING OF THE CAPABILITIES OF OUR ARMED FORCES, A BETTER COOPERATION AMONG ALL WEAPONS AND UNITS -- BECAUSE IT IS ONLY ON THE STRENGTH AND CAPARILITIES OF FACH ARMY THAT THE CAPABILITY TO FIGHT -- IF NEEDED --

TOGETHER AGAINST AGGRESSION DEPENDS.

4. THE AMBASSADOR ASKED NEWLY-APPOINTED DEFENSE MINISTER MILEA ON DECEMBER 21 WHETHER THE PRESIDENT'S WORDS. MINISTER OLTEANU'S EARLY DECEMBER VISIT TO MOSCOW, AND THE WARSAW PACT'S COMMANDER IN CHIEF, SOVIET MARSHAL V. G. KULIKOV'S DECEMBER 28 VISIT TO BUCHAREST SIGNIFIED CLOSER MILITARY TIES BETWEEN ROMANIA AND THE PACT, AS THE WESTERN PRESS WAS SPECULATING. MILEA STRESSED THAT "OUR FOREIGN POLICY IS NOT CHANGING. " HE SAID THAT ROMANIA'S POLICIES ON MILITARY COOPERATION WITHIN THE WTO WERE "VERY FIRM -- THEY WERE NOT ESTABLISHED YESTERDAY," AND THAT JUST AS THE U.S. IS AWARE OF THIS POLICY, SO ALSO ARE THE SOVIETS. 



- THIS MESSAGE REVIEWS THE CHANCES FOR SUMMARY: PROGRESS ON OUR MAJOR HUMAN RIGHTS ISSUES AND SUGGESTS HOW WE MIGHT HANDLE THEM. IT RECOMMENDS A MODERATE FLOW OF INFLUENTIAL VISITORS TO BUCHAREST, AND SUGGESTS A DERWINSKI VISIT CLOSE TO SOME CRUNCH POINT IN THE ADMINISTRATION OR CONGRESSIONAL DECISION-MAKING PROCESS, WHEN HIS LEVERAGE WILL BE GREATEST. WE HAVE DOUBTS ABOUT URGING CONGRESSIONAL TRIPS, AND ARE CERTAINLY NOT IN A POSITION TO PROMISE THAT ANY CONGRESSIONAL VISITOR WOULD GET A CONCESSION TO BRING HOME. END SUMMARY.
- 3. FOUR TIMES WITHIN THE LAST TWO MONTHS, AMERICAN FIGURES VERY IMPORTANT TO CEAUSESCU HAVE GIVEN HIM OUR PRINCIPAL HUMAN RIGHTS CONCERNS. THEIR PRESEN-TATIONS, WHILE DIFFERING SLIGHTLY IN NUANCE, HAVE FOCUSSED ON SEVEN MAJOR AREAS: BIBLES, NAZARENES, EMIGRATION NUMBERS AND WRITTEN PROCEDURES, SPECIFIC CASES. CHURCH CONSTRUCTION/DESTRUCTION, AND ROMANIA'S PRESENTATION OF ITS CASE IN THE US.
- CEAUSESCU HAS TOTALLY REJECTED IMPORTATION OF PROTESTANT BIBLES. HE HAS LEFT THE DOOR OPEN A SMALL CRACK TO STEPS TOWARD PRINTING THEM IN ROMANIA. THIS WOULD BE HELPFUL, EVEN THOUGH ACTUAL DISTRIBUTION WOULD BE FAR DISTANT, AND PROBLEMATICAL.

  DESPITE HIS FLAT REFUSALS, WE THINK CEAUSESCU MIGHT ALLOW A ONE-TIME IMPORT OF, SAY, 50,000 BIBLES IF HE FELT THIS NECESSARY TO BUY MFN. WE FELL THE BIBLE ISSUE SHOULD CONTINUE TO BE STRESSED, EMPHASIZING THE NEATNESS AND IMPACT OF IMPORTATION BUT ACKNOWL-DOMESTIC PRINTING AS AN ALTERNATIVE, THOUGH EDGING LESS EFFECTIVE.

5. RECOGNITION OF NAZARENES IS HOPELESS AND IT IS NOT PRODUCTIVE TO MAKE THIS A MAJOR POINT IN TALKS WITH THE ROMANIANS. A MORE PROFITABLE APPROACH WOULD BE TO URGE THE ROMANIANS TO AVOID GRATUITOUS HARASSMENT OF NAZARENES. IN WASHINGTON, WE COULD POINT OUT THAT THE PRESS CRITICISM OF THE NAZARENES OF LAST JULY HAS NOT RECURRED, AND PACKAGES FROM AMERICA ARE APPARENTLY GETTING THROUGH.

6. THE ROMANIANS MAY TAKE STEPS TO INCREASE THE EMIGRATION NUMBERS OVER THE LAST FEW MONTHS' FIGURES. WE CAN PUSH FOR THIS, REALIZING, HOWEVER, THAT THE LEVELS WILL NOT REACH THOSE OF 1984 (OR EVEN THOSE OF 1985), AND THE ROMANIANS WILL CONTINUE TO CITE OUR IMMIGRATION RESTRICTIONS AS THE REASON. IN WASHINGTON, WE CAN POINT OUT THAT TCP NUMBERS ARE DOWN IN GOOD PART BECAUSE OF A MARKEDLY SHRINKING POOL OF ELIGIBLES (SEPTEL).

7. WE SEEM TO HAVE FOUND A WAY TO PRESENT LAST SUMMER'S AGREEMENT ON EMIGRATION PROCEDURES TO CONGRESS WITHOUT A WRITTEN US-ROMANIAN AGREEMENT. WE MUST RECOGNIZE, HOWEVER, THAT THE BENEFICIAL EFFECT OF THE NEW PROCEDURES IS LIMITED. VIRTUALLY NONE OF THE ROMANIANS WHO ALREADY HAD EMIGRATION PASSPORTS ARE BETTER OFF, AND THERE IS LITTLE REASON TO EXPECT THIS TO CHANGE. THESE PEOPLE DO NOT WANT TO GIVE UP THEIR EMIGRATION PASSPORTS AND WILL NOT SEEK ROMANIAN CITIZENSHIP AGAIN. EVEN MANY OF THOSE NOW RECEIVING ADEVERINTAS HAD ALREADY LOST THEIR JOBS, AND SOME NEW APPLICANTS

ARE LOSING THEIRS. IN SHORT, THE AGREEMENT SHOULD BE PORTRAYED AS MAKING SIGNIFICANT, BUT LIMITED, PROGRESS.

8. SPECIFIC CASES ARE A WORTHWHILE SUBJECT TO RAISE, BUT WE SHOULD PROBABLY NOT EXPECT ANY MOVEMENT UNTIL JUST BEFORE WHAT CEAUSESCU SEES AS THE CRUCIAL MOMENT ON MFN, PROBABLY SOME TIME THIS SUMMER. RELEASES FROM PRISON ARE USUALLY ANNOUNCED, BY CATEGORY, ON THE OCCASION OF THE TRADITIONAL AUGUST 23 NATIONAL HOLIDAY AMNESTY. IT WOULD BE A MARKED DEPARTURE FROM PAST PRACTICE FOR CEAUSESCU TO PROMISE RELEASE OF A SPECIFIC INDIVIDUAL, PARTICULARLY BEFORE THE ANNIVERSARY, AND ESPECIALLY IF CEAUSESCU FELTHIS PROMISE WOULD BECOME PUBLIC.

FOREIGN FUNDS SEEMS VERY UNLIKELY. CONSTRUCTION WITH LOCAL FUNDS IS NOT RULED OUT, BUT DEPENDS ON A HOST OF LOCAL (AND MANIPULATABLE) FACTORS. IT DOES NOT SEEM ONE OF THE MORE PROMISING SUBJECTS FOR DISCUSSION. DESTRUCTION OF CHURCHES IS LIKEWISE A TANGLED WEB, GIVEN LOCAL PREJUDICES AND URBAN RENEWAL PLANS, AND THE COMPLEXITY OF BUILDING PERMIT CONFLICTS. PERHAPS THE BEST WE CAN DO IS TO GET A DOCUMENTED RECORD OF THE (ALLEGEDLY 15) BAPTIST CHURCHES BUILT IN THE LAST TWO YEARS -- WE WILL SEEK THIS.

- 10. MEASURES TO IMPROVE PRESENTATION OF ROMANIA'S CASE ARE USEFUL -- PREFERABLY AS A COMPLEMENT TO SOME FORWARD ACTION ON OUTSTANDING ISSUES. WE SHOULD WELCOME THEM, BUT NOT TREAT THEM AS A SUBSTITUTE FOR ACTION ON THE ISSUES. PUBLIC RELATIONS MOVES SUCH AS THE JEWISH YOUTH CHOIR WILL PROBABLY HAVE A REAL IMPACT, THOUGH BEST LEFT IN NON-GOVERNMENTAL HANDS.
- THE BEST WAY TO PURSUE ALL THIS, IT SEEMS TO US IS TO HAVE A MODERATE FLOW OF INFLUENTIAL VISITORS TO BUCHAREST AS A COMPANION TO THE REGULAR PRESSURE THROUGH DIPLOMATIC CHANNELS. THE PRESIDENT'S LETTER AND THE SECRETARY'S VISIT WERE VERY IMPORTANT; HAVE BEEN SUPPLEMENTED BY TWO TOP-LEVEL PRIVATE SECTOR EMISSARIES TO CEAUSESCU IN QUICK SUCCESSION. WE THINK ABOUT ONE A MONTH IS NOW ENOUGH, ASSUMING NO CHANGE IN THE CONGRESSIONAL PICTURE. WE NOTE ROSENTHAL MAY COME IN LATE MARCH, AND SPITZER AGAIN AT THE END OF MAY. DEPUTY FOREIGN MINISTER GROZA WILL PROBABLY BE IN WASHINGTON IN EARLY APRIL.

WE COULD CONSIDER A SECRETARIAL, OR EVEN PRESIDENTIAL, LETTER AT SOME POINT, BUT WE SHOULD NOT DUPLICATE PREVIOUS, LARGELY UNSUCCESSFUL, MISSIVES. HOSTILE CONGRESSIONAL REPRESENTATIVES ARE LIKELY TO COME AWAY WITH NEW ARGUMENTS FOR THEIR POSITION. THOSE FAVORABLY INCLINED WOULD NEED AN ASSURED CONCESSION TO BRING HOME TO MAKE THEIR TRIP PROFITABLE, SOMETHING WHICH WOULD BE IMPOSSIBLE TO GUARANTEE AND WHICH WOULD GO AGAINST CEAUSESCU'S STYLE. 4. URSU SAID THAT AS SOON AS GOR LEARNED ABOUT THE CHERNOBYL INCIDENT, IT HAD ALERTED ITS NATIONAL NETWORK OF MONITORING STATIONS TO MEASURE AIR, WATER AND SOIL RADIOACTIVITY. UNTIL THE NIGHT OF APRIL 30/MAY 1, THERE HAD BEEN NO SIGNIFICANT INCREASE IN RADIOACTIVITY -- WHICH HAD RESULTED IN A "COMMUNIQUE" OF THE NATIONAL COUNCIL FOR ENVIRONMENTAL PROTECTION TO THAT EFFECT ON APRIL 30. (NOTE: WE HAVE NOT SEEN THIS REPORT.)

5. DURING THE NIGHT OF APRIL 30/MAY 1, THERE WAS A GREAT INCREASE IN RADIOACTIVITY IN SEVERAL REGIONS OF ROMANIA, ESPECIALLY IN THE NORTHEASTERN PART, URSU CONTINUED. PRESIDENT CEAUSESCU CHAIRED A MEETING OF THE LEADERSHIP TO REVIEW THE RESULTS, WHICH URSU ATTENDED IN HIS OFFICIAL CAPACITY AND AS A PHYSICIST. THE LEADERSHIP DECIDED TO FORM A PARTY/STATE GROUP, HEADED BY ACADEMICIAN ELENA CEAUSESCU TO IMPLEMENT THE NECESSARY MEASURES TO PROTECT THE POPULATION, LIVE-STOCK AND THE COUNTRY IN GENERAL. THE LEADERSHIP ALSO ASKED TO PASS TO U.S. AUTHORITIES, IN CONFIDENCE, THE KEY RADIOACTIVE MEASUREMENTS, AND A REQUEST FOR ASSISTANCE BY SPECIALISTS OR APPROPRIATE MATERIALS TO HELP ANALYZE THE SITUATION IN ROMANIA. URSU SAID THAT SINCE IT WAS A HUMANITARIAN MATTER, GOR DID NOT OBJECT TO SHARING THE INFORMATION WITH OTHER STATES, BUT ASKED REPEATEDLY THAT IT BE HELD CONFIDENTIALLY.

- 8. ASKED WHY THERE MIGHT BE SUCH A SUDDEN INCREASE IN RADIATION, AFTER NORMAL READINGS, URSU SAID HE HAD NO OFFICIAL CONCLUSION. HOWEVER, IT LOOKED TO HIM AS IF ROMANIA HAD BEEN LUCKY AT FIRST, WITH THE WIND HEADED TOWARD POLAND; BUT UNFORTUNATELY THE WIND SHIFTED. HE ATTRIBUTED THE SUDDEN CHANGE IN SOIL RADIOACTIVITY TO AN ACCOMPANYING LIGHT RAIN -- "NOT MUCH RAIN, BUT ENOUGH."
- 9. REQUEST FOR ASSISTANCE. URSU AND IVASCU SAID ROMANIAN SCIENTISTS WANTED INFORMATION FROM U.S. SCIENTISTS ON PREVENTION AND TREATMENT OF HARM FROM THE VARIOUS ISOTOPES. THEY WERE AWARE OF RADIOACTIVE IODINE AND THE THREAT TO THE THYROID; THEY WERE LESS ACQUAINTED WITH CESIUM AND STRONTIUM. WHAT WERE THE ANTIDOTES? WERE THERE NOT ANTIDOTES MORE SOPHISTICATED THAN POTASSIUM IODIDE (WITH WHICH THEY WERE FAMILIAR)? WHAT TREATMENT WAS THERE FOR ANIMALS? WERE THERE OTHER ISOTOPES? SO FAR, ROMANIA HAD NEVER HAD ANY CASES OF RADIATION POISONING, AND URSU REALIZED THAT THE U.S. HAD A GREAT BODY OF EXPERIENCE. THEY THEREFORE REQUESTED WHATEVER WRITTEN MATERIALS OR INSTRUMENTS WOULD BE APPROPRIATE. THEY WOULD WELCOME A VISIT BY SPECIALISTS. THEY WANT KNOWLEDGE, NOT BROAD ADVICE. URSU THEN ADDED, ALMOST AS AN AFTERTHOUGHT, THAT ROMANIA HAD NO INFORMATION WHATSOEVER ABOUT THE REACTOR INCIDENT ITSELF, OTHER THAN THAT AVAILABLE THROUGH THE PRESS, AND SAID HE WOULD APPRECIATE ANY INFORMATION THE U.S. COULD PROVIDE, ON A CONFIDENTIAL BASIS.

AFTER CONSIDERABLE DELIBERATION, WHICH REVEALED STRONG CONGRESSIONAL OPPOSITION AND RESERVATIONS WITHIN MY OWN ADMINISTRATION, I HAVE TODAY SIGNED A REPORT TO THE CONGRESS CONTAINING MY DETERMINATION TO CONTINUE ROMANIAN MFN FOR 1966-87.

THIS WAS A DIFFICULT DECISION FOR ME. IT WILL NOT BE EASY FOR THE ADMINISTRATION TO DEFEND IT IN CONGRESS. IN MY DECEMBER & LETTER, I WROTE OF THE HEARTFELT CONCERNS OF LARGE NUMBERS OF THE AMERICAN PEOPLE REGARDING OBSERVANCE OF RELIGIOUS FREEDOM IN ROMANIA. I CANNOT ACCEPT, AS YOU REPLIF. "" YOUR JANUARY 7 LETTER, THAT THESE CONCERNS ARE ARTIFICIAL OR UNFOUNDED. I PERSONALLY SHARE THEM. AT MY REQUEST, SECRETARY SHULTZ PRESENTED TO YOU ON DECEMBER 15 PROPOSALS REGARDING BIBLES AND TREATMENT OF UNRECOGNIZED RELIGIOUS GROUPS. WHICH WE BELIEVE ARE WELL WITHIN YOUR DISCRETIONARY POWER TO ACCOMMODATE. OUR REPRESENTATIVES HAVE PURSUED THESE POINTS IN NUMEROUS CONVERSATIONS IN BUCHAREST AND WASHINGTON.

AS I SAID IN MY DECEMBER & LETTER, OUR INTEREST HAS NOT BEEN TO UNDERMINE ROMANIAN SOVEREIGNTY OR INTERVENE IN ROMANIAN INTERNAL AFFAIRS, BUT TO UPHOLD THE COMMITMENTS WHICH OUR TWO GOVERNMENTS HAVE MADE TO ADDRESS BASIC HUMAN RIGHTS ISSUES.

TOGETHER WITH THE AMERICAN CONGRESS AND PUBLIC, I SEEK TO ALLAY SERIOUS CONCERNS WHICH THREATEN THE CAREFUL BALANCE IN RELATIONS BETWEEN OUR TWO COUNTRIES. YOUR GOVERNMENT'S UNWILLINGNESS TO ACCOMMODATE THESE CONCERNS HAS PLACED AT RISK OUR POLICY, WHICH BENEFITS ROMANIA SUBSTANTIALLY. I HAVE DECIDED THAT ONCE AGAIN, MY ADMINISTRATION WILL SEEK TO ARGUE THE CASE FOR CONTINUED ROMANIAN MFN BEFORE CONGRESS, RECOGNIZING THAT WE ARE UNDER A SEVERE HANDICAP IN DOING SO. #### EXTENSION OF WAIVER AUTHORITY

PURSUANT TO SUBSECTION 402 (D) (S) OF THE TRADE ACT OF 1974 (HEREINAFTER "THE ACT"). I HAVE TODAY DETERMINED THAT FURTHER EXTENSION OF THE WAIVER AUTHORITY GRANTED BY SUBSECTION 402 (C) OF THE ACT FOR TWELVE MONTHS WILL SUBSTANTIALLY PROHOTE THE OBJECTIVES OF SECTION 402 AND THAT CONTINUATION OF THE WAIVERS CURRENTLY APPLICABLE TO THE PEOPLE'S REPUBLIC OF CHINA. THE HUNGARIAN PEOPLE'S REPUBLIC. AND THE SOCIALIST REPUBLIC OF ROMANIA WILL ALSO SUBSTANTIALLY PROHOTE THE OBJECTIVES OF SECTION 402 OF THE ACT. BY DETERMINATION IS

THE GENERAL WAIVER AUTHORITY CONFERRED BY SECTION 402 (C) OF THE ACT IS AN IMPORTANT MEANS FOR THE STRENGTHENING OF MUTUALLY BENEFICIAL RELATIONS BETWEEN THE UNITED STATES AND CERTAIN COUNTRIES OF EASTERN EUROPE AND THE PEOPLE'S REPUBLIC OF CHINA. AUTHORITY HAS PERHITTED US TO CONCLUDE AND MAINTAIN IN FORCE BILATERAL TRADE AGREEMENTS WITH HUNGARY, ROMANIA, AND THE PEOPLE'S REPUBLIC OF CHINA. THESE AGREEMENTS CONTINUE TO BE FUNDAMENTAL ELEMENTS IN OUR POLITICAL AND ECONOMIC RELATIONS WITH THOSE COUNTRIES, INCLUDING IMPORTANT EXCHANGES ON HUMAN RIGHTS AND EMIGRATION GRANTING OF MFN GIVES U.S. COMPANIES THE MATTERS. ABILITY TO COMPETE IN THOSE MARKETS. MOREOVER, CONTINUATION OF THE WAIVER AUTHORITY HIGHT PERHIT FUTURE EXPANSION OF OUR BILATERAL RELATIONS WITH OTHER COUNTRIES NOW SUBJECT TO SUBSECTIONS 402 (A) AND (B) OF THE ACT. SHOULD CIRCUMSTANCES PERMIT. I BELIEVE THAT THESE CONSIDERATIONS CLEARLY WARRANT THIS RENEWAL OF THE GENERAL WAIVER AUTHORITY.

I CONTINUE TO BELIEVE THAT EXTENDING THE CURRENT WAIVERS APPLICABLE TO HUNGARY. THE PEOPLE'S REPUBLIC OF CHINA, AND ROMANIA WILL SUBSTANTIALLY PROMOTE THE OBJECTIVES OF SECTION HOW OF THE ACT.

I NOTE THE ROMANIAN GOVERNMENT'S CONTINUED RESPONSIVENESS TO OUR CONCERNS AROUT ITS EMIGRATION RESPONSIVENESS TO OUR CONCERNS AROUT ITS EMIGRATION RECORD. HUNGARY HAS CONTINUED TO TAKE A RELATIVELY POSITIVE AND CONSTRUCTIVE APPROACH TO EMIGRATION MATTERS. NEARLY ALL HUNGARIANS WHO ARE ELIGIBLE TO APPLY TO EMIGRATE FOR PURPOSES OF FAMILY REUMIFICATION RECEIVE PERMISSION TO DEPART. THE AMERICAN EMBASSY IN BUDAPEST ISSUED 103 IMMIGRANT VISAS IN 1985, APPROXIMATELY 15 PERCENT MORE THAN IN 1984. THERE IS ONE PENDING DIVIDED FAMILY CASE, BUT A RESOLUTION IS EXPECTED SHORTLY. THERE ARE NO SYSTEMATIC OFFICIAL SANCTIONS IMPOSED ON PERSONS WHO SEEK TO EMIGRATE.

#### -- ROMANIA.

EMIGRATION FROM ROMANIA. BOTH OVERALL AND TO THE UNITED STATES. HAS INCREASED SUBSTANTIALLY IN THE TEN YEARS SINCE THE WAIVER HAS BEEN IN EFFECT. ALL TOLD MORE THAN 354-000 ROMANIANS HAVE ENIGRATED TO THE (U.S.) ISRAEL, AND THE FEDERAL REPUBLIC OF GERMANY DURING THIS PERIOD. IN 1985. OVER 17-000 ROMANIANS EMIGRATED LEGALLY TO THE FRED U.S. AND ISRAEL. THE AMERICAN ENBASSY IN BUCHAREST ISSUED VISAS OR OTHER DOCUMENTATION TO 2.751 PEOPLE IN 1765 FOR LEGAL DEPARTURE FROM ROMANIA TO THE UNITED STATES. THIS IS SIX TIMES THE PRE-MFN LEVEL. ALTHOUGH THE FIGURE REFLECTS A FALLOFF IN ROMANIAM PASSPORT APPROVALS TO INDIVIDUALS QUALIFIED FOR U.S. ADMISSIONS PROCESSING IN MID-1985. HORE THAN 1-000 RECENT HEW APPROVALS AND CONVERSATIONS WITH THE ROMANIAN GOVERNMENT SUGGEST THAT IT IS TAKING STEPS TO INCREASE THE FLOW TO A LEVEL CONSISTENT WITH U.S. IMMIGRATION AND ADMISSIONS ETHNIC GERMAN DEPARTURES FOR THE FEDERAL PROCEDURES. REPUBLIC OF GERMANY CONTINUED APACE, WITH 13-072 IN THE 1-327 ROMANIAN JEWISH ARRIVALS IN ISRAEL WERE SLIGHTLY BELOW THE AVERAGE FOR THE LAST TEN YEARS. AND EMIGRATION TO ISRAEL HAS NOW REDUCED THE ROMANIAN JEWISH COMMUNITY TO UNDER 25-000 PEOPLE.

ALTHOUGH NUMEROUS PROBLEMS REMAIN IN THE EMIGRATION AREA. THE ADMINISTRATION NOTES THAT THE ROMANIAN GOVERNMENT'S SUBSTANTIAL IMPLEMENTATION OF NEW PROCEDURES FOR EMIGRATION FROM ROMANIA TO THE UNITED STATES WHICH WERE ARRIVED AT LAST YEAR HAS REDUCED MATERIAL AND PHYSICAL HARDSHIPS FOR THE MAJORITY OF PEOPLE DEPARTING FOR THE U.S. SINCE THE MIDDLE OF 1985. 1. (C) SUMMARY. THE ROMANIAN COUNCIL OF STATE PROCLAIMED A WIDE RANGING AMNESTY/SENTENCE REDUCTION JUNE 2. FULL AMNESTY IS GRANTED FOR OFFENSES CARRYING SENTENCES OF THREE YEARS OR LESS. THOSE SERVING SENTENCES OF LESS THAN FIVE YEARS ARE GIVEN FULL REPRIEVES, THOSE SERVING TERMS OF 5-8 YEARS HAVE THEIR TERMS REDUCED BY ONE-THIRD. AND THOSE SERVING SENTENCES OF 8-10 YEARS BY ONE-FIFTH. EXCEPTED FROM THE AMNESTY ARE REPEAT OFFENDERS. THOSE CONVICTED OF MURDER, ROBBERY, ILLEGAL ABORTION, RAPE, CAUSING SERIOUS HARM TO PUBLIC PROPERTY. BRIBERY, INFLUENCE PEDDLING, "VIOLENT OUTRAGE", AND ESCAPE. THE DECREE ALSO ANNOUNCES THAT OFFENSES WHICH DO NOT POSE "THE SOCIAL DANGER OF A CRIME" WILL NO LONGER BE PUNISHED. THIS REFERENCE AND SOME OF THE DETAILS OF THE AMNESTY ARE AS YET UNCLEAR. HOWEVER, IT APPEARS FROM THE TEXT OF THE DECREE THAT LARGE NUMBERS OF THOSE PRESENTLY IN PRISON WILL BE FREED, INCLUDING MANY HUMAN/RELIGIOUS RIGHTS CASES. WE NOTE THAT THE RECENT RELEASE OF DOREL CATARAMA REMAINS EXCEPTIONAL AS HE WOULD NOT HAVE QUALIFIED FOR IMMEDIATE RELEASE UNDER THE TERMS OF THE AMNESTY.

2. (C) THE ANNOUNCEMENT WAS MADE IN CONNECTION WITH ONE OF THE RARE ANNOUNCED MEETINGS OF THE COUNCIL OF STATE. ACCORDING TO PRESS REPORTS THE COUNCIL CONSIDERED A NUMBER OF LAW-RELATED REPORTS. THERE IS, HOWEVER, NO MENTION OF THE MOTIVATION FOR THE AMNESTY. UNLIKE PAST AMNESTIES THERE IS NO

OBVIOUS TIE-IN WITH AN IMPORTANT NATIONAL HOLIDAY. WHATEVER THE REASON WE WELCOME THIS STEP BY THE ROMANIAN GOVERNMENT. IT IS STRONG EVIDENCE THAT POWERS HERE ARE RESPONSIVE TO WORLD PUBLIC OPINION ON HUMAN RIGHTS ISSUES. END SUMMARY.

- 3. (U) ROMANIAN PRESS ANNOUNCED JUNE 3 THAT THE COUNCIL OF STATE HAD MET JUNE 2, AND AMONG OTHER ACTIONS APPROVED A DECREE OF AMNESTY AND REPRIEVES. ALL PAPERS PUBLISHED THE DECREE SUMMARIZED BELOW:
- THE DECREE GRANTS A FULL AMNESTY FOR
- 1. -- CRIMES PUNISHED BY THE PENAL CODE WITH 3-YEAR PRISON TERMS AND/OR A FINE;
- AND A FULL REPRIEVE OF SENTENCES FOR
- 2. -- CRIMES PUNISHED BY PRISON TERMS UP TO 5 YEARS, INCLUDING THOSE TO WHICH FINES WERE ADDED BY THE COURT; YOUNG PEOPLE UNDER AGE FALLING IN THIS CATEGORY WILL NO LONGER BE SENT TO SPECIAL "RE-EDUCATIONAL SCHOOLS:"
- AND A PARTIAL PARDON AS FOLLOWS
- 3. -- PRISON TERMS BETWEEN 5-8 YEARS WILL BE REDUCED BY 1/3;
- -- PRISON TERMS BETWEEN 8-10 YEARS WILL BE REDUCED BY 1/5.
- THE AMMESTY RULES OUT
- -- THOSE GUILTY OF REPEATED OFFENSES AND THOSE WHO HAVE BEEN SENTENCED TO PRISON TERMS SEVERAL TIMES FOR THE SAME CRIME;
- -- PRISONERS SENTENCED FOR MURDER, SERIOUS INJURIES WHICH CAUSED DEATH, ROBBERY, ILLEGAL ABORTION PRACTICES, RAPE, LOSSES TO PUBLIC PROPERTY "WITH GRAVE OR VERY GRAVE CONSEQUENCES, " BRIBING AND ACCEPTING BRIBES, INFLUENCE PEDDLING, VIOLENT OUTRAGE AND ESCAPE.

WE CANNOT TELL FROM THE DECREE OR PENAL CODE SECTION 18 JUST WHAT OFFENSES ARE TO BE DECRIMINALIZED AS THE LANGUAGE OF THE DECREE SEEMS TO IMPLY. WE WILL CHECK WITH LOCAL LEGAL SOURCES TO TRY AND PIN DOWN THE EXACT PARAMETERS OF THE DECREE. END COMMENT.
- 5. (C) WHILE WE HAVE NO EXACT FIGURES, IT APPEARS TO US THAT LARGE NUMBERS OF PRISONERS COULD BE RELEASED UNDER THE DECREE. INCLUDED IN THEIR NUMBERS SHOULD BE FOUR OPEN BRETHREN -- NICULA, MICH, RUSE, DOCIU (REF A) -- CONVICTED IN BUCHAREST LAST YEAR FOR BIBLE DISTRIBUTION, AND ILIE NEAMTU, AN OPEN BRETHREN LEADER FROM PLOIESTI CURRENTLY JAILED ON EMBEZZLEMENT CHARGES (REF B). THE TERMS OF THE DECREE APPEAR TO APPLY TO ANYONE WHO COULD BE CONSIDERED A POLITICAL PRISONER, INCLUDING WHAT MUST BE A LARGE NUMBER OF PEOPLE CURRENTLY JAILED FOR ATTEMPTING TO LEAVE THE COUNTRY ILLEGALLY AND FOR "PARASITISM" -- BEING WITHOUT A JOB FOR SIX MONTHS.
- 6. (C) WHEN DEPUTY FOREIGN MINISTER GROZA TOLD THE AMBASSADOR OF THE RELEASE OF DOREL CATARAMA (REF C) LAST WEEK, SHE SAID HE "AMONG OTHERS" WOULD BE RELEASED. SHE GAVE NO INDICATION THAT THE OTHERS WOULD INCLUDE SUCH A LARGE NUMBER. IT IS NOTEWORTHY THAT CATARAMA WOULD NOT HAVE QUALIFIED FOR IMMEDIATE RELEASE BECAUSE HIS SENTENCE WAS FOR MORE THAN TEN YEARS. WHILE TWO OTHER RECENTLY RELEASED HUMAN RIGHTS CASES -- CONSTANTIN SFATCU (REF D) AND EMIL MOCANU (SEPTEL) -- WOULD HAVE QUALIFIED FOR RELEASE UNDER THE JUNE 2 DECREE, A THIRD RECENT RELEASE, RADU FILIPESCU (REF E), ALSO WOULD HAVE BEEN INELIGIBLE FOR IMMEDIATE RELEASE UNDER THE AMNESTY DECREE.

BUT WE HAVE NO EVIDENCE IF ROMANIA DID ONCE GIVE DIRECT MATERIAL SUPPORT TO SUCH GROUPS. IT SEEMS TO HAVE DWINDLED, AND PERHAPS EVEN CEASED. CEAUSESCU STILL MAINTAINS THE LINES: ABU JIHAD VISITED HERE OPENLY THIS YEAR, AS DID ARAFAT. OUR CONSULTATIONS GIVE US THE OPPORTUNITY TO REMIND GOR OF THE RISKS OF SUPPORTING RADICAL GROUPS IN THE MIDDLE EAST, AT A TIME WHEN THEY MAY ALREADY BE SOMEWHAT SPEPTICAL OF SYRIA, LIBYA AND EXTREME PLO FACTIONS.

TERRORISM IN ROMANIA IS A SUBJECT OF KEEN CONCERN TO CEAUSESCU, PROBABLY ONE OF THE WORLD'S LEAST-LOVED AUTOCRATS. HE DEMONSTRABLY FEARS ASSASSINATION AND GOES TO EXTRAORDINARY LENGTHS TO PROTECT HIMSELF. HE HAS AN INTERNAL SECURITY SERVICE WHICH IS VERY WELL-FUNDED AND POSSIBLY THE LARGEST, PER CAPITA, IN THE C O N F I D E N T I A L SECTION 02 OF 04 BUCHAREST 09349 EURZEEY: PLEASE HOLD FOR AMIASSADOR FIRK E.O. 12356: DECL: OADR TAGS: PTER, PREL, US, RO OTRA (ADAMS, ALVIN) SUBJECT: DIALOGUE WITH ROMANIA ON TERROFISH. WORLD. YET IN 1984, THIS FERVASIVE DOMESTIC INTELLIGENCE AND SECURITE APPARATUS WAS UNABLE TO FREVENT THE ASSASSINATION OF A JORDANIAN DIPLOMAT, PROBABLY THE RESULT OF A CONSPIRACY SUPPORTED FROM ABROAD. KILLING OCCURRED ALONG A ROUTE CEAUSESCU HIMSELF SOMETIMES TRAVELED TO AND FROM WORK, NOT FAR FROM POLICEMEN ON DUTY. MORE RECENTLY, ABU NIDAL THREATENED TO SEND "HIT TEAMS" AGAINST ARAB PARTICIPANTS IN A PLO MEETING WITH PRO-PLO ISRAELIS HERE. WE DO NOT KNOW HOW THE GOR REGARDED THIS THREAT OF ACTION WITHIN ITS OWN TERRITORY, BUT THE PLO PARTICIPANTS CERTAINLY

TOOK IT SERIOUSLY.

7. CEAUSESCU WILL NOT WISH TO OFFEND ARAB COUNTRIES OR THE PLO THROUGH HIS CONSULTATIONS WITH US ON TERRORISM. THIS CONDITION MAY EVEN APPLY TO SYRIA, ALTHOUGH ROMANIA'S DEALINGS WITH THE PLO, LEBANESE PRESIDENT GEMAYEL AND OTHERS HAVE LED TO POORER ROMANIAN-SYRIAN RELATIONS. THUS WE BELIEVE THAT A LOW-KEY CONSULTATION -- WITHOUT PRESS ANNOUNCEMENTS ON OUR SIDE -- IS ESSENTIAL FOR EVEN MODEST SUCCESS. ROMANIAN PUBLICITY, IF ANY, WILL PROBABLY BE LIMITED TO BRIEFEST MENTION OF AMBASSADOR'S HIGHEST LEVEL OFFICIAL MEETING HERE, IF HE SEES FOREIGN MINISTER TOTU OR CEAUSESCU.

A LOW-KEY APPROACH ALSO HELPS AVOID ANY PUBLIC IMPRESSION THAT WE ARE SOMEHOW CONVEYING TECHNIQUES USABLE AGAINST ANY DOMESTIC NON-TERRORIST OPPOSITION. FRANKLY, WE CANNOT IMAGINE WHAT GOR COULD LEARN FROM US ABOUT DOMESTIC REPRESSION. ALTHOUGH CONTACT WITH THE INTERIOR MINISTRY AND POLICE ORGANIZATIONS IS VERY DESIRABLE, IF WE ARE TO GET ACTIVE SUPPORT AGAINST INTERNATIONAL TERRORISTS. THE FACT THAT GOR HAS NAMED A FOREIGN MINISTRY OFFICIAL AS LEADER OF ITS SIDE WILL HELP PREVENT A FALSE IMAGE FROM BEING CREATED. WE THINK OUR MAIN OBJECTIVES -- DISCOURAGING POSSIBLE ROMANIAN SUPPORT FOR TERRORISTS. AND SEEKING CHANNELS FOR MODEST ROMANIAN HELP AGAINST TERRORISTS -- ARE IN OUR MUTUAL INTEREST AND EASILY DEFENSIBLE WITH THIRD PARTIES.

#### GOR PUBLIC STATEMENTS ON TERRORISM

- 9. PRESIDENT CEAUSESCU HAS PROBABLY SPOKEN OUT AGAINST TERRORISM MORE THAN ANY WARSAW PACT LEADER. HE WAS ONE OF THE FIRST TO EXPLICITLY REJECT TERRORISM AS LEGITIMATE WEAPON IN WARS OF NATIONAL LIBERATION. WE DON'T KNOW HOW STRONGLY HE VOICES THIS THEME IN INNER WARSAW PACT OR CEMA COUNCILS, BUT BELIEVE WE CAN ENCOURAGE THIS BY EXPRESSIONS OF APPRECIATION FOR HIS CURRENT FORTHRIGHT POSTURE.
- CEAUSESCU'S FORMULATION CONDEMNING "STATE TERRORISM" IØ. CAN BE READ AS APPLYING TO ARAB GOVERNMENT SUPPORT FOR TERRORIST GROUPS, TO U.S. ACTION AGAINST LIBYA OR TO ISRAELI ATTACKS IN LEBANON. WE ASSUME HE INTENDED THIS AMBIGUITY. GIVEN CEAUSESCU'S STRONG AND PERSONAL REPRESENTATIONS TO US OVER OUR LIBYAN POLICY, AMBASSADOR ADAMS SHOULD EXPECT TO DISCUSS BOTH LIBYAN AND SYRIAN SANCTIONS.

SATISFIED WITH ROMANIAN COOPERATION AND THEIR SECURITY MEASURES; IF TRUE IT WOULD BE HELPFUL FOR AMB. ADAMS TO NOTE IT. WE ARE NOT AWARE OF ANY SPECIFIC U.S. NEED TO EXPAND THIS TO INCLUDE PERIODIC FAA VISITS TO ROGALNICEANU AIRPORT AT CONSTANTA, ON THE BLACK SEA. Or at timisoara airport in the extreme west, romania's ONLY OTHER INTERNATIONAL AIRPORTS. FOREIGN AIR CARRIERS USE THESE TWO ONLY IN EMERGENCIES. A FEW FLIGHTS BY THE ROMANIAN AIRLINE TAROM USE THEM AS SCHEDULED AIRPORTS OF ENTRY OR EXIT FROM ROMANIA. BUT NOT ON FLIGHTS TO OR FROM THE U.S. 14. WE SHOULD PROPOSE CLOSER BILATERAL JUDICIAL COOPERA-TION, EVEN THOUGH GOR MAY RESPOND WITH POSITIVE RHETORIC RATHER THAN PRACTICAL STEPS. DESPITE AN EXPRESSED GOR DESIRE TO CONTINUE TO PURSUE WAR CRIMINALS, WE HAVE NEVER RECEIVED ANY RESPONSE TO A LONG-AGO JUSTICE DEPARTMENT INQUIRY SUGGESTING COOPERATION IN SCREENING OLD GOR RECORDS OF IN-ABSENTIA CONVICTIONS OR INDICTMENTS. WANTED A LIST WE COULD COMPARE WITH U.S. IMMIGRATION SERVICE COMPUTER RECORDS. WHEREAS IN THE MORE DISTANT PAST THE GOR WAS FAIRLY FORTHCOMING IN RESPONSE TO OFFICIA USG REQUESTS FOR RECORDS, ETC., IN CONNECTION WITH ONGOING U.S. WAR CRIMES INVESTIGATIONS, IN THE FAST TWO YEARS RESPONSE RATE TO THIS TYPE OF REQUEST HAS BEEN ALMOST ZERO. APPARENTLY THE ROMANIAN JUDICIAL APPARATUS NOW PREFERS TO KEEP US OUT OF THEIR RECORDS. WE SHOULD USE AMBASSADOR ADAMS' VISIT TO SEE WHETHER WE COULD GAIN ACCESS IN FUTURE, SPECIFIC CASES RELATED TO TERRORISM, AND THROUGH WHOM.

- 15. CLOSER LIAISON. WE WOULD RECOMMEND GIVING HIGH PRIORITY TO THE ESTABLISHMENT OF ONE OR MORE CHANNELS FOR FAST AND EFFECTIVE EXCHANGE OF INFORMATION ON TERRORIST ACTIVITIES, WHEN IT IS IN OUR INTEREST TO DO SO. THERE IS NO NEED TO MAKE COMMITMENTS ABOUT PROVIDING OPERATIONAL DETAILS -- GOR IS SURE TO WITHHOLD INFORMATION, AND WILL NOT EXPECT WONDERS FROM US. BUT WE NEED SUCH CHANNELS ON TWO LEVELS.
- A. DENYING HAVEN OR ASSISTANCE TO SPECIFIC TERRORISTS IN A FAST-MOVING INTERNATIONAL SITUATION, SUCH AS WHEN ACHILLE LAURO HIJACKERS WERF RELEASED. COOPERATION IN INTERNATIONAL POLICE MATTERS IS NOW VERY POOR. DESPITE ROMANIAN INTEREST IN LARCOTICS CONTROL, WHEN WE ASK FOR INFORMATION ON INTERNATIONALLY-WANTED NARCOTICS OR OTHER OFFENDERS, WE ARE ALMOST ALWAYS TOLD TO PUT THE REQUEST THROUGH INTERPOL CHANNELS. SUMMARY: IN A FORMAL NOTE AND IN PERSONAL COMMENTS, FOREIGN MINISTER TOTU HAS ASKED THAT THE U.S. RE-ANALYZE ITS DECISION TO WITHDRAW ROMANIA AS A BENEFICIARY UNDER THE U.S. GENERALIZED SYSTEM OF PREFERENCES (GSP), DRAWING ON HIS CONVERSATIONS WITH SECRETARY SHULTZ AND DEPUTY SECRETARY WHITEHEAD, TOTU INSISTED THAT LOSS OF GSP STATUS WAS ESSENTIALLY A POLITICAL ISSUE, BASED UPON POLITICAL "MISJUDGMENTS" OF ITS INTERNAL AFFAIRS, AND INCONSISTENT WITH THE U.S. STATED DESIRE FOR CLOSER POLITICAL COOPERATION. ROMANIA COULD NOT BE EXPECTED TO CHANGE ITS TRADE UNION SYSTEM FOR THE SAKE OF TARIFF PREFERENCES. - (A) THE EXCLUSION OF ROMANIA FROM THE LIST (OF GSP BENEFICIARY COUNTRIES) REPRESENTS AN ACT OF DISCRIMINATION, EQUIVALENT TO NEGATING THE STATUS OF A DEVELOPING COUNTRY, CONTRARY TO THE PROVISIONS OF THE TRADE AGREEMENT BETWEEN THE U.S. AND ROMANIAN GOVERNMENTS OF APRIL 2, 1975, ARTICLE ONE, PARAGRAPH THREE, AND THE FUNDAMENTAL PRINCIPLES AGREED IN THE UNCTAD FRAMEWORK WITH RESPECT TO NON-RECIPROCITY AND NON-DISCRIMINATION IN GRANTING TARIFF PREFERENCES.

- (C) THE EXCLUSION OF ROMANIA FROM THE LIST OF BENEFICIARIES CONTRADICTS UNDERSTANDINGS AND DOCUMENTS AGREED BETWEEN THE TWO COUNTRIES WITH RESPECT TO THE DEVELOPMENT OF BILATERAL RAPPORT AND COOPERATION IN INTERNATIONAL AFFAIRS, AS WELL AS WITH DECLARATIONS OF REPRESENTATIVES OF THE U.S. ADMINISTRATION WITH RESPECT TO DEVELOPMENT OF RELATIONS WITH ROMANIA. IN FACT, IT IS REMARKABLE THAT, OF THE 140 COUNTRIES BENEFITING FROM THE SYSTEM OF TARIFF PREFERENCES OF THE U.S., PRACTICALLY THE ONLY ONE WHICH IS TO BE EXCLUDED IS ROMANIA.
- (D) BILATERAL RELATIONS CANNOT BE LASTING C O N F I D E N T I A L SECTION Ø2 OF Ø3 BUCHAREST ØØ175 EXDIS
  AND CANNOT HAVE A STABLE AND EFFICIENT CHARACTER UNDER CONDITIONS IN WHICH ONE OF THE SIDES UNDERTAKES UNILATERAL MEASURES CONTRARY TO THE DEVELOPMENT OF THOSE RELATIONS. EXCLUDING ROMANIA FROM THE LIST (OF BENEICIARIES) SANNOT BUT NESTLY-LY INFLUENCE THE PROCESS OF DEVELOPING RELATIONS BETWEEN THE TWO COUNTRIES.
- (E) THE FOREIGN MINISTRY REQUESTS THE U.S. EMBASSY TO TRANSMIT THESE CONSIDERATIONS TO THE SECRETARY OF STATE GEORGE SHULTZ, TO BE BROUGHT TO THE ATTENTION OF PRESIDENT RONALD REAGAN, TOGETHER WITH THE REQUEST OF THE ROMANIAN SIDE CONTINUE THE DIALOGUE ON THIS SUBJECT WITH THE INTENTION OF MAINTAINING ROMANIA ON THE LIST OF BENEFICIARY COUNTRIES OF THE SYSTEM OF TARIFF

PREFERENCES OF THE USA.

- (F) THE NOTE CONCLUDES WITH A REQUEST FOR A RESPONSE "AS URGENTLY AS POSSIBLE."

FOREIGN MINISTER'S REMARKS

5. TOTU SAID THAT DURING THEIR MEETING LAST FALL, HE AND THE SECRETARY EXPRESSED THEIR CLEAR DESIRE TO IMPROVE BILATERAL RELATIONS. THE SECRETARY, ACCORDING TO TOTU, EXPRESSED HIS SPECIAL ESTEEM FOR ROMANIA'S INDEPENDENT FOREIGN POLICY, AND THESE POINTS HAD BEEN CONVEYED TO PRESIDENT CEAUSESCU.

DURING TOTU'S TWO MEETINGS WITH THE DEPUTY SECRETARY, AND THE DEPUTY SECRETARY'S MEETING WITH PRESIDENT CEAUSESCU, THE U.S. HAD STATED ITS INTENTION TO DEVELOP OUR BILATERAL RELATIONS, AND TOTU HAD FULLY AGREED.

- 6. IN THIS CONTEXT, THE GOR WAS SURPRISED AT THE PRESIDENTIAL DECISION, TOTU CONTINUED. ROMANIA DID NOT EXPECT THE U.S. TO BE MAKING ARGUMENTS ON THE INTERNAL SITUATION HERE, BECAUSE WORKERS HAVE RIGHTS TO ACT AND PARTICIPATE (IN DECISIONS) AT THEIR WORKPLACE. THE GOR DID NOT EXPECT SUCH A DECISION AT A TIME WHEN SO MANY U.S. OFFICIALS HAD EXPRESSED A DESIRE TO IMPROVE BILATERAL RELATIONS.
- 77. THE GOR COULD NOT ACCEPT THE POLITICAL ASPECT OF THE DECISION, TOTU SAID. OF THE ONE-HUNDRED-FORTY COUNTRIES INCLUDED, ONLY ROMANIA WAS AFFECTED. TOTU DISMISSED THE DECISION TO WITHDRAW GSP FROM NICARAGUA, SAYING THAT IT "DID NOT APPLY" (PROBABLY REFERRING TO OUR SANCTIONS). ROMANIA DID NOT INTEND TO MAKE ITS INTERNAL POLITICS A SUBJECT OF DISCUSSION. HE ASKED THAT WE EMPHASIZE TO THE SECRETARY THE POLITICAL ASPECT OF THE PRESIDENT'S DETERMINATION, AND TO NOTE THAT IT WOULD AFFECT NEGATIVELY OUR POLITICAL RELATIONS. ::
- 8. TOTU ASKED WHY WE WOULD CREATE SO GREAT A POLITICAL PROBLEM OVER SUCH A SMALL ECONOMIC QUESTION. THE FIVE OR SIX MILLION DOLLARS IN TRADE AFFECTED BY THE PRESIDENT'S DECISION WAS NOT SIGNIFICANT TO THE U.S. ECONOMY. ROMANIA CAN "ACCEPT THE PLAY OF THE MARKET," BUT NOT A POLITICALLY MOTIVATED DECISION.
- 9. THE U.S. CHARGE REPLIED THAT HE DID NOT WANT TO ANTICIPATE WASHINGTON'S RESPONSE, BUT DID WANT TO EMPHASIZE THAT THE ADMINISTRATION HAD ACTED IN RESPONSE TO A CHANGE IN THE LAW, AND HAD NOT SOUGHT SPECIFICALLY TO ELIMINATE GSP FOR ROMANIA. THE ADMINISTRATION HAD BEEN OBLIGED TO EXAMINE COMPLAINTS THAT A NUMBER OF COUNTRIES WERE INELIGIBLE UNDER THE NEW LAW, AND HAD CONSULTED WITH THE GOR OVER THE MATTER. THE PRESIDENT COULD NOT IGNORE THE LAW AND ITS DEFINITIONS, WHICH LEFT THE ADMINISTRATION LITTLE FLEXIBILITY. ROMANIA'S REPRESENTATIVES HAD MET IN

DECEMBER WITH REPRESENTATIVES OF VARIOUS U.S.G. AGENCIES IN WASHINGTON, WHO HAD ALSO STATED THE REASONS FOR THE DECISION.

- 10. CHARGE REITERATED THAT U.S. POLICY TOWARD ROMANIA HAD NOT CHANGED. NOR HAD THE U.S. CHANGED ITS DESIRE, EMPHASIZED BY THE DEPUTY SECRETARY DURING HIS NOVEMBER VISIT TO BUCHAREST, TO CONTINUE AND DEVELOP BILATERAL RELATIONS.
- 11. TOTU THEN LAUNCHED INTO A MORE EMOTIONAL ANALYSIS OF THE QUESTION. "YOU KNOW CLEARLY," HE SAID, THAT ROMANIA WOULD NOT CHANGE ITS SYSTEM -- "YOU CAN DO WHAT C O N F I D E N T I A L SECTION Ø3 OF Ø3 BUCHAREST ØØ175 EXDIS

YOU WANT. " ROMANIANS, HE ADDED, "HAVE A CLEAR CONCEPTION" OF WORKERS' RIGHTS TO EDUCATINN, WORK, AND PARTICIPATION IN INDUSTRIAL LEADERSHIP. "DO NOT BELIEVE," HE SAID, "THAT WE WILL CHANGE OUR SYSTEM FOR \$6,000,000." HE ADDED THAT ROMANIA DID NOT AGREE WITH THE UNITED STATES ON MANY U.S. INTERNAL ISSUES. IT DID NOT, HOWEVER, SPEAK OF U.S. UNEMFLOY-

MENT, OR THE DRUG PROBLEM, BECAUSE THIS WAS NOT THE WAY TO CARRY OUT A BILATERAL RELATIONSHIP. ROMANIA WAS A MODERATING INFLUENCE ON OTHER COUNTRIES WHO WANTED TO MAKE THESE INTO MAJOR ISSUES.

- 12. TOTU SAID THAT NEITHER HE, NOR OTHER INDIVIDUALS HAD CREATED THE ROMANIAN LABOR SYSTEM: "THE WORKERS DID IT." THE SYSTEM WOULD NOT CHANGE, AND THE GSP DECISION "WILL HAVE NO EFFECT EXCEPT ON OUR POLITICAL RELATIONS." HE SUGGESTED THAT AMERICAN LABOR LEADERS VISIT ROMANIA TO EXAMINE WORKERS' SITUATION HERE. HE COMPARED AMERICAN LABOR LEADERS TO "OTHER CIRCLES" WHO REFUSE TO VISIT ROMANIA BUT CONTINUE TO CONDEMN IT.
- 13. TOTU MENTIONED MFN ONLY ONCE, NOTING THAT MFN ALSO "PUTS ROMANIA UNDER EXAMINATION," AND SAYING THIS PROCESS ALSO UNDERCUT BILATERAL RELATIONS.
- 14. CHARGE COMMENTED THAT THE EMBASSY HAD NOT BEEN INSTRUCTED TO INTERVENE IN INTERNAL AFFAIRS, BUT WOULD DISCUSS ANY ADDITIONAL INFORMATION THAT GOR MIGHT SUGGEST ON THE ISSUE. THE ESSENTIAL POINT WAS THAT USG HAD TO IMPLEMENT THE LAW. TOTU SAID THAT WAS TRUE FOR ROMANIA, TOO.
- 15. COMMENT: THIS DEMARCHE WAS FULLY COORDINATED WITHIN GOR AND WITH PRESIDENT CEAUSESCU. FOLLOWING OUR MANY BRIEFINGS ON THIS SUBJECT, WE ALSO CONCLUDE THAT CEAUSESCU AND TOTU FIND IT HARD TO BELIEVE THAT OUR PRESIDENT 5 HANDS WERE TIED ON THIS ISSUE. WE DO NOT EXCLUDE SOME FORM OF ECONOMIC RETALIATION LATER, BUT THIS DEMARCHE IS AN OFFER OF FURTHER HIGHLEVEL COMMUNICATION. WHETHER OR NOT IT IS POSSIBLE TO RECONSIDER OUR ANALYSIS, IT WOULD BE EXTREMELY USEFUL TO CONVEY PROMPTLY THE PERSONAL VIEW OF THE SECRETARY OR DEPUTY SECRETARY THAT WITHDRAWAL OF GSP DOES NOT IMPLY A REASSESSMENT OF OUR FOREIGN.
