# Soviets Buy 58 Percent Of Argentina's Grains

BUENOS AIRES — Argentina sold 11,302,915 metric tons of grain for export in the first five months of 1983, the National Grain Board said.

The Soviet Union remained Argentina's largest customer, buying 6,553,382 tons of grain, or nearly 58 percent of the January-May total.

Wheat sales totaled 6,475,992 tons during the period, reflecting a record wheat crop, compared with 3,810,546 tons in all of 1982, the board said.

Soviet grain purchases in the first five months included 4,007,855 tons of wheat, compared with a total of 2,741,468 tons in 1982, and 1,433,563 tons of corn, compared with 3,301,498 tons in all of 1982.

The Soviets also placed orders for 1,033,478 tons of sorghum and 78,486 tons of soybeans during January-May, compared with 1982 totals of 5,359,285 and 1,922,870, respectively.

Analysts said although the Soviet Union this year had increased its share of overall Argentine grain exports compared with a year ago, it was not assured total sales would be substantially higher this year.

The U.S.S.R. imported 9,476,660 tons of Argentine grain in 1982, about 57 percent of total exports, but analysts said this figure would not necessarily be considerably higher at the end of this year.

They said traders expected "substantially lower" harvests and export surpluses this year of sorghum and soybeans — both of which the U.S.S.R. bought in large quantities from Argentina in 1982.

There was no official reaction to recent reports from Moscow suggesting Soviet officials had informed an Argentine trade delegation that U.S.S.R. did not plan to increase purchases of Argentine grain this year.

Under a Soviet-Argentine agreement, the U.S.S.R. must buy a minimum of 4.5 million tons of grain annually from Argentina, although actual purchases have run much higher in recent years.

Despite the lack of official comment, official sources confirmed Argentina's trade team had been warned in Moscow the Soviet government's was expecting a good grain crop this year and would not need to increase imports above "planned levels."

Trade sources suggested the Soviet Union wanted to link any increase in imports of Argentine grain to pledges Argentina will step up reciprocal purchases of Soviet machinery and equipment to help redress a Soviet deficit of over \$1.5 billion on trade with Argentina in 1982.

Market analysts, meanwhile, said the trend indicated by the January-May grain export figures may be misleading, since it mainly reflected the effect on export orders of the record wheat crop in the early stages of the grain shipment season.

China was second among Argentina's grain export customers in the first five months of 1983. China's orders totaled 1,631,003 tons, including 1,583,121 tons of wheat.

Japan, Argentina's second-largest customer in 1982, is the third largest so far this year, with purchases of 777,033 tons, mainly sorghum. Iran is the fourth-largest customer, with purchases of 695,566 tons. Italy bought 179,795 tons of grain during January-May.

Total fine grain exports of 16,622,677 tons in 1982 included 5,359,285 tons of sorghum and 5,214,214 tons of corn. Market sources said those totals may not be matched this year.
