- 1. THIS MSG CONSTITUTES FOLLOW-UP TO TAIPE! 4381, WHICH GAVE PERTINENT OATA REGARDING AIRCRAFT. TAIMAN AF STATES THAT THERE WERE NO MISSILES, ONLY AN M39-A3 GUN, ABOARD, BUT HSINHUA BEIJING REPORTED ON 11 AUG THAT AIRCRAFT WAS EQUIPPED WITH TWO SIDEWINDER MISSILES. SMALL HOLES IN TAIL SECTION OF AIRCRAFT WHICH WERE NOT THERE WHEN IT LEFT TAOYUAN AFB WERE VISIBLE ON A MAINLAND TV TAPE, ACCORDING TO LTG CH'EN HSIN'LING, DIRECTOR OF THE TAF GHQ POL WARFARE DEPT.
- 2. REUTERS (BEIJING) REPORTED THAT HUANG, IN NEWS CONFERENCE OF 20 AUG IN GREAT HALL OF PEOPLE, STATED THAT NO PRC PLANES ROSE TO CHALLENGE THE APPROACH OF HIS AIRCRAFT INTO CHINA'S AIR SPACE, BUT OFFERED NO COMMENT OR EXPLANATION AS TO WHY HE COULD FLY INTO CHINA UNCHALLENGED. REUTERS ALSO REPORTED THAT HUANG SAID, "I HAVE LEARNED THAT MILITARY EQUIPMENT HERE IS OUTDATED AND THAT THE LIFE OF THE PEOPLE IS VERY DIFFICULT", AND THAT WHEN ASKED ABOUT LIFE IN TAIWAN, HE REPLIED "I ENJOYED AMPLE FREEDOM". ON OTHER HAND, CHINA YOUTH NEWS OF 13 AUG REPORTED THAT ON NIGHT OF 6 AUG HUANG GOT DRUNK WITH SOME OTHER TAF PILOTS AND REMARKED, "THIS IS THE LAST TOAST ! WILL DRINK WITH YOU ALL". SOMEONE REPORTED THIS TO HIS CO, WHO CALLED HIM IN FOR QUESTIONING, BUT HUANG GOT OFF BY SAYING THAT HE WOULD GIVE UP DRINKING. HUANG WAS QUOTED AS CONDEMNING TAIWAN AS A CHAOTIC AND UNEQUAL AUTOCRACY WHERE THERE IS NO FREEDOM, ADDING "IN TAIWAN WE HAVE OUR OWN CAR, A HOUSE WITH AIR CONDITIONING AND A MONTHLY SALARY OF 25,000 DOLLARS (NT, ABOUT US \$658), BUT TODAY MANY YOUNG PEOPLE LACK SPIRITUAL SATISFACTION . . . THEY FEEL THERE IS NO FUTURE, NO WAY OUT." HUANG ALSO WAS QUOTED AS SAYING THAT HE STARTED PLANNING HIS ESCAPE ROUTE THREE MONTHS BEFORE HE LEFT TAIWAN, STUDYING MAPS AND INFORMATION ABOUT PRC AIRFIELDS AND FIGURING THE . FUEL NEEDED. THE PAPER SAID THAT HE TOOK OFF FROM TAOYUAN AIRPORT, CROSSED THE COAST AT THE MOUTH OF THE . DANSHUI (TAN-SHUI) RIVER, PULLED OUT THE WIRES FROM HIS RADIO, HEADED FOR THE MIN RIVER ESTUARY ON THE MAINLAND, FLYING CLOSE TO SEA LEVEL, AND THEN LANDED. MAINLAND REPORTS HAVE NOT MENTIONED A CO-PILOT AND HAVE NOT ATTEMPTED TO EXPLAIN THE EMPTY REAR SEAT OF THE F-5-F. HUANG'S FAMILY'S OLD HOME IS IN YUNG-CHUNG, KWANG-HSI (GUANGSI) PROVINCE, BUT HE WAS BORN IN TAIWAN AND HAS NO KNOWN TIES ON THE MAINLAND. WHEN ASKED ON BEIJING TV ON NIGHT OF 11 AUG IF HE WOULD SOON BE "GOING BACK" TO GUANGSI, HE REPLIED, "YES, BUT I DON'T KNOW A SINGLE PERSON THERE. "

TAIWAN'S RESPONSES TO THE INCIDENT ARE EXPECTED TO BE TWOFOLD: INCREASED EMPHASIS ON LOYALTY INDOCTRINATION AT THE MILITARY POLITICAL WARFARE LEVEL, AND DISCIPLINARY ACTION AGAINST HUANG'S FORMER COMMANDER OR POL WARFARE OFFICER AT TAO-YUAN AFB. ALTHOUGH PRC TECHNICIANS WILL REVERSE-ENGINEER THE AIRCRAFT AND ATTEMPT TO IMITATE IT. THE EFFORT WILL REQUIRE AT LEAST FIVE YEARS "AT THE PRESENT TECHNICAL CAPABILITIES OF THE CHINESE COMMUNISTS". Intensifying Pressure to Block FX Sale (C)

I sent you this morning (Tab A) a memo spelling out an orchestrated effort to pressure the President on the FX issue. We now have the latest demarche from Peking which escalates the level of concern on their part. (Tab B). (C)

This is the most direct linkage I have seen between the FX sale to Taiwan and a retrogression in Sino-US relations. The Chinese, as we suspected all along, are focusing in on the FX as the real issue, not as they stated earlier, the whole issue of arms sales to Taiwan. (C)

In my view, the Chinese are banking on:

- -- The President's reputed pragmatism which will cause him to adjust his position on arms sales to Taiwan to the "strategic imperative." (C)
- -- Their supporters in and out of government to use these statements to buttress their position against FX sales. (C)

I noted, however, the Chinese did not link their concerns for the FX to the visit of Deputy Chief of Staff Liu. This seems to me to be a rather poignant omission and reinforces my belief that we should unleash Rich Armitage on the People's Liberation Army. (C)

THE CEINESE GOVERNMENT HAS REPEATEDLY STATED ITS OPPOSI-TION TO THE U.S. GOVERNMENT'S CONTINUED SALE OF WEAPONS TO TAIWAN, WHICH IS AN INTERFERENCE IN CHINA'S INTERNAL AFFAIRS AND DETRIMENTAL TO THE RELATIONS BETWEEN THE TWO COUNTRIES. THE CHINESE GOVERNMENT SINCERELY WISHES TO SEE FURTHER DEVELOPMENT OF SING-U.S. RELA-TIONS. HOWEVER, SHOULD THE U.S. GOVERNMENT DISREGARD THIS FIRM POSITION OF THE CHINESE GOVERNMENT AND EVEN DECIDE TO SELL SUCH ADVANCED WEAPONS AS THE FX FIGHTERS TO TAIWAN, IT IS BOUND TO LEAD TO RETROGRESSION IN SINO-U.S. RELATIONS. I WOULD LIKE TO ASK MR. CHARGE D'AFFAIRES TO CONVEY MY ABOVE REMARKS TO THE U.S. GOVERNMENT. END TEXT.

- 4. CHARGE RESPONDED BY OBSERVING THAT THE COMMENTS BY SENATORS GLENN AND ZABLOCKI WERE NOT MADE ON BEHALF OF THE U.S. ADMINISTRATION. THEIR STATED VIEWS SHOULD THEREFORE BE TAKEN AS THEIR INDIVIDUAL OPINIONS AND NOT THE POSITION OF THE ADMINISTRATION.
- 5. ZHANG SAID THE CHINESE RECOGNIZE THAT BOTH ZABLOCKI AND GLENN ARE DEMOCRATS IN THE LEGISLATIVE AND NOT THE EXECUTIVE BRANCE. HE REMARKED, HOWEVER, THAT THE TWO HOLD RESPONSIBLE POSITION IN THE FOREIGN AFFAIRS AND FOREIGN RELATIONS COMMITTEES OF THE HOUSE AND SENATE RESPECTIVELY AND THAT THESE COMMITTEES ARE PERIODICALLY BRIEFED BY ADMINISTRATION OFFICIALS, INCLUDING SECRETARY HAIG.
