Dear President and Mrs Reagan,

I would like to re-introduce myself to you, since our meeting was a big part of my past, and I know a situation you probably won't even remember. It was the summer of 1949, and my sister and I were introduced to you via letter written to you by Charles Grimm, then manager of the Chicago Cubs. Charles had asked you to arrange a tour for us through Warner Brothers Studio. You were kind enough to write to us concerning the arrangements. (A copy of the letter is enclosed.). You not only followed through with the request, but you also came to the studio to meet us. You said you had been washing your car, and had decided to come over to meet the two girls from Union, Missouri. What a thrill! I still remember what you wore, Mr. President, a yellow tee shirt, black slacks, and a baseball cap. You also had broken your leg. You spent part gof the afternoon with us, and you told us of places to go. As a a point of interest, I still hear from Charles Grimm. He was and always will be my Santa Claus, so I talk to him every Christmas. His first wife died, and he remarried a darling lady who was Bing Crosby's first leading lady. He still plays the Banjo and they live in Scotsdale, Arizonia.

Later in my life I wrote you to see if we could again go through a studio because my husband and I were taking the "in-laws" to California. You arranged for us to get tickets at Universal Studios. You at this time were making waves about running for Governor. I remember writing to thank you for the tickets and telling you that I would be praying for you. I also wrote that I felt you would go higher in office than Governor. God as always was right in answering prayers.

I am now writing you the third time, and I must admit a bit hesitant because of your position and the fact that I am older and not as impulsive. I am not asking to go through a studio, but I do want you to know that I am still praying for you and your family. I was so thrilled when you made 1983 the Year of the Bible. That was truly an answer to prayer. The proclamation centered our great country back on its founding principals which is a great comfort to me during these adverse times. I have been inspired to read the Bible in total once again. I would like to know where I could get a written copy of the proclamation if possible.

Our whole family is very supportive of your policies and programs because we sense a sincerity behind your decisions.

You always put the country above your personal goals and gains.

In fact your personal goals are to do the best for the country even if the stance is unpopular politically.

My husband is a Judge of the District Court for the state of Kansas, and he is particularly supportive of your stance for the role of the Judiciary. "Judges are to interrupt the law, not make the law." Enclosed is a section from a ruling from the Supreme Court of Kansas on one of Bob's cases. You may find this of interest because it illustrates the fact that he not only agrees with your position for the Judicial, but he is in a position to put them into practice. He is also the past president of the District Court Judges of the State of Kansas. The Kansas legislature passed a law as a result of this verdict.

In closing, I would like to mention that two dear friends are going to be attending the tea that you are giving, Mrs. Reagan, on May 19. They are Mrs. Gary Bubeck and Mrs. Robert Rafferty. SYLLABUS BY THE COURT

1.

All crimes in Kansas are established by legislative act. There are no common law crimes in this state, and there can be no conviction except for such crimes as are defined by statute.

2.

Rules of statutory construction of a criminal statute stated. and applied.

3.

K.S.A. 21-3301 and 21-3302, when read together, do not include the crime of attempted conspiracy and prior to May 13, 1982, no such crime existed in the Kansas Criminal Code.

Appeal from Johnson County district court, Appeal from Johnson County district court, judge. Opinion filed January 14, 1983. Affirmed.

The opinion of the court was delivered by

HOLMES, J.: This is an appeal by the State under K.S.A. 22-3602(b)(l) from the dismissal by the trial court, on motion of the defendant at the preliminary hearing stage, of criminal charges against Bobby R. Sexton, Jr. The defendant was charged with an attempt to conspire to commit murder. The trial court found there was no such crime as attempted conspiracy and therefore dismissed the action.


There were no facts presented to the trial court and the parties have stipulated that for appeal purposes, the allegations of the information may be taken as true and are controlling.

Greatly summarized, the information alleges that the defendant Bobby R. Sexton, Jr. attempted to conspire with two agents of the United States Alcohol, Tobacco and Firearms unit for the agents to murder Sexton's wife. Several meetings were held in which a price for the murder was determined and details for carrying out the murder were furnished by Sexton, including the present whereabouts of his estranged wife.

It is undisputed that the two agents were working undercover after receiving a tip from the Olathe police department that

Sexton was seeking someone to murder his wife. It is also undisputed that neither of the two agents ever had any intention of entering into an actual conspiracy to murder Sexton's wife.

Based upon the information secured by the USATF agents, the defendant was charged with an attempt to conspire to commit the murder of his wife. He was not charged with attempted murder nor conspiracy to commit murder and the State concedes that under the facts alleged, such charges would not lie. The sole question before this court is whether under the Kansas statutes, as they existed at the time, there was any such crime as attempted conspiracy. The trial court found that no such crime, essentially the crime of solicitation, was included in our statutes. We agree.



The State contends that the facts alleged in the information support a charge of attempted conspiracy to commit murder in violation of K.S.A. 21-3301, 21-3302 and 21-3401. K.S.A. 21-3401 defines first-degree murder. The pertinent portions of K.S.A. 21-3301 provide:

"Attempt. (1) An attempt is any overt act toward the perpetration of a crime done by a person who intends to commit such crime but fails in the perpetration thereof or is prevented or intercepted in executing such crime.

(2) It shall not be a defense to a charge of attempt that the circumstances under which the act was performed or the means employed or the act itself were such that the commission of the crime was not possible."

K.S.A. 21-3302 provides in part:

"Conspiracy. (1) A conspiracy is an agreement with another person to commit a crime or to assist to commit a crime. No person may be convicted of a conspiracy unless an overt act in furtherance of such conspiracy is alleged and proved to have been committed by him or by a co-conspirator."

It appears to be the position of the State that conspiracy, unlike the crime of attempt, is a substantive crime which can be charged even when the object crime is completed, while an attempt merges with the object crime if that crime is actually consummated. As such, an attempt to commit the crime of conspiracy is a chargeable offense if the conspiracy itself is not completed. Appellant, on the other hand, makes several arguments, as pointed out in the trial court's opinion, to the effect there is no such crime as attempted conspiracy.

The learned trial judge in his order of dismissal stated:

"It is for this Court and all of our courts to uphold
the law and protect the citizens of this State no matter
who they might be. It is not the function of this Court
to create new laws no matter how justified they appear.

If this Court could create a good law today, there would
be nothing to prevent this Court from creating a bad law;
tomorrow, and for this reason our founding fathers wisely
created the separation [of] powers giving the legislature
the power to make laws and the courts the power of
interpreting those laws by filling in any gaps and clarifying
ambiguities.

"This Court finds the facts stipulated to and the information to be disgusting and repulsive. However, the buck stops here and this Court must make its determination solely upon the law.

"The Court makes the following findings:

- 1. That for the purpose of this hearing defendant stipulates that the State could prove all of the allegations set forth in the information.
- 2. That there cannot be a criminal offense of attempting to commit an act which if completed was not a crime. This case is similar to State v. Crozier,

 225 Kan.120. The Supreme Court held in that case that the acts of defendant of paying money to an individual to carry out the murder of her husband, transporting the hired individual to her husband's residence, and providing the gun and shells to shoot her husband, did not constitute the crime of conspiracy to commit murder since the person hired to commit the murder had never intended to commit murder. The Supreme Court in referring to State v. Roberts, 223 Kan. 49, stated that an agreement, by its very nature, requires a meeting of two minds;

meeting of the minds and no conspiracy to commit murder was involved. The Court finds that a person cannot be convicted of attempting to commit an act which even if committed was not a crime.

The Court further finds that the Kansas statutes categorize attempt and conspiracy under the heading of 'Anticipatory Crimes.' This Court finds that one anticipatory crime cannot be stacked or added to another anticipatory crime in order to arrive at a new crime.

The Court does not find from the facts in this case that there has been an attempted crime. For there to be an attempted crime under the statute, the Supreme Court has held that an accused must have taken steps beyond mere preparation by doing something directly moving toward and bringing nearer the crime he intends to commit. The Court cited 21 Am. Jur. 2d, Criminal Law, Section 111, page 191, '. . . in a general way it may be said that preparation consists in devising or arranging the means for measures necessary for the commission of the offense and that the attempt is the direct movement toward the commission after the preparations are made. It has been held that even though a person intends to commit a crime, his procurement of the instrumentalities adapted to that end will not constitute an attempt to commit the crime in the absence of some further overt act . . . ', State vs. Gobin, 216 Kan. 278.

There is no question in the Court's mind but that the defendant, under the facts stipulated, solicited the murder of his wife, but under <u>Kansas vs. Bowles</u>, 70 Kan. 821, 838, the Court held, 'so long as the will of the person solicited is opposed to the corrupt conduct, there can be no attempt, in the legal sense.

It would appear to the Court that if there were a

Court could find probable cause to believe that the defendant had committed such a crime. However, there is no such crime in Kansas and this Court can make no such finding.

The Court, after giving full consideration to the matter pending before it, does not find probable cause to believe that a felony occurred in Johnson County, Kansas, as alleged, and the case is ordered dismissed and the defendant discharged."

We concur with the ultimate ruling of the trial court and much of what is said in the opinion. However, in view of our opinion in State v. Logan and Cromwell, (#54,775 and #54,776, consolidated, this date decided), we do not concur in the suggestion that legal impossibility, if it exists, is always a defense to a charge of an attempted crime. While it is true that it is an ultimate function of the courts to determine whether a statute or a combination of statutes actually proscribes certain conduct as criminal, great weight must be given to the intent and action of the legislature when it determines to establish certain conduct as constituting a new crime. The 1982 Legislature specifically adopted the crime of criminal solicitation. L. 1982, ch.132, sec. l. The legislative history of the new enactment reveals that during hearings before the Senate Judiciary Committee on March 3, 1982, the Johnson County District Attorney advised the committee, inter alia, that:

"Kansas presently does not have a statute which makes solicitation of a criminal act a crime. I have adopted as a premise that for one person to solicit another to commit a crime, and particularly a heinous crime, (e.g., murder) is or should be illegal. If you accept that premise, presumably it was thought that either a charge of conspiracy (K.S.A. 21-3302) or attempt (K.S.A. 21-3301) would address those situations in which an individual solicited another to commit a crime. It appears that is not the case."

Minutes of the meeting of the Tudici

to the effect that S.B. 751 (subsequently enacted as L.1982, ch.132, \$1) created "a new crime known as criminal solicitation." The positions of the Johnson County District Attorney and the Kansas County and District Attorneys Association were supported at the hearing by the Shawnee County District Attorney, who urged enactment of the new bill.

It has long been the rule in Kansas that all crimes are established by legislative act. There are no common law crimes in the state, and there can be no conviction except for such crimes as are defined by statute. State v. Young, 55 Kan. 349, 356, 40 Pac. 659 (1895).

It is also the rule in this state that a criminal statute will not be "extended by courts to embrace acts or conduct not clearly included within its prohibitions." State v. Doyen, 224 Kan. 482, 488, 580 P.2d 1351 (1978). Our criminal statutes are to be construed strictly against the state. State v. Kearns, 229 Kan. 207, 208, 623 P.2d 507 (1981).

It is a fundamental rule of statutory construction, to which all other rules are subordinate, that the intent of the legislature governs when that intent can be ascertained. Kansas State Board of Healing Arts v. Dickerson, 229 Kan. 627, 629 P.2d 187 (1981);

State v. Seymour, 5 Kan.App.2d 95, 612 P.2d 1248 (1980). The 1982 Legislature, by the enactment of L.1982, ch.132, §1, has revealed that its intent in enacting the attempt and conspiracy statutes did not include solicitation as a crime. It is also a rule of statutory construction that older statutes are subordinated to newer enactments and it is the latest expression of the legislative will which controls if there is possible conflicting construction in a case. Farmers State Bank & Trust Co. of Hays v. City of Yates Center, 229 Kan. 330, 338, 624 P.2d 971 (1981); City of Salina v. Jaggers, 228 Kan. 155, 169, 612 P.2d 618 (1980).

The legislature has now specifically made criminal solicitation a substantive crime by enactment of the following statute which became effective May 13, 1982:

- "(a) Criminal solicitation is commanding, encouraging or requesting another person to commit a felony, attempt to commit a felony or aid and abet in the commission or attempted commission of a felony for the purpose of promoting or facilitating the felony.
- (b) It is immaterial under subsection (a) that the actor fails to communicate with the person solicited to commit a felony if the person's conduct was designed to effect a communication.
- (c) It is an affirmative defense that the actor, after soliciting another person to commit a felony, persuaded that person not to do so or otherwise prevented the commission of the felony, under circumstances manifesting a complete and voluntary renunciation of the actor's criminal purposes.
- (d) Criminal solicitation of a class A or B felony is a class D felony. Criminal solicitation of a felony other than a class A or B felony is a class E felony."

 L.1982, ch.132, §1.

This act appears to be a legislative recognition that prior to May 13, 1982, Kansas had no criminal statutes which covered the fact situation presented by the instant case and that the existing attempt and conspiracy statutes were inadequate to reach criminal solicitation.

The solicitation of the USATF officers by the defendant, in seeking to have his wife murdered, is not only morally reprehensible but constitutes totally unacceptable social behavior of a type ordinarily prohibited by the criminal statutes. It is unfortunate that Kansas did not have a solicitation statute which would allow this defendant's presecution and it was only through the alert and

competent work of Olathe police officers and the USATF agents that a serious crime was prevented. Much as we might desire to do so, it is not our function to create a crime where the legislature has not done so. The members of the legislature are to be commended upon their speedy action in moving to fill an existing gap in our criminal code once it was called to their attention.

The judgment is affirmed.

Dear Mr. President,

I'm taking this long overdue opportunity to write you this letter to support your courageous and rational approach to Central America. I watched your recent address to Congress and cheered through much of the speech. I guess I must admit, though, that I'm a bit skeptical that the United States can stave off the spread of communism throughout that region, which I attribute to the defeatism which has so long paralyzed (mainly our elected officials in Washington) our attempts to maintain our vital national interests.

With reference to your efforts at arms control negotiations, I feel that you have been more than fair with the Russians and frankly if no good agreement can be reached, then at least <u>no</u> agreement is better than a bad agreement. Please hold your ground.

I am a Roman Catholic and feel that the American Catholic Bishops are foolish and irresponsible in calling for a nuclear arms freeze. I don't believe the average Catholic agrees with the Bishops' position. I think that the Bishops will lose much of their influence with American Catholics. They goofed. Mr. President, I want you to know that you already appeal to many Catholics because of your stand on the abortion issue. Funny, but the Bishops don't really seem concerned about this issue anymore.

Mr. President, lately I have been writing to my Senators Glenn

and Metzenbaum and Representative Tony Hall asking them for support of your administration's positions on all of the above issues. I don't really think that my voice alone does a whole lot of good, but I do know that if you continue to drive home your views again and again with the vim and vigor of your last speech on Central America, that you can arouse the sleeping silent majority to contact their respective senators and congressmen. That is one point you do need to drive home in you addresses is that the average guy on the street needs to write his elected officials repeatedly to ask for support of your administration.

Mr. President, you are called The Great Communicator and I believe you are indeed. The issues facing our nation and the free world are enormous and the threat to our very survival is great. I believe your programs, if enacted, will ensure peace, prosperity and freedom, but we need more speeches and more Communication from you. I believe that you alone can rouse the masses and I feel you will.

Mr. President, thank you for your time. You got my vote in 1980 and you'll get it again in 1984. Please do run again. America needs you badly. Thanks for all your effort.

P.S. Pardon my typing. By the way, I liked your "Star Wars" speech. Keep up the good work.

You have already suggested several positive steps to support our friends in Central America, and those steps are deeply appreciated and widely supported in Central America. There are other items which you might also want to consider. I will set forth below a combination of steps which I feel could strengthen freedom in Central America.

- 1. The Congress should enact, without delay, your Caribbean Basin initiative with emphasis on more open trade with the United States.
- Consideration should be given to a greater expansion of the Peace Corps in Central America with total emphasis on health, education and nutrition.
- 3. Since no Army Officers from Guatemala have been trained in the United States since 1977, I would urge that this policy be reviewed. Human rights arguments could actually be supported by including that subject in training given within the United States.
 - 4. You must continue your strong approach to continued military support for El Salvador. With several thousand Russians and Cubans in Nicaragua, the Congressional debate should be focused on what the Russians and Cubans are doing -- not on 55 military advisers in El Salvador.
 - 5. Economic assistance must be greatly accelerated.
 A "Marshall Plan" for Central America should be enacted as soon as possible.
 - 6. A greater effort must be made to mobilize public opinion in support of your policies within the United States. Educators, and labor and business leaders all have a stake in Central America, and could help with public awareness to counter those who are trying to thwart your policies through naivete or political intentions.

If El Salvador is not stabilized, the many people I talked to in Honduras are concerned that Honduras would also become destabilized. It would be a matter of time before the instability

would flow to Guatemala and Mexico.

You may be sure that I will express these views to members of Congress and other business people. I believe that "staying the course" in Central America is as important as it was in your Economic Recovery Program.

On April 28, the day following your address to the Joint Session regarding Central America, I visited our factory at Allende, Mexico for a celebration of our success in that town. We raised the Mexican flag, the flag of the state of Coahuila, and our company flag.

Our company operates five factories in the United States, and the one at Allende, Mexico. The Mexican plant employs approximately 25% of our total employment using raw materials manufactured in the United States, with the finished product coming back into this country under Section 807 of the Tariff Act. The factory is a splendid example of the type of economic cooperation that can benefit Latin American countries, as intended by your Caribbean Initiative.

During the ceremony, all 600 plant employees were in attendance, as were local city officials and the high school drum and bugle corp. The Mexican national anthem was sung by all in attendance.

During the ceremony, I noticed a young worker from the plant wearing a T-shirt that said "Eat Your Heart Out Russia." A picture of that young lady is enclosed as evidence to you that the programs you advocate can be successful in promoting the spirit of democratic capitalism.

Dear Mr. Wright:

Unlike you I had never met Al Schaufelberger but I share your sorrow. I knew of him, of course, and his record -- one of the best -- and I feel a great sense of rage at the cowardly terrorists who took his life. You are right. About 5'9", built like a linebacker, he was of brilliant mind and strongest character. He graduated near the top of his class at Annapolis, and was tops in Spanish at our Defense Language Institute. A Lt. Commander in the SEALS, he seemed more than just one man. He was a one-man army, (or navy). He was the sort of guy who makes you proud to know him, proud that he's on our side, and damned glad that he is. He was the special sort "out there" who made you sleep better at night.

By comparison, those who murdered him are miniscule. Such is the ironic demise of patriots.

Our way of life is at war. Right now. I grieve for my friend Al Schaufelberger, and send my deepest respects to the other Americans "out there" who are protecting my rights to express thoughts such as these.



Dear Mr. President:

I am unaccustomed to writing letters to public figures, but up until now, I have not felt this strongly about a situation. I have only believed strongly in one former Presidential candidate, Barry Goldwater, but I was too young to vote when he ran. I don't think I have voted in a presidential election, except maybe once for Nixon, but I must confess, my 1984 vote will be for you.

Your speech on the computer industry about a month ago was inspiring, but unfortunately came off poorly because your speech writers did not do their homework. But that aside, I believe your intentions were in earnest.

I am in the computer biz and have been a guest speaker and lecturer at civic groups and technical gatherings, as well as on radio. I have spoken on everything from "Stop Worrying and Learn to Love the Computer" (my sequel to Dr. Strangelove), and "Computer Crime" to "Dealing with People Who Deal with Computers." In all of my presentations, I informed my audiences, "The Computer is here to stay; you might as well accept it."

This brings me to my point. For the past five years, I have told people that computers and automation were going to replace them, and to get on the bandwagon early. They listened and applauded politely, but they didn't hear the warning. Automation replaced some people little by little, until the unemployment slide started. The slide became an avalanche and before long, millions of people lost their jobs. Some because of automation, some because those who became unemployed stopped buying the products that others produced. You know the rest of the economic spiral.

I recall a lady on a call-in radio show I was doing who said, "You and your damn computers stole my job. Now how am I going to feed my babies?" I replied, "The same way I feed my three babies; find a job that is needed and forget about what used to be. Progress must move forward, and those who fail to keep up with it will be left behind."

Jesse Jackson, in one of his speeches for Harold Washington in the Chicago Mayorial race said, "We want it All, we want it Here, we want it Now." This, of course, is not unlike The Grasshopper telling the industrious Ants, "The world owes me a living."

When my grandfather immigrated to this country, he said, "I want a chance to earn a living to support my family." My father, with his high school diploma in hand said, "I want a chance to give my family a better life." Unfortunately, members of my generation want the life of leisure and are not willing to go the extra mile to have that better life.

The freedom my grandfather left Italy for, the freedom my father, my brother and I fought for in World War II and Viet Nam is not only being taken for granted, but may someday be given up for free room and board "cuz the world owes me a livin'".

I beseech you to not give into this "Jobs Program" nonsense, but rather support a Jobs Training program for those who are willing to invest in their future. The economy will heal itself and the "Grasshoppers" of my generation will have to pull themselves up and start over again. Don't weaken to "FDR types and their "WPA mentalities".

Don't tax Hi-tech and Software Development; hi-tech is our only real edge over the rest of the world, and if you discourage innovation, our last chance of survival may be shot down. (See Forbes, April 11, 1983, pg. 120).

Finally, don't be swayed by detractors, pollsters and whisperers. You have taken some hard stands, put some doom-sayers in their place and have tried to heal a failing nation. I believe the American people will see the light when the time comes and you will be re-elected. Though I hate the triteness of your slogan (where do you get these writers?), "Stay the Course", or as they say on the street, "Hang in There".

Thank you for your letter and excuse the lateness of my reply. Your letter has only just now reached my desk.

I appreciate your kind words about the report of our Commission on Excellence in Education. I believe Secretary Bell was only pointing out that among a number of things we've been trying to do is restore some of the tax resources to local and State levels of government by reducing the Federal share.

Actually, the Federal share of education funding is only 8% of the total. The defense budget funds local education to pay for the cost of military dependents.

Total spending on education has increased 600% over the last 20 years. Per pupil costs in constant dollars have doubled. Much of what the Commission recommended will require no increase in financing. Where there are added costs, they should be distributed among the levels of government based on the responsibilities of each level.

Dear Mr. President:

Congratulations on having appointed the Commission on Excellence in Education. I am delighted with the recommendations and hope that this Foundation can be of assistance in working for their adoption.

On the MacNeil-Lehrer Report which was devoted to the Commission's findings (Tuesday, April 26), a question was raised as to the federal government's role in funding the costs that some of the recommendations will lead to. Secretary Bell indicated that your administration was dealing with that by cutting the income tax on individuals. This would leave money in taxpayer's pockets and thus available to the states to tax and make available for schooling. I hope that is not the view in the White House. Federal tax cuts cannot help national recovery if their consequence is countervailing state tax increases. That simple shifting of taxing and spending from one locus of government to another would make a mockery of all the fine ideas and rhetoric that surrounded the Tax Reform Act.

Even though I do not expect the idea will be popular with you or Secretary Weinberger, I think a strong case can be made for spending some of our defense budget on schooling. When the federal government became heavily involved in education in 1958, the act which produced the action was entitled the National Defense Education Act, recognizing the connection between our security and the effectiveness of our educational system. That connection is even greater today, what with high tech ordnance and more complex manuals. Well-educated soldiers are just as vital as well-armed soldiers. The education will persist long after the arms are obsolete. I urge you to let the defense budget provide appropriate support for our presently inadequate educational system.

Dear Mr. President:

Recent actions by and your administration prompted this letter.

I am extremely grateful for the actions of the Health and Human Services Department in their efforts to prevent the withholding of food or medical treatment from handicapped infants. The starvation death of "Baby Doe" in Indiana was tragic.

This new medical ethic of "quality of life" has me particularly concerned. I was diagnosed with a rare form of cancer at the age of 5 months. I had only one lung, was paralized from the waist down, and the cancer was headed for my heart. If I were born today would I be a candidate for starvation? Today, however, I am 33 years old, a graduate of the University of Texas with a degree in mathematics and psychology, and have been employed in private industry over ten years.

I was also encouraged by your actions at a recent Republican Congressional Women's meeting in which you offered your silence on the Equal Rights Amendment for their support of a Human Life Amendment. I am not a Republican, nor even conservative, but I voted for you in 1980 because of your pro-life position. This recent incident proved to me that stopping abortion is truly one of your top concerns.

Currently pending on the Hill is legislation that I feel is the greatest hope for the pro-life movement; the Respect Human Life Act (S. 467 by Sen. Jepsen and HR 618 by Rep. Hyde). I do hope you will put all the forces of your office behind this most important piece of legislation. This comprehensive pro-life bill will end tax subsidized abortion and prohibit withholding food, water, or medical treatment from handicapped infants. Numerous times during your administration it was said it could never pass (such as your reduced budget), but your personal intervention proved the experts wrong. Please give this matter your personal attention.

Dear Mr. President,

After my recent return from visiting relatives in Poland (my first to that country), I felt that I owed you this latter. Until three weeks ago I supported a nuclear freeze, arms reduction, and the Conference of Catholic Bishop's weighty statements.

How I wish people of our great country, including the Catholic clergy, could have been with me during my two week tour of Poland with a side trip to the U.S.S.R..

Poland is a concentration camp. Encircled by the same double strands of barbed wire that is displayed at Auschwitz and Buchen-wald; camps so atrocious they have been preserved so that we shall never forget, and never permit this sort of thing to happen againit is happening today, in the great nation state of Poland.

The fear in the faces of men, women and children is also a reminder of things past. People speak in whispers, book over their shoulders constantly, and a few brave young persons will tell you that people still disappear daily from their jobs and their homes. As an American observer I see little difference between the Gestapo and the KGB.

Long lines form for any meager thing that may find its way into the shops. Two shoe coupons a year buy nothing, if there are no shoes, and no money with which to buy them.

Young married couples must wait approximately 20 years (as it is now projected) for their own small poorly constructed apartment. And the convenience of a telephone is something they may never know in their lifetime.

Our American dream is owning a home of one's own. Can you imagine the sacrifices that are being made by these people who are living two and three families to a single unit. Our convicts are shown greater human freedoms here in America, than Russia is allowing the Polish people.

Water cannons are turned into churches, and priests openly talked with me of the fear and oppression that has fallen heavily upon the Catholic Church. Would any statement made by the Council of Catholic Bishops be heard in the Soviet Union?



Polish school's have become Russified, with the glorious past of Poland and her hero's being removed from its history. Polish culture is being liquidated. Printed religious materials are almost non-existent, and purchased at great personal risk.

Few Americans, in our great country today, are unaware of the Bill of Rights and the work of the A.C.L.U., and, I feel, that it is a good thing that a free society exercise its rights by protesting, marching and certainly all faiths are free to issue statements regarding such complicated matters as nuclear warfare, but I wonder where the logic of these protestor's would take them, if they were trying to express these same thoughts in Poland today, under a Communist government....confronted with gums, secret police, barbedwire, police dogs, and never knowing when, for any out-spoken or overt act against the government, they may be taken from their homes or jobs and simply disappear.

I too support human rights, Mr. President, but my question to these well meaning protestor's and clergy would be, where does the responsibility for the protection of such rights lie? If I, and my grandchildren are being spared a nuclear holocaust, so that we might physibly end up oppressed and in bondage, as the Polish people live today, I responsibly say, No thank you!

I was ask in Warsaw, Katowice, and Krakow, if people in America understood what was happening in Poland under Russian domination.

I said, no. No, because we do not know fear, oppression, religious censorship, we have never know the hopelessness that comes from living under a dictatorship. If there could only be one protest march in Poland today, Mr. President, it would not be for arms reduction, jobs, or food, or even clothing, but rather for the most prized and valued fundamental right of every living soul in this universe,....Freedom.

I cannot give to every American, now enjoying this wonderful gift of freedom in our great country, my traumatic and frightening experience of viewing a country existing under communist control, but I can give to you my vote of confidence in your nuclear and space programs for a stronger and safer America. I can speak out in support of what I now know to be the only way possible to deal with a country like Russia...defense....a strong national defense.

Our responsibility to the future, it would seem to me, is that we should keep our light of freedom burning strong and bright for the oppressed people's of the world. Certainly the Polish people are looking for that light across the Atlantic...their only ray of hope.

Wasn't it Patrick Henry who said, "Give me liberty or give me death"....nothing seems more applicable in the struggle for world peace and FREEDOM.



Dear Mr. President:

With each passing day, Central America is geography which more and more Americans are becoming familiar with; and, yet, with all of the increased attention by the media, our knowledge about that part of the world is appallingly shallow. During the last few days, I had the opportunity to be in Central America on business and spent considerable time talking to businessmen in both Guatemala and Honduras. In addition, I talked to taxi drivers, hotel workers, Indians and U.S. Embassy personnel. While it was very clear that none of the Guatemalans or Hondurans I talked to wanted a Communist takeover, it was also clear that one's personal point of view about Central America could soon be lost in confusing and conflicting facts. I did have a point of view prior to going to Central America and that view was substantially reinforced by my visit. The United States must continue to support our friends in Central America -- both because of the area's strategic importance and because our nation's moral values mandate that continued support.

I want to make it absolutely clear that the conclusions I have reached are personal and have no relationship to my company's small investment in Guatemala and Honduras. In terms of the size of Avon Products, Inc., sales and profits in that region are infinitesimal. I am concerned, however, as an American that the Congress must become more realistic in its approach to supporting your foreign policy objectives in Central America. There seems to be a continuing knee-jerk cadence from certain members of the Congress who completely shut their eyes and ears to the struggle of millions in that region who only want to live in peace and freedom.
