I have been involved in Lebanon since 1975, working through a local church and its pastor, Sami Dagher. Last year we were able to rebuild approximately 250 homes that were destroyed as a result of the fighting. We have also been working in the Sabra and Shatila camps and have been able to help 6,000 Palestinian families with food and medicine. We are thankful to God for the opportunities He has given to us to show His love to those less fortunate than we.

I have made over 20 trips to Lebanon and plan to return in December. I hope I will have the opportunity of preaching to the Marines while I am there.

Thank you for what you are doing for those in Lebanon. My wife, Jane, and I have three little boys and we are grateful to you for making this a safer world for them to grow up in.

It shows clearly to the world the barbaric nature of our enemy. We feel with those who have lost loved ones through this senseless act of murder. We know how the American people feel; for we have gone through it ourselves. May the hope of the living Christ comfort the hearts of your people at this time.

Your nation has become a partner in the pain and suffering of our nation—this battle we are fighting together for freedom and democracy. We are so grateful for your President's stand to continue his commitment to defend the free world and its values; otherwise, it would mean that one day you would fight this battle on the borders of America.

All the church brethren prayed earnestly on Sunday morning for the families who lost loved ones and we prayed that God would give us peace and strength to fulfill the task given to us.

My dear Mr. President:

Knowing you all these years, respecting you and admiring you, I realize fully well the many agonizing hours you have faced this past week.

In short, Bill argues that the Dole plan contains mostly illusory savings on the spending side and real increases on the tax side. He makes a compelling case.

DOLE DEFICIT PACKAGE CONTAINS ILLUSORY SAVINGS

Dear Colleague:

Our colleague, Bob Dole, recently unveiled a plan designed to reduce the federal deficit. Although Senator Dole's motives are commendable, the fact is that his program contains mostly illusory savings on the spending side but very real and permanent increases on the tax side. I hope you will take a very close look at the Dole plan because I am convinced that when you do you will be constrained, as President Reagan and I am, to oppose it.

The package, if enacted, would require \$38.4 billion in mandated tax increases and could go as high as \$53.8 billion in tax increases if the powers given to the President are fully implemented. He attempts to balance this program with \$60.4 billion in supposed spending reductions. A close study of this spending package indicates that the spending savings are substantially less than the real tax increases.

Let'me delineate some of the real problems of the Dole proposal:

- 1. The plan includes \$12.4 billion in directed measures. The fact is, however, that over \$9 billion of this amount has already been recommended by my Governmental Affairs Committee and is not dependent on this package.
- 2. The proposal uses as its baseline the First Concurrent Budget Resolution, which is fully \$32 billion above the President's budget request. Thus, the \$10.3 billion savings he attributes to enacted or pending measures really isn't a "reduction" at all; rather, we are just slowing the amount of increase proposed by the Congressional Budget Resolution.
- 3. In this package \$7.9 billion is attributable to cuts in programs, such as AFDC and child nutrition. In the First Budget Resolution Congress already indicated its support for these programs. Yet the plan has the audacity to suggest that "these savings are the Administration's responsibility to veto and sustain..."

Only a magician could pull these savings out of the Congressional hat.

- 4. An additional \$23.8 billion in savings is attributable to new Temporary Emergency Control Powers given to the President. In order to achieve these savings, the President would have to cut Social Security and military and civilian COLAs 2½ percent in an election year while at the same time scrapping part of his tax indexing program. These savings are further conditioned upon Congress approving such cuts, which is highly doubtful.
- 5. The \$6 billion savings on debt service is highly speculative. It could only occur if the other savings are made.

Only one thing is for certain in this package -- taxes are going up dramatically.

Depending on the use of emergency powers, between \$25.2 billion and \$34.3 billion in new taxes will fall on the middle class, including \$6.2 billion in taxes on personal savings. At least 11 of the tax provisions directly hit the middle class. In addition, at least \$16.5 billion in new taxes fall on business.

One final but very important note -- the proposal substantially modifies the impoundment and rescission powers of the Congress by allowing the President to withhold appropriated funds. These issues are beyond the jurisdiction of the Finance Committee, and should be properly referred to other Senate Committees that have the appropriate jurisdiction. If this legislation is allowed to proceed, we will be well on the road to a serious breach of Committee responsibility.

In summary, the Dole plan lures us through doubtful spending changes into adopting a massive tax increase bill. In 1982, we were promised that for every dollar of taxes raised, we would cut spending by three dollars. Instead, we have raised spending by as much as \$1.14 for every dollar of taxes raised.

Let's not make the same mistake twice.

IN THE WAKE OF THE GHASTLY TERRORIST ATTACK WHICH CLAIMED THE LIVES OF OVER 225 MARINES IN BEIRUT, MANY PEOPLE ARE CONFUSED ABOUT AMERICAN INVOLVEMENT IN LEBANON, WHAT THE MARINES ARE DEFENDING THERE, AND WHY THEY NEED TO STAY.

IN LOOKING AT THESE QUESTIONS WE MUST FIRST PUT AMERICAN

INVOLVEMENT IN LEBANON INTO PROPER PERSPECTIVE. WE SHOULD AVOID

OVERSTATING WHAT WE ARE TRYING TO DO. UUR GUALS IN LEBANON ARE WORTHY

AND ARE ESSENTIAL TO THE PEACE PROCESS IN THE MIDDLE EAST, BUT

ACCOMPLISHING A UNITED, SOVEREIGN LEBANON IS NUT VITAL TO THE SECURITY

OF THE UNITED STATES AND THIS GOAL SHOULD NUT BE VIEWED PRIMARILY IN

STRATEGIC TERMS OR AS PART OF THE EAST-WEST BALANCE OF POWER.

HOW LONG MUST THE MARINES STAY? IF WE SAY WE WILL STAY UNTIL

LEBANON IS A STABLE COUNTRY AND SYRIA NO LONGER A THREAT, WE MAKE A

MORE OPEN COMMITMENT THAN WE CAN AFFORD. IF WE SAY THE MARINES

WILL STAY A FIXED NUMBER OF DAYS OR WEEKS, OUR COMMITMENT IS TOO

FEEBLE, AND WE HAND OUR ADVERSARIES THE ABILITY TO OUTMANEUVER US.

PERHAPS IT IS BEST FOR US TO SAY THAT WHEN WE JUDGE THAT THE LEBANESE

ARE ON THE ROAD TO NATIONAL RECONCILIATION AND A BETTER SECURITY

SYSTEM IS AVAILABLE IN THE COUNTRY, OUR MARINES WILL BE ON THEIR WAY

HOME.

THE UNITED STATES NEEDS A DIVERSIFIED STRATEGY IN LEBANON IN ORDER TO WITHDRAW THE MARINES BEFORE THE 18-MONTH DEADLINE WORKED OUT BY THE PRESIDENT AND THE CONGRESS. THE UNITED STATES MUST NEGOTIATE WITH THAT WITHDRAWAL IN MIND, AND IN A MANNER CONSISTENT WITH OUR INTERESTS IN THE REGION.

SIX GOALS SHOULD BE THE FOCUS OF AMERICAN POLICY:

THE FIRST IS AN AGREEMENT ON THE WITHDRAWAL OF ALL FOREIGN TROOPS FROM LEBANON. WE MUST PRESS HARD FOR AGREEMENTS FOR THE WITHDRAWAL OF SOME 50,000 SYRIAN TROOPS, 15,000 ISRAELI TROOPS, CLOSE TO 10,000

PALESTINIAN GUERRILLAS AND OVER 1,000 TRANIANS, LIBYANS, AND OTHER NATIONALS.

SECOND, WE MUST WORK TO RESTART THE WHOLE MIDDLE EAST PEACE
PROCESS. THAT PROCESS CANNOT WAIT FOR DEVELOPMENTS IN LEBANON.

ACHIEVING PROGRESS IN THESE BROADER MIDDLE EAST PEACE TALKS MAY BE ONE
WAY TO MOVE THE PEACE AGENDA IN LEBANON.

THIRD, THE PROCESS OF NATIONAL RECONCILIATION MUST GET UNDERWAY
IN A CONFERENCE OF ALL LEBANESE FACTIONS. A CONFERENCE WILL LIKELY
BEGIN MONDAY IN GENEVA. DUT OF THIS CONFERENCE MUST COME THE CRITICAL
COMPROMISES LEBANON NEEDS IF IT IS TO SURVIVE. SUCH COMPROMISES MUST
LEAD TO A BROADLY BASED GOVERNMENT OF NATIONAL UNITY, BACKED BY
INTERNATIONAL ECONOMIC ASSISTANCE. AMERICAN DIPLOMATS CAN HELP THIS
PROCESS ALONG, BUT ONLY LEBANESE LEADERS CAN MAKE IT SUCCEED. IF
LEBANESE LEADERS DO NOT SEE IT THAT WAY AND FAIL TO PLAY THEIR BEST
HAND, THE MARINES WILL BE USEFUL NO LONGER AND SHOULD BE WITHDRAWN.
STRONG PRESSURE TO COMPROMISE MUST BE PUT ON ALL FACTIONS IN LEBANON.
THEY MUST UNDERSTAND THAT THEIR CHOICE IS UNITY OR ANARCHY, AND THAT
THE HOUR IS LATE. IT IS THEIR NATION, NOT OURS, WHOSE FUTURE IS ON
THE LINE.

FOURTH, AN ACCEPTABLE SECURITY STRUCTURE COULD BE BUILT UP AROUND A BETTER TRAINED AND EQUIPPED LEBANESE ARMY, APPROPRIATELY DEPOLITICIZED AND ORGANIZED TO REFLECT THE RELIGIOUS MOSAIC OF THE NATION. MILITARY AID FROM A NUMBER OF NATIONS COULD BE MADE AVAILABLE TO THE LEBANESE ARMY IN A FORM AGREED TO BY ALL FACTIONS. SOLDIERS OF OTHER COUNTRIES COULD BE ROTATED THROUGH THE MULTINATIONAL FORCE, KEEPING IT IN PLACE AS LONG AS IT WAS NEEDED BUT ALLOWING THE MARINES TO DEPART MORE QUICKLY THAN WOULD HAVE BEEN POSSIBLE OTHERWISE.

FIFTH, IN THE DAYS JUST AHEAD, WE MUST ALSO STRENGTHEN THE SECURITY AREAS IN BEIRUT WHERE THE MARINES OPERATE. WE CAN NOT ACCEPT THE NOTION THAT NOTHING CAN BE DONE TO PROTECT THE MARINES FROM

KAMIKAZE TACTICS. THERE IS NO HIGHER PRIORITY IN THE MIDDLE LAST THAN THE PROTECTION OF THEIR LIVES.

Finally, we should make a quick but exhaustive investigation of the terrorist attack, which may have been Launched by a small group of uncontrollable fanatics seeking to create anarchy for their own purposes. They should be dealt with summarily before their twisted vision for Lebanon overwhelms the sensible vision of the majority of Lebanese people.

THE MISSION OF THE 1,600 MARINES NOW ON THE GROUND IN LEBANON
SHOULD BE PUT INTO PERSPECTIVE. THE MARINES WERE DISPATCHED TO

LEBANON ONE YEAR AGO TO PARTICIPATE IN A MULTINATIONAL FORCE REQUESTED

BY THE LEBANESE GOVERNMENT. THE MARINES ARE NOT IN LEBANON TO TIP THE

BALANCE OF POWER. THEY ARE THERE AS ONE ELEMENT AMONG SEVERAL TO HELP

ACHIEVE STABILITY. THEIR MISSION REMAINS ONE OF KEEPING THE PEACE,

NOT FIGHTING A WAR.

They are symbols of our commitment to the Lebanese people and to a sovereign, independent Lebanon. Withdrawing them immediately would make hollow our insistence that diplomacy be given a chance. What we have worked for, and what those men have died for, would be jeopardized, if not lost. The Soviet Union would be given more leeway as it tries to dominate Lebanon, and the entire Middle East would become a mure inviting target of Soviet opportunity. Syria would never honor its pledge to pull its thoops out, nor would it end its support of rebel factions or its collaboration with Iran. Israel's northern border would be even more vulnerable. Moderate Arab states would be alienated from us, and our general influence in the Middle East would sink while the influence of radicals rose. We would also have more difficulties in restarting Middle East peace talks and in getting the parties in the area to take risks for peace.

FORMIDABLE OBSTACLES CONFRONT THE UNITED STATES IN LEBANON, BUT

THE ROAD TO PEACE IN THE MIDDLE EAST HAS ALWAYS BEEN STREWN WITH OBSTACLES.

AS A GREAT POWER, THE UNITED STATES MUST SHOULDER THE RESPONSIBILITY THAT ACCUMPANIES POWER. WE CANNOT WALK AWAY FROM LEBANON AND EXPECT THE WORLD TO BE THE SAME AGAIN.

Dear Mrs. Kinyoun:

I read your letter to the editor in the October 29 issue of Human Events -- a paper I read regularly. With the constant drumbeat of criticism by much of the press I can understand why you might have a distorted view of what I have done or not done. There is a political bias -- whether they will admit it or not -- in much of the press and it can hardly be described as in my favor.

First-with regard to your letter, let me thank you for the support you gave to me as Governor and now as President. I hope I can prove to you I haven't changed in my beliefs. I do not support large tax increases. We passed the biggest tax cut in our nation's history but the so-called tax increase that followed was to straighten out some "goodies" which had been added by Congress and went beyond what we had asked for. Fully a third of the increase was not an increase at all but measures to better collect taxes already owed and which were being evaded because of various loopholes. But let me tell you what the majority in Congress promised if I'd support that tax increase: there would be \$3 in spending cuts for every \$1 of added revenue. I regret to tell you, the Congress has not kept that promise.

Let me just say about the World Bank: these international funding agencies are useful in keeping world trade going by helping the new developing countries get on their feet and remain as customers of countries like our own.

As for deficits believe me I want to get back to a balanced budget end tried to persuade (without success) Congress to support a constitutional emendment requiring that. Half the present deficit is the result of the recession. That will come down as recovery continues. The other half is structural. It is built into the automatic increases built into so many programs by Congress. We have only gotten about half the spending cuts we asked for. If Congress had given us the rest, the present deficit would be \$40 billion less than it is.

Congress is also the problem with regard to the Departments of Energy and Education. The leadership on both sides of the aisle will not move on this.

Mrs. Kinyoun, on the Korean Airline massacre, some of the actions that were suggested we've already taken. We persuaded our allies last Spring to stop sales of high technology to the Soviets and also to stop trade with them based on low interest credit. We cancelled several things that were desired by the Soviets and that were in the works. I'll admit even so to being frustrated because there is so little we can do short of shooting at them.

I'm very proud of the improvement we've made in our military strengths and there will be no "weak America." I think we showed some of that improvement in Grenada.

Forgive me for burdening you with this long letter but I felt you deserved a reply.

Dear President Reagan,

I have been thinking of you so much these days. I want to just sit down and tell you about some of what is in my mind and in my heart. I don't know how you will even have the time to be reading letters from people like me, with all the priorities there must be for you. But for whenever you may get any of this, here is what I want to say. It is quite a collection of thoughts.

First of all, this fall early, there was a note in the news that you are now using a prosthetic device due to a hearing loss. I don't know what it means to you to have these kinds of personal matters described and projected in the news. But I do much work with both handicapped persons as well as the elderly. In both of these divisions of people, there are often situations of hearing loss. At the Iowa Veteran's Home, I remember how many people had a hearing aid in their med drawer. It was my job to give these folks their morning meds and with them, to give them their hearing aid for use that day. Most of the time, these people would decline. I never really knew what all was involved, only that so many of them could have had the use of the device and it would have made such a differance to them. Anyway, what I am saying, is that it is neat to have you as a role model for them! They can look to you as not only their president, but as an intelligent, informed and very distinguished man, who also has something of a handicap and still functions admirably and effectively. That has got to have a positive effect.

Now to the second matter; It was the event when a Korean plane was shot down. The whole world was shocked and then enraged that a Soviet pilot would and could reduce a group of that many human lives to a "target" to be removed. In the face of that incredible action, we in this country and even the part of the rest of the world that

were aware of your anger and your sadness for the people involved. But along with that, we saw you move, in what seemed to be restrained are cautious steps, based upon the intellegence that was being fed into you. That, I believe, is what we pay you to do. I am glad and was then, that you did not pop off with angry and uncalculated responses which could have resulted in grave and unchangeable consequences. Thank you for that.

Now to the recent events in this past week. I have been watching lots of television and reading the newspapers, as I would guess has been much of the country. I work three nights a week in a nursing home. My first reaction to what I saw and heard, was tears. When I saw what had happened in Lebanon, I noticed how much Marine green looks like Army green. The young men walking around and being carried out of the blasted area all looked like Ted. I was momentarily thankful that he is "safe" in Arizona. That didn't last long tho. It was very quickly overshadowed by the realization that the "safe" is very conditional, and that Ted himself would probable be unhappy with my attitide. I knew he would probably wish he could be there and be involved. I found out later that I was right. The next tears that I cried were for the moms. I feel so sad for them.

Whe the Granada thing opened up, I saw and heard about the Airborne men and their involvement. I knew that Ted was undoubtedly plugged in to all that was taking place and I felt a little thrill. I have listened to him for so long talk about how great that group of men is and how much he longs to become a part. I have to sak that when the students who arrived back home later, began to tell about their experiences, I heard again in my mind, a reflection of the greatness Ted had described in these men. Even tho I still know that fear that probably only a mom knows, I notice it moving over in favor of an understanding and an acceptance. Some of the students kissed American soil and wept. Others talked openly of their thankfulness for their country, their president, and told how thankful they were for

I just went all warm and teary and for the first time ever, I really began to grasp in my mind and heart, some of what this young soldier of mine is all about. After I watched you on television, I did a first. I picked up the phone and I called Ted. I have not ever done that, except when his sister had brain surgery a year ago. It is important to Ted to be now making cuts with the ties at home and so we wait for him to do the calling when he feels he wants to do so. But last night I had to hear his voice, and to say to him, "I love you so much and am so proud of all that you are and of all that you want to become. And I do now understand just a little bit more than I did a week ago." Of course, he is feeling really left out because he would like to be there doing his thing.

I have taken your time again. I do that every now and then. I just needed and wanted to tell you how proud I am of you and of my country and that I am thankful that you are there and that you are you. It has been difficult in the first days of the week to hear the critical remarks directed toward you and the workings of the administration. I do happen to be an idealist and a bit naieve. It is not difficult for me to trust and to believe in the line of authority. Because of that, I happen to believe that you and those who surround you have the information available to you to make the decisions that will effect the country in the most positive way. There have been those in the last decade whose behaviors and activities have tended toward erroding that kind of belief. But watching people like you and Mr. Weinberger has gone a long way toward bring back a faith in the system. I thought a lot about Iran and! the hostages this week and also thought a lot about how interesting it is that a British Commonwealth island would have several hundred Cubans working there ...
