Dear Mr. Madsen:

Thank you for writing and thank you even more for your help as a member of the Grace Commission. I think Barrons February 6 article is inaccurate. The final commission report has been delivered to us. It contains almost 2500 specific recommendations. About 70% of these will require legislation. We have a task force working on the report now.

By coincidence, I have just announced to the press that the Republican Congressional leadership and I have reached agreement on a downpayment on the deficit of \$150 billion over the next three years. Part of that \$150 billion is made up of Grace Commission savings.

You say we are being fiscally irresponsible in having the deficit we have. May I remind you we've had a history of practically 50 years of virtually unbroken deficit spending. For some 45 of those 50 years the Democrats had control of both houses of the Congress. I suggest the deficit is largely structural and results from policies built into our government.

The majority party has refused more than half of the spending cuts we have asked for and, indeed, has tried to pass additional new spending programs. If we were following the budgets as projected by the previous Administration, our deficit would now be \$191 billion bigger than it is. We know the \$150 billion downpayment is not the final answer, but it does set the next three years' deficits on a downward glide. We intend to go on to the structural reforms which will then bring us to a balanced budget a few years down the road.

Dear President Reagan:

As a member of the Grace Commission, I spent 2 months in Washington D.C. in 1982 working with government agencies as a private citizen to find ways to reduce federal expenses. To date I have not had any feedback as to whether these recommendations will be implemented.

The total Grace Commission report identified nearly \$113 billion in total annual savings and according to a February 6th Barrons article "...that report appears likely to disappear without a trace...".

Your proposed budget for FY 1985 shows a projected deficit of \$180 billion, which in my opinion is ludicrous. I, for one, am truly shocked at the apparent lack of implementation of Grace Commission recommendations and fiscal irresponsibility that you and your colleagues are showing toward the federal deficit.

One way to change this perception and begin obtaining results would be to issue instructions to your appointees to implement the Grace Commission recommendations, no questions asked. I am confident any really unsound recommendations will be reversed by Congress soon enough.

Re-elections aside, it is up to <u>you</u> to bring the federal deficit under control. No one else even stands a chance.

Dear President Reagan,

Never before have I been motivated to write a letter to the President of the United States of America. On this occassion I am so prompted for two reasons.

First, to express gratitude and support for your decision to seek re-election. More than ever this nation needs your confident and sensible style of leadership.

Second, to relate an area of government that I have great concern for. I refer specifically to our state and federal court systems. As a police officer for 12 years I have seen many hardened and dangerous criminals set free to seek new victims by courts more concerned with procedural perfection than the obvious guilt of the accused based upon the facts presented at trial. Numerous times voters of this state have been frustrated by federal judges who have invalidated laws ranging from control of pornography to the death penalty. These acts had been mandated by initiatives and ratified by an overwhelming majority of the voters, yet were swept aside by the decision of a single man. Seemingly, the "will of the people" fell victim to the "will of the courts".

Enclosed is a short news article that I read yesterday. It tells of a judge who ordered a father to give four of his sons into state custody because he and his wife had violated that state's compulsory education act by teaching them at home. As a father, I can think of no more cruel or unusual punishment than to take away one's children. Surely this offense, if any, cannot justify such a terrible penalty.

These incidents, combined with the insight gained due to my professional involvement with the judicial system, give rise to a genuine fear of the power assumed by our federal and state judges. They seem immune to whatever check and balances our administrative and legislative branches attempt, and are unresponsive to even the expressed will of the voters.

The father deprived of his children wonders, "...if there's any authority to counter what this man has done." In search of an answer to this question that I have so often asked myself I discovered the following verse in my Bible. Ecclesiastes 5:8 states, "If thou seest the oppression of the poor, and violent perverting of justice and righteousness in a province, marvel not at the matter; for He that is higher than the highest regardeth; and there are higher than than they."

Seeing this in my daily work it is difficult for me at times not to "marvel at the matter". Nevertheless, as one in authority, I shall do all possible at my station to reduce such "oppression of the poor and violent perverting of justice and righteousness", but I'm convinced that efforts must be made at the highest possible levels of our government to reduce the focus of power held by these individual judges.

While maintaining faith in "He that is higher than the highest" I encourage you, Mr. President, to study and invoke whatever remedies may be most beneficial to restoring some balance of power in the judiciary. I believe this will help to insure for the people of this great nation the freedom and liberty we hold so dear.

Thank you for your time and may God continue to bless you and Mrs. Reagan in your next term.

Thank you very much for writing as you did. Needless to say, we are in great agreement. We can't turn to the "quick fixes" that have been the response to the previous recessions since . WW II. They have also been the cause of each succeeding recession.

I'm sure you know by now that we've made a proposal to the Congress for what I've called a downpayment on the present deficit. Of course, this is only a start. Much more must be done in the next year or two to bring about structural reforms and get us once and for all back to a balanced budget policy. This will include securing passage of a Constitutional amendment to require balanced budgets.

Our downpayment calls for some additional revenues but no change in tax rates. I've asked the Treasury Department to bring me a plan for overall tax simplification which could be taken up in '85. Some of the loopholes we presently propose closing would probably have been part of that simplification. However, we must not yield to those who are demanding surtaxes and increased rates. The answer to our persistent economic problems is less government not more, and certainly less redistribution of earnings.

Dear Mr. President:

According to the average stockbroker, the recent heavy selling in the stock market can be laid to concern about the federal deficit and its effect on interest rates in the future. My congressman, Don Pease, in so many words hinted at the impending turn in his last questionaire for his constituents. In one question he made first the statement that taxes would have to be raised and then asked, again in so many words, how we wanted to take the medicine (income taxes, surtaxes, etc).

Frankly, I am puzzled that people have been so startled to realize that the deficit is real; disappointed that the Federal Reserve is not going to roll the presses they are now rushing to sell. The federal deficit has been staring at my grandparents, my parents, and now me and my wife for fifty years. In my opinion the policies of the past guaranteed the fiscal condition of the government. Your policies have averted disaster.

But once again comes your opposition telling us that higher taxes— to which we are assumed to be accustomed— will fix everything by balancing the national budget. My common sense tells me that more taxes will solve nothing but the problems of the House of Representatives.

Our economy needs some new real growth businesses. Our trading partners in the free world, having borrowed a significant portion of our available capital, have now been entrusted to perform a lot of the work our country once did. This is necessary not just so they can pay back our banks but more importantly because these free people want a better life. Why do our citizens think they borrowed the money in the first place? Besides, these developing economies perform this work for a lot less and make quality goods.

In my view these events embody the only strategy we who love liberty can hope to provide protection against the dangerous competitors we all have in common- namely the tyrants of centralization. Not all of them call themselves communists. Someday perhaps free people can do more business in good faith with these oppressive systems. But for now there is apparent great risk in this plan.

To see a great investment made in the "emerging" free economies by our citizens subsequently confiscated by groups like the communists would be tragic and dangerous. Likewise, aggressively limiting the ability of centrally planned economies to operate can result in a perfectly natural but equally dangerous retaliatory response. In my opinion these are the overriding risks that require us to spend unfortunate sums on weapons and soldiers. Nobody likes it. But nobody could live the way Americans want to live if we do not spend this money now.

Printing exhorbitant amounts of money and raising taxes was the past method of trying to accomodate all things at once. It was a means to soothe the conscience of the prosperous or prejudiced when they had been forced to see the needy and outcast. This was a substitute plan for real change that only parents can teach children. But it was the easy way out. In my opinion, the quality of the result delivered to those this plan was supposed to uplift was a "ripoff" best described as hypocrisy. When capital formation opportunities better than our own economy's grew out of the zeal of our trading partners, the task of the Federal Reserve to keep the lamp lit around the globe became ridiculous. Gradually people realized it was unwise to save money or invest capital here. Every person I knew then had borrowed money to the hilt, expecting to pay later with inflated money. I personally suspect that many members of the House in particular, perhaps aware of the eventual outcome, doled out via legislation vast sums to their constituents while hoping for a magical answer to appear. Unfortunately it seems our government can no longer afford this sort of anasthetic- unfortunate for the Congress perhaps, but a blessing for the American people.

I am grateful to you and Mr. Volcker for recognizing the somewhat threadbare economy we have been wearing around for the last fifteen years while imagining it to be the emperor's new clothes. There is no long-run benefit that the federal government can generate with the kind of capital money our economy is requiring to develop less energy intensive, more productive lines of work. Only people at work trying to make a living by making something out of something else can do this job, unless of course, the government wants to go into business and try to make a profit. I would not be surprised to learn that many in Washington would favor the latter path to the former. Then Uncle Sam could raise taxes and prices too without having to wait for inflation.

Members of the Congress will now have a second chance to answer the same questions asked of them four years ago. The American people have grown wise to their plan of raising taxes and prices for the sake of concentrating greater amounts of our labor's fruits in some town on the Potomac River. How would the legislators like to go about stopping it? Would they rather shrink the government or stop the economy? I stand with you, Mr. President. I think higher taxes are a burden and exhorbitant money growth little short of a lie.

These are exciting times- watching so many tough questions answered by our democracy. I hope you got the job of President in time to help us. I want you to know that I will vote for you in 1984- with great admiration.

Dear Mr. Cornelison:

Thank you for writing and giving me an opportunity to respond. In view of the partisan demagoguery and the constant drum beat in much of the media -- especially the TV news I can appreciate why you feel as you do about military spending. May I present a few facts which have been overlooked?

First, there is no question about the need to balance the budget. I've been making speeches about that for 30 years. Our country has been following a policy of deliberate deficit spending for half a century. It is true I said I would set about balancing the budget. I also said I would restore our defenses which were in total disarray.

We had ships in our Navy which couldn't leave port for lack of men to man them. Half our planes on any given day couldn't fly for lack of spare parts, and for those that could, flying time was so limited to save fuel that our accident rate was on a steady climb. Officers and non-commissioned officers were leaving the service in such numbers we couldn't properly staff many units. The active reserve was virtually non-existent. Incidentally, our strategic nuclear weapons were at their lowest point in 25 years.

Well enough of that. Our buildup still leaves the defense spending at little more than onefourth of the total budget. Historically defense has been around half of federal spending. In Kennedy's term it was 47.8%. Those stories about waste and simple spare parts costing a hundred times more than they should are true. But we are the ones who provided those figures. We discovered these extravagances and have turned this around. There have been hundreds of indictments and millions of dollars in rebates.

So far Congress has given me less than half the spending cuts I asked for in the entire budget. If we had continued on the budgets projected by the previous Administration the present deficit would be \$191 billion bigger than it is. I've been trying for more than two years to get an amendment to the Constitution requiring a balanced budget, without success.

Dear Mr. President:

I have recently seen a graph of the <u>national debt</u> and the deficit expressed as a percentage of GNP. It is <u>frightening</u> to see the increase in the deficit. I do realize that some of it is built in and that it cannot be altered over night, but it must be stopped. It is certainly time for a constitutional amendment to require the government to live within its means as all of us must.

Although I realize we need a strong military in the real world, we cannot afford the kind of military spending we have been doing. If we become economically bankrupt military strength will be beside the point. I supported you strongly in the first election. But you promised to bring down the deficit. Even expressed as a percentage of GNP it is the highest ever! I also realize that congress plays a part in this, but you have been successful in keeping the military spending disproportionately high and I feel you dismiss your responsibility in that too lightly.

You have done exceedlingly well in helping get inflation down to a more reasonable level. But you will not have done your job until you also get the deficit to zero without raising taxes. You seem to be overly concerned about how Russia will interpret a reduction in military spending. If we correct our economy, Russia will have far more to fear than if we build more military strength. As Commander in Chief of the military, you can do much more than you have to eliminate waste, reduce overseas personnel and keep our military priorities straight. I think you are underestimating the number of voters who must be convinced that you are serious about balancing the budget. From your past performance we can't feel encouraged!

In summary, BALANCE THE BUDGET and get interest rates for homes back under 10%. If it takes cutting military spending, CUT. If it takes eliminating foreign aid, CUT.

Dear Mr. Peterson:

Thanks very much for your letter. Believe me I'm in complete agreement on the matter of the deficit. You probably are aware that we have approached Congress with a proposal that will reduce the deficit by \$150 billion over the next three years. Now before you say it let me say that isn't enough. I've called this a downpayment because the structural changes needed to do more must be carefully studied and put into legislative form. We have almost 2500 specific proposals in the Grace commission study. They represent the best thinking of almost 2000 leaders in business and industry from the private sector.

I'm not going to minimize the deficit but want to point out as a percentage of G.N.P. it is more manageable than it seems if we compare the number of dollars to past deficits. So far we've cut the rate of growth in government spending in half and would have done better if Congress had given us the spending cuts we asked for. So far we've been allowed a little under half.

But you are right, we must take our case to the people and will do so in the days ahead.

Dear Mr. President:

I urge you to forget normal political guidelines and go directly to the American people on the deficit situation. This has been postponed far too long, and can be illustrated by the following facts:

- 1. Since your inauguration, Federal debt has increased an incredible 76%.
- 2. Interest paid by the Federal government has grown from \$20.6 Billion in 1972 to about \$125 Billion in fiscal year 1984.
- 3. Interest expense as a share of Federal outlays has increased from 6-3/4% in 1972 to 14-1/2% in fiscal year 1984.
- 4. Interest expense alone equals 70% of private capital generated in the economy.
- 5. The Deficit, which must either be financed or monetized, is at \$180 Billion, approximately equal to private capital generated.
- 6. Federal spending is growing faster than receipts; there has been no meaningful control over spending put in place. In the current budget proposal, spending is slated to increase 7% vs. 4-1/2% probable gain in national output.

Mr. President, neither all the political talk anyone can put together, nor all the charts the Treasury staffers can construct can refute that this tide of red ink has the potential to sink this economy, and place an intolerable future debt servicing burden on our children and grandchildren. These deficits and their future trending burdens are what keep real interest rates so high. Further, they are partially responsible for our high trade deficit.

We cannot wait to solve this until 1985--in 1985 there will be 1986's Congressional race, in 1986 there will be the 1988 Presidential race, etc., etc. The \$100 Billion "down payment" idea is fine for a start, but unless you want to kill the potential for a long-term economic recovery, much more needs to be done, and the only way to accomplish this is to go across the board in spending cuts. I think this can be explained to the public. The reduction in spending would lower interest rates and inflationary pressures, which would present an offsetting benefit to the reduced spending. I urge you to take this crucial issue to the American people. I ask you, what government agency can really argue persuasively that they can not find 5-7% in spending reductions that could be accomplished?

How long will we protest foul air, felled trees, endangered species or bewail the "inhuman" treatment of cats, dogs, fowl and fish and allow such "human" treatment of our unborn babies?

In this day of dilemma for our youth with unwanted pregnancies, you have courageously lit your lamp for all here and in eternity to see. Keep that light going, I beg you, sir, for the sake of countless infants and their misguided mothers-to-be. The latter, who, in pursuing their right to joy in sex, have denied the right of those so conceived to live. The wail of their aborted babies may well be the sound they hear in their unending hereafter, crying for the Creator they may never see.

Dear Mr. President:

I am writing to you in support of your recent statements against abortion. In attempting to define the magnitude of this problem I will refer to statistics from the National Center for Health Statistics and from a recent article in the New England Journal of Medicine. These sources cite that in 1980 approximately 1,180,000 abortions were reported to the Center for Disease Control. This amounts to approximately 3,200 abortions per day and represents a ratio of 359 abortions per 1,000 live births, i.e. one child aborted per 2.8 live births. Maternal mortality is 1.3 deaths per 100,000 abortions, which would amount to approximately 15 maternal deaths per year.

As a physician I see many ironies in the way our society deals with the unborn child. In the mid 1970's it was felt that an infant born at 28 weeks gestation had approximately 15 per cent chance of survival. In the last 5 to 10 years those chances have improved dramatically. In fact, handled in appropriate high-risk medical centers a 28-week gestation infant has a very good chance of survival. Authorities are now indicating that the survival rate of a 24-week gestation infant in appropriate centers is approximately 30 per cent. In Illinois a woman wishing to have an abortion may do so relatively easily up to 16 weeks gestation. An abortion can be performed at 20 weeks in Madison, WI, and 24 weeks in St. Louis, MO. On the other hand, if a woman has a spontaneous abortion and the infant weighs less than 14 ounces and is less than 4 3/8" in length, which occurs at approximately 18 to 20 weeks gestation, the infant is considered a miscarriage by the state. No funeral arrangements are necessary. An infant above these measurements is considered an individual and is handled as such with proper funeral arrangements. Why is it that we will go to great lengths and spend tens of thousands of dollars in trying to salvage and sustain the life of an infant at 24 weeks destation in one instance, yet abort other infants of the same gestational age? I do not understand how we can consider the unborn child a life in one situation and not a life in the other.

Those who would argue in favor of abortion point to the rights of the woman in having the freedom to choose what happens within her body. Arguments are also made that abortions are a rational choice when there are known deformities of the unborn child. An example of this is Down's syndrome. Physicians go to great lengths to detect in utero the presence of such conditions, giving moms the option to elect an abortion. A Down's syndrome child certainly has the potential for many physical deformities, the most pronounced being the potential for significantly reduced intelligence. Other issues such as birth control, inconvenience, inability to care for the child and financial considerations are also arguments made in favor of abortion.
