## Dear Chris:

Hearing your April 5 newscast regarding the Administration's record on women's issues, I have to believe you lacked some information. I'm speaking of your assertion that there has been "a sharp cut in enforcement of equal opportunity laws," etc. -- that we are handling 75% fewer cases than three years ago.

In FY 1983, the EEOC closed 19% more complaint cases than in 1980 (68,058 cases in 1983, compared with 57,327 cases in 1980). Total financial settlements recovered by EEOC through complaint processing for victims of discrimination in 1983 were 158% more than in 1980 (\$147.9 million in 1983, compared with \$57.3 million in 1980). In addition, EEOC recovered 74% more in total financial settlements for victims of discrimination through litigation in 1983 than in 1980 (\$35 million in 1983, compared with \$20.3 million in 1980).

You said, "And backpay awards for women working for federal contractors have dropped from more than \$7 million in 1980 to \$294,000 last year." OFCCP's records show that it collected \$947,000 in back pay for women last year (in addition to \$5.8 million in other wage adjustments and other financial settlements on behalf of women). backpay figure is lower than in 1980 primarily because OFCCP in this Administration has pursued a policy of reducing the competition and overlap with EEOC's nondiscrimination activities which prevailed in the last Administration. While total back pay recovered by OFCCP has thus dropped \$12.4 million (from \$16 million in 1980 to \$3.6 million in 1983), this drop has been eclipsed by the \$105.3 million increase in REOC recoveries of back pay and other financial settlements during those years. (Note: EEOC does not break out back pay recoveries by sex.)

Compared with 1980, OFCCP completed 38% more complaint investigations and 63% more compliance reviews in 1983.

Your third point was that "The number of poor working women is up sharply . . . and women are still pouring into the lowest paying jobs." The total number of working women is up sharply, rising by 1.7 million or 3.8% from December 1982 to December 1983. Employment of women executives, administrators, and managers is growing even faster, 8.9% during this period. The comparable growth figure for men is only 1.3%.

Dear Mr. President.

I am writing this letter in support of your Central America policy, especially as regards support for Honduras and actions against the Sandanista government in Nicaragua.

My wife and I are both United States citizens. I have worked throughout Central America including eastern Nicaragua during the regime of Anastasio Somoza. I am a medical doctor and my wife is a registered nurse. We are presently working as medical missionaries with the Miskito Indians in far eastern Honduras only 25 miles from the Nicaraguan border. Much of our work is with Miskito Indian refugees that have fled the oppression in Nicaragua.

After talking with a great many Miskito families who have had their food and belongings confiscated, their houses burned, and family members imprisoned or killed by a regime that claims it has no hard feelings against the Miskito, it is quite difficult for us to listen to smug Congressmen speak in favor of the Sandanista government. The Sandanistas like many of the Communist bloc speak their lies so loudly, widely, and persistently that many naive onlookers take them for the truth.

In November of 1983, our small village of Cauquira received medical aid as part of the Big Pine II operations. A U.S. Army UH-60 Blackhawk helicopter with an American crew brought in a vaccinating team that was able to dispense free vaccines to village children. I feel it is very important that people in the United States are informed of the humanitarian and social aspects of these operations. Many people in Honduras have benefited from help provided by U.S. Military personnel during these exercises.

Keep up the good work. We hope that your Central America support budget is passed intact through Congress. My wife and I both support you in your bid for reelection.

Dear Mr. President:

This has been America month here in Vienna. In the past three weeks I have been able to welcome Bill Buckley, Jean Kirkpatrick and Larry Eagleburger for seminars, speeches, debates, interviews, etc. Needless to say, each of them was superb, stimulating public discussion about world affairs the likes of which haven't been seen in some time.

Mr. President, before you embark on your important mission to China, may I unburden myself of a growing concern?

As you know so well from experience, campaign seasons hold special challenges for an incumbent. It takes a great deal of strength for a President to stay the course in light of all the well-meaning advice from supporters and friends to adjust and change policies as necessary in order to assure re-election. Unless I totally misread the signals, there are forces at work to convince you of the "need" for an arms control agreement. I certainly hope you don't believe it for a moment! What we need is a President who continues a realistic approach towards the Soviet Union in general and arms control in particular.

While the Europeans have probably been our worst critics in this area, I see signs everywhere that they are finally coming around to realizing that failure to achieve an agreement lies not with us but with the Soviet Union. Larry Eagleburger delivered a poignant speech on the subject (a highlighted copy is attached). No one argued with his reasoning; it was followed by total silence! If the Europeans can be sensible about it despite all the emotionalism that preceded the deployment of the Pershings and cruise missiles, I have faith that the Americans will be rational too!

Mr. President, please don't interpret this letter as lack of faith in your commitment to principle. I know better. But it's precisely for that reason that I ask you to beware that no one drags you into a summit that's unlikely to produce meaningful results.

It was wonderful seeing you during our state visit which, by all accounts, was a great success.

They know, however, exactly where I stand with regard to Taiwan and, incidentally, so do our friends on Taiwan. Our relationship is as solid as ever.

reception to members of the Trilateral Commission, President Reagan has figuratively thumbed his nose at those of his conservative supporters for whom the commission has become the symbol of amorality in foreign affairs. Then why did the President cater to this bete noire of the Right and darling of the international bureaucrats? Simple. Politics.

It seems certain that the decision to wine and dine the Trilateralists was a cold and calculated attempt to buy votes among the foes of the populists who comprise Reagan's staunchest line of support. The President, a shrewd politician, must have felt that he was running a safe risk. After all, it wasn't likely that the Left's kept presidential candidates, Walter Mondale, Gary Hart and Jesse Jackson, would protest.

But Reagan may also have succeeded in undermining the morale of those of his conservative backers who understand what the Trilateral . Commission represents.

Contrary to the hairy scaremongering of extremists, the commission is not a subversive organization. It is not controlled by Moscow or some other foreign powler. Its members are motivated not by any fondness for Marxism but by common global financial interests land visions of One World in which they and others of their ilk prosper.

In playing host at a White House connections running back to Cyrus Eaton's old Pugwash confreres, the United World Federalists, the Bilderbergers, the World Affairs Councils, and other internationalist groups - literally groomed Carter for the presidency. Eager to have a Southerner in their ranks, the founders of the Trilateral Commission invited then Georgia governor Carter to join. It was partly under Brzezinski's tutelage that he began what he himself later described as 'a splendid learning opportunity."

As President Reagan knows full well, under Carter, America's disastrous foreign policy was, in fact, Trilateralist foreign policy. Members of the organization occupied most of the key positions -Carter in the White House, Brzezinski as Carter's top national security adviser; Cyrus Vance as Secretary of State, Harold Brown at Defense and W. Michael Blumenthal at Treasury.

At one point, at least 16 highposts in the Carter administration were held by men and women associated with the Trilateral Commission. They included Andrew Young, U.S. ambassador to the United Nations; Deputy Secretary of State Warren Christopher; Anthony Solomon, deputy secretary for Monetary Affairs; Elliot Richardson, representative to the U.N. Law of the Sea Conference, whose proposed giveaway of U.S. offshore natural resources Reagan helped scuttle; Sol

So now, more than two months after the event, the word is out: the 18: New Hampshire Superior Court justices voted unanimously to allow law enforcement officers to wear their sidearms in court.

- According to Chief Justice Richard Dunfey, he placed the item on the agenda of the January 26th session of the trial court justices because he "wanted uniformity and didn't want 18 judges going in nine different directions."

? And why have the judges maintained a studied silence concerning their vote of two months ago? Well, says Dunfey unconvincingly, "we weren't hiding our action. My main concern was to seek uniformity" until such time as "any other rules or


regulations were promulgated by the Supreme Court."

The decision taken by the judges, Hizzoner said, "didn't require advertising . . . I didn't feel it was our business to go herald this or make a press production of it."
