Following the discovery and implementation of his painting medium, he received four of his earliest mural commissions. Among these early commissions were Grant's Tomb in New York City and Treasury Department commissions for Post Offices in Augusta, Georgia, West New York, New Jersey and Rosenberg, Texas. These early mural paintings prepare him for the murals for the "West Point of the Air" at Randolph Field, Texas.

## TITEMS OF INTEREST AND EVENTS WHICH DEAN FAUSETT IS MOST PROUD

1. DISCOVERY AND DEVELOPMENT OF SPECIAL PAINTING (EMULSION) MEDIUM.

This medium has been responsible for most of Dean Fausett's accomplishments in the field of classic traditional painting. Through the encouragement of his older brother, Lynn Fausett, a painter, muralist and President of the Art Students League of New York as well as other painters and instructors such as: Reginald Marsh, Edwar Laning, Isobel Bishop, Kenneth Hayes Miller, Kimon Nicholaides, Boardman Robinson, the great German authority, Dr. Max Doerner and the French authority, Jacques Maroger he found his way to the techniques of the old masters on which he based his direction in painting resolve. \*

- 2. CARNEGIE PRIZE.
  Was awarded the Carnegie Prize in 1940 and 1946 in Pittsburgh,
  Pennsylvania
- 3. JOHN SIMON GUGGENHEIM FOUNDATION FELLOWSHIP. Received the fellow-ship in 1940 and a renewal in 1942. It was during these fellowships that he painted three thousand square feet of murals at Randolph Field, Texas from 1941 thru 1943 from a direct assignment from General "Hap" Arnold, Chief of Staff.
- 4. NATIONAL SOCIETY OF MURAL PAINTERS AWARD FOR "BEST WAR MURAL" IN 1944. This award was presented at the Architectural League of New York and carried honorary membership in the Society of which he has been the President for the last five years.
- 5. SELECTED AS ONE OF THE NATION'S "TEN BEST". This was awarded by the Art Magazine editors in an exhibition held at the famed Durand-Rhuel Galleries and arranged by "ART NEWS" in 1944.
- 6. CO-INITIATED AND FOUNDED THE SOUTHERN VERMONT ART CENTER.
  In 1950 Dean Fausett with Richard M. Ketchum and the then Board of Directors of the Southern Vermont Artists, Inc. founded the Southern Vermont Art Center in Manchester, Vermont. He served as President of the Art Center from 1959 to 1961.
- 7. PRESIDENT DWIGHT D. EISENHOWER APPOINTMENT. Appointed as Artist Consultant to the Chief of Staff of the newly organized United States Air Force. During this time he painted the Air Force Signet painting "GLOBAL POWER" for the U. S. Capitol and "FLIGHT THROUGH THE AURORA BOREALIS" for the Pentagon. Both paintings helped to establish the United States Air Force Historical Foundation, a collection of Air Force history. During this period he painted portraits of many Washington notables including studies for his portrait of President Eisenhower which was later completed in California.

8. MAJOR MURAL COMMISSIONS IN THE LATE 1950'S.

"BROTHERHOOD OF MAN" (1956), Entrtance Foyer, Building for Brotherhood, National Conference of Christians and Jews, New York City.

"THE FOUR CHAPLAINS", Rogal Room, YMHA, University of Pittsburgh, Pittsburgh, Pennsylvania (1957)

"EDUCATION IN A FREE SOCIETY: (1959) Entrance Foyer, New Jersey Department of Public Education, Trenton, New Jersey.

- 9. PORTRAIT OF SIR ALEXADER FLEMING. Painted a heroic-scale portrat of the great Scottish scientist, Sir Alexander Fleming, the discoverer of penicillin in his laboratory. The portrait was unveiled for the dedication of the new Headquarters of the AMERICAN Academy of General Practice, Kansas City, Missouri.
- 10. IMPORTANT COMMISSIONS DURING THE 1960'S AND 1970'S.
  "IMPORTANT EVENTS IN THE LIFE OF GENERAL ARTHUR ST.CLAIRE" (1965)
  Mural on the Revolutionary War General for the St.Clair Wing of
  Fort Ligonier Museum, Ligonier, Pennsylvania.

Dean Fausett's paintings to celebrate Major John Wesley Powell's exploration of the Green River and Colorado River canyons of 1869-1873 were featured in the Centenial Celebrations held throughout the West and Southwest. During three painting trips to Lake Powell, several large muralesque panels were painted for the Bureau of Reclamation, Department of the Interior. These paintings are shown at the Visitor's Center of Glen Canyon Dam in Page, Arizona.

Two large muralesque paintings "LASOOING THE IRON HORSE" and "PURSUIT AT SUNSET" depicting the Plains Indians and the early railroad were commissioned by the Union Pacific Railroad Foundation and unveiled in 1972 in the Buffalo Bill Historic Center as part of the Whitney Gallery of Western Art in Cody, Wyoming.

- 11. During the late '60s and early 70s a grand tour of forty seven exhibitions were held throughout the West and New England which were initiated by a retrospective hexhibition at Dean Fausett's home University, Brigham Young University in Provo, Utah. This exhibition included over five hundred works borrowed from major museums and collections, many paortraits and preliminaries for murals as well as oils and watercolors of landscapes and still lifes from many parts of the world.
- 12. BICENTENNIAL YEARS. Dean Fausett as Vice President and President of the National Society of Mural Painters was responsible for the tour of the Society's "CARAVAN OF FREEDOM", murals designed on "AMERICAN FREEDOMS" and the portfolio of mural designs "MOMENTOUS EVENTS IN AMERICAN HISTORY". Fifty one American muralists are included in the latter which will circulate the United States as a benefit for the United States Capitol Endowment Fund. The tour has reached some forty three institutions to date.

August 1976, Dean Fausett was honored at St. Andrews University in Scotland when the Honorable Ann Armstrong, United States Ambassador to the United Kingdom presented to the Scottish people a heroic-scaled portrait of President Dwight D. Eisenhower. The muralesque painting had been purchased by a group of Scottish American Societies to present to the people of Scotland as a Bicentennial gift for having made a home and headquarters for General Eisenhower during his leadership as Chief of Staff during World War II in the European Theatre of War. This honor was deeply appreciated by the artist, as his "Green Mountain Boys" ancestors were of Scottish origin in 1648.

"DEAD - HEART - HANDS - HEALTH", a commemorative mural for the J.C. Penney Hall (1977), National 4-H Center, Washington, D.C. The mural honoring Mr. J.C. Penney was attended by over three thousand people and marked Dean Fausett's love of painting children for which he had gained fame not only in his murals, but as subjects throughout his career.

13. ADDRESS TO JOINT HOUSES IN SEPTEMBER 1982. Dean Fausett was invited the Senate and House of Representatives to deliver an address representing the artistic community of the United States in September 1982. The address was to pay tribute to Dr. Allyn Cox, a fellow muralist who had completed murals in the Capitol Rotunda and the corridor ceilings in the House of Representatives. The address was delivered as part of a beautiful ceremony in Statuary Hall, the old Senate chamber. Following this address he flew to Eastern Illinois University to install an exhibition of his paintings for the dedication ceremonies of the beautiful Tarble Arts Center.

Dean Fausett's current labors in New York are to further the Grand Opera productions given free to the public in New York's Central Park Mall and developing a permanet headquarters and galleries for the National Society of Mural Painters.

CHICAGO--Dr. John Willingham, a native of Charleston, and Dean Fausett, a nationally-recognized artist, will receive honorary degrees from Eastern Illinois University at spring commencement ceremonies on May 12.

Authorization was given today by the Board of Governors of State Colleges and Universities at the request of President Stanley Rives. Willingham will receive an honorary Doctor of Law degree and the honorary Doctor of Humane Letters degree will go to Fausett.

Willingham, son of Mrs. Russell Willingham and the late
Mr. Willingham, is a partner in Peat, Marwick, Mitchell and Company,
one of the nation's largest public accounting firms. He is responsible
for research activities in the company's main offices in New York.

A 1957 graduate of Eastern, Willingham holds the Ph.D. from Ohio State and the M.S. from Pennsylvania State University. He is a certified public accountant in Illinois, Ohio, New York, North Carolina and Louisiana.

Before joining his present firm, Willingham was a professor of accounting at the University of Houston. He began his professional career in 1958 as a staff accountant with Dill and Rowland, an accounting firm in State College, Pa.

Willingham is co-author of five books and many magazine articles. In 1978 he was named a Distinguished Alumni by Eastern's School of Business.

Dean Fausett, American artist of national and international recognition, son of George Adelbert Fausett and Helen Josephine Bryner Fausett, was born July 4th 1913 in Price, Utah.

He received his early college art training at the Brigham Young University in Provo, Utah. Following these studies in painting and sculpture, he joined his older brother, Lynn Fausett, a prominent American muralist and President of the famed Art Students League of New York where he studied under many prominent painters and sculptors of the '30s and '40s.

Fausett was awarded a Tiffany Fellowship under which he painted for three seasons in the studios of Mr. Louis Comfort Tiffany in his Laurelton home on Log Island, New York.

As an assistant, he worked with his brother and Hildreth Meire on murals for the Union Station, Kansas City, Missouri, Nebraska State Capitol in Lincoln, Nebraska, Washington D.C. Cathedral, Saint Michaels Monastary Church in Union City, New Jersey. He also assisted his brother on murals for the Chicago Tribune Tower.

Fausett's artistic strengths are also in the fields of portraiture and landscapes. Among his portrait subjects have been Dwight D. Eisenhower, Eugene Ormandy, Sir Alexander Fleming, Grandma Moses the Duke and Durchess of Windsor, Lord Methuen of Corsham Court in England and currently President Ronald Reagan. He is well known for his portraits at home and abroad.

Honorary Degrees

Dean Fausett is represented by his figure paintings and landscapes in major museum collections across the United States which includes the Metropolitan Museum of Art, The Whitney Museum of American Art and the Museum of Modern Art in New York. Other collections which include his work are the Art Institute of Chicago, San Diego Museum, Harris Fine Arts Center at the Brigham Young University, Witte Museum in San Antonio, Texas and the Whitney Gallery of Western Art in Cody, Wyoming. He has won prizes at the International Exhibition of the Carnegie Institute in Pittsburg, The Chicago Institute of Art and the Salamagundi Club in New York.

Fausett's early mural commissions began at age twenty four and include murals in Grants Tomb, government buildings in Augusta, Georgia, Rosenberg, Texas and West New York in New Jersey. In 1941 he was commissioned to paint three thousand feet of mural under two Guggenheim Fellowships by special assignment from General "Hap" Arnold for the "West Point of the Air" at Randolph Field, Texas. Fausett served under an Eisenhower appointment as Consultant to the U.S. Chief of Staff in the Pentagon where he painted "Flight Through the Aurora Borealis" and "Global Power" for the Capitol. His World War II murals earned him a gold medal at the Architectural League of New York and an honorary membership in the National Society of Mural Painters of which he is now its President.

Other murals which-gained Fausett national recognition include "The Brotherhood of Man" in the Building for Brotherhood in New York, "The Heroism of the Four Chaplains", Pittsburgh, Pennsylvania, "Education in a Free Society", New Jersey Department of Education in Trenton and "Head, Heart, Hands and Health" for the 4-H National Headquarters in Washington, D.C. Two large murals, "Lasooing the Iron

Horse" and Pursuit at Sunset" were commissioned by the Union Pacific Railroad for the Whitney Gallery of Western Art, Buffalo Bill Historic Center, Cody, Wyoming.

As one of the nation's leading muralists, Fausett was a guest of honor at the formal opening of the Tarble Arts Center,

Eastern Illinois University. An exhibition of his work was shown at that time. He will open an exhibition this Spring at the Tarble Arts Center which will include works by fifty one American muralists of "Momentous Events In American History".

Before coming to Eastern Illinois University for the inaugural showing of his work for the dedication of the Tarble Arts Center in September 1982, he addressed a joint celebration of the Senate and House of Representative in Statury Hall of the Capitol in Washington, D.C. Fausett was chosen to represent the artistic community of America in an address as a national tribute to Dr. Allyn Cox who had completed his historic murals in the Capitol.

Fausett divides his time between his New York studio in the "des Artistes" and Dorset, Vermont where he lives in a pre-Revolutionary house in which the Green Mountain Boys founded the independent State of Vermont and where Ethan Allen and Seth Warner planned Revolutionary military strategy.
