Ronald Reagan's faith in his own insights is a continuing inspiration, and I will happily contribute to any monument that would memorialize the chief of these, for instance: "ON THIS PODIUM ON MARCH 23, 1983 PRESIDENT RONALD WILSON REAGAN ANNOUNCED HIS STRATEGIC DEFENSE INITIATIVE WHICH LED TO LIFTING THE THREAT OF NUCLEAR HOLOCAUST THAT TORMENTED MANKIND DURING MUCH OF THE TWENTIETH CENTURY."

Mr. Reagan saved the day by acting on that insight, but it was a very narrow miss, and the circumstances of the occasion have hugely enhanced the resources of the enemy, foreign and domestic. Yes, foreign and domestic.

Foreign because it should now be clear that the Soviet
Union's obsessive fear of our space shield was behind the
high drama of their proposals. Mind you, they were, in the
end, empty proposals, but they were enough to dazzle minds
parched for synthetic disarmament. The Soviet Union was going
to eliminate intermediate nuclear weapons from the face of
Europe, in return for the United States doing the same thing.
Wow. Then the Soviet Union would reduce its major strategic
nuclear inventory by fifty percent, and so would we. Double
wow. And then by the end of the century, or perhaps earlier
-- who knows -- there would be a total elimination of nuclear
bombs: and all of that, the result of a single meeting in

Iceland. Sort of renews one's faith in the deliberative process, does it not?

Ronald Reagan would then have returned to the United
States to answer a few questions. Among them: How would we
in fact police the elimination of the theater weapons by the
Soviet Union? Given that these are mobile, exactly how would
we find a hundred or two in the event the Soviet Union
followed its customary practice of cheating on treaties? What
would "verifiable" mean? You could make a deal with a
haystack giving you full rights to verify its agreement not
to husband a needle, and you have the agreement, but the
haystack is pretty safe with its needle.

And the Soviet Union's strategic missiles are reduced by one-half. Reduced, to use round numbers, to five thousand. These are the international warheads, the ones that can pop El Paso, Texas, if told to do so. Question: How is Paris, France, or Florence, Italy, left safer by the apparent absence of the smaller, theater weapons? A missile capable of soaring 9,500 miles to its target can be directed to go a mere 950 miles to a closer target? Presumably the only argument against using it for such purposes would be the waste of gas, an extravagance the Soviet Union might be willing to put up with, in a tense situation.

Question: If indeed we are going to strip western Europe of all nuclear weapons, what is it we would propose to do in the event that the Soviet army marched west into the area in which we have sixteen American divisions? By what means would

we propose to defend them? By firing nuclear warheads from Omaha, Nebraska? And since this is unlikely, what would be the effect on west European politics of the apparent delinking of America's nuclear umbrella from its little nuclear parasols within western Europe?

And then, of course, the major question, the only question. What reason have we to believe that, on that critical open future date, the Soviet Union would actually agree to move across the apocalyptic threshold, defined as the point beyond which its entire remaining nuclear force would cease to threaten the entire United States? What evidence is there that it has ever crossed the mind of Gorbachev, or of any known likely successor to Gorbachev, so to emasculate Soviet nuclear power, leaving the Soviet Union a massive, indigent East European state?

But hear now the peacenikery. Already, sundry U.S. senators have said that Ronald Reagan has missed the greatest possibility since the Congress of Vienna to bring peace to our time. And the Social Democrats in Europe will raise a clamor alongside which the fight against the deployment of the Pershings and the cruise missiles was nothing. Their demand is horribly easy to formulate: KILL SDI. And the domestic enemies of the best opportunity the world will ever have to seek out at once freedom and independence, together with the elimination of the practical threat of nuclear confrontation, will go after Ronald Reagan, to kill SDI. They will fight him on the seas and oceans, in the air, and on the beaches, in the fields and in the streets and in the hills.

They will never surrender. Ronald Reagan is beleaguered as he was never beleaguered before Reykjavik.

And only he, backed by the American people, can get us back on course. That course is the development of SDI.

SUBJECT:

Guaranteed Minimum Rate on U.S. Savings Bonds

As you are aware, interest rates have come down sharply this year. Under the present law, the Secretary of Treasury, with your approval, fixes the investment yield on U.S. Savings Bonds.

Because of the drop in interest rates, the present guaranteed minimum rate of 7.5 percent destroys the cost-effectiveness of the savings bonds program. Attached is a memorandum from Secretary Baker recommending a new 5.5 percent guaranteed minimum rate effective November 1, 1986.

However, due to current market conditions, the Chief of Staff recommends that the rate be lowered to 6 percent, not 5.5 percent. In fact, although the public accepts the need to lower the rate, the potential rate change has been recently criticized in the press for penalizing small investors who constitute a large percentage of savings bonds purchasers.

I recommend that you approve the attached memorandum, but that you add a note that the rate be lowered only to 6 percent, not 5.5 percent. This has been discussed with Secretary Baker who concurs with this recommendation.

SUBJECT: Reduction in the 7.5 Percent Guaranteed Minimum Rate on

U.S. Savings Bonds.

Under existing law, the Secretary of the Treasury, with the approval of the President, is authorized to fix the investment yield on savings bonds. In October 1982 you approved our current offering of market-based Series EE savings bonds with interest rates equal to 85 percent of the rate on 5-year Treasury marketable securities for bonds held at least 5 years. Such bonds also include a guaranteed minimum rate of 7.5 percent. Market yields, however, have declined substantially since 1982, and it has become apparent in recent months that the 7.5 percent floor must be reduced in order to maintain the cost effectiveness of the savings bonds program and to avoid excessive competition with other savings forms. On April 30 Treasury announced that it is considering the need to reduce the 7.5 percent floor. Reactions to the announcement suggest general public recognition and acceptance of the need to reduce the rate.

The new variable-rate savings bonds have been very well received by investors and have resulted in substantial savings to the Treasury in the costs of financing the public debt, as compared to financing with marketable securities. In order to continue these savings, I recommend that the guaranteed 7.5 percent minimum rate be reduced to 5.5 percent, effective November 1, 1986.

New issues of Series EE bonds held less than 5 years would earn interest on a fixed graduated scale, rising from 4 percent at 6 months to 5.5 percent at 5 years. New issues of the companion Series HH current income bonds would earn a flat 5.5 percent. There would be no reduction in the guaranteed yield to maturity for outstanding Series E, EE, H, and HH bonds. Similarly, there would be no change in the formulation of the market-based variable interest rate on Series E and EE bonds.

The new guaranteed minimum rates for savings bonds should be announced no later than October 29 to go into effect November 1, 1986.

Grand Dame Of Mississippi: Delta Queen Sails Through 60th Year, Sprightly As Ever

NEW ORLEANS

The ghost of Annie Christmas, the legendary too-tall harlot of old Natchez-Under-The-Hill up the Mississippi where river men of old came to pay and play, salutes another big Muddy regular wayfarer every time she ties up with a roster of spenders — the old Delta Queen. The paddle-wheeler, owned by more different kinds of people and enterprisers than the most recalcitrant runaway slave, still preens herself and cuts a mighty fine figure in this, her 60th year.

How foxy is she?

Consider these happenings in 1986:

In July, she went up the "four rivers" (Mississippi, Ohio, Tennessee and Cumberland) opener to Nashville in time to coincide with the birthday of another venerable 60-year old institution, the Grand Ole Opry, of WSM-TV origin. They jibed so well, it was announced there will be seven return cruises in the 1987 paddle-wheel season.

The same month, she was participant in a reachout from the Soviet Union's INTOURIST, which decided to go afield with its annual custom of a "peace cruise" on the Volga, and the Delta Queen was bought out for a thematic, slow-paced meander from St. Paul to St. Louis, wearing a big banner proclaiming "Promoting Enduring Peace."


Delta Queen versus the Mississippi Queen. And the Delta Queen won the Commodore's Cup in that one!

The Commerce interest was tied tightly to U.S. efforts to bring potential Japanese tourist attention that the American land mass includes more than Los Angeles and Disneyland, Orlando and Disney World, and Gotham — for instance, fun, frolic and relaxation to a Dixieland beat all over navigable portions of the mighty river system central to this country.

Delta Queen Reprieved

The Delta Queen, on the rivers since 1926, has just emerged from dark days ahead into the sunlight. He asked Jerome Kern and Oscar Hammerstein II to do the music, and they did provide the score for the hit which went 572 performances in the old Winter Garden in New York. That was "Showboat."

The Delta Queen has had a struggle on her hands almost since the National Registry of Historic Places officially recognized and listed her in 1966. Plagued by legislative memories of the Morro Castle disaster at sea in 1934, over-zealous solons have picked on her periodically lintil wiser


