

CARLTON E. TURNER, PH.D.
Deputy Assistant To The President
For Drug Abuse Policy

President Reagan appointed Carlton E. Turner as Special Assistant to the President for Drug Abuse Policy on April 7, 1983. Dr. Turner joined the Administration in July 1981 as Senior Policy Adviser for Drug Policy and on June 24, 1982 was sworn-in as Director of the White House Drug Abuse Policy Office in the Office of Policy Development.

In his position at the White House, Dr. Turner is primarily responsible for assisting the President in formulating policy for, and in coordinating and overseeing, international as well as domestic, drug abuse functions by all Executive agencies. He serves on the Cabinet-level Executive Board of the National Narcotics Border Interdiction System, assists the First Lady in her drug abuse education projects and works with the private sector as they join the President's Drug Awareness Campaign.

Dr. Turner was born on September 13, 1940 in Choctaw County, Alabama and educated in Organic Chemistry at the University of Southern Mississippi; B.S. 1966, M.S. 1969, Ph.D. 1970. He is married and has two daughters.

Immediately prior to joining the Administration, Dr. Turner was Director and Research Professor at the Research Institute of Pharmaceutical Sciences, School of Pharmacy, University of Mississippi (on leave of absence). Since 1971, he has also served as Project Director for the National Institute on Drug Abuse (NIDA) Cannabis-Coca Project where he was responsible for all phases of a large multi-disciplinary research program (from which he is now on leave of absence).

Dr. Turner has been working in drug research since becoming a postdoctoral fellow in the NIDA sponsored Cannabis-Coca Project. In the area of drug research, he has published over 100 scientific papers, patents, chapters in books and is co-author of Marijuana, An Annotated Bibliography, Volumes I and II. In addition, Dr. Turner has lectured widely on issues pertaining to drug abuse; international cooperation, drug law enforcement, education and prevention, and research.

Dr. Turner is listed in American Men and Women of Science, Men of Achievement, Dictionary of International Biography, Personalities of the South and Who's Who in America. He is the past president of the American Council on Marijuana's Scientific Advisory Board.



DRUG ABUSE POLICY OFFICE WHITE HOUSE OFFICE OF POLICY DEVELOPMENT

The Director of the Drug Abuse Policy Office is responsible for coordinating and overseeing both international and domestic drug abuse functions by all executive branch agencies. Eleven cabinet departments and 37 Federal agencies are involved in the broad Federal effort. The Director of the Office is also the primary drug abuse policy advisor to the President of the United States. Dr. Carlton E. Turner, PhD, is Deputy Assistant to the President and Director of the Drug Abuse Policy Office.

In addition to overseeing the drug law enforcement and health-related drug abuse activities of the Federal Government, the Director also is responsible for encouraging private sector activities to reduce the abuse of drugs. The primary drug abuse policy document is the National Strategy for Prevention of Drug Abuse and Drug Trafficking which is published by the Drug Abuse Policy Office. The 1984 Strategy establishes a comprehensive national strategy where all individuals; all business, civic and social organizations; all levels of government, and all agencies, departments and activities within each level of government are called upon to do everything they can to eliminate drug abuse in the United States. The Strategy sets forth the tone and direction of the national response to drug abuse problems and is designed as a source of information and guidance to assist and encourage the private sector in efforts to reduce drug abuse.

The Director also oversees the implementation of the Strategy within the Federal Government, to include monthly meetings with the heads of the Federal agencies which have major drug abuse program responsibilities. An annual budget review of the Federal drug abuse programs is conducted each spring. Additionally, the Office places special emphasis on selected programs which are key to the implementation of the National Strategy. The oversight functions of the Office include international narcotics control, border and domestic drug law enforcement, treatment and rehabilitation of drug users, drug abuse education and prevention, research activities, and drug abuse reduction within the Armed Forces of the United States. The Office also assists with and coordinates support of specific private sector initiatives such as the preparation and distribution of over 4 million drug abuse awareness comic books to young school children, the development of the Pharmacists Against Drug Abuse program, and numerous other national programs sponsored by the private sector.
