Dear Mr. President:



Dear President Reagan:

As a federal employee it has come to my attention that you intend to freeze our pay until 1991. Many of us "civil servants" do have a strong work ethic and give you a full days work for a full days pay. For the past eight years we have fallen way behind the private sector in wages because of the reduced COLA's that we have received.

That I have accepted with reasonable grace-however, the administrative plans to use federal employees as examples so other employers would follow suit has fallen flat. Our cost of living continues to escalate just as everyone in the private sector yet our raises have only off-set the increases in our contributions to the health plans, social security, etc.

Is it true Congress intends to vote itself a healthy wage increase? If so, in all good conscience how can this happen? Why not make congressional salaries the responsibilities of the states that the congressmen represent. Their constituents would probably be more vocal if they felt they had more control over these people.

My first position at the shipyard was as a timekeeper and purchasing agent for our engineering code. I observed tremendous waste in the purchasing as dictated by GSA. One example that comes to mind is the purchase of 5-1/4 inch floppy disks for the computer systems. Because the government has a "contract" we pay approximately \$2.70 each for generic brand disks. For my own system, at home, I NEVER pay more than \$1.50 each for brand names such as Maxell and Fuji. I purchase through discount outlets -- why can't the government do the same? Another example is a power strip which our code paid about \$40.00 for (I can't remember the exact amount), again because of that imperial "contract". At about the same time I went to Ernst and bought one for \$15 for my own system. Why can't each installation have a buyer who is free to take advantage of better deals rather than having to put up with "contract" rip-offs?

Also when I held that position I became distressed over some equipment/furniture we had stored in the upper floor of our building. Perfectly good items but I was unable to transfer them to departments that could use them because there appeared to be no-one around who knew the needs of the various codes/shops. I submitted a Bene Sug, requesting that PSNS create some sort of storeroom facility where all the offices could retire their old equipment and possibly trade for something they could use. They claimed the suggestion wasn't feasible.

My examples are minor, however multiply them by the number of federal agencies and you are talking big dollars.

Meaning no disrespect, it appears to me that the government could balance their budget more easily by re-evaluating the wastes that are apparent in the entire purchasing system and/or standardizing our method of taxation (why not make EVERYONE; big business, small business, rich, poor, middle income--EVERYONE pay a flat 20% of their gross. If you make 15,000 a year you'll pay \$3,000; if you make \$100,000 you'll pay \$20,000, etc., etc., etc.) Not only would you be collecting taxes from those who have never paid a fair share but you could also eliminate 50% of the IRS employees who are needed to administrate the collection. Please don't try to balance the budget at the expense of a few.

Mismanagement appears to be a major flaw of the U.S. government. Private industry would not tolerate the abuses.

In closing, you really do appear to be trying to create some order out of chaos and I certainly don't envy your position—it's the stuff gray hairs are made of, but I do ask you to reconsider the pay freeze and try to handle the balancing of our budget in a more equitable manner.

I hope that you and yours have a joyous holiday season.

Dear Mr. Hawksley-Cooke:

I appreciate your January 7 letter and your favorable comments on the actions President Reagan has taken to counter Libyan support for terrorism.

In your letter, you also expressed concern over support by Americans for the Provisional IRA, and I would like, if I may, to offer a few comments. First, I want to emphasize our longstanding condemnation of violence and discord in Northern Ireland. Over the past five years, President Reagan has on many occasions called on Americans to ensure that no material, financial, or psychological help is given to those who practice or advocate violence. It is our firm policy that such persons should find no welcome in the United States, and we have intensified our efforts to ensure that the United States is not the source of guns or money for such activity.

At the same time, we are mindful of the help we can provide in the search for an end to the conflict. President Reagan has encouraged Americans to let their foreign investment and vacation dollars contribute to the employment opportunities that can play a significant role in promoting peaceful change. Following last November's Anglo-Irish agreement, the President also pledged that we will work to find tangible ways for the United States to lend practical support.

The problems of Northern Ireland are of special concern to us in the United States, with our close ties to the peoples of the United Kingdom and Ireland. I can assure you that we will continue to do everything we can to help.

Dear Roone:

We were rather astonished last night, following the President's address on the nation's security needs and Majority Leader Jim Wright's response -- to see ABC give eight minutes of rebuttal time on national television to a trained propagandist for the Soviet Union.

Mr. Posner performed according to script, disparaging the address as "dishonest," and directly accusing the President of the United States of falsehoods.

Roone, it is our belief that the debate over what America requires -- to defend herself, her allies and friends from the awesome military power of the Soviet Union -- is a debate for Americans to conduct. Soviet propagandists have no legitimate role in that discussion.

How is a free society's search for consensus served by introducing into its national debate the scripted falsehoods of a regime which has, as its historic and stated purpose, the destruction of that free society? How is the search for truth served by turning ABC's national audience over to an individual whose concept of truth is whatever statement will advance Communist objectives? How is fairness served when the trained propagandist of a hostile regime is put onto the same plane with the President of the United States?

Would you have felt it an expression of objective and balanced journalism, if in the 1930's, Mr. Churchill's calls for the rearmament of his country were immediately followed by the BBC's granting of an unrebutted commentary to some functionary for the Third Reich?

By putting Mr. Vladimir Posner on a plane with the President of the United States and House Majority Leader Jim Wright, ABC gave this Soviet propagandist a standing he does not merit, a legitimacy he does not deserve. We find it difficult to believe that the affiliates of ABC were either aware of -- or would have approved of -- what was done; and we trust that, in the future, before adopting a posture of benign neutrality as between the crafted words of an American President and the party line of a Soviet functionary, you will give the matter more consideration.
