MEMORANDUM FOR THE PRESIDENT

FROM: FREDERICK J. RYAN, JR. *FJR*
SUBJECT: Private Sector Initiatives - International Interest

Over the course of your Administration, private sector initiatives in this country have increased at an unprecedented rate. The most recent figures for charitable giving reach nearly \$80 billion per year and there has been an 82% increase in annual giving since 1980. More Americans currently volunteer their time than any other period in history and corporations have become involved in countless innovative new partnerships in their communities.

As you have often noted, private sector initiatives have developed as a "uniquely American" way of life and are not common in most other countries. However, because of the success in America over the past few years, several European countries have become very interested in learning more about how the program has worked here.

The French, in particular, have been very interested in our Private Sector Initiatives program. With the recent focus on the privately funded restoration of the Statue of Liberty and the Chirac government's emphasis on private sector activity, they would like to implement a private sector initiatives program of their own.

In order to answer the French inquiries and those of other European countries, we are planning an International Conference on Private Sector Initiatives. The conference will be held in Paris, France, in late November, 1986. Attending the 2-day conference will be approximately 200 private sector leaders and government officials from France, England, Germany, Switzerland, Belgium and the United States.

Through a series of presentations and workshops, various aspects of our Private Sector Initiatives program will be presented. Speakers will include leaders of charitable institutions, business leaders and Cabinet members. Through the information presented at this conference, European business and government leaders will learn about the success in the American Private Sector Initiatives program and possible ways that it may be adapted to apply in their countries.

This conference will be sponsored by private sector funding which already includes significant commitments from American Express and the New York Stock Exchange.

Because of your leadership, this American spirit of "neighbor helping neighbor" has become a more important part of our daily lives. This opportunity to spread this program internationally presents very exciting possibilities.

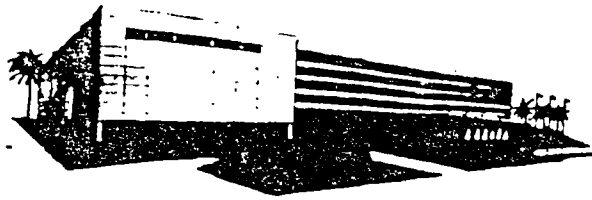

I am a physician practicing Internal Medicine and Cardiology. My partner, Dr. Crandall, and I both see a significant number of adolescents. Our experience as physicians and our convictions as Christians prompt us to encourage you to see to it that the recommendations of the Attorney General's Commission on Pornography are implemented. I would hope that you would oversee it personally rather than delegate it to the bureaucracy. I would hope that we can stop the flood of pornography with which we are being besieged. I would add, parenthetically, that it is my prayer that we can once again some day soon be a nation "under God." Ever since the Kinsey Report allowed us to treat the "average sexual behavior" as normal, we have begun a tendency to drift away from the Judeo-Christian value system upon which our government has been based.
