Dear Mr. President:

Thank you very much for the honor, the recognition and the kindness. I'm sure all of us must feel the same as I do.

Aware I would have little opportunity to talk to you personally when presenting this book, I thought I'd write you a note, aware that you're busy, but hopeful you might enjoy the coincidences.

When I was here as your guest with baseball Hall of Famers, March 27, 1981---as a member of the Hall's directors and its' old-timers' electoral committee---I handed you a book I had written called "Super Stars of Baseball". It included a photo of you taken in Cardinals' uniform, with Bob Lemon showing his breaking-ball grip, for "The Winning Team". (My chapter was, of course, on Grover Cleveland Alexander.)

Monday noon, at a weekly group of sports' characters in St. Louis, I talked about you to W. J. Dukes said, yes, he had known you, but only slightly because you did University of Iowa football. At dinner that night, I told my wife that I had planned to send you the Frisch book. As a former RN, dear Lynne urged me to do so, insisting, "Between his executive and medical staffs in convalence, the President will need a chance to relax."

So on April 1, I sent you the book and a note. Around the Fourth of July when I was back in Washington, which I've seldom visited since I was a Marine 40-plus years ago, I got a note from you. (I was in the Capital for a holiday Americana jamboree on baseball at Smithsonian.) Your note was a delight, saying my wife was right!

At the time you were shot just minutes after had talked about you, I thought that Dukes Duford must have had the same knee-jerk reaction. Just wait until I saw good of Dukes again! I didn't. Fast 80 then, he died of a heart attack the next week. Through him, I'd become acquainted with his old Marquette classmate and your good friend, Pat O'Brien. I always liked it when Pat would say, "Rock" talking about "The Gipper", that you had become President of the United States and that he had become president of the Holy Name Society.

Over a couple of drinks, he liked to tease me shout the time he came here with his wife and daughter Bridget (1969) for a three-person play. On his night off from the theatre, a raw, rainy Monday, I arranged for him to sit in the pressbox. Myself, I went to a premiere of a football movie starring Charleton Heston (No. 1.) it. Perhaps Mrs. Reagen will, too, because Elizabeth Bacon Custer, widow of the General, was a remarkable woman who lived until she was 92 (1933) and really never received enough credit for her spunk and talent. The show was fun.

Now, going back to when you went to Hollywcod---and I do recall your playing Guster in one film---I'm tinkering with a play I wrote 20 years ago that just missed making St. Louis's 12,000-seat outdoor Municipal theatre. It's a now-and-then revision of "Varsity Show", a Warner Brothers' movie (1937) that starred Dick Powell, Fred Waring and his gang, including the Lane sisters, and Johnny (Scat) Davis. The music was very good, I supplemented it and now hope in '87 on the showboat to use a '65 setting for a couple returning from the '38-40 era so that, in effect, an audience of three generations might enjoy the difference of music-dance-collegiste lingo changes, etc.

Help! Help! Help! Help! Help!

I am engaged in a one-man effort to correct the deficiencies in mathematics education in America and I need help from the readers of HUMAN EVENTS. These readers know that almost everything we have that has value has come from the efforts of individuals and that committees seldom produce anything worthwhile. In this case, I am the individual, and I am fighting a gigantic committee called the mathematics education establishment. I ask for your help in my battle.

In January 1986, a study of mathematics achievement in 26 nations was released. The scores of the 500 classes of American students who participated were at the bottom of the scores of the civilized nations and just above those from Swaziland. More frightening, the top 5 percent of the Americans scored at the 25th percentile of the Japanese. That means that 75 percent of the Japanese students outscored our top 5 percent. This is a portent of disaster for America in a technological world.

Children Alienated from Mathematics

American children are not genetically inferior. American society is not sick. American teachers of mathematics are totally competent. The disaster in mathematics education in America was caused and is being perpetuated by well meaning people in mathematics education whose ineptness borders on incompetence. These people believe that mathematics is a game and that mathematics education is a toy invented for their own amusement.

These educators have great influence on the style and content of mathematics textbooks and unfortunately they disdain the teaching of mathematics as mundane. Instead, they insist their mission is to teach children "to think and to create" and they believe that this can be accomplished by asking children mathematical questions that they do not know how to answer.

For over 30 years we have watched in horror as these people have used this pseudo-Socratic pedagogy to

issue of Reader's Digest, William F. Buckley Ir. has published three articles by me in National Review, has had me as a guest on "Firing Line" and has discussed me and my books in his nationally syndicated column. My books were the subject of two major articles in Human Events (July 16, 1983 and December 3, 1983, and a twocolumn article in the September 15, 1984 issue), and one article in the Conservative Digest.

I was naive enough to believe that this publicity would suffice to spread the good news and that the country would welcome a better way to teach mathematics. I thought that a method that would produce even a 10-percent gain in mathematics scores would be nationally acclaimed. When I saw that the gains in tests of skills produced by my books ranged between 110 percent and 300 percent, I smiled and waited. Gains of this magnitude certainly could not be ignored.

How wrong I was. Not only have these gains been ignored, but I have been attacked and ostracized. I have written books that concentrate on teaching concepts by using long-term practice of fundamentals as a vehicle. This approach is the philosophic antithesis of the approach that began with the "new math" and continues to this day in American mathematics education.

The perpetrators of the disaster demand that understanding must always precede doing and that our overriding goal is the teaching of "creativity." If the gains produced by my books are accepted, then the falsity of the prevailing philosophy of teaching mathematics is irrefutable.

Establishment Cannot Admit Mistakes

These people have been telling the big lie for 30 years. They have told the lie to their colleagues, to their families and friends, and have written and published papers. They are humans, and to admit a mistake of this magnitude requires more intestinal fortitude than most humans possess.

Calibration

they are almost never academically venturesome, for their primary goal is not education, but keeping the lid on and not getting fired.

But, there is a chink in the armor of the educational giant and this is the dedication of the members of the school boards.

School board members work for no pay just to be of service to the community. School board members have common sense and they believe that a better way can be found. That is the reason they serve.

What Readers Can Do

The first thing I ask of readers who want to help is to send'a copy of this article to a member of one or more school boards in their area. These board members are not competent to recommend a mathematics curriculum. But, if they write me or call me, I can send them reports from schools and put them in touch with schools who have used my books and have had wonderful results. Conversations with teachers from these schools will convince them that a test of my books in their own schools might be wise. The test will prove the validity of my claims.

I would be happy to send the same packet to any reader of this article who sends a request to me at 1002 Lincoln Green, Norman, OK 73072.

Also, someone who reads this article will know a way to get the major media to investigate me. Newsweek magazine has made a living for five years telling of the disaster in education, but Newsweek doesn't seem to be interested in an investigation that might produce a happy story. The same goes for ABC, CBS, NBC, TBN, "60 Minutes," "20-20," the Washington Post, the New York Times. Associated Press and all the rest.

I am real. The results I am getting are real and wonderful. Surely some reader of this article knows someone in the major media who would like a good story that is positive. I would also make a good subject

have made us a country of mathematical cripples. They have caused serious injury to the competency of the work force on which our industrial society depends. Enough is enough.

I propose that the readers of this article help me to take their toy away from them. With your active support, we can have a total turnaround in mathematics education in America in less than five years. Let me explain.

I have written and published a series of junior high and high school mathematics textbooks that are causing unbelievable gains in scores on tests of mathematical skills and in upper division mathematics and science enrollment. College board scores in mathematics in schools that use the full series have jumped over 20 percent.

My Book Attracts Students

My books caused second-year mathematics enrollment in the Dallas, Texas public schools to increase 49.9 percent in just one year, from 2,573 to 3,857. Dallas is a typical metropolitan school system. The gains in Dallas can be duplicated in any metropolitan school system in this country.

The greatest previous third-year mathematics enrollment at Newman Catholic High School in Sterling, Illinois, had been 12 until my books were introduced. Last year the enrollment was 42.

In Minco, Oklahoma, third-year mathematics enrollment has increased from three to 22. Tahanto Regional High School in Boylston, Massachusetts, has doubled second-year mathematics enrollment and Ponderosa High School in Parker, Colorado, has doubled thirdyear mathematics enrollment.

My books are producing wonderful results in over 2,000 school systems in 50 states and are used in prestigious private schools and in affluent suburban schools such as those in Scottsdale, Arizona. All of these schools have tested the Saxon math books and have found that they work as well as I say they do.

Publicity Alone Doesn't Work

My books are not a total secret. Trevor Armbrister wrote a feature article on my books in the March 1985

teachers who are enthusiastic about my books and have done their best to denigrate my work.

As an example, I was scheduled to give a paper at the big Texas mathematics conference, CAMT, to be held in Austin in October 1986. In June 1986, I was informed by the program chairman that my name had been removed from the list of acceptable speakers by a special vote of the executive committee. This committee consists of the mathematics director for the Texas Education Agency, the president of the state mathematics supervisors, and three professors of mathematics education from the University of Texas in Austin.

They disagree with my philosophy and since they consider themselves to be leaders in mathematics education, they object most heartily to my comments about incompetent leadership. They do not want me to be able to tell Texas mathematics teachers about the gains in the Dallas schools and the gains in other schools in all 50 states. If I am allowed to give a paper, even in an outer room, some thoughtful Texas teachers might hear me and begin to think for themselves.

The schools that use my books do so because brighteyed, aggressive teachers have tried my books and have found that they work. Then, they must convince their fellow teachers to try the books. Often, this is an uphill job because many teachers are timid and dislike any change that disturbs their comfortable routine. Also, many are fearful of trying an approach that is not approved and promoted by the mathematics education establishment.

The administrators are no help because many of them know very little mathematics and their time is taken up with problems of discipline and finance. Also,

Business Leader Sought

The third thing that I need is a one-hour audience with the chief executive officer of any major American technological corporation. These executives know how much their companies and America would benefit from having a work force that is mathematically competent.

I don't know of any effective way to contact the CEO of Ford, GM, Chrysler, 1BM, Standard Oil, Gulf, ESD, or other large companies. I have tried to contact people like Lee Jacocça and Ross Perot with no success.

To fight the educational establishment successfully, I need a powerful sponsor from corporate America. I will propose to this CEO a big evaluation of my books — say 3,000 students — to be approved by and monitored by his engineers. The evaluation will be conducted over a two- or three-year period in schools to be selected by the corporation.

When I prove that I can double the fourth year mathematics enrollment, increase chemistry enrollment over 25 percent, double physics enrollment and cause a gain of at least 20 percent in college board scores in mathematics, then with a powerful sponsor it may be possible to get the results to every school board member in America.

These dedicated and concerned people will know what to do. They will insist on making the changes that will produce graduates that are mathematically competent.

The readers of this newspaper helped elect our president. Surely you can help me to get investigated so that I can prove that I have a better way for mathematics education. We always wonder why "they" don't do something. Many of us have lived long enough to understand Pogo when he said, "We have met the enemy and them is us."

I have done my part by providing a solution. Now I need some active support from you. I have received no support from the center or the left. These people believe that all good things come from federal grants. Help me to prove to them that the efforts of individuals are really what makes a difference.

Lies, Lies, Lies

Since one can't — or at least shouldn't try to — defend the indefensible, U.S. Senator Gordon Humphrey and U.S. Representative Bob Smith deserve high marks for intellectual honesty for unequivocally repudiating the shabby deal struck by President Ronald Reagan in swapp-

ing American reporter Nicholas Daniloff, an innocent man illegally held hostage by the Soviet Union, for accused Soviet spy Gennadi Zakharov. This newspaper wishes it could say the same of the other two members of the state's congressional delegation, U.S. Senator Warren Rudman and U.S. Representative Judd Gregg. But they prostituted themselves for the sake of partisan politics, rationalizing presidential actions they would have condemned in purple prose if they had been engaged in by a Democratic chief executive.

To put it bluntly and factually, President Reagan just plain lied when he pledged earlier that there would be no trade for Daniloff.

And he lied when he told the American people Monday that it was the Soviets who "blinked" in the confrontation between Washington and Moscow.

He lied again that same day when he assured the nation that he "did not" swap Zakharov for Dani-

And Reagan lied for at least the fourth time, even as the deal was being consummated, when he stood before reporters in a jammed White House briefing room Tuesday and declared: "There was no connection between the two releases."

Call these "diplomatic lies," call them what you will, but they are outright fabrications nonetheless, and they must leave millions of Americans feeling atypically cynical—as if they'd just been lied to by their favorite uncle. The President's response Tuesday when reminded that he'd said only Monday that the Soviets had "blinked" during the standoff — "Shouldn't have said that. No comment"—only served to underscore his moral confusion on 'this issue.

The American people would have understood (they might not

have agreed) if Reagan had said that he would not allow national prestige, let alone the fate of any one man, to stand in the way of a summit conference. But he pretended to believe otherwise.

As far as this newspaper Is concerned, President Reagan has already forfeited the right to claim the high moral ground at a summit conference. If he "blinks" there when confronted with Soviet resolve, the results could be catastrophic for the human race! In our view, the deceptions perpetrated by "Mr. Conservative" himself clearly document the need to preserve the 22nd Amendment's prohibition against more than two presidential terms.

The ridiculous claims of Rudman and Gregg to the contrary notwithstanding, the United States got little from a deal that Senator Humphrey summed up concisely as "exchanging a Soviet spy for an innocent American citizen in order to preserve a summit meeting." Representative Smith, who protested "a dangerous precedent" set by the swap, was equally precise: "We give them an accused spy and they return to us a reporter who should never have been arrested in the first place."

What has been lost here is obvious. American citizens abroad have lost a measure of personal security; terrorists everywhere are emboldened to prey on them. The President, heretofore a paragon of toughminded realism, has lost credibility. His stature at a summit conference is dangerously impaired. The American judicial system lost integrity; the Reagan administration prostituted it by allowing Zakharov to bypass the Justice Department's own guidelines concerning no-contest pleas. (The judge didn't even state the length of the prison sentence he was suspending!) And, finally, the President, faced with threats of Soviet retaliation, simply lost his nerve and backed down on the supposedly firm order terminating the spy mission of several Soviet diplomats at the United Nations.

Our gain is that the Soviets allowed an innocent man to go free and promised to permit the emigration of prominent Soviet dissident Yuri Orlov and his wife, Orlov's "Crime" being that he monitored Moscow's violations of the Helsinki accords.

But Secretary of State George Shultz says, "I think you have to look at all of these things as a package."

We look at them more as a box
—a diplomatic Pandora's Box
whose total evil could be released on
mankind at a summit conference for
which we have already paid an unconscionable price: our national
honor.



Liberal news experts, political analysts, and the "peace at any price" marchers will disagree, of course, but the results of Iceland are good.



We may not have full confidence in our team's coach, George Shultz, described by columnist Ralph deToledano as "the wimp in charge of the State Department."

And there are those, ourselves included, who have had doubts about the firmness of our star hitter, Ronald Reagan. However, we are used to doubting while at the same time harboring a dream of victory. (Cheering for the Red Sox over so many years has made us that way.)

Dear Mr. President,

Thank you so much for your letter of October 3. It was very kind of you indeed to take time to write to me before you left for Iceland. Of course I followed the events there with keen interest and want to tell you that I thought your speeches, both as you left Iceland and last night, were wonderful -- restrained, striking exactly the right tone. Congratulations! I know that it must have been difficult to find such a tone, considering the performance they put in there, but I remain convinced that your tenacity and integrity will win in the end.

Your remarks about human rights within the Soviet Union, for Russians and other Soviet peoples, were especially fine. I do not think that any other President has enunciated that theme more clearly and effectively. How they treat their own is the root of the problem, the bottom line. Until the Soviet Government can honor the commitments they have made to their people -- including their own constitution, they will never completely honor those they have made with others. I have always believed this, and for many years insisted -- both in the United States and the Soviet Union -- that their performance on the Helsinki Pact is not incidental, but an essential key to establishing the trust necessary for other agreements as well. It simply cannot be put aside, and in my view, we should never allow them to forget it.

One thing I can tell you. As I heard you speak, I thought

of how many Russians would applaud you. Please know that there are many there who understand your goals, respect your firmness and see in your resolve a hope for their country as well.

Hang in there, Mr. President as I know you will. You are so right - a bad agreement is worse than no agreement. They will be back, although no doubt, not until after November 4. One thing they know how to do is wait, and we can take a leaf from that book.

May God bless you and help you.

Reagan Destroys a Taboo

By Robert Karl Manoff

The Reykjavik summit meeting has shown Americans that President Reagan is a man of greater vision than many of us expected, bolder and more foresighted than most of those who oppose his nuclear policy.

The agreements on strategic and intermediate-range nuclear weapons that he and Mikhail S. Gorbachev discussed could eventually have led to the elimination of whole categories of nuclear weapons that until now have barely been constrained by arms control agreements. His willingness to contemplate such a course of action should send an important message to everyone seriously concerned with the threat of nuclear war.

Why was the President able to be more forthcoming than his Congressional opponents, the arms control community and the peace movement? For one thing, these advocates of traditional arms control (myself included) have been advised and in many cases led by men and women who have a political, intellectual or psychological stake in maintaining a policy of deterrence — a doctrine based on nuclear balance between the two superpowers. This meant that they often resisted as destabilizing proposals for significant weapons

Second, the President's opponents were fearful of pressing too hard for an agreement, lest they offend what they saw as the anti-Soviet sensibilities of the American people.

As a result, the President's opponents were often forced into the corner of defending deterrence against the Strategic Defense Initiative. Politically cautious and on the defensive, they also hesitated to propose bold initiatives to match the President's. This allowed him to emerge at

The summit's silver lining.

Reykjavik as more committed to eliminating nuclear weapons than his opponents, who are pursuing such short-range goals as eliminating particular weapons systems, achieving a test ban or cutting another \$10 billion from the defense budget.

Three years ago, the President stole much of his opponents' thunder with his proposal for a Star Wars defense. The opposition had stirred fears of nuclear war, but it was the President who seemed to have the vision necessary to prevent it. He was thus able to transcend the movement's rhetoric and to harness the

political and moral energy it had generated for his own purposes.

The agreement that the President apparently contemplated in Reykjavik was far more ambitious than any his opponents have permitted themselves to contemplate or to build their platforms on. Even though in the end he was not successful, his willingness to discuss such a proposal has already put the elimination — not merely the control — of nuclear weapons at the top of the American political agenda.

The President had been moving toward this position for the last several years, in fact, but at Reykjavik he handed his opponents a gift: quite apart from what he believes about Star Wars, he has destroyed the taboo against talking about the abolition of nuclear weapons. Reykjavik may have failed in the near term, but Ronald Reagan may indeed have earned his place in history with his willingness to negotiate what no President has had the courage to touch.

His opponents and his allies alike ought to recognize this achievement. A broad-based antinuclear coalition ought to take advantage of the opening he has created for fresh thought and political action around the program of eliminating, absolutely, the nuclear weapons of nations. Three years ago, the President one-upped the opposition. Now he has handed it a program. Audacity is required to pursue it, but in the long run nothing else is going to appeal to the American people.
