

Dear Mr. President:

Conferees for the House and Senate reached agreement last week on a package of banking legislation, including a plan for recapitalizing the FSLIC insurance fund. I urge you to sign this legislation when it reaches your desk.

Press reports indicate that some senior Administration officials intend to recommend a veto of this legislation which is vital to the public confidence in our financial system. You not only should sign the bill, but you should take some credit yourself for this forward step to restore public confidence. The bill reaffirms that the full faith and credit of the U.S. Government stands behind deposits up to \$100,000.

You are aware of the continued negative publicity about savings and loans and the FSLIC over the past several months as the House and Senate debated the issues. The public does not differentiate between strong institutions like Great American and the weak, who pose a problem for the FSLIC.

Over the first five months of the year our entire industry suffered net depositor withdrawals. The bill approved by the conference committee can restore public confidence, but only if it quickly becomes the law of the land. Under the legislation the S&L business commits its own money — not taxpayer funds — to replenish the FSLIC's reserves through bonding authority for \$8.5 billion in borrowings. While this is less than that sought by the Treasury, I repeat that the funds are provided entirely by our industry as an unprecedented self-help effort. Additional funds can be added later if necessary and again this would be funded by the S&L business and not the Treasury. This approach is in line with your philosophy of not asking for government handouts for the private sector.

Your signature on this legislation is important not only for our institutions but for the entire banking sector. Because of the write-off of non-performing foreign loans the large commercial banks will be reporting their worst earnings since the Great Depression in the next few weeks — coinciding with the time you must make your decision. Conditions in the financial sector are extremely fragile and could be made much worse with a veto. It is possible that financial institution runs and panic would be the result of a liquidity crisis and such a scenario is a very real possibility in the current very negative atmosphere relating to the safety and soundness of financial institutions with the continual bad press.

For the sake of your economic program, signing H.R. 27 as soon as possible is of the greatest importance. We are all convinced that \$8.5 billion is a much more logical and supportable figure than the \$15 billion package asked for by Treasury.
