U.S. Churches Aid Persecutors, Not Victims

The Sandinista regime of Nicaragua has launched a campaign of persecution against virtually every religious group operating in that country. Ironically — and sadly — many American church groups have found themselves on the side of the persecutors, not the victims.

The evidence is beyond question on both counts. One of the Sandinistas' first actions in the Atlantic Coast region, for example, was to deny the Miskito Indians their traditional network of indigenous leadership — including the elders' council, which represented 256 communities — and replace it with a network of Sandinista Defense Committees.

The Sandinistas immediately began replacing Moravian and other Protestant school teachers with Cuban Communists. Sandinista cadres stormed the headquarters of several Indian groups and Moravian churches and offices, made mass arrests and killed some of the captured Miskito leaders.

On March 15, 1982, the Nicaraguan regime decreed the state of emergency which involved complete prior censorship of all media, and in August 1982 the Roman Catholic Church's radio station was forced to close for one month. When the station was allowed to reopen, it was placed under severe restrictions. It had to submit all pro-

grams to the state censors. By Easter 1983, the Sandinistas decreed that homilies and sermons of church leaders had to be censored as a precondition for broadcasting,

When the Catholic Church became increasingly critical of the Sandinistas' imposition of totalitarian measures upon the country, President Daniel Ortega stated in 1982 that the bishops were not Christians. Another Sandinista leader, Tomas Borge, called them "false prophets" and even prostitutes.

In one instance, Pentecostal pastor Prudencio Baltodano was arrested and tortured by the Sandinistas. Humberto Belli, a former Sandinista and onetime editor of La Prensa, reports that "Baltodano said that they declared themselves to be Communists and challenged him to pray to his God to see If He would save him. He was beaten and tied to a tree, and then his ears were cut off. One of the soldiers stabbed him in the neck with his bayonet, and they left him to bleed to death. The knife, however, missed the jugular. After hours of attempts, Baltodano was finally able to free himself"

"I met Baltodano in the U.S. where I heard his testimony. He showed me his mutilated ears and the big scar on his neck. Baltodano's narrow escape had

allowed the curtain of silence to be briefly lifted."

The leader of the Roman Catholic Church in Nicaragua, Cardinal Obando y Bravo, was a vigorous opponent of the regime of President Somoza. Now, he is applying the same standards to the Sandinistas and finds the current regime even worse than the one it replaced. In his 1980 New Year's message, he declared: "A Christian denounces the slaughter of men and women whatever their ethnic character, age, political creed or condition. Christians denounce torture...they denounce all forms of oppression and exploitation of man by man, of man by state."

In the case of the Jewish community. Humberto Belli reports that "The small Jewish community in Nicaragua was also a target of early harassment by the Sandinistas. In 1978, the Sandinistas, chanting anti-Semitic and PLO slogans, attacked Nicaragua's only synagogue. Once in power, they confiscated it. They also confiscated the property of many Jewish families on the grounds that they had been Somocistas—some had, some had not. Abraham Gorn, the informal leader of the Jewish community, was arrested in 1979. Other Jews received threatening phone calls advising them to leave the country. Most fled."


The record of religious persecution on the part of the Sandinistas is a long one. Yet, American churches have uttered hardly a word of criticism. Instead, many have embraced the Sandinistas — the persecutors — rather than the victims.

Roman Catholic Bishop Thomas J. Gumbleton of Detroit led a march in Washington in March 1986 in opposition to aid to the Contras. He declared: "A scaffold of deception is being constructed around Nicaragua" and said that there was no religious persecution in Nicaragua — and that the Marxists were not Marxists at all. When it was brought to his attention that Cardinal Obando v Bravo - the leader of the Nicaraguan Catholic Church—took exactly the opposite position, Bishop Gumbleton said that the cardinal did not "speak for the Church in Nicaragua." Perhaps Bishop Gumbleton was unaware of a survey conducted by the Centro de Estudios Religiosos—in August 1981, which showed Obando y Bravo to be the most popular figure in Nicaragua.

More recently, Stephen Kinzer of the New York *Times* discussed Obando (now an archbishop) and his popularity in these terms: "Archbishop Obando can draw an instant crowd anywhere in Nicaragua. Anyone who follows Obando on his trips in the countryside can see that he is venerated even more emotionally among the poor."

On Nov. 14, 1982, the National Council of Churches issued a statement entitled "No Religious Repression in Nicaragua Say Two NCC Officials." This stated that "Reports of repression of religion in Nicaragua are exaggerated and are part of a general trend in the U.S. to discredit the Nicaraguan government."

The Rev. Paul McCleary was quoted as saying that the Sandinista regime was guilty of only "some mistakes" which "it seems eager to correct." This is the

This is the same Paul McCleary who traveled to Vietnam after the North Vietnamese victory as executive director of the NCC's Church World Service. He returned to report that on a tour of one of the infamous "re-education camps" - where political prisoners were being worked and starved to death—that he, found the food "delicious" and that. the Communists were doing a better job of "healing the wounds of war" than had the U.S. in welcoming back its deserters and draft-dodgers.

The Washington office of the Presbyterian Church (U.S.A.) issued a report entitled, "Our Nation is Providing Support for the Powers of Death in Central America." At the same time, it is active in promoting tours of Nicaragua—part of an increasingly active Sandinista disinformation program.

We could fill pages with reports of similar activities by American church groups in behalf of the persecutors of religion—rather than the victims. How long will American church members permit their funds and their faith to be used in this manner? If those in the pews of our churches remain silent and permit this affront to all decency to continue, it is they who will be held responsible for the results.

THE PRESBYTERIAN MOMENT

N HER Anecdotes of Samuel Johnson, Mrs. Thrale reports that (in a situation where politics was irrelevant) a Whig was behaving oddly. The Tory Dr. Johnson remarked, "Is he not a citizen of London, a native of North America, and a Whig? Let him be absurd, I beg of you; when a monkey is too like a man, it shocks one."

Something like Johnson's remark must occur often to Presbyterians as they observe the behavior of their national leadership. Just in the last 18 months, the Presbyterian Church has protested the bombing of Libya, filed a court brief in a case seeking to legalize sodomy in Georgia, published a Sunday-school book aimed at Hispanics that features Jesus as an immigrant (the Holy Family fled to Egypt, then returned), and issued a communiqué urging protests against ABC's mini-series Amerika.

If a Presbyterian is looking for theological leadership, he will not find it at the denomination's annual meeting, the General Assembly. The current Presbyterian Church was created in 1983 when the "southern" and "northern" denominations, each of which has its own creed, merged. A joint creed is in the process of being drawn up, but, in the meantime, no church official could explain to me which creed Presbyterians are supposed to adhere to. Worse yet, no one in Presbyterian officialdom really seems to care. Yet the need for theological leadership has never been more apparent. The denomination's concept of "mission," for example, is now so loose that a "Major Mission Fund" recently raised more than \$75 million-and ninety missionaries were retired during the fundraising period. Some of the Mission Fund

money, in the name of "justice," went to fund abortions.


Some Presbyterians find such conduct so upsetting that they ignore the national leadership altogether and concentrate only on their local church. Others have taken a different tack, and have responded by organizing groups outside (and often over the protests of) the denomination's official agencies. These groups promote Biblical teaching, spread Christian renewal, help protect the unborn, and encourage Christian missions.

Counterculture

ry about the denomination's declining membership—it loses thirty thousand to fifty thousand members per year, one million in the last twenty years. They also worry about the stance the denomination now takes toward American culture. Formerly, American Presbyterians played an enthusiastic yet not uncritical role in

shaping the culture of which they were unabashedly a part. Presbyterians with a historical turn of mind recall that James Madison studied at Princeton under John Witherspoon, the Presbyterian divine and signer of the Declaration of Independence, and they speculate on the extent to which Calvinist practices shaped the American political system. The way congressmen represent their districts, for instance, resembles the way Presbyterian elders represent their congregations. But now, instead of participating in American culture, the top Presbyterian leadership is more interested in denouncing it.

It's not surprising, therefore, that Presbyterians have formed yet another group outside the denomination's agencies: Presbyterians for Democracy and Religious Freedom (PDRF). Although PDRF is only one year old, it has recently involved itself in a fight, certain to continue through next year's General Assembly, over "war resistance." A denomination agency has circulated a paper entitled *Presbyterians*

and Peacemaking: Are We Now Called to Resistance?, which suggests that Presbyterians resist U.S. "militarism" by giving sanctuary to Presbyterians involved in civil disobedience, pressing to decertify chaplaincy in the armed forces as a legitimate ministry, resigning from the armed forces and companies involved in defense, eliminating ROTC from church-related colleges, and, most controversial of all, withholding a portion of one's income tax as a protest. The paper's rhetoric reaches a level of irresponsibility unmatched since the political ascendancy of Presbyterianism in Puritan England. This treatment of World War II is typical:

It is ironic how fundamentally the identification of the enemy can be changed. In the 1940s the Russians were our allies and the Germans and Japanese were our enemies. In a relatively short period of time the Russians became our enemies and the Germans and Japanese our allies. There seems to be a deep human need, perhaps arising out of various fears and insecurities, to identify enemies on which to project the worst so we can feel justified in identifying ourselves with the best.

The Demon Theory

Stephen Marshall used the Song of Deborah (Judges 5), in which the prophetess curses the neutralist inhabitants of Meroz for not slaughtering the Canaanites, to condemn Parliament's unwillingness to slaughter the rebellious Irish Catholics—and, by extension, the followers of King Charles I. Deborah's Song is repeated as farce in this paper:

The translation of the theological stance of resistance into the political realm involves refusing to cooperate with demonic policies and seeking their transformation as a decision of faith in a God whose judgment is redemptive. It is indeed a conversion to authentic faith.

Disagree with the paper's total opposition to American military policy, in short, and, at the very least, your faith is inauthentic. More likely, you are demon-possessed (to use the paper's jargon), and possibly a heretic and unbeliever to boot.

PDRF responded to this paper with an impressive—and devastating—anthology of ten essays, including distinguished contributions by James Woolsey, Under Secretary of the Navy under Carter, and John Jefferson Davis, a professor at Gordon-Conwell Seminary. And the denomination's response? The General Assembly's Advisory Council on Church and Society asks that the anthology be reviewed for infringements against "responsible dissent . . . and journalism; and asks that appropriate action [against PDRF] be taken should the material be found to be out of compliance with these standards."

Bureaucratic Backlash

against the largest of the conservative Presbyterian groups, the Presbyterian Lay Committee, which has been denied access to next year's General Assembly. The attempt to suppress these groups may backfire, however. One of the Lay Committee leaders told me, "These people [in the bureaucracy] never learn. Every time they attack us, we get a tremendous response, both in terms of support and money. When they attacked us in 1974, it was worth a quarter of a million dollars."

Though well organized and persuasive, PDRF joins half a dozen other such groups that have almost totally failed to affect the direction of their denomination. When I asked a wellplaced official in one of these groups to list its accomplishments, he paused, and finally said that it had at least helped prevent the ordination of homosexuals as elders and ministers. That's something, to be sure, but this summer the church approved a new study on human sexuality, which Presbyterian gay activists will presumably use in their quest for ordination. The denomination's leaders are still largely the Democratic Socialist Party at prayer.

The question confronting the Presbyterians of PDRF and others like them is whether they have the stamina and the savvy to affect a bureaucracy, the institution Max Weber considered the most difficult to change. It is clear that the current denominational leadership has the stamina to stay its wayward course. PDRF and its sister groups must summon a great deal of stubborn endurance if they are to pull the denomination back to the straight and narrow.

Mid-session Revision of Economic Projections

Your economic advisers have met to consider revisions to the Administration's economic projections to be used in conjunction with the Mid-session Review of the Budget. Our recommendations for projections concerning real GNP growth rates, inflation rates, interest rates, and unemployment rates for 1987 through 1992 are summarized in the attached table and are compared with the projections employed in your January Budget. Your approval of the revised economic projections is required soon so that the Mid-session Review of the Budget may proceed on schedule.

Real GNP Growth Rates

Given relatively strong performance in the first half, we recommend retaining the January Budget forecast of 3.2 percent growth of real GNP between the fourth quarter of 1986 and the fourth quarter of 1987. For 1988 and later years, we recommend a slight 0.2 percentage point reduction in projected growth rates for real GNP. This reflects a slight lowering of projections for productivity growth, as well as concerns about the effects of the recent tightening of U.S. monetary policy and of sluggish growth in some of our major trading partners.

Even with these slight downward revisions, the Administration's projections for both real GNP growth and productivity growth would remain above the average of outside forecasters. The upward revisions to previous estimates for real GNP growth in 1984, 1985, and 1986 announced last week, together with revisions announced in previous years, help to justify this optimism. We remain confident that the growth potential of the U.S. economy, under the policies of your Administration, is stronger than that implied by many economic forecasts. We expect that renewed growth of business investment and household consumption spending, together with continuing improvement in real net exports, will provide the demand necessary to sustain growth during a period of restraint on Federal spending.

Unemployment Rates

The significant progress that has already been made in further reducing unemployment so far in 1987 justifies downward revisions in projections of unemployment rates. The unemployment rate for all workers fell from 6.6 percent in December 1986 to 6.2 percent in April 1987, and fell a further 0.2 percentage points in June. Part of the June decline may be a statistical abberation associated with the timing of the June employment survey. Nevertheless, the projected average unemployment rate for all workers in 1987 should be reduced from 6.7 to 6.2 percent to account for what has already been achieved in the first half. Comparable reductions are also recommended for unemployment rates projected for later years.

Inflation Rates

The forecast in the January Budget envisioned increases in inflation rates in 1987 above the very low rates recorded in 1986. The temporary effects of the sharp decline in oil prices in reducing inflation rates in 1986 were expected to wear off in 1987. In fact, early this year, oil prices rose significantly above the level assumed in the January Budget. Together with rising import prices, this contributed to inflation rates during the first half of 1987 that exceeded the forecast in the January Budget.

To take account of higher than expected inflation so far this year, we recommend that the forecast for inflation in 1987 be raised from 3.8 percent to 4.8 percent for the CPI and from 3.5 percent to 4.2 percent for the GNP deflator. These revised forecasts imply that the CPI inflation rate in the second half will fall to 4.5 percent from the 5.1 percent rate recorded in the first half. They also allow for expected increases in import prices to continue to generate a small excess of inflation as measured by the CPI over that measured by the GNP deflator.

For 1988 through 1992, we also recommend increases in projected inflation rates, generally of about half of a percentage point. Our recommended projections continue to show a declining trend for inflation, but recognize that progress in reducing inflation will be somewhat more difficult in an environment of higher oil prices and a weaker dollar. We believe that under appropriate economic policies, especially monetary policy, gradual progress can be made toward the ultimate objective of price stability, without injuring prospects for economic growth.

Interest Rates

Our recommendations concerning upward revisions in projections of short and long term interest rates are consistent with recent market developments and with recommended revisions in projections of inflation. Interest rates on 3-month Treasury bills have risen only about 0.3 percentage points from the rates that prevailed at the end of 1986. Interest rates on 10-year Treasury bonds have risen about 1.3 percentage points. Recommended adjustments to forecasts for interest rates in 1987 reflect these market developments. The projected downtrends in interest rates for 1988 through 1992 are consistent with the continued projection of a downtrend in inflation rates.

Policy Assumptions

As with the projections in the January Budget, the recommended economic projections for the mid-session review assume that there will be no significant change in the tax code beyond tax reform, and that the incentives for economic activity implied by relatively low marginal tax rates will be preserved. They also assume that gradual and persistent reductions will be made in the Federal deficit through restraint on the growth of Federal spending. For monetary policy, they assume that the Federal Reserve will pursue a policy consistent with the long-term goal of price stability and will avoid an excessively restrictive policy that might impair real economic growth.





WASHINGTON (AP) - Lt. Col. Oliver North on Tuesday gave a scaled-down version of his pitch for U.S. aid to the Nicaraguan rebels after congressional Iran-Contra investigators squabbled over whether their hearings should be used as a forum for North's well-practiced appeal.

The following is a transcript of the briefing, edited only for clarity by deleting misspoken words. In some cases, the spelling of names

and places could not be confirmed.

LT COL OLIVER NORTH: The briefing in its current format - and there were many different formats for it, of course, and we tried to update it - has 57 slides, Senator.

CHAIRMAN DANIEL INOUYE: Are there notes that you refer to?

LT. COL. NORTH: No. 1 would - in the formut that I gave it in many times, sometimes even up here on the Hill, I would simply put the slides up on the screen and describe the - the ships. And of course the - the contents of the erare briefing demonstrated the Soviet threat in this hemisphere and how the resistance was

CHAIRMAN INOUYE: Fine, sir.

LT. COL. NORTH: — responding to it. CHAIRMAN INOUYE: Without objection, 57 slides will be made part of the permanent re-


LT. COL. NORTH: All right, sir, Perhaps the hest way to do that is to simply go through the presentation as it - as it exists, and I will try to quickly go through the slides and indicate what I would have said had the slides been up on the screen.

The first slide simply demonstrates the geography and why this part of the world seems to be of so much interest to the Soviets. The first slide shows the effect of Soviet penetration in this hemisphere in the form of a consolidated Communist regime in Cuba and the threat that poses to our sea lines of communication, both to Europe and through the Panama Canal, and the threat it poses to 55 percent of our oil supplies coming up from Latin America.


The second slide is a photograph of Andrei Gromyko, then the Foreign Minister of the Soviet Union, and a quote from Mr. Gromyko to the effect that he said in Moscow in 1983, "The region is builting like a cauldron. Cuba and Nicaracua are living examples for the countries in that part of the world," talking about their

There is then a summary of Soviet policy in the region, based on Soviet literature, and summarized, that there goal is to create such turmoil in the Caribhean Basin that the United States must divert attention and military resummarizes critical to the Soviets.

A following slide depicts the fact that the Soviets are out-spending us in our own hemisphere on a ratio of about five trone, and that's figures—1984's figures. They have since gotten worse.

A photograph showing the Soviet warships deployed in the Caribbean, what used to be referred to as an American lake. Sixteen miles off the coast of Louisiana, the Kiev battle group deployed for a refueling and replenishment exercise.

A photograph of the Soviet submarines provided to Cuba. And the text that would have gone with it will describe the fact that Adolf Hitler was able to shut down 44 percent of the shipping from the United States during the opening days of World War II from submarines based 4.000 miles away, and these submarines are based less than 200 miles away in Cuba.

A photograph of a US Navy F-4 escorting a Soviet Bear strategic reconnaissance aircraft. If miles off the coast of the Virginia Capes.

And then a photograph taken by a U.S. reconnaissance platform of the Soviet military facility at San Antonio de los Banos in Cuba. It is, that is that facility which allows the Soviets to recover their reconnaissance alreraft which fly down the east coast of the United States. And, until they complete their base in Nicaragua, they aren't able to do so in reconnoilering the west coast of the United States.

Then a photograph of the Soviet signals intelligence site at Lourdes, Cuba, by which the Soviets — not the Cubans, but the Soviets — intercept our communications, particularly our telephone and satellite communications on which we rely for almost all of our military and diplomatic correspondence via telephone and telex.

A photograph showing the militarization of the Cuban children — a sixth-grade class out for their firing exercises.

Then a photograph showing a map showing where Cuban forces, as the mercenary army of the Soviet Union, are deployed — 3,000 in Nicaragua, 400 in the Congo, 35,000 in Angola, 700 in Mozambique, 5,000-plus in Ethiopia and 500 in Yemen. That chart would have been updated, had I still been in my current employ, to show the 1,500 now in South Yemen. And the fact is that the Soviets are, indeed, using the Cubans as a mercenary army throughout the world. To point out that the Soviets weren't satisfied simply with having Cuba, that the militarization of the island of Grenada was first observed by U.S. reconnaissance platforms in the extension and expansion of an airfield at

warehouses full of weapons, stamped with "Cuban economic office," and full of munitions.

The next slide shows a Chinese rockel launcher, probably made in the 1550s, probably apptired in Vietnam, shipped to Greinada, and the shipping documents for that document, "weapon captured in El Salvador," the shipping documents found in Greinada showing that Greinada was being used as a location to support Soviet designs for subversion and revolution in this bemisphere.

Then a photograph of the five secret military agreements found in Grenada after the U.S. rescue operation. Military agreements for the Soviet Union. Bulgaria, North Korea, Cuba and Hungary. Somehow, we were unable to get those things before the American people in such a way as that they understand what was really happening in this hemisphere. It has not only happened in Cuba, it is now happening in Nicaragua.

The next slide shows simply a map of Nicaragua, describing the fact that this country of about the size of lowa, or Michigan, a country with about 3 million in population, the only country in Latin America with a decreasing population. And why that population is decreasing is because of the internal repression perpetrated on the people of Nicaragua, it shows the growth of the active duty forces in the Sandinista military machine, an enormous military buildup supported by the Soviet Union

The next series of slides show some of the military equipment, on which I have already been questioned, but it shows the T-55 lanks, now numbering over 150; the PT-76 tanks and the armored personnel carriers numbering over 300.

The buildup taken from reconnaissance platforms at Sandino airfield, turned from a civilian air facility under Somoza into one of the most sophisticated military facilities in Central America.

This is the armored storage area at El Tempesque, built along the Cuban model.

The special airfields built by the Soviets to support their — and the Cubans, to support the Sandinista military operations along the nothern tier of that country.

The construction of another armored storage area inside Nicaragua.

The construction of a major port facility along the Pacific coast in order to handle the off-load of Soviet military supplies being delivered along the Pacific Coast at Corinto, two shots of that.

The next photograph is the Soviet HIND helicopter, the most sophisticated assault platform in the world today. It has been delivered by the dozens to the Sandinistas. Assembled by Soviet technicians and test flown by them, it is flown by Cuban and Nicaraguan pilots against the resistance, and to intimidate their neighbors.

There is also a photograph of a Soviet AN-20 reconnaissance aircraft flown by Soviets in this hemisphere — not Cubans not Nicaraguans — marked neatly with Aerollot (the Soviet Union's airline) markings on the side, photographed surreptitionally from an aircraft landing at Sandino Airport.
