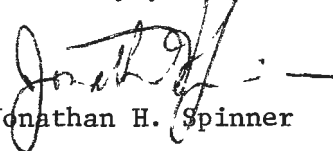
Dear Mr. Breger:

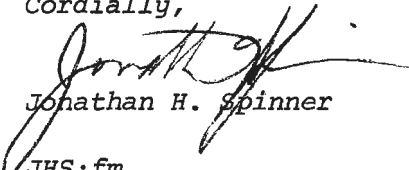
Dear Mr. Breger:

As you were informed by Jeffrey Kassoover, Mordecai Gur will not be able to attend the "Krystalnacht" commemoration to be held in Washington Heights on November 11 due to a scheduling conflict. I am happy that you have agreed to serve as the main speaker at this program which we consider to be a special liason between the Washington Heights-Inwood Jewish Community and State of Israel Bonds.

I ask that you speak on the subject of "Krystalnacht" and its meaning to Jews then and now. It would be appropriate to link the development of the State of Israel to "Krystalnacht" as a symbol growth coming out of the ashes of the holocaust. But, I leave it to you to find the appropriate words to express the concept. I would ask you to speak within a 20 minute time frame since we have a number of items on the program, including a State of Israel Appeal.

The community is quite excited about your appearance and we are very pleased about your coming. We will arrange with your office details for your transportation from the Jewish National Fund meeting up to Washington Heights and back to midtown. If you have any questions, please call me.
