I very much hope to have the opportunity to visit your Institution in the near future.

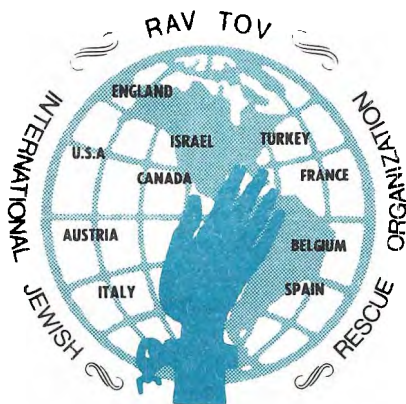

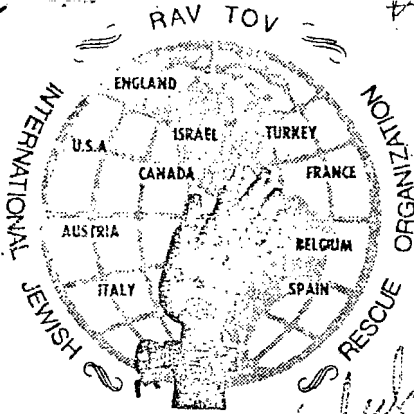
