Facts

Swan is pro-American, and his party is moderate-conservative. Bermuda is internally self-governing, but the United Kingdom remains in charge of defense and foreign relations. The United States has key defense assets on the island, and these are not an issue in Bermudian politics.



Bermuda's Premier Requests Meeting with the President

Consul General Friedersdorf reports that Bermuda's Premier John Swan is interested in paying a courtesy call on the President on March 22, during his first trip to the U.S. as premier. Friedersdorf:

- o Strongly recommends that the President receive Swan for a handshake and picture.
- o Notes that Swan is extremely popular, opposed to independence, and strongly supports U.S. military presence on the island.
- o Believes a presidential meeting would reinforce a newly elected pro-American, pro-administration black political leader and send good vibrations to the Caribbean, which has close ties with Bermuda. (C)

Max Friedersdorf, our Consul General in Hamilton, Bermuda, strongly recommends that the President receive the Premier of Bermuda for a handshake and photograph on Monday, March 22, 1982. We support this recommendation.

John Swan, only the second black to be Premier of Bermuda, assumed office in January. Conservative and pro-American, he leads Bermuda's multiracial political party. A photograph with the President would be seen on the island as a sign of the esteem which we attach to the close US/Bermuda relationship, and would underscore our support for moderate, democratic black leaders in the Western hemisphere.

The US Navy Air Station on Bermuda is vital to our security because it (with bases on Iceland and the Azores) monitors Soviet submarine activity in the North Atlantic; hence the particular importance to us of moderate political leadership on the island.
