

The purpose of the Challenger Center, which was established by the families of the Challenger's crewmembers, is to stimulate and enhance young people's knowledge and participation in science, particularly space science.

A draft proclamation is being forwarded separately for your consideration. S.J. Res. 24 passed both Houses by voice vote.






