Biography

Sharyn A. Lumpkins (born April 9th, 1945) is a civil servant and author. Lumpkins worked for a number of government agencies throughout the 1970s and 1980s including the Department of Justice and the Drug Enforcement Agency. During this time, she was loaned to the Drug Abuse Policy Office several times.

Lumpkins's first detailee assignment was from August 1982 to September 1983. She returned in September 1984 and stayed until December 1984. In March 1986, Lumpkins became a permanent staff member and remained at this agency until March 1988.

Scope and Content

The Reagan Library has arranged this collection of subject files alphabetically. This collection consists of a broad amount of topics within the spectrum of drug related policy. Topics include prevention, addiction, health issues stemming from addiction, drug use, and abuse.
