**UNITARY TAX – UNITARY TAX REPEALER ACT, S. 1974 (NOT ENACTED)**

The only piece of legislation for the 99<sup>th</sup> Congress involving the unitary tax was S.1974 – the Unitary Tax Repealer Act, introduced by Senator Pete Wilson (R) of California. This proposed bill would not allow states to apply a unitary tax to multinational corporations. The proposed bill died in committee.

The material listed here is not necessarily about this proposed legislation but covers the unitary tax issue for the entire Reagan Administration. It includes pro and con viewpoints on this issue beginning in 1981.
