Minutes

Powell: Thought it would be useful to review briefly where we stand on Gulf policy, especially UNSC effort and reflagging/protection. Let's begin with intelligence update.

Kerr: Striking that Iranians have managed to alienate just about everyone now -- running battles with British, French, Turks. [REDACTED] still very concerned about hostile Iranian reactions to reflagging. Iranians have put themselves in box through their own rhetoric -- now in position where they have to react in some fashion. Not sure exactly what form this will take. Could be terrorism, sabotage, or something less subtle. But very clear threat exists.

Powell: DOD/JCS should review threat conditions in Manama, as well as leave policy and security precautions. Bahrain especially attractive target for Iranians.

Ikle: Agree -- will look into this immediately.

Kerr: Hajj begins July 27 -- will bring 100-150,000 Iranian pilgrims to Saudi Arabia. Hajj season lasts better part of month. Another upcoming target for Iranians will be opening of Iraqi-Turkish pipeline.

Struck by Vorontsov comment to Matlock, noting bellicose Iranian attitude and view that U.S. was vulnerable to "another Lebanon." Not surprising that Soviets would take this line, but interesting nonetheless.

Powell: Let's turn to diplomatic front.

Armacost: FRG amendment has thrown wrench into works at UNSC, but hope sort out today. Key is keeping five permanent members together -- Germans have no leverage otherwise. Still aiming for Monday (July 20) meeting and vote. Walters will deliver President's letter to SYG tomorrow. Secretary Shultz will meet SYG in New York before SC meeting. Iraqis indicate they will respond formally and positively to ceasefire call day or two after passage of resolution. Hope energize SYG act as soon as vote occurs.

Will send another message to Iran before reflagging, stressing non-provocative intent. Mainly for record -- don't expect Iranian response.

Oakley: Swiss may take 2-3 days deliver -- should take that into account in determining when send.

Powell: Would like at this point to review projected timetable for reflagging and protection. President has decided reflag first two vessels on July 21. Plan is we would be prepared to begin escorting from that point on, but President will decide specific date for commencement after we see what progress we're making at UNSC. Will probably make that call Monday (July 20) afternoon or Tuesday morning -- but we should be prepared to begin escorting July 22.

Howe: Given Aspin leak, might be better begin either before or after July 22.

Armacost: Little later than July 22 would provide more time for SYG to get act in gear after passage of resolution, allow Iraqi ceasefire to take hold.

Oakley: If gap between reflagging and departure/beginning of escorting, must take very careful look at protecting newly-registered U.S. tankers at Khor Fakkan.

Powell: Right. Vulnerability begins July 21.

Howe: Think we're in pretty good shape on that score, but need take harder look. We will task Navy and see what additional defensive measures are needed.

Powell: Also look at dockside vulnerability.

Cockell: Believe Gas Prince will be at anchor. Bridgeton may be alongside pier. Will check.

Powell: DOD and JCS should take this task on -- protection at Khor Fakkan.

Howe: Convoy rehearsals July 11 and July 14 went well. Overall -- ready begin escorting any time.

Two loose ends: U.S. overflight UAE, Oman; Saudi AWACS orbit. Team will arrive UAE Saturday (July 18).

Murphy: Must avoid situation in which team seesaws between UAE and Oman. Should stay in UAE until deal struck.

Howe: Agree.

Oakley: Should we ask Mrs. Thatcher to help with Omanis?

Murphy: Useful to let her know what we're doing -- but think we'll get what we need without her intervention.

Howe: Just to be clear, we could execute escort mission without UAE or Oman overflight for tankers, but overflight would provide margin safety. Minesweeping seems to be proceeding fairly smoothly; once GOK gives green light, we'll destroy identified mines in cooperation with Saudis (hopefully).

Deconfliction with Iraqis still worrisome -- hasn't worked as well as we had hoped. Language and communication problems.

Ikle: We shouldn't fiddle around -- tell Iraqis quite directly stay away from specific zone around our convoys.

Powell: Agree -- need be very clear and unambiguous.

Howe: Iraqi aircraft enroute to attacks on oil facilities also problem -- LaSalle was overflown yesterday.

Ikle: All the more reason to add technical-military arguments (avoiding another Stark incident) to political arguments (isolating Iran, giving SYG room maneuver) for Iraqi restraint in shipping war.

Powell: Present situation dicey -- need transmit clearer, stronger message to Baghdad. Provide maximum margin safety. State and DOD should take on this task -- prepare message to Baghdad as soon as possible.

Howe: We may need quick clearances from State to add few extra systems to MEF -- like special anti-boat helicopters. Probably have fly into Bahrain and move to MEF.

On aerial tanker support, may need base more tankers in Saudi Arabia or Diego Garcia if overflight UAE and Oman falls through.

BBBG won't reach Gulf area until end August.

Powell: COMIDEASTFOR ready escort anytime after July 21?

Howe: Yes -- although lot more comfortable with southern AWACS orbit over UAE and UAE/Oman overflight.

Murphy: Need both UAE and Oman overflights?

Howe: UAE provides better corridor -- prefer to Oman, if forced choose.

Powell: Press pool on first convoy?

Armacost: Why press pool?

Powell: Pool is good idea -- been training for this since Grenada.

Oakley: Minimizes to some extent dangers of massive numbers of small boats, etc., chartered by media.

Murphy: Groundrules proscribe dateline from particular capitals or ships. Information on ship movements embargoed.

Powell: Final round Congressional consultations (before reflagging) took place July 14. Will continue keep Congress posted.

Will report to Carlucci that everyone understands first reflaggings to occur July 21. MEF will be ready escort from that point on, as directed by President.

Not sure NSPG needed -- will make call on that Monday.

Ikle: Just want add last point: need bear in mind we will be in much better position retaliate against Iranian attack after BBBG arrives late August. Until then, not as well-equipped.

Howe: Carrier can do job if necessary.

Ikle: But better off with BBBG. More devastating response, with less risk (using TLAM-C).

Powell: Need continue close coordination -- avoid any public statements might be perceived to be provocative. Low profile. Thanks for coming.

Pakistani Procurement for Nuclear Program

A Pakistani citizen, Arshad Z. Pervez, resident of Canada, was arrested in Philadelphia last Friday and charged with efforts to export nuclear-related materials to Pakistan in violation of U.S. law and regulations. Indictment is expected next week. Specific charges include conspiracy and bribery of an undercover Customs investigator.

The above case, which we have been expecting, raises the following issues for consideration at the PRG: (1) whether details of the case meet the tests of the Solarz Amendment; (2) whether a Presidential determination should be made prior to a judicial decision (as Solarz is suggesting); (3) [REDACTED]

(4) next steps with Congress -- Solarz has called hearings on July 22, Glenn is talking about attaching still more legislation to the State Department budget, which will be coming to the floor of the Senate next week; and (5) [REDACTED]

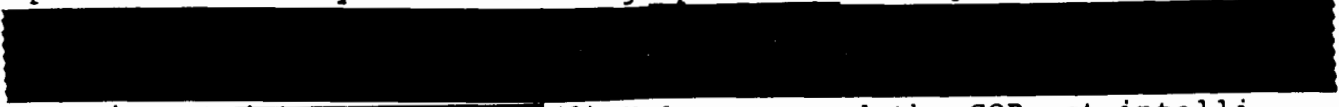

There is general agreement within the Administration that: (1) we need to proceed carefully so as not to jeopardize the legal case although



(3) Unless we and the GOP act intelligently and rapidly, the assistance package for Pakistan, basic U.S.-Pakistan relations and perhaps even the Afghanistan program will be in great danger.

Steve Solarz has put out a public statement which includes a call for a Presidential Determination if it is clear that the maraging steel was destined for the Pak nuclear program. Solarz expects a halt to the assistance unless the President issues a waiver, which he claims would make a complete mockery of our non-proliferation policy "and be a signal that other countries can ignore American laws with impunity." Glenn has taken a similar position.
