REQUEST: Meeting with Pakistani Foreign Minister Yaqub Khan.

PURPOSE: To receive Zia's written and sensitive oral reply to the President's letter of September 12 on Pakistan's nuclear program.

BACKGROUND: The President first discussed the Pakistani nuclear program in a private meeting with Zia in December, 1982. The subsequent letter to Zia has led to a review of Pakistan's nuclear program. We followed up with a McFarlane/Yaqub meeting on October 10. Zia is now sending Yaqub with the Pakistani reply. The critical points will be in the unwritten portion which Yaqub has been asked to present personally because of their sensitive nature. It is important that the President see Yaqub and receive Zia's response.

PREVIOUS PARTICIPATION: The President has met Yaqub Khan before.

DATE AND TIME: Between November 16 and November 20, 1984.
DURATION: 30 minutes.

LOCATION: Oval Office.

PARTICIPANTS: The President, Robert C. McFarlane and NSC Staffer.

OUTLINE OF EVENTS: Receive letter and message.
