SUBJECT: Pakistan: Proposed Discussion of Follow-up to Visit of Prime Minister Junejo, at 2:00 p.m. in NEA Conference Room (New State 6245) on 8 August.

Acting in place of NEA/DAS Robert Peck, who is away from Washington, I would like to convene a brief and informal interagency meeting on Friday 8 August to discuss where we stand on a variety of pending/follow-up actions and issues in the wake of the recent successful visit to the United States of Pakistan Prime Minister Junejo. The time would be 2:00 p.m.; the place, the NEA conference room (State Department, room 6245).

NEA/PAB has pulled the enclosed list together by going over the various papers and discussions of the visit as a tentative, post-visit checklist. I plan to use this as the agenda for our discussion, but would also welcome your comments and any additions or deletions you may suggest then or even beforehand.
