I. PURPOSE

To discuss US-Pakistan relations and Afghanistan.

II. BACKGROUND

Following meetings with Secretary Weinberger, Secretary Shultz, and Under Secretary Armacost, you will meet the Foreign Minister for a brief discussion of US-Pakistan concerns. The agenda, multi- and bi-lateral, is far too broad to support detailed discussions of the complex issues confronting us, but your meeting will serve as a very useful preparation for the more substantial discussion he will have with Frank Carlucci tomorrow.

The Foreign Minister will emphasize three issues: the ~~five~~<sup>six</sup>-year aid program, the Afghanistan problem and Prime Minister Junejo's urgent request for early provision of an AEW system. Unfortunately, as he did during his visit to Pakistan last year, Secretary Weinberger today exceeded the agreed intra-agency position (as well as his own DoD/JCS position) and promised "anything you want." As that issue won't be settled for some time, you should not commit yourself.

The four points you need to emphasize are:

- 1987 is a crucial year for Afghanistan.
- (He's heard it before) The President's word is on the line on the nuclear issue; we have not received the SPECIFIC assurances we need.
- AEW is not a foolproof shield against air attack, maybe not even the best one. It remains controversial and costly.
- Finally, our strategy in South Asia seeks a degree of Indo-Pak harmony; it pays for Pakistan to take the initiative.
