Dear Mr. Timken:

Thank you for your letter of June 25, 1987 regarding the Administration's position on antidumping amendments to S. 1420, the "Omnibus Trade and Competitiveness Act of 1987," dealing with exporter's sales price (ESP). These provisions were considered and adopted by the Senate on June 30, 1987, as amendment #357 to S. 1420.

The Administration recognizes that some of our trading partners have provisions in their dumping laws and regulations which are similar to those proposed in amendment #357, and I fully understand why they would seem advantageous to you. This Administration, however, continues to believe that amendment #357 would, if enacted, severely impair our exporters by encouraging countries to stretch the boundaries of their unfair trade laws even further through copying other adverse assumptions which we make in dumping cases. In addition, the Department of Commerce's current treatment of related-party profit and ESP offset provide for accurate and fair comparisons of prices in dumping cases.

The Administration will continue to consult with our trading partners concerning the elimination of these ESP practices abroad. I appreciate your taking the time to explain your position on this issue.

I couldn't agree with you more that this is a serious global issue. We are committed to a global treaty. Any international agreement that does not have the potential for global support or that creates incentives to stay outside the protocol would not be acceptable to the United States.

Dear Mr. Rehnquist:

Thank you for your letter of June 2, 1987, concerning your Foundation's support for research being conducted by Dr. William K. Summers into use of the experimental drug THA as a treatment for Alzheimer's disease. Thank you, also, for the brochure that you wrote about Alzheimer's disease and about the work of the National Neuropsychiatric Research Foundation.

I am informed that Dr. Summers met with Commissioner of Food and Drugs Frank E. Young and staff members of the FDA's Center for Drugs and Biologics on May 29, 1987. I have been assured that Dr. Young will see to it that the FDA gives thorough and prompt consideration to Dr. Summers' application to expand his THA clinical studies as soon as the FDA receives all of the information that, I am told, they already have requested. I have also been assured that the FDA will place the highest priority on seeing that THA receives the best possible clinical development, and that this is the standpoint from which they will approach Dr. Summers' research.

While I am pleased to pass this information along to you, I must hasten to add that my position as White House Chief of Staff does not permit me to undertake an independent review of the facts in this case. If your concerns continue to be unmet, therefore, they would more properly be addressed to the Inspector General of the Department of Health and Human Services, who is authorized to consider independently matters such as those raised by your letter.

I am glad you wrote to me about this important public health issue. I appreciate your kind words, and I want to commend you on your work in the cause of furthering research on Alzheimer's disease.
