Thank you for your useful letter on tungsten that set out quite clearly the problems facing this industry as a result of imports from the People's Republic of China (PRC).

Last week, the President instructed the U.S. Trade Representative to negotiate an orderly marketing agreement (OMA) with the Chinese. This remedy is in line with the International Trade Commission's recommendation while addressing the problem of circumvention. As further protection to the industry, the President decided to impose quantitative restrictions on imports of ammonium paratungstate and tungstic acid if the negotiations fail.

I understand that the industry's preliminary reaction to this decision has been favorable. We will continue to work with the industry through the negotiating process to assure a successful outcome.

Again, thank you for writing me on this important matter. I am very grateful for your support now as in the past.

Dear Mr. Boardman:

Thank you for your letter requesting that the President reconsider his position with regard to Federal funding for Amtrak. I apologize for the delay in responding.

You are correct in stating that Amtrak has made considerable progress during the Reagan Administration toward decreasing its dependence on Federal subsidies. However, the Administration continues to believe that Federal subsidies to Amtrak are not justified. Amtrak has cost the Federal government over \$12 billion since Amtrak was established in 1972. In 1986 the estimated average subsidy per Amtrak passenger was \$27. This huge Federal expenditure has subsidized mostly middle- to upper-income citizens. For example, Amtrak admits that a sizable portion of Northeast Corridor passengers have incomes of \$40,000 a year or more and that one third of these passengers have had post-graduate studies. These people do not need the subsidy that is provided them through Amtrak. In addition, despite Amtrak's virtual monopoly of intercity passenger rail transportation, Amtrak carries less than 0.5 percent of intercity passenger travel.

The President's 1988 Budget proposes to dispose of some or all of Amtrak's assets to one or more private sector companies. If Congress approves this proposal, such transactions would be designed to preserve viable intercity rail passenger service. In our view, this free market approach is preferable to the current process that maintains uneconomical routes.

Thank you for your letter on the Roger Altman article that appeared in the New York Times recently. I appreciate you taking the time to give me your thoughts on the important linkages between trade and finance. We examine these issues almost daily at the White House and have identified many of your same points as criteria for the future economic health of this nation.

I believe that we are already taking the actions that Altman believes are important and that we are doing them pretty well. As you know, we are pressing the Congress to make the difficult decisions necessary to cut expenditures and bring the budget deficit under control. On the issue of the mark-yen relationship to the dollar, I believe Secretary Baker's efforts since the Plaza meeting have borne fruit. We are seeing a resurgence in exports, particularly in the industrial area. The Department of the Treasury is also working closely with the World Bank to channel Japan's increased contributions to the third world. The issue of protectionism occupies the entire Cabinet. The Economic Policy Council, chaired by Secretary Baker, meets often (two and three times a week) on trade matters. Right now, the trade bill is one of their highest priorities.

The Council depends heavily on our able special trade negotiator, Clayton Yeutter. Ambassador Yeutter, who has cabinet rank, has done an outstanding job over the past two years. He has aggressively launched a new round of multilateral negotiations that will bring discipline to the
