Thank you for your letter about attorneys' fees in Social Security cases. I appreciate getting your views on this subject.

The Reagan Administration is committed to the general principle that government should not regulate areas better left to the free market. Concerning the specific policy issues you raise in your letter, Congress, as you probably know, has been considering legislation concerning attorneys' fees under the Social Security Act. As a result, it would not be appropriate for me to indicate a personal position under these circumstances. I'm sure you can appreciate the reasons why this policy is necessary.

Similarly, as regards your administrative appeal, the White House Counsel's Office advises me that because the matters you have raised are now before the agency for adjudication, I am precluded from taking a position or role. This is pursuant to a long-standing White House policy applicable to all White House staff members.

Dear John:

Thank you for your letter regarding increasing the number of charter flights which U.S. airlines will be permitted to operate between the United States and Japan. I apologize for the delay in responding.

Under a 1982 interim agreement with Japan, each nation's carriers may operate up to 300 one-way charters per year. Until this year, U.S. carriers operated far fewer than that number. This year, however, U.S. carriers exhausted the quota of 300 charters by early June. The charter year runs from October 1 to September 30. More charter authorizations, therefore, will not become available until October 1, unless we can obtain additional authorizations from Japan before then.

On June 24 and 29, officials of the Departments of State and Transportation met with representatives of the Japanese Embassy to discuss the charter issue. Although flexibility to borrow from next year's charter allocations was achieved at those meetings, these officials are still actively trying to nail down the details for this short-term solution. In addition, our negotiators will continue to seek a larger number of charters for future years.

I enjoyed seeing you at Malcolm Forbes' "Party of the Century." It was a delightful evening.

Dear Ted:

Thank you for your letter regarding the proper interpretation of the ABM Treaty. While I apologize for the delay in my response, I appreciate the opportunity to share with you my views on this matter.

President Reagan directed at the inception of the SDI program that it be conducted in full compliance with all U.S. international legal obligations, including the ABM Treaty. The SDI program was initially structured to conform to a restrictive interpretation of that Treaty, which would prohibit development and testing of ABM systems based on "other physical principles," except those in a fixed land-based mode. In 1985, the United States undertook a review of the ABM Treaty and its negotiating history in order to gain a more precise understanding of what the Treaty permits with respect to the development and testing of ABM systems. That review led the President to conclude that a broader interpretation of the Treaty -- permitting development and testing of all ABM systems involving other physical principles, regardless of basing mode -- was fully justified.

The only provision of the Treaty which deals with future technologies is Agreed Statement D, which allows "creation" (i.e., development and testing) of ABM systems based on other physical principles and provides for consultations and agreement only on deployment. The negotiating record clearly demonstrates that the United States tried, but failed, to secure Soviet agreement to a Treaty text that would have prohibited development of space-based and other mobile-based ABM systems based on future technologies. The Soviets firmly rejected that U.S. effort, arguing that restrictions could not be imposed on systems and components that were not yet created and thus not yet defined.

While some statements by White House officials during the ABM Treaty ratification process tended to support the restrictive interpretation, others were consistent with the broader interpretation. President Nixon's letter of transmittal did not address future ABM systems at all; the treatment of the subject in Secretary Rogers' official report on the Treaty is entirely consistent with the broader interpretation. The report of the Foreign Relations Committee included only a brief statement concerning future ABM systems, which repeated the thrust of

Secretary Rogers' report. The resolution of advice and consent did not in any way condition the Senate's consent to the Treaty on the restrictive interpretation.

In any case, even if some Senators believed that the United States and the Soviet Union had agreed to the restrictive interpretation, those beliefs could not create binding bilateral obligations under the Treaty. The best evidence of what the United States and the Soviet Union agreed to is in the Treaty text and the negotiating record. The Soviet Union refused to accept what is now called the narrow interpretation, and the United States has no greater obligation than the obligation the Soviet Union was willing to undertake.

I hope this is helpful to you in your examination of ABM Treaty issues. Please feel free to get back in touch if there is anything else I can do.

Thank you very much for your letter urging that the President not issue a national finding permitting the export of North Slope natural gas.

The President's Economic Policy Council met in late July to consider the issue of exporting natural gas from the North Slope. The Council agreed that before making any recommendations to the President, we should honor the Canadian Government's request to enter into consultations. The Canadians have expressed concerns about how the Trans Alaska Natural Gas (TAGs) project might affect the Alaska Natural Gas Transportation System (ANGST).

Once the consultations are completed, probably during the fall, the Economic Policy Council will consider again the issue of exporting North Slope natural gas. The Council at that time will take a number of factors into consideration, including the Canadian concerns and the importance of developing our natural resources.
