Rarely is there recognition, as your study ably points out, that corporate taxes can have dramatic effects on the value of shares and the amount of dividends paid.

Dear Ms. Steele:

Thank you for your June 17 letter in which you express concern about the policies governing the Administration's support for overseas family planning programs. I am sorry this reply is so long overdue.

The policy of this Administration is to provide strong support for voluntary population programs, but firm opposition to the use or advocacy of abortion as a method of family planning. This policy is based on the statutory law governing U.S. foreign assistance, and, as you know, it was announced by the United States at the International Conference on Population sponsored by the United Nations and held in Mexico City in August 1984.

To implement this policy, the Agency for International Development (AID) does not provide U.S. funds to foreign nongovernmental organizations that perform or actively promote abortion as a method of family planning. This policy does not infringe on the rights of foreign organizations to decide how they will spend their own funds, nor on the opportunity Third World women have to obtain advice from whomever they wish regarding their pregnancies. Rather, the United States has the right to decide how it will spend its funds for population assistance.

It is important to note that implementation of the Administration's policy (i.e., AID's withholding funds from foreign organizations which engage in abortion activities) has not reduced our total family planning assistance. AID has increased its support for family planning under this Administration, and AID remains the largest single donor in international family planning, providing more than 40 percent of the estimated \$500 million in assistance from all international donors last year.

AID considers population assistance to be a critical part of its effort to improve the health and survival of mothers and children. Family planning makes possible adequate birth spacing, thereby lowering maternal and child mortality rates. Administration policy emphasizes contraception and natural family planning (NFP), rather than abortion, as a means of child-spacing, and AID's support for family planning services measurably reduces reliance on abortion.

Each of the major U.S. organizations that have requested new grants since August 1984, except the Planned Parenthood Federation of America, which has sued AID, has accepted funding subject to the restrictions against providing appropriated funds to foreign organizations that conduct abortion activities. These U.S. organizations continue to operate effective programs making subgrants to nongovernmental organizations in foreign countries.

In conclusion, I do not believe the Administration is prepared to alter the Mexico City policy.

Again, thanks for setting aside the time to send me your thoughts.

Dear Mr. Griva:

Thank you for your recent letter expressing your opposition to the provision in the Senate-passed trade bill requiring advance notice to employees of plant closings and layoffs of 50 or more employees during any 90-day period.

The Administration will insist on removal of the Senate provision during the House-Senate conference on the trade bill. Contrary to the reported objectives of trade legislation, mandatory advance notice would make American industry less competitive, not more.

In his most recent letter to the Senate on this legislation, the Secretary of Labor stated that inclusion of any mandatory plant closing provisions would make it impossible for the President's senior advisors to recommend approval of a trade bill.

Thank you for sending me a copy of your assessment of the Guatemala City Accord. The Administration shares many of the concerns raised in your report.

After meeting with members of the Resistance Directorate on August 27, the President stated that we intend to see that the Nicaraguan Resistance has adequate funds until a cease-fire is in place and a verifiable and irreversible process of full democratization is underway in Nicaragua. The Sandinistas' history of broken promises and fervent commitment to Marxist-Leninist principles require that the United States give the process of reform in Nicaragua the strictest scrutiny. The Sandinistas would not have sat down at the bargaining table in Guatemala City without the military pressure from the Resistance. We believe it is crucial that the Resistance remain intact until Sandinista compliance with the Guatemala Agreement can be assessed and irreversible progress toward democratization has been made.

For this reason, the President will request that Congress approve \$270 million to meet the needs of the Resistance over the next 18 months. The timing of the Administration's request will depend heavily on what is happening with the peace process in Central America. There are a number of variables, particularly the behavior of the Sandinistas, which will affect how the request is structured.

The President recently appointed Deputy Assistant Secretary for Inter-American Affairs Morris Busby as Special Negotiator for Central America. His role is to maintain a continuous dialogue with the four democracies, both at the working and policy levels, to ensure that U.S. policy is clearly understood and to insist on timely and effective implementation of the Guatemala Agreement. Special Negotiator Busby is stressing our commitment to the Resistance and the need for the Central American democracies to take their views into account.

On behalf of the Administration, I would like to thank you for your support of our policy in Central America. Organizations such as the National Committee on American Foreign Policy make a real contribution in providing the public with information on the situation in Nicaragua and Central America.
