Dear Dr. Hughes:

Thank you for sending me a copy of your letter to the President regarding religious freedom in Romania. I appreciate receiving your views. In the spring, the President will again have to make a determination regarding the extension of Most Favored Nation (MFN) tariff status to Romania, and your observations will be of value in reaching a decision on this.

As you know, there is congressional opposition to continuation of Romania's MFN status because of that country's human rights practices. Both the Senate and the House of Representatives have adopted amendments to the trade bill which would suspend Romanian MFN for six months. While understanding and sharing the motivation behind these amendments, the Administration opposes them because we do not believe that they would have the desired result of improving Romania's human rights performance.

At this point, it is not clear what the outcome of the congressional action on Romanian MFN will be. However, we hope that it will be possible for us to continue MFN status for Romania and also to motivate improvements in the human rights situation there. We welcome your interest in this endeavor.


Dear Rudy:

Dear John:

Thank you for your letter of December 2, 1987, urging the President to meet with Prime Minister Mulroney in the Vancouver area to sign the Free Trade Agreement on January 2, 1988.


I certainly concur with your assessment that this agreement represents one of the most important accomplishments of this President.

I am informed, however, that the formal signing of that document does not require that the President and Prime Minister be together on that date. Further, there is no requirement that Canada sign on January 2; the only party that is required to sign on that date is the United States.

Finally, the President's schedule provides an event in Palm Springs on January 2nd that will preclude his traveling to Canada on that day.

For these reasons the President has decided not to go to Canada on January 2, 1988. We might consider, however, an appropriate event to highlight this historic trade agreement when we transmit the implementing legislation to Congress.

Dear Mr. Morford:

Thank you for your thoughtful letter of November 16 about Raoul Wallenberg. I regret that we were not able to arrange a meeting for Ambassador Anger with President Reagan before the Summit. We are aware that he has worked tirelessly on Mr. Wallenberg's behalf.

We remain unswerving in our efforts to persuade the Soviet government to release more information about Raoul Wallenberg. U.S. officials have raised his case with Soviet representatives several times over the past year -- most recently during the Washington Summit -- but have not, to date, received a satisfactory response to their inquiries. We will not relent in our efforts to receive a full accounting of this tragic case from Soviet officials. As President Reagan said in a statement commemorating the fortieth anniversary of Mr. Wallenberg's disappearance, we believe that the Soviet Union "has a moral obligation to answer the questions we have about his fate."

Raoul Wallenberg demonstrated great courage under the most difficult circumstances in his struggle to save Hungarian Jews during World War II. We will not forget his sacrifice.
