

Dear Mr. Shabout:

Thank you for your letter concerning the disturbances in the West Bank and Gaza and U.S. policy toward Israel.

The United States has watched with profound concern the pattern of violence in the occupied territories which began in early December. We are deeply grieved by the loss of life and by the large number of people who have been wounded. Such events threaten the well-being of both Palestinians and Israelis and harm the prospects for a peaceful resolution of the forty-year-old Arab-Israeli conflict.

The absence of peace and the resulting twenty-one years of Israeli occupation of the West Bank and Gaza have exacted a toll on the 1.5 million Palestinians in the territories and on the citizens of Israel as well. In the absence of a political agreement between the parties, the prevailing atmosphere has been one of mutual tension and mistrust. This environment has contributed to the recent violent protests by Palestinians and has prompted harsh security measures by Israeli authorities to restore order.

The United States has repeatedly urged both sides to adopt practices that avoid unnecessary confrontation and ease tensions. We oppose the use of lethal force and consider beatings and deportation to be counterproductive to the peace process and Arab-Israeli reconciliation. At the same time, we acknowledge the need for the preservation of public safety and believe that the Israelis have the right to seek the restoration of order in the occupied territories. We have taken a stance in the U.N. Security Council consistent with our overall assessment of the situation, while also noting that we do not believe the Council should dwell repeatedly on the same issues.

The current unrest underscores the urgent need for movement in the Middle East peace process. We have undertaken a new initiative on the Middle East, recognizing the importance of making practical progress. Secretary Shultz has travelled to the region, consulted regional leaders, and developed a proposal

that, if accepted, could get negotiations going -- negotiations that would soon offer real political gains to the Palestinians, meet Israeli security needs, and pave the way to a comprehensive peace.

However, no peace will be possible if Israel is not secure. President Reagan emphasized in his September 1982 Middle East initiative that, in order for the peace process to succeed, no one must doubt the security and legitimacy of Israel. Our military and economic assistance reflects this U.S. commitment to Israel as a free and democratic state and will remain essential for giving Israel the confidence to make peace.

We believe that all the parties involved see the urgency of taking practical steps to bring about reconciliation, negotiations, and peace. We will continue to be involved and do our best to move the peace process forward.
