TRUDEAU VISIT

Q. Can you tell us anything concerning a visit by Prime Minister Trudeau to Washington?

A. Prime Minister Trudeau will be visiting Washington on July 10. The Prime Minister will meet and have lunch with President Reagan. The discussion is expected to deal with OTTAWA Summit-related issues.

Q. At whose initiative was the meeting arranged?

A. The meeting was arranged at Prime Minister Trudeau's initiative, as host for the forthcoming Ottawa Summit. *(He will also be visiting European leaders participating in the Summit)*

FROM: JAMES M. RENTSCHLER

SUBJECT: Trudeau Visit, Mike Rashish, etc.

During a phone exchange with Mike Rashish on the Gaston Thorn business, he asked me, with a view to seeking your intervention, to pass on the following word:

He feels strongly about being excluded from the President's meeting with Trudeau tomorrow and says Bill Clark feels strongly about it too, and is prepared to call you or Mike Deaver about it. Rashish said he is not one to push himself, but that he was a lead player in the Ottawa Summit preparations and ought to be present in order to be up on any of the pre-trip nuances, etc, (face, of course, is also a consideration, since his Canadian counterpart, Allan Gotlieb, will be present).

I told him that on the basis of the meetings I had attended with you, I knew that you were in favor of his participation (I did not mention that apparently some considerable changes have since been ordered in the meeting and lunch format, about which I myself am very little informed). I promised him I would pass on his views, and so I have. For what it's worth, I do doubt the wisdom of excluding State's key substantive guy on economic issues, especially in the context of a meeting that is likely to turn technical and difficult. On the other hand, if the character of the lunch meeting has been completely changed (now more social than working) maybe it doesn't make much difference....
