PASSENGERS WHO WISH TO DEPART WITHIN NEXT 42 HOURS WILL BE COVERED BY PASSPORT WAIVER AT PORT OF ENTRY. OTHER PASSENGERS WHO HAVE CHOSEN TO REMAIN IN PARIS ARE BEING ISSUED REPLACEMENT PASSPORTS. TWA HAS ARRANGED HOTEL ROOMS AT CONCORDE LAFAYETTE HOTEL AND PASSENGERS WERE TAKEN THERE BY BUS AFTER PROCESSING TO AVOID A LARGE CROWD OF NEWS JOURNALISTS WHO WERE WAITING TO INTERVIEW THEM.
